**DEFENDANTS' RULE OF APPELLATE PROCEDURE 3(F)(2) MOTION TO AMEND
NOTICE OF APPEAL FOR PURPOSE OF PROVIDING A TRANSCRIPT IF NEEDED**

COMES NOW the current Defendant / Appellant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt") along with Defendant / Appellant The Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter "The Church) [none of which are or were lawfully within the proper jurisdiction of this local Lake County Court of Ohio] to file this Motion under the Ohio Rules of Appellate Procedure 3(f) for the purpose of getting done a transcript of the farcical three-day Lake County ~~Lynch Mob~~ jury trial in which both Pastor Lindstedt and Lindstedt's one-man Dual-Seedline Christian Identity Church were found to have somehow defamed a homosexual mongrel antifa & agent-provocateur pretending to be a White Supremacist nearly a decade ago named Bryan Reo who apparently has a special relationship with the Lake County Court to practice barratry.

Initially Pastor Lindstedt balked at the price of \$2,276 but Bryan Reo is well on its way to claiming for attorney's fees for itself and another fellow agent-provocateur and board member of the Foundation for the MarketPlace of Ideas, also an officer of the Court named Brett Klimkowsky who incited the Charlottesville Fiasco and the shakedown of sundry state universities in Florida, Michigan, Pennsylvania, and Ohio which reach into the tens of thousands against Pastor Lindstedt's inheritance in South Dakota and Missouri using "lawfare" so this price for the transcript will be money well spent if the post-trial Motions to overturn the Lake County ~~Lynch Mob~~ jury trial are unsuccessful.

There have been numerous post-trial judgment filings since the Final Appealable Order signed by Judge Patrick Condon on July 1, 2019. Appellants Pastor Lindstedt and Lindstedt's

Church filed a Notice of Appeal on July 30, 2019 to ensure that they get an appeal even though they do not recognize any Ohio court having any just jurisdiction over them practicing their Dual-Seedline Christian Identity religion holding in regards to Bryan Reo, who as a non-white wannabe White Supremacist and long-time antifa agent-provocateur. Bryan Reo has filed numerous motions for attorney's fees for itself and Brett Klimkowsky, for interest dating from when it was losing the frivolous federal case for alleged defamations that it was a homosexual mongrel dating from three years before it filed the federal case and thus outside the Ohio Statutes of Limitation for Defamation, and for sanctions because Pastor Lindstedt wouldn't obey Bryan Reo's discovery games in which Reo demands everything under the sun but Reo wouldn't admit to the mere names of those Reo was homosexually blackmailing and of Reo's tortuous interference in taking down Church web pages. Bryan Reo is trying to shakedown Pastor Lindstedt and trying to deny Lindstedt's right to a fair hearing on Reo trying to collect its "foreign judgment" in Newton County Missouri and Stanley County South Dakota, even though they have laws mandating full legal process before property can be seized and sold. Pastor Lindstedt declines to ask this Appellate Court for any such stay of execution as it will be an admission of jurisdiction of which no court in Ohio has or ever had over the publishing of true and largely public information available elsewhere over the Internet from 900 miles away nearly a decade ago on Bryan Reo and Reo's fellow ZOGbots.

Since these post-trial Motions by both Pastor Lindstedt and Bryan Reo are before the trial court and have not been ruled on, much less appealed, the provisions of Appellate Rule 4(B) and 4(5)(C) might apply and this appeal might be pre-mature or become mooted. However the transcript of the three-day farcical trial is now being ordered and paid for today while there is a Appellate Rule (4)(B) Motion to Remand to Trial Court pending for Appellate Case 2019-L-073 (and should also be for 2019-L-074 but isn't for some reason). The Court Recorder for this case, Susan Goodell, says that it will be necessary to ask for an extension of time to prepare the lengthy transcript so therefore I so ask for that extension as necessary right now.

Appellate Rule 3(F)(2) says this Amendment of Notice of Appeal shall be filed in both this Appellate Court and the trial court, therefore two copies each of this motion and one for Reo. Exhibit #1 is the ordering of the Transcript and the \$2,276 money order to pay for it.

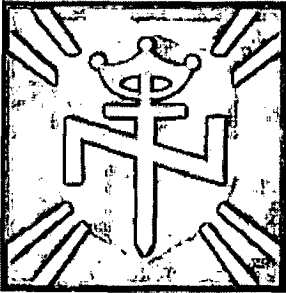

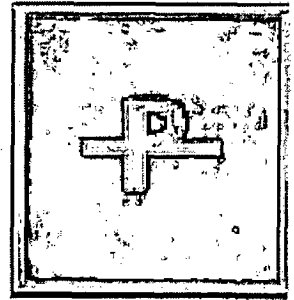
