Before me, the undersigned Notary Public, on this 29 day of August, 2019, personally appeared Pastor Martin Lindstedt, known to me on the basis of satisfactory evidence in the form of government-issued photographic identification to be said credible person of lawful age, who being by me first duly sworn, on his oath, deposes and says under penalty of perjury:

Between January 2017 and June 2018, Brett Klimkowsky served as the attorney-of-record for *Bryan A... Reo in Bryan Anthony Reo v. Martin Lindstedt, et al.*, which was Case Nos. 15CV001590 and 16CV000825 at the State of Ohio's Court of Common Pleas of Lake County. From early 2016 until March 3, 2018 Brett Klimkowsky was an attorney serving on the Board of Directors for the Foundation For the MarketPlace of Ideas as were Bryan Reo (as a law school) and Kyle Bristow. Along with other White Supremacist Movement leaders and lawyers they posed as the White Supremacist version of the Southern Poverty Law Center. However Bryan Reo started out as antifa pretending to be White Supremacist and looking at the cases in which Kyle Bristow (Bryan Reo was Bristow's law clerk) they seem to be liberal lawyers. In short all three lawyers are federal and state agents provocateur.

On 9 Nov. 2019 between 4:10 to 4:45 pm Brett Klimkowsky called me up at my home for 35 minutes, had to hang up for a minute to check up on his mother, then called me again from 4:46 to 6:35 pm for one hour 55 minutes. What was discussed was me demanding to know why Klimkowsky signed off of a Reodrafted Motion in Limine in June 2017 to prevent me from testifying on my own behalf at Reo's litigation in Lake County on the basis of since I was illegally ssent to a State NutHouse I was too crazy to be allowed to testify on my own behalf although not crazy enough to not be sued by Reo. I told Klimkowsky so that he should be disbarred. What was not discussed was Resistance policy that traitors should be tortured to death and their spawn made into geldings and walking wombs. Klimkowsky claims he spent slightly more than twenty-one (21) hours providing legal services to Mr. Reo for the above-referenced case. At his reasonable hourly rate of \$200, the bill to Mr. Reo is four thousand two hundred dollars (\$4,200.00) for said twenty-one (2 1) hours of work. However, around the 3 minute mark on the second call which would be around 4:50 pm 9 November, 2019 Klimkowsky says "I don't like making any money at it, I just like helping him (Reo) out because I can."
