DEFENDANTS' AMENDED PRE-TRIAL MATTERS



Reo lost at the federal level before going to this court sans jurisdiction and Reo's enemies amongst the NIM-Busters have spread them far and wide. If Reo tries to destroy this evidence like it has destroyed much other evidence during the five years of litigation, then such should be noted. 
