RULE 74.14(d) MOTION TO STAY JUDGMENT OF FOREIGN OHIO COURT GIVEN THAT THERE ARE POST-TRIAL MOTIONS IN PLAY AND THAT A NOTICE OF APPEAL HAS BEEN FILED

COMES NOW the Defendant(s)/Respondent(s) Pastor Martin Luther Dzerzhinsky Lindstedt, of and the Church of Jesus Christ Christian / Aryan Nations of Missouri (The Church) who lost a jury trial on 26 June 2019 commenced by Bryan Reo in September 2015 and April 2016 after Bryan Reo lost the Federal court case for \$10.75 million for calling Bryan Reo a homosexual mongrel pretending to be a White Supremacist. The jury trial lasted three days, Pastor Lindstedt was not allowed to present his evidence and Bryan Reo was allowed to cherry-pick stuff taken nearly a decade ago from the Church web pages. The racially mixed hostile jury decided to punish both Pastor Lindstedt and "Aryan Nations" for advocating the Dual-Seedline Christian Identity doctrines of White Racial Supremacy. (If the action by Reo against Roxie Fausnaught and The Church of Jesus Christ Christian initiated by Reo in the Mentor Municipal Court hadn't mentioned "Aryan Nations" then maybe the jury would have thought that Pastor Lindstedt's Church was a mere Mormon cult.) Bryan Reo called Pastor Lindstedt a "convicted child molester" who was punished by imprisonment in the Fulton State NutHouse (which this Court packed Lindstedt off for nearly three years for not accepting a lawyer to sell him out). The jury decided to ignore these facts and the fact that the Ohio Statute of Limitations for libel and defamation are only one year and allowed Reo to present alleged defamations from 2010, 2011, 2012 because Reo pretended that its federal filing in April 2014 which was dismissed acted as a sort of refrigerator. Reo therefore makes a Claim to collect \$105,000

in compensatory and punitive damages from Pastor Lindstedt and \$200 for compensatory and \$200 for punitive from The Church of Jesus Christ Christian.

However Missouri Supreme Court Rule 74.14(d) regarding Foreign Judgments states:

(d) Stay.

(1) If the judgment debtor shows the circuit court that an appeal from the foreign judgment is pending or will be taken or that a stay of execution has been granted, the court shall stay enforcement of the foreign judgment until the appeal is concluded, the time for appeal expires, or the stay of execution expires or is vacated upon proof that the judgment debtor has furnished the security for the satisfaction of the judgment required by the state in which it was entered. (Emphasis added)

Pastor Lindstedt and Lindstedt's Church have filed a Notice of Appeal before the 11th Appellate Court in Ohio on 30 July 2019, #2019-L-073 & -074. Pastor Lindstedt has printed out that Appellate Court Docket for #2019-L-073 as proof that this case is pending. Right now under the Ohio Court Rules there are half a dozen post-trial motions waiting to be ruled upon by the trial court and if Pastor Lindstedt's Rule 50 Motion to Vacate or Motion for New Trial is granted then there will be no need for the appeal to take place. In any case, Missouri Court Rule 74.14(d) mandates that this Court stay any judgment or further proceedings until the judgment is overturned by the Ohio trial court or the appeals are finished. Bryan Reo has filed yet another lawsuit against myself in Lake County for making fun of it in my filings and Pastor Lindstedt is going to file a federal lawsuit or two against Bryan Reo and Reo' co-conspirators who are actually antifa and agents provocateurs whose function is to induce these mass shootings amongst unstable individuals and to get them to take part in foolish White Supremacist rallies like the Charlottesville fiasco. That and work to get Bryan Reo, Kyle Bristow and Brett Klimkowsky who are Ohio lawyers and ZOGbots disbarred. The ridicule of Bryan Reo shall continue as White People need to be warned about this self-loathing psychotic mongrel who is notorious in the state and federal courts of Ohio at churning up litigation. This might take another four or five years to resolve unless Reo goes postal as promised.

Wherefore Plaintiff Pastor Lindstedt and Pastor Lindstedt's Church of Jesus Christ Christian / Aryan Nations of Missouri files this Rule 74.14(d) Motion for Stay of Judgment pending appeal in the Ohio courts which this Court has no option other than to grant until the appeals process or vacation of judgment takes place. Pastor Lindstedt received this Court Clerk's Notice of commencement of this action under Rule 74.14 today, 16 August 2019.
