CONTESTING NON-FINAL JUDGMENT OF UNLAWFUL SANCTIONS FOR PLAINTIFF MAKING A VALID MISSOURI SUNSHINE ACT ENFORCEMENT ACTION; DEFENDANTS CITY OF GRANBY, THEIR ATTORNEY BRIAN GOLDSTEIN AND THIRD PARTY ATTORNEY BRYAN REO'S CRIMINAL CONSPIRACY TO VIOLATE PLAINTIFF PASTOR MARTIN LINDSTEDT'S CIVIL RIGHTS UNDER COLOR OF LAW

COMES NOW the Plaintiff(s)/Petitioner(s) Pastor Martin Luther Dzerzhinsky

Lindstedt, to contest the non-final judgment of Charles Curless overturning the Missouri

Sunshine Law and the First Amendment by deliberately misreading the provisions of the

Missouri Sunshine Law Revised Statute of Missouri 610.023. (3)'s provision that "Each
request for access to a public record shall be acted upon as soon as possible." and (4)s
provision If a request for access is denied, the custodian shall provide, upon request, a
written statement of the grounds for such denial." Furthermore Judge Curless violated
the Missouri Sunshine Act by granting the the City of Granby's Attorney Brian

Goldstein's claims that because Plaintiff Lindstedt dared to sue the City of Granby based
upon his reading of the Missouri Sunshine Act, that Plaintiff should be sanctioned by
having to pay Goldstein's lawyers fees for Granby of \$4000. After around 30 minutes of
what appeared to be nothing more than corruption and oppression from the bench, Judge
Curless ruled as following on July 25, 2018:

Petitioner wholly fails to state a claim upon which relief may be granted. Court further finds all allegations of said "Petition" are frivolous and without merit. Court grants sanctions against Petitioner in favor of Defendant Attorney in the sum of \$4000.00 SO ORDERED. Charles Curless

Judge Curless refused to say why Plaintiff's "Petition" done in good faith according to Plaintiff's reading of the Sunshine Law statute was "frivolous" or why grant Granby City Attorney Brian Todd Goldstein's lawless and perjurous claims Pastor Lindstedt should be sanctioned for daring to sue the City of Granby according to that statute. Since Judge Curless told Pastor Lindstedt to "put on his appellate shoes" then Judge Curless, having denied Plaintiff's Motion for him to Alter, Amend or Revise his Judgment on Sept. 18, 2018, should have been more than ready to make a Final Judgment on this case so that Pastor Lindstedt can make an appeal to the Missouri Court of Appeals. Pastor Lindstedt filed such a Motion for a Final Judgment so that this case could be appealed on Oct. 17, 2018. Judge Curless has refused to rule on it and thus this case remains in limbo.

Thus the City of Granby, its lawyer Brian Todd Goldstein violated the Missouri Sunshine Act and dared to punish Plaintiff Pastor Lindstedt for doing so with a lawless "sanction" disallowed by Missouri Law and Constitution for bringing this civil action encouraged by law, not to be punished for daring to sue a corrupt Granby city council for malfeasance and lawlessness in trying to cover up their nefarious schemes. Thus the non-final "judgment" of \$4000 in unlawful "sanctions" to be paid to Attorney Goldstein is not valid or to be applied to Plaintiff Pastor Martin Lindstedt, at least not until there is appellate review brought up upon a final judgment by Judge Curless or upon Pastor Lindstedt re-filing the case as it was dismissed without prejudice being a Missouri Sunshine Act case.

This past week (Oct. 15-19th, 2019) the City of Granby, without due process and solely upon the determination of its police employees, public works employees and selective enforcement of their municipal ordinances chose to employ a contractor to tear up the ground on Pastor Lindstedt's and Roxie Fausnaught's Granby properties and that of Lindstedt's nephews and niece to plow under the grass and bulldoze down the smaller trees and tear up the ground. This was done without any due process of law other than the determination of the Granby City Council and Granby police and public works employees. At the same time (Oct. 14, 2019 3:10pm) Pastor Lindstedt was notified by Attorney Bryan Reo who won a defamation civil lawsuit against Pastor Lindstedt and

Pastor Lindstedt's Church of Jesus Christ Christian / Aryan Nations of Missouri 900 miles away in Lake County Ohio that he was "purchasing" this bogus "judgment / sanction" for \$1000 to collect \$4000. Upon asking Council-man Ashley Edgmon if this was true Monday night Oct. 14, 2019 Ashley Edgmon confirmed that this was the case. The next day (Oct. 15, 2019) the illegal bulldozing began.

It is obvious that Bryan Reo, who has been stalking Pastor Lindstedt for nearly a decade decided to "buy" this fraudulent and unlawful "judgment" for a \$1000 so that it could harass Pastor Lindstedt for \$4000, use it as a learning experience in collecting its \$105,000 "defamation" lawsuit now under appeal in the Ohio 11th District Appellate Court and work on stealing Pastor Lindstedt's inheritance in South Dakota through four more lawsuits by itself, its wife and father. For their part, the City of Granby is punishing Pastor Lindstedt for daring to stand up against their corruption. Attorney Brian Todd Goldstein, during another hearing on a Sunshine Act Enforcement Action hissed to Pastor Lindstedt, "You owe me four thousand dollars." Pastor Lindstedt said right back, "You owe me four thousand heads and pelts, jewboy." Thus this is clearly an illegal conspiracy by the City of Granby, their jew lawyer Brian Todd Goldstein and another Satanic mongrel abomination Bryan Reo, Esquire, to harass, defraud and violate the civil rights of Pastor Martin Lindstedt under color of law.
