**DEFENDANT'S MOTION FOR SANCTIONS AGAINST ATTORNEYS BRYAN REO,  
BRETT KLIMKOWSKY, AND KYLE BRISTOW ACTING IN CONSPIRACY TO  
DRAFT ADDITIONAL CHARGES UPON PASTOR LINDSTEDT & LINDSTEDT'S  
CHURCH THROUGH FRAUDULENT POST-TRIAL MOTIONS PENDING APPEAL**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt") along with Defendant The Church of Jesus Christ Christian / Aryan Nations of Missouri ( hereafter "The Church) [none of which are within the proper jurisdiction of this local Lake County Court] to propound good reasons that far from granting \$4200 to Attorney Brett Klimkowsky that rather this Court should instead sanction under these three attorneys – Bryan Reo, Brett Klimkowsky, and Kyle Bristow -- of the former "White Supremacist Lawfare" corporation on the Board of Directors for "The Foundation For the MarketPlace of Ideas" or as Pastor Lindstedt calls it "the ZOGbot Poverty Law Center" under



Civ. R. 11 and R.C. 2323.51. (Exhibit #1, Board of Directors of FMI). On 27 August 27 Pastor Lindstedt discovered that Attorney Kyle Bristow was the author of Bryan Reo's Motion for Attorney Fees on behalf of Brett Klimkowsky. (See Exhibit #2, Microsoft Office Metatdata showing Kyle Bristow is the author of this document turned around by Pastor Lindstedt). And recently Pastor Lindstedt has retrieved two phone calls made 9 Nov. 2018 in which Attorney Brett Klimkowsky took it in his head to call up Pastor Lindstedt to disclaim working for Bryan Reo for free because Klimkowsky "just likes helping him (Reo) because I can.) See Pastor Lindstedt's Affidavit of 29 August 2019 (Exhibit #3). And thus, contrary to Bryan Reo's case, it is entirely likely that these three lawyers are engaged to work with both state and federal security agencies as agents provocateur / ZOGbots to disrupt genuine White Supremacist / White Nationalist groups and churches like Pastor Lindstedt and Lindstedt's Aryan Nations Church.

1. For the reasons set forth in Defendants Pastor Lindstedt and Lindstedt's Church Brief in Support of Defendant's Motion for Sanctions against Attorneys Bryan Reo, Brett Klinkowsky, and Kyle Bristow, the Court (without any real jurisdiction over Pastor Lindstedt and Lindstedt's Church for what was said on the Internet 7 or 8 years ago about Bryan Reo but has jurisdiction over its erring and criminal officers of its own court) should award Defendants Pastor Lindstedt and Lindstedt's Church a negation of all awards reached by fraud against Pastor Lindstedt of \$40,000 in unspecified compensatory damages, \$50,000 in punitive damages, \$15,000 in "false light" for opinions reached and questions raised about Bryan Reo's North Perry Nuclear Power Plant employment and Lindstedt's Church of \$200 in compensatory damages and \$200 in punitive damages for something or another and make Bryan Reo pay the court costs for this frivolous litigation well past the Ohio Statutes of Limitation of one year since first made. Additionally these three lawyers should be sanctioned \$10,000 each and disbarred for fraud and



abuse of legal process as sanctions due to corrupt misconduct engaged in by these three attorneys during the instant civil action and afterwards in order to in collusion and conspiracy act against this particular White Supremacist / White Nationalist Dual-Seedline Christian Identity Pastor and Church..

WHEREFORE, Defendant Pastor Lindstedt and The Church of Jesus Christ Christian / Aryan Nations of Missouri asks that this local Lake County Court with no jurisdiction over Defendants living 900 miles away in a different state but with jurisdiction over its criminal and perjurous officers of its Court will in effect dismiss the bogus case against Defendants and will punish these three lawyers with \$10,000 sanctions payable to Defendants and their disbarment from ever practicing lawfare against their White Supremacist / White Nationalist quarry again.
