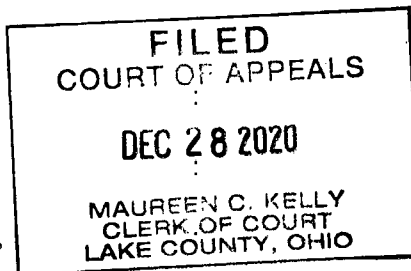

Comes now Pastor Martin Lindstedt and The Church of Jesus Christ Christian / Aryan Nations of Missouri (henceforth Pastor Lindstedt's Church but not Roxie Fausnaught, deceased since 4 Aug. 2020) to plainly pro-offer under this Ohio Court sans jurisdiction an Appellate Rule 26 Application for this Court to have an opportunity to Reconsider its Judgment/Opinion of 14 or 16 December 2020 wherein it affirmed the Lake County Court of Common Pleas judgments for Bryan Reo against Pastor Lindstedt and Lindstedt's Aryan Nations Church.
