**DEFENDANTS' RESPONSE TO THIS FRAUDULENT EX PARTE ORDER MADE
WITHOUT JURISDICTION BY THIS CORRUPT COURT DEMANDING EITHER A

APPEARANCE BY TELEPHONE BY PASTOR LINDSTEDT**

COMES NOW the current Respondent Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt") along with his Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter "The Church) [none of which are within the proper jurisdiction of this local corrupt Lake County Court] to Respond asking for a Dismissal or punishment of Attorney Bryan Reo who has been stalking Pastor Lindstedt and Lindstedt's Church for over a decade and has "lawfared" them since April 2014 in both federal and Lake County Courts.

Pastor Lindstedt asked for and got the current skimpy results for this bogus case by Bryan Reo – this is Reo's second civil stalking case based upon lies and designed solely to harass and oppress by forcing Pastor Lindstedt to have to drive 892 miles from his home in Granby Missouri to Painesville Ohio – on Friday, May 22, 2020. The Church of Jesus Christ Christian / Aryan Nations of Missouri 16CV000825 and these cases, along with Bryan Reo appeals for “pre-trial interest” are currently before the Ohio 11th District Court of Appeals, 2019-L-073 & 074 and 2019-L-137 and 138.
