**RESPONDENTS' INTENTION TO CALL IN REGARDING THIS FRAUDULENT EX
PARTE ORDER PROCEDURE MADE WITHOUT JURISDICTION BY THIS COURT**

COMES NOW the current Respondent Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt") along with his Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter "The Church) [none of which are within the proper jurisdiction of this local corrupt Lake County Court] to Announce his intention to call in to these fraudulent proceedings by which Bryan Reo seeks to gain a second fraudulent "protection order" Pastor Lindstedt and Lindstedt's Church. Bryan Reo has stalked Pastor Lindstedt for over a decade and has "lawfared" them since April 2014 in both federal and Lake County Courts. Pastor Lindstedt has publicly ridiculed Bryan Reo and Bryan Reo's jew, mongrel and homosexual ZOGBot friends for over a decade but has never actually called Bryan Reo up. Pastor Lindstedt has instead urged anyone listening to him to have nothing to do with Bryan Reo and anyone who will have anything to do with Bryan Reo.

On the afternoon of 25 May 2020 Pastor Lindstedt called into the chambers of this "Magistrate Andre". Magistrate Andre said that he wouldn't speak *ex parte* about this ex parte case filed by Bryan Reo. Pastor Lindstedt asked "Why not, you accepted *ex parte* claims and then ruled in favor of Bryan Reo? Why not accept my *ex parte* defense?" What Pastor Lindstedt wanted was to appear by telephone instead of having to drive 891.1 miles to the Lake County Courthouse from his home in Granby. Magistrate Andre refused to allow this at all, just as happened back in Feb. 2016 and after more refusals to allow Pastor Lindstedt to appear by telephone hung up on Pastor Lindstedt.

Bryan Reo is delusional and vicious and in other cases refuses to appear for depositions unless it is before a friendly judge. In any case, Pastor Lindstedt has only met Bryan Reo before via cases Bryan Reo has fraudulently initiated. This is simply “lawfare” by Bryan Reo with the aid of a corrupt Lake County Court system in which further harassment is likely contemplated.

Pastor Lindstedt and Pastor Lindstedt’s Church do not recognize the jurisdiction of this corrupt Lake County Court to place a second (or a first) bogus Order of Protection crossing county or state lines other than to create a pretext for racial and religious civil warfare. However, Pastor Lindstedt shall attempt to appear by telephone on May 28th @ 11:15 a.m. and give this corrupt court an opportunity to dismiss this fraudulent procedure and punish Bryan Reo.
