COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to file this Initial Response to Attorney Robert Konrad as an antifa lawyer for non-white "white supremacist" agent provocateur Bryan Reo's fraudulent Motion for Summary Judgment for figures in Bryan Reo litigation well outside the initial filing of this vexatious and frivolous lawsuit when initiated in Feb 2019 and upon litigation racked up in Ohio that is still ongoing and under appeal. Pastor Lindstedt just found out this weekend about Judge Bridget Mayer's 10 Aug. 2021 ORDER denying Pastor Lindstedt's Motion for a Continuance and read Susan Bessman's lawyer Sarah BaronHuoy's Response over the weekend. Pastor Lindstedt also got hold of the 31 Aug. 2021 Hearing Transcript and is looking it over and sees that the only judgment which was filed upon was the \$105,000 against Pastor Lindstedt and \$400 against Pastor Lindstedt's Church of Jesus Christ Christian / Aryan Nations of Missouri. The Ohio Supreme Court refused to rehear these Bryan Reo v. Martin Lindstedt, Aryan Nations Church Lake County litigation on Aug. 3, 2021 but Pastor Lindstedt

has 90 days from that date to petition for writ before the U.S. Supreme Court and intends to do so. The rest of the Bryan Reo barratry cases are either before the 6th Circuit Court of Appeals in Bryan Reo v. Martin Lindstedt 19-cv-02103 (for \$1 million) 6th Circuit Case 21-3633 and Pastor Lindstedt presented his Objections to Bryan Reo collecting on Anthony Domenic Reo v. Martin Lindstedt 19-cv-02615 (for \$500,000) 6th Circuit Court of Appeals Case 21-3661. The other two cases are before the Northern District of Ohio awaiting further process and hearing before appeal

Ever since last year Bryan Reo, Attorney Konrad and Susan Bessman's first lawyer Kody Kyriss has been extorting and blackmailing Susan Bessman with the loss of her estate as well as what Pastor Lindstedt gave her of his inheritance back on Oct. 25, 2019. Bryan Reo even filed a bogus case before Ohio against Pastor Lindstedt, his Aryan Nations Church and Susan Bessman, 21-cv-000753 which upon drawing Federal Judge James Guinn who isn't amenable to non-white homosexual federal agents provocateur in 2021 any more than in 2014 forced Bryan Reo to voluntarily dismiss in that venue. Thus Attorneys Bryan Reo, Robert Konrad, and Kody Kyriss are not only engaged in extortion and barratry by trying to harass and extort Susan Bessman into giving them the payoff they have sought since late 2013 when Konrad stole confidential legal files regarding Susan Bessman from the Ollinger Law Firm of Pastor Lindstedt's inheritance but are seeking to destroy Susan Bessman as well. This in direct violation of the very permanent injunction that they have sought and gained through fraud forbidding the further sale or transfer of the disputed property **until all Ohio litigation is complete** which this very judge signed off on on 2 Nov. 2020. In fact, as noted that Susan Bessman agreed to this preliminary injunction. Yet these lawyers have pressured and extorted Susan Bessman to instead give it to them and emboldened by there being no dire consequences for their thievery are now demanding in effect that this injunction be set aside and the Pastor Lindstedt's former property as well as another

\$1.2 million of her own property be given to them because the former inheritance isn't worth as much for them to take.

This proposed fraudulent Summary Judgment is directly at variance with Judge Mayer's Memorandum Decision of 31 July 2021 in which Judge Mayer wrote, page 2: "*If granted, the preliminary injunction would prevent transferral or encumbrance of the property until the legal matters are concluded in the Ohio cases.*" Additionally on page 3 Judge Mayer wrote: "*The preliminary injunction would merely preserve the property in question until the Ohio matters are decided.*"

Thus since none of the Ohio legal matters have been finally decided, not even the \$105,000 judgment against Pastor Lindstedt or the \$400 against Pastor Lindstedt's Aryan Nations Church until the U.S. Supreme Court refuses to hear whether it is wise or just to allow one of its non-white homosexual agents provocateurs pretending to be a white supremacist (i.e. Bryan Reo and most of the Foundation for the Marketplace of Ideas) as a public figure and agent provocateur to file lawsuit after lawsuit for "defamation and libel" against an Aryan Nations (and alleged domestic terrorist "AmeriKlan TalibKlan") Church and pastor living 900 miles away who has advocated since 13 June 2016 chernobyling the North Perry Nuclear Power Plant and turning Northeastern Ohio into a nuclear wasteland reservation, prion-poisoning the entire ZOGLand by spreading Mad Cow and Chronic Wasting Disease since 1996 sometime (which happened in Wisconsin in 2000 and Missouri in 2010), and since March 2020 of Noachian Deluging the Missouri River impoundments in Montana, North & South Dakota until their lawyers, judges, police, politicians and their families are exterminated or enslaved. As Pastor Lindstedt looks at it, even though he did get in touch with the Ohio Congressional Republican Delegation of NorthEastern Ohio asking for U.S. Congressional permission to sue the entire State of Ohio, if

the U.S. Supreme Court denies Pastor Lindstedt's Petition for Cert. there is a second ailing nuclear power plant in Columbus as well as North Perry. And it seems that idiots with mental problems are beginning to show up pretending to have bombs in their trailers at the North Perry Nuclear Power Plant this past April which Pastor Lindstedt found out about. Pastor Lindstedt and his Aryan Nations web page publishing that Bryan Reo is a crazed delusional homosexual mongrel who interfered with someone's federal case and was talking on StormFront about killing FBI, BATF, and Lake County police so that Bryan Reo got fired from working there as an "internal security threat" and removed from the nuclear technician training program at Lakeland Community College. Pastor Lindstedt might have inadvertently saved 6 million ZOGling whigger and mamzer lives around Cleveland and was punished by being sued for doing so. So if after chernobyling the North Perry Nuclear Power Plant the rest of the State of Ohio wants to "double-down" then chernobyling the Columbus nuclear power plant and killing another tens of millions might teach the remainder of the ZOGLand that Mighty Evil Empires are bad. Pastor Lindstedt is certain that the inhabitants of the upper and lower Missouri River that it would be better to exterminate or eliminate the [d]ruling classes rather than have to destroy these impoundments after a new Noachian Deluge.

Pastor Lindstedt is noting that the only claim that Bryan Reo has is for the \$105,000 which was extant when Bryan Reo filed in early Feb. 2019. That while the federal courts were suicidally corrupt, it wasn't known that even they would go so far as to do away with the 7th Amendment right to jury trial in civil matters over \$20 and the 8th Amendment of "no excessive fines" involving literally millions of ZOGbux. As it is now, all of these cases are still pending in federal district court or before the 6th Circuit Court of Appeals. All of the pleadings are public records posted on Pastor Lindstedt's numerous Aryan Nations web pages, that the Ohio and

federal regimes are out to destroy White People and their Resistance. Whether Bryan Reo will prevail remains to be seen. However, this proposed Fraudulent Motion for Summary Judgment drafted by Attorney Robert Konrad goes against Judge Mayer's Memorandum Judgment of 31 July 2020 in that none, much less all of the never-ending Bryan Reo fraudulent litigation is even remotely over. Nor should Susan Bessman's property outside what Pastor Lindstedt signed back to her in Oct. 2019 be at any risk or hazard whatsoever.

Susan Bessman's second lawyer Mark Marshall was initially instructed to file a quitclaim back of the property to Pastor Lindstedt in April until the inept Bryan Reo attempt in federal court whereupon Susan Bessman told her then lawyer to "grow a pair" and the proposed quitclaim was negated. Thus even if prematurely decided, the question of "fraudulent transfer" means that at the most, Susan Bessman would be forced by this Court to transfer back to Pastor Lindstedt the property warranty deeded to her by Pastor Lindstedt in Oct. 2019.

What has come out has been exactly what Pastor Lindstedt has written in numerous court filings. Pastor Lindstedt was having his and Roxie's and his niece and nephews' Granby property illegally bulldozed, Bryan Reo was working with the Granby City Council on one of his harassing lawsuits and Pastor Lindstedt found out about it on 14 Oct. 2019. The next day around 12:35 p.m. Pastor Lindstedt intended to shoot the Granby police and employees bulldozing the Granby property without legal process but decided to hold off until more could be ambushed, Pastor Lindstedt could transfer his South Dakota property to his sister, make a last will and testament and Roxie could be safely buried. Bryan Reo wasn't much of a concern as much. Then the Covid-19 ZOGvirus hit, ZOG was falling apart, and Pastor Lindstedt hasn't thought of seriously shooting Granby Council-Criminals since Jan. or Feb 2020. Of course Pastor Lindstedt didn't tell Susan Bessman anything about this as she isn't very racist and ruined by working with

Newton County social services and Pastor Lindstedt didn't want to put her in the position of "red-flagging" Pastor Lindstedt. Around Feb 27, 2020 someone was trying to serve Susan at her Florida rentor's house and Pastor Lindstedt thought Bryan Reo and his crooked SD lawyer got her name off of the Missouri Secretary of State's web page for Pastor Lindstedt's Aryan Nations Church. Pastor Lindstedt didn't find out until a few weeks later that the reason Bryan Reo knew her e-mail address and was sending extortionary e-mails was that Reo got it off of Konrad who used to work for Ollinger law firm. That night of 27 Feb 2020 myself and Roxie voted to remove Susan Bessman as an officer of Pastor Lindstedt's Aryan Nations Church.

So as both Pastor Lindstedt court filings and Attorney Konrad's sundry depositions prove, Susan Bessman didn't know anything about Bryan Reo nor about shooting Granby council-criminals and thus did not "conspire" to defraud Bryan Reo. Pastor Lindstedt who has been running Resistance operations and militias for the past 25 years didn't tell Susan Bessman anything she didn't need to know. This has been made clear from the very beginning. Thus the 31 July 2020 Memorandum Decision holds in which no Motion for Summary Judgment can be entertained but rather the property deeded back to Susan Bessman will be held in reserve until such time as ALL of the Ohio Bryan Reo litigation is over. Pastor Lindstedt suggests that this means only the \$105,000 Lake County Judgment, NOT the fraudulent and tyrannical Bryan Reo and Reo family litigation for millions imposed by corrupt federal judges without benefit of jury trial for mythical compensatory and tyrannical punitive damages. Thus Susan Bessman is not a proper defendant but rather a person who is holding property for which the maximum possible claim is for \$105,000 (Aryan Nations has no SD property.) after a trial by jury determination in which a judge must first determine whether Pastor Lindstedt got a valid foreign judgment for \$105,000 against himself according to SD 15-16-45 & 46 prohibiting foreign libel barratry.

Pastor Lindstedt in any case is demanding a trial by jury on this matter. But for now, Attorney Bryan Reo and Robert Konrad's Motion for Summary Judgment is unlawful in that they have been extorting Pastor Lindstedt's sister and terrorizing her by threatening to steal her property which has nothing to do with how much Bryan Reo gets from corrupt state and federal foreign courts in violation of Judge Bridget Mayer's 31 July 2020 Memorandum and 2 Nov. 2020 Preliminary Injunction. *"Ultimately, should there be a finding of a fraudulent transfer to Bessman, the property would still be Lindstedt's and it could be utilized by Plaintiff to satisfy any valid judgments. . . "* Pg. 3, *Memorandum*. Thus Attorney Reo and Konrad are claiming that Pastor Lindstedt's sister is a defendant responsible for whatever end results of Bryan Reo's never-ending litigation happens and since the tally before appeals amounts to \$2.75 million and the property which was deeded back is now only \$1.3 million and Bryan Reo wanted \$2 million that Susan Bessman as the holder of the property must pay \$1.2 million additionally. Thus Konrad is in effect making Susan Bessman responsible for the political and racial conduct of her brother when she holds no such beliefs as her Aryan Nations pastor brother.

The money shot is Judge Mayer's closing argument on her Memorandum Decision of 31 July 2020 on page 3.

"It is worth noting that once Defendant realizes that the preliminary injunction would merely preserve the property from being further transferred and encumbered (but does not resolve the merits of the underlying complaint), Defendant might very well agree that the preliminary injunction should be granted. The preliminary injunction would serve to preserve the property in question, until the Ohio court matters are resolved, and this matter is concluded."

Thus the preliminary injunction sought and gained by Bryan Reo and Robert Konrad has in fact been violated by both of them. They sought this preliminary injunction as a "first

step” to forcing Pastor Lindstedt’s sister to not further transfer or encumber the inheritance deeded back to her and then extorted and harassed her with the aid and assistance of her first lawyer Kody Kyriss. Now in his Motion for Summary Judgment Attorney Konrad having failed to extort and blackmail Susan Bessman now seeks to set aside the terms and conditions of this initial lawsuit and preliminary injunction which was “to preserve the property in question, until the Ohio court matters are resolved, and this matter is concluded.” Ibid.

Pastor Lindstedt as head of the Aryan Nations of Missouri -- and elsewhere -- has had to fight this Satanic Mighty Evil Empire of ZOG/Babylon and every single Satanic servant and Spawn of Satan and that especially means Bryan Reo who was trying to infiltrate the White Supremacist and Dual-Seedline Christian Identity Movements since 2002. Pastor Lindstedt found out “SwordBrethren’s”/Bryan Reo’s identity and address Halloween 2010. After agreeing that Bryan Reo would leave the Movement and never come back from 1-4 Nov. 2010 Bryan Reo broke the agreement it sought and made and went off on a tear in censoring and removing around a dozen of Pastor Lindstedt’s Aryan Nations and allied web pages. For over three and a half years Pastor Lindstedt truthfully told everyone that SwordBrethren / Bryan Reo was a crazed delusional Satanic homosexual mongrel abomination agent provocateur and Bryan Reo lied that Pastor Lindstedt was a child molester and a convicted one at that. Pastor Lindstedt’s Aryan Nations web page got Bryan Reo fired from the North Perry Nuclear Power Plant. Bryan Reo along with his Aryan homosexual lover Attorney Kyle Bristow and another lawyer Brett Klimkowsky and Richard Spencer and Mike Enoch and other longtime ZOGbots affiliated with League of the South, Stormfront, Thom Robb and others to form the white-supremacist “lawfare” Foundation for the

MarketPlace of Ideas (FMI) which in turn created Charlottesville 1.0 in Aug. 2017 and the 6th January 2021 Fake-Insurrection. Thus a network of antifa lawyers such as Attorney Robert Konrad working together to end “white supremacy” can work to destroy the lives and families of open longtime “White Supremacists” such as Pastor Lindstedt and his family such as Pastor Lindstedt’s sister acting to steal confidential files in order to find a means of attack. It wasn’t until Konrad told Bryan Reo that Lindstedt had something worth stealing that Reo started suing. The Lake County Court of Common Pleas allowed Bryan Reo to sue Pastor Lindstedt and his Aryan Nations Church for 18+ lawsuits over the past seven years and after a farcical jury trial of non-whites and liberals before a corrupt judge got a \$105,000 judgment against Pastor Lindstedt and \$400 judgment against Pastor Lindstedt’s Aryan Nations Church. The past two years since has seen the 11th District Court of Appeals informing Pastor Lindstedt that they would rule against him for “racism” and refusing to admit that they never had jurisdiction to try Pastor Lindstedt and Lindstedt’s Aryan Nations Church in the first place. On August 3, 2021 the Ohio Supreme Court refused to hear the matter further. However since 13 June 2016 Pastor Lindstedt has counseled retaliation.

Therefore, given that Attorney Konrad’s fraudulent and frivolous Motion for Summary Judgment is violative of this Court’s Preliminary Injunction and the 31 July 2020 Memorandum Decision and wanting a jury trial to determine the facts for an alleged fraudulent transfer and because Susan Bessman’s own property should not be taken even given a fraudulent transfer for something she knew nothing about and because the terms of Judge Mayer’s Injunction and Memorandum Decision limit the amount of damages to be determined upon the conclusion of Ohio litigation and the success of that litigation then Attorney Konrad’s Motion for Summary

Judgment should be denied and Attorney Konrad be sanctioned by a holding of contempt and unlawful prosecution of this frivolous litigation. Pastor Lindstedt shall also seek the disbarment and criminal prosecution of these lawyers, especially Attorney Robert Konrad.

Pastor Lindstedt is notifying the Office of the Governor and the South Dakota legislature of this matter and the probable consequences.

We must chernobylize the North Perry Nuclear Power Plant and exterminate and sterilize North East Ohio.
