

Sarah Baron Houy, being first duly sworn, deposes and states as follows:


1. I am the attorney representing Defendant Susan Bessman in this matter.

The report shows that between August 5, 2013 and May 19, 2021, he has been a plaintiff in 78 cases. One of those cases was a dissolution of marriage action filed by Bryan Reo against Stefani Rossi Reo in February of 2019 (19 DI 000108). The dissolution case was dismissed without prejudice in May of 2019.
