COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to file this Motion Showing Cause why Attorney Robert Konrad as an antifa lawyer for non-white "white supremacist" agent provocateur Bryan Reo's fraudulent Motion for Summary Judgment for figures in Bryan Reo litigation well outside the initial filing of this vexatious and frivolous lawsuit when initiated in Feb 2019 and upon litigation racked up in Ohio that is still ongoing and under appeal for a continuance of this Summary Judgment Motion until Pastor Lindstedt can subpoena the extortionary communications between Plaintiff Bryan Reo, Attorney Robert Konrad, Kody Kyriss Pastor Lindstedt's sister Susan Bessman's first lawyer and Susan Bessman in which Susan Bessman is under terroristic and extortionary pressure to sign over the property that Pastor Lindstedt signed over to Susan Bessman in late Oct. 2019 and threatening to take her inheritance as well. In short, Attorney Robert Konrad (and it is expected that this Court) are working together under color of law to deprive both Pastor Lindstedt and Lindstedt's sister under color of

law of everything they got as punishment for Pastor Lindstedt calling out Bryan Reo and other federal and state agents provocateur posing as “white supremacists” over the Internet. Attorney Robert Konrad has Pastor Lindstedt’s sister so terrorized that today, 30 July 2021 when Pastor Lindstedt mentioned that Konrad only quoted six or so pages from the 31 Aug. 2020 Hearing Transcript that made him and Bryan Reo look good and that Pastor Lindstedt wanted her to purchase the transcript to give to him, Susan said that she already had the transcript ***but would not give Pastor Lindstedt*** a copy. She even admitted to being forced to sign an agreement by Attorney Konrad to not provide Pastor Lindstedt with a copy of the latest property assessment even though it would be a public record later, Then Pastor Lindstedt said that he would have to subpoena that and a lot of the material from last winter in which Konrad and Kyriss were pressuring her to sign over the property in return for letting her keep her own property. Eventually Susan was going to sign it back via quitclaim to Pastor Lindstedt then after a ridiculous federal Bryan Reo lawsuit in Ohio against Pastor Lindstedt, Aryan Nations and Susan which Reo dismissed upon drawing a hostile federal judge decided to instruct her second lawyer to withdraw the quitclaim. Now in this Motion for Summary Judgment, Attorney Konrad is demanding that the scope of the alleged unlawful transfer be not just annulled but that Bryan Reo be rewarded everything still before the federal court and now under appeal amounting to \$2.8 million including a unlawful \$400 judgment against Pastor Lindstedt’s Aryan Nations Church. Today saw a terrified Susan Lindstedt hanging up twice on Pastor Lindstedt over her refusal to provide evidence of Konrad extortion and refusal to buy the \$92 transcript probably given her by her lawyers and send Pastor Lindstedt her copy. The argument soon degraded over Pastor Lindstedt’s and Aryan Nations intentions of destroying not only the lawyers and judges and politicians involved in this destruction or chernobylization of NorthEastern Ohio but over how in

order to impose the judgment of Sodom and Gomorrah upon South Dakota as the errant whore state-daughter of the Mighty Evil ZOG/ Babylonian Empire it would become necessary to destroy all of ZOG's works and lacking a nuclear power plant it would be necessary to flood the Missouri River Valley of all of the impoundments – especially Oahe Dam – in order to pressure the ZOGLings to turn over the regime criminals and theirs' entire families for extermination and/or sterilization. After Susan begged for the hundredth time to “Not make it difficult for me in South Dakota” and upon Pastor Lindstedt asking about whether she read Konrad's Motion for Summary Judgment and how Pastor Lindstedt is involved since this judgment asks for the last half of 2019 rent payments Pastor Lindstedt certainly is involved even though Pastor Lindstedt deeded over the “Armageddon Bait” of his inheritance – now only worth \$1.3 million instead of \$2 million – and the only way to win is to exterminate 90 percent for the sins of the evil few – and that there are no innocents in a civil war – only sides, upon the second hangup neither of us wanted to talk any more today. Susan calls every day or so to make sure Pastor Lindstedt is alive and free.

Likewise, after an hour-long hearing on 9th July 2021 Attorney Konrad hasn't presented his preliminary Motion to Hold in Contempt which was supposed to be drafted then signed as appropriate by Judge Bridget Meyer. Asking the Stanley County Clerk who asked if any such hearing was even held and then asking for all paperwork submitted to Court, there is no evidence other than Pastor Lindstedt's Motion Showing Cause for Contempt showing what happened on 9 July 2021. Pastor Lindstedt thinks that this is a case for collusion because any such ORDER would be appealed to the South Dakota Supreme Court for review, so all the lawyers are scheming to get what they want through this fraudulent and frivolous Summary Judgment

granting far more than was at cause when filed in Feb. 2019 and against the express Mandate of Judge Mayer at the end of June 2020.

Pastor Lindstedt made it quite clear that he and his Aryan Nations Church follow Biblical Law which holds that entire populations can be treated like Canaanites / jews when their leaders and lawyers be they in Sodom and Gomorrah or in Gibeah Benjamin and lawfully exterminated along with everything that breathes just as in Genesis and Judges. Pastor Lindstedt has made it quite clear that it doesn't matter how much in millions or billions that Pastor Lindstedt racks up by the Ohio state and federal courts deciding to take a final wipe of their precious toilet-paper Constitutions and Bills of Goods, that ultimately it is necessary to unleash the sword of civil warfare and depending upon the means at hand go along with reducing the population to where it is exclusively white and ruled over by local military dictatorships, a sort of Klan government. Pastor Lindstedt has admitted having no respect for these laws or these courts and of wanting to simply exterminate all of them so that the 10-20 % of White People remaining can be free.

However, for now, Pastor Lindstedt is asking for a continuance on this fraudulent summary judgment hearing until all the facts can be taken in as opposed to an ambush as on 31 Aug. 2020, for Attorney Konrad, Bryan Reo, and Kody Kyriss can provide every bit of their extortion to terrorize Susan Bessman into deeding over the inheritance given back to her and a subpoena for Susan Bessman to provide the transcript and every single communication between her and Reo, Konrad and Kyriss. And upon that genuine material facts showing extortion and fraud by Bryan Reo, Robert Konrad and Kody Kyriss for this case to be dismissed in favor of Defendants Pastor Lindstedt and Susan Bessman (even if she didn't work for it) or for this case to go to trial upon the merits by a Stanley County jury. This continuance should be for a minimum of two months until the end of October 2021.

Pastor Lindstedt shall also seek the disbarment and criminal prosecution of these lawyers, especially Attorney Robert Konrad.
