COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to file this Motion Showing Cause for any imputation of Contempt of this Court – which has a long and disgraceful record of allowing Plaintiff Bryan Reo – a long time crazed homosexual mongrel agent provocateur within the "White Supremacist" and Christian Identity [bowel] Movements for 20 years – along with Reo's antifa lawyer Attorney Robert Konrad who stole confidential documents belonging to Pastor Lindstedt's sister Susan Bessman and probably Pastor Lindstedt's brother while working at the Ollinger Law Firm in Pierre South Dakota and who at the 31 August 2020 evidentiary hearing mockingly gave Pastor Lindstedt a pen with the Ollinger Law Firm brand in order to show how much in power Konrad was over the judge. Since then Konrad and Susan Bessman's first lawyer Kody Kyriss have been extorting Susan Bessman to transfer the inheritance Pastor Lindstedt deeded back to her in October 2019 or they would take her property as well that she inherited and built up in her own right instead of signing a quitclaim back to Pastor Lindstedt. Bryan Reo

even created a pathetic lawsuit in the Ohio federal district court on April 8, 2021 against Pastor Lindstedt. Lindstedt's Aryan Nations church and Susan Bessman 21-cv-000753 before drawing Judge Guinn, who in the very first Bryan Reo lawsuit in 2014 transferred it to the Western District of Missouri federal district court where it was dismissed because Bryan Reo couldn't prove any damages. Bryan Reo immediately sued Pastor Lindstedt and Lindstedt's Church and Lindstedt's woman in the Mentor Municipal Court and Lake County Court and after a number of years before a biased jury and corrupt judge won a \$105,000 judgment against Pastor Lindstedt and \$400 against the Aryan Nations Church. Bryan Reo filed four more frivolous lawsuits in Lake County which Pastor Lindstedt foolishly transferred to the Ohio federal courts. Recently these corrupt federal judges have violated not only the First Amendment but the Seventh Amendment right to jury trial and Eighth Amendment promise of no excessive fines to where Pastor Lindstedt has racked up \$2.75 million in judgments for Bryan Reo which is in the Rule 59(e) and appeals process. Bryan Reo has also asked that Pastor Lindstedt be jailed and fined for contempt of court. Pastor Lindstedt has admitted that he has nothing but contempt for the state and federal courts – in the case of Judge John R. Adams who was threatened with being put in a nuthouse and is an even worse judge than the negro-jew Solomon Oliver Pastor Lindstedt invited Adams to cum into his jail cell and lick clean his shit-encrusted asshole on 12 May 2021 – two days before the 14 May 2021 appearance To Show Cause scheduled by antifa Reo lawyer Konrad. Konrad was obviously hoping that this defiant contempt by Pastor Lindstedt to the federal judge Adams would cause Lindstedt to be jailed in Ohio. Lindstedt later “apologized” to Adams solely because Adams showed no sign of being a homosexual like Bryan Reo and Kyle Bristow – Bryan Reo's homosexual hump and another ZOGbot lawyer – and thus a duty to honesty compelled this “apology” even though Pastor Lindstedt still said that he found Adams to

be a particularly sorry specimen even by the standards of incompetent and tyrannical judges. Adams struck those Motions and threatened Pastor Lindstedt with contempt.

First of all, Pastor Lindstedt is requesting a jury trial to see if any contempt citation is justified.

Secondly, while antifa Reo lawyer Konrad states that “The required elements for . . . civil contempt are (1) the existence of the order; (2) knowledge of the order; (3) ability to comply with the order; and (4) willful or contumacious disobedience of the order” (*Keller v. Keller*, 2003 S.D. 36, etc.). To which Pastor Lindstedt responds by stating what should be obvious – that Pastor Lindstedt has no confidence in being treated fairly and decently by a court system obviously out to destroy Pastor Lindstedt, his Aryan Nations Church and his family and His People over whom a corrupt system claiming to be under the “common law” – a misnomer for something which is nothing more than a lawyer on the bench says it is as opposed to being a civil law initiated by a king or a sovereign People. Thus Judge Bridget Mayer’s ORDER of 24 November 2020 was a foolish exercise in judicial power in that it decreed something that she had no lawful jurisdiction to make and doubtless drafted by Bryan Reo antifa lawyer Konrad. In short, it was an exercise in fiat power over someone dubious of the legitimacy of this court and of the methods under color of law/tyranny exercised.

Nor does Pastor Lindstedt have the (3) ability to comply with Judge Mayer’s Order as likely drafted by Attorney Konrad without putting his very soul in danger of punishment by YHWH. Pastor Lindstedt simply will not “bend his knee to Baal” and certainly not to a Satanic system of judicial tyranny pretending to be of the Will of the People, no matter how degraded. Antifa lawyer Konrad has tattled continually although this Court has responded, recently in refusal to grant Pastor Lindstedt a free transcript in pdf format after it has already been paid for

by Bryan Reo, Bryan Reo's ZOG handlers, and Robert Konrad showing that Bryan Reo and Konrad are merely lying lawyers working to destroy Pastor Lindstedt, Pastor Lindstedt's Church, and now Pastor Lindstedt's sister. (Speaking of which, Pastor Lindstedt's sister has a pussy and is a pussy at least until a few months ago when she grew a pair and had her second lawyer Mark Mitchell grow a pair and decide not to be extorted by Bryan Reo, Robert Konrad and her first worthless thieving lawyer Kody Kyriss but rather to fight to keep what Pastor Lindstedt gave back to her the past few months. She refuses to talk to Pastor Lindstedt about this case, or about how the population of ZOG/Babylon needs to be treated during and after the current Collapse, sometimes hanging up on Pastor Lindstedt. Maybe she will buy a copy of the transcript as well as a \$200 tombstone for Roxie Fausnaught who she loved and bought a cheap trailer as an investment for her to live in more than Pastor Lindstedt, which is to be expected.)

Pastor Lindstedt in dealing with Bryan Reo litigation follows YHWH's Law absolutely in that it is the Population which is to be punished for the misdeeds of their Beast rulers. Since 13 June 2016 in reaction to a Lake County judge on 7 June 2016 [d]ruling that Pastor Lindstedt could not defend his Aryan Nations Church nor his woman Roxie Fausnaught because you lawyers granted to yoursselves a fraudulent patent of nobility that they must hire a licensed officers of these corrupt baal-korts to [mis]represent them, Pastor Lindstedt in line with the punishment of Sodom and Gomorrah and the other Three Cities of the Plain has promoted the chernobylization of the North Perry Nuclear Power Plant and thus turning Lake Erie into the New Dead Sea for their crime circa 2000 B.C. at the time of Abraham for them kidnapping travelers upon the caravan route between the Red Sea port and Babylon and then judicially robbing and murdering them under color of law. Earlier on 8 April 2021 some nut from Michigan drove a pickup truck and trailer and made a bomb threat. Bryan Reo used to work there

until a series of accidents at the ailing nuclear power plant made the operators due a due-diligence search where thanks to Pastor Lindstedt's Aryan Nations web page they found out that "SwordBrethren = Bryan Reo" and fired the crazed delusional homosexual mongrel ZOGBot who was talking about gunning it out with the FBI/BATF/Lake County Ohio Sheriff's department and anyone else who made fun of Bryan Reo.

However, Pastor Lindstedt is not really relying upon crazed homosexual mongrel pervert ZOGBots like Bryan Reo to do the Work of YHWH, but rather as Resistance policy upon the Collapse of the Mighty Evil Empire to deliberately quatrillize and then chernobylize the North Perry Nuclear Power Plant in Northeastern Ohio in order to turn it into an irradiated wasteland with a few sick survivors while the prevailing winds to the Northeast poisons a passel of Blue States in order to make certain for the next quarter-million years that no other Mighty Evil Empire is ever established over YHWH's Servant Nation of Aryan Christian Israel. Rather the new form of government shall be of Ten Thousand Warlords over 10-30 million ex-whiggers run according to Dual-Seedline Christian Identity theocratic doxology using 1890s style agriculture. A government of Klansmen in which no regime is bigger than a current county and using biological weaponry to keep the international order.

Thus of course the present System and its lawyer and police and political structure and the current Order of life will be changed and the present holders of power shall be absolutely destroyed along with their families. Pastor Lindstedt on his web pages goes into more detail, which is why Pastor Lindstedt's sister refuses to go to Pastor Lindstedt's Aryan Nations web page or to listen much to Pastor Lindstedt over the telephone. She hasn't visited Pastor Lindstedt since she was extorted by Bryan Reo, Robert Konrad and Kody Kyriss in Jan. 2021 in fact. She

will call every two or three days to make sure Pastor Lindstedt isn't jailed or dead to take care of Pastor Lindstedt's dog Gustavus Adolphus.

On 31 August 2020 when Attorney Konrad was telling Bryan Reo that he ought to visit and see Oahe Dam then Bryan Reo mentioned that Pastor Lindstedt has advocated the destruction of that dam and all the rest in order to reduce the carrying capacity of the Missouri River basin and flooding out the wicked unless they exterminate the lawyers, judges, police and ruling classes downriver. Pastor Lindstedt did not correct Bryan Reo because that has been said quite often since the initiation of the Bryan Reo / Robert Konrad litigation in Feb. 2020. Those who accept evil rulers must be punished for their ruler's misdeeds and until they rise up then Sodom and Gomorrah must perish.

Pastor Lindstedt has been a "made man" in the White Supremacist and Christian Identity Movements for most of the past 30 years and a Spokesman for the same since 1993 after Waco when he founded two militias. For the survival of YHWH's Servant Nation of Aryan Christian Israel it is necessary that the mixed-race jew dominated population of the Mighty Evil Empire be reduced by 90 percent or greater, and godly governance of petty county-level warlordcies imposed in which no non-white or jew idea or gene be allowed to survive and poison the cleansed White population. Thus *of course* Pastor Lindstedt has nothing but hatred and contempt for the current System and is working as best possible to help destroy it even though on the verge of Collapse. Pastor Lindstedt thus cannot bend his knee to Baal/Satan and thus is unable to even feign respect for the current order or its corrupt courts. Pastor Lindstedt is thus unable to comply (3) with the Order of Judge Bridget Mayer likely drafted up by Bryan Reo's antifa lawyer Robert Konrad. However, just like the negro-jew federal judge Solomon Oliver and even the crazed idiot judge John R. Adams, it would be best to set aside any notions of holding Pastor Lindstedt

in contempt if for no other reason that it is yet another item to be tried and retried and placed under appeal to a higher court which might not want to shed needed legitimacy.
