COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to file this Response under SDC 15-6-59 and SDC 15-6-60(b)(3) & (6) regarding Judge Bridget Mayer's ORDER drafted up under the supervision of Bryan Reo attorney Robert Konrad and sent to Pastor Lindstedt via e-mail on 1 Oct. 2021. In it Judge Mayer even dares to fine Susan Bessman for the proceeds of her owning the South Dakota inheritance Pastor Lindstedt deeded back to her without her ever knowing about Bryan Reo and being willing once she did know about Bryan Reo wanting to quitclaim it back in defiance of Bryan Reo and Attorney Konrad's extortion to deed the whole to Reo otherwise she would lose it all. This corrupt Court unilaterally fines Susan Bessman "damages" for \$56,070 to Bryan Reo independent of the fraudulent Ohio damages of \$105,400 because she received the lease money of 2020 and part of 2021 and paid the property taxes and Pastor Lindstedt \$18,690 even though Pastor Lindstedt only received \$15,500 from one of the leasers in Oct. 2019 **after** the 24-25 June 2019 farcical Lake County Ohio lynch-mob trial before he

transferred the inheritance back to his sister and thus not in any way in violation of Bryan Reo's and Attorney Konrad's corruptly-granted temporary *ex parte* restraining order starting out in Feb 2021 and permanent injunction of Nov. 2020. Thus this Court is a liar and criminal as well as a tyrant in setting out and proceeding with a such a lawyer-created proscription.

Neither Pastor Lindstedt nor his sister Susan Bessman nor even the corrupt lawyers Reo, Robert Konrad nor even this corrupt Court lacking jurisdiction to so abuse the color of the law have denied that Pastor Lindstedt when he gave back his inheritance to Susan Bessman didn't say anything about shooting Granby regime-criminals working with Bryan Reo or anything about Bryan Reo when he transferred the inheritance back and made his will on Oct. 25, 2019. In fact, it was on the table for Susan Bessman to quitclaim back to Pastor Lindstedt the inheritance and for her second attorney Mark Marshall to have a hearing before this corrupt court and thus render the entire proceedings moot when Bryan Reo's other fraudulent Ohio litigation fell short. Until a literal two or three days before the proceedings of Aug. 27, 2021 Attorney Konrad was trying to extort Susan Bessman's entire estate and all of her property for \$2.8 million until he asked that only the inheritance Lindstedt gave to Bessman be set aside as a fraudulent conveyance. The entire second half of 2020 and first half of 2021 was nothing but Attorney Konrad, Bryan Reo, and her first lawyer Kody Kyriss demanding that she sign over the entire inheritance deemed worth \$2 million recently appraised for \$1.2 million to Bryan Reo or they would take everything she had because of Bryan Reo lawsuits in the Ohio federal and state courts. This corrupt Stanley County Court has given everything that Attorney Konrad has asked for – with the exception of the fraudulent contempt of court foolishness which would have been sent to the South Dakota Supreme Court.

Pastor Lindstedt thinks that this Court should deny Bryan Reo and Attorney Konrad their payday by dismissing this action, fining and disbarring Attorney Konrad and Kyriss, and letting Pastor Lindstedt's sister Susan Bessman keep the inheritance deeded back to her as that would lessen the vengeance dealt out by the Aryan Nations' warlord successor regimes against the State of South Dakota and its officials given the racial and religious Second Civil War against the ZOG federal and Ohio regimes. This Court itself, on Page 12 of its Memorandum Decision says in *Wooster v. Wooster*, 399 N.W.2d 330, 332 states:

When a foreign judgment has been appropriately filed the grounds for vacating it are limited to lack of personal or subject matter jurisdiction of the rendering court, fraud in procurement of the judgment, satisfaction, lack of due process, or other grounds that make the judgment invalid or unenforceable;

Bryan Reo is not only a public figure known for being non-white, homosexual and psychotic within the White Supremacist and Christian Identity Dissident Movements but actually being a Ohio state and federal agent provocateur. There are public pages admitting that Bryan Reo = "SwordBrethren" and that he intended to use "lawfare" against Klan and Christian Identity churches such as Pastor Lindstedt's Aryan Nations Church – and has done so with a 100% rate of success. The down side is that this creates a causus belli for Pastor Lindstedt and his Aryan Nations Church to wage nuclear and biological warfare against the federal ZOG/Babylonian regime and its daughter states now of Ohio, Missouri and South Dakota. Since 13 June 2016 Pastor Lindstedt has invoked the Sin of Sodom and Gomorrah of abuse of legal process to rob and murder those not under their dominion to justify the quantrillization and chernobylization of the North Perry Nuclear Power Plant. Since March 2020 Pastor Lindstedt has recommended the destruction of the federal Missouri River impoundments unless the population rises up and eliminates and/or sterilizes the ruling governments and its lawyers, judges and police who cannot

be turned to a successor petty states of theocratic warlords. Thus all these corrupt decisions, especially this 8th Sept. and 30th Sept. 2021 decisions on behalf of Bryan Reo justify fighting and winning this current 2d Civil War which is being lost by the federal and state criminal regimes.

Pastor Lindstedt intends on appealing this Court's decision but is filing these SDC 15-6-59 and 15-6-60 Motions for this Court to reconsider, alter, set-aside and/or abolish its ORDERS particularly of 8th Sept. and 31 Sept. 2021 as a preliminary.

Pastor Lindstedt is grateful for his sister Susan Bessman for literally saving his life for the past two years. If there had been no hope of salvaging something by giving back his inheritance that Bryan Reo was after since Attorney Konrad notified Reo of it in late 2013 then doubtless Pastor Lindstedt would have taken 2d Civil War-fare action on Oct. 15 to Feb. 2020 which might well have led to the pre-mature death of Roxie Fausnaught once Pastor Lindstedt wasn't around. It would be best if this Court decided to punish Bryan Reo, Attorney Konrad, and Kody Kyriss by simply denying them a payoff, by disbarring and filing criminal charges of fraud against them. However it is unconscienceable for this Court to summarily fine Pastor Lindstedt's sister for funds outside the \$105,400 judgment for her merely taking good care of the property, paying her lawyers - both crooked and those not so much crooked - and paying the taxes on the property. Nor is it lawful for this Court to assess further fines of \$18,000 against Pastor Lindstedt for monies received many months before the unlawful and corrupt ex parte decision of this Court. This Court as a Satanic corrupt tyrannical court obviously prefers to believe incredible lies placed forth by its licensed attorney officers such as Robert Konrad thus must suffer extermination by the Warlords representing the People root, branch and tender twig.

Pastor Lindstedt and Pastor Lindstedt's Aryan Nations Church consider that the State of South Dakota to be at war with them and YHWH and YHWH's Servant Nation. And just as in the Thirty Years War it was not incumbent to rely upon lying paper promises such as the First Amendment of the Bill of Goods or fake laws but rather by means of the sword to worship YHWH and restore YHWH's Servant Nation. +
