COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to file this belated Response to Attorney Robert Konrad as an antifa lawyer for non-white "white supremacist" agent provocateur Bryan Reo's and his interactions with Stanley County South Dakota judge Bridget Mayer over findings of contempt which upon reflection these spurious proceedings were first ignored then "purged" so as to not trigger South Dakota Supreme Court scrutiny so that Attorney Konrad could proceed with his Motion for Fraudulent Transfer Summary Judgment without another Supreme Court appeal acting as a temporary or permanent speed bump.

Ever since 2002 Bryan Reo has not only been a public figure within the White Supremacist and since 2009 the Christian Identity / Aryan Nations Movements but ever since Halloween 2010 when Pastor Lindstedt found out that Bryan Reo's real name, non-white and homosexual status and Bryan Reo agreed to yet again leave the Movement but instead took down dozens of Pastor Lindstedt's Aryan Nations web pages but thinking that Pastor Lindstedt was

living in poverty until Attorney Konrad stole confidential legal files belonging to Pastor Lindstedt's sister from the Ollinger Law Firm sometime in late 2013 or so refrained from litigation until early April 2014 when Reo filed a federal lawsuit in Ohio which was removed to SW Missouri federal district court and then on Sept. 10, 2015 dismissed for \$10.75 million. Then Bryan Reo proceeded to refile much the same lawsuit well after the Ohio Statute of Limitations of one year ran out and then sued Pastor Lindstedt's woman and Aryan Nations Church. Upon being told that Pastor Lindstedt could not defend his elderly bed-bound domestic partner or Church because Pastor Lindstedt is not a lawyer, since 13 June 2016 Pastor Lindstedt has invoked the Curse of Sodom & Gomorrah of having chernobylized the North Perry Nuclear Power Plant as the Sin of Sodom and Gomorrah was in judicially robbing and murdering parties travelling on the caravan route between the Red Sea and Babylon circa 2000 BC in the time of Abraham. Since neither YHWH nor YHWH's Law change, the relevant penalties for exercising false dominion and jurisdiction under color of law is still the absolute and total extermination of the entire society which practices it. So even though Pastor Lindstedt and Pastor Lindstedt's Aryan Nations Church has a fraudulent and tyrannical judgment of \$105,000 against Pastor Lindstedt and \$400 against Pastor Lindstedt's Aryan Nations Church this judgment against the new Sodom and Gomorrah is to be extended not only to the Ohio Lake County, the federal regime which has further allowed Bryan Reo barratry in the hypothetical millions of ZOGbux, not only to the Great Whore of Neo-Babylon but to her erring state criminal regimeist daughters as well. In the case of South Dakota which doesn't have a nuclear power plant but does have massive hydro-electric dams the penalty would be to destroy those impoundments so that a deluge could clear and clean up the Missouri River Valley in a Great Flood and thus reduce not only the non-white population but much of the sinning whiggers as well and establish local

theocratic military dictatorships of 10-30 million surviving ex-whiggers called The Ten Thousand Warlords which Pastor Lindstedt has advocated as a Biblical Final Solution for years.

As pointed out during the farcical July 7th 2021 Hearing called twice by Attorney Konrad, Pastor Lindstedt does not recognize the jurisdiction by what Pastor Lindstedt recognizes as Satanic courts out to destroy the Aryan Christian Israelite population. Attorney Konrad is the sort of attorney which will get the rest of you attorneys, judges, police and politicians and their families exterminated come the impending Collapse. These proceedings were nothing more than a “Lawyer’s Proscription” which will inevitably lead to racial and religious civil war in which the brutal backlash will lead to a massively reduced population able to live frugally over desert lands. A drumhead tribunal of vengeful reactionaries be it under Felix Sulla or Oliver Cromwell can establish a military dictatorship in which the old order is exterminated root and branch.

Pastor Lindstedt is not going to repeat what has been written since 1996 on his Aryan Nations Church web pages about how establishing local military dictatorships, liquidating non-white and jew population by means of nuclear weaponry from nuclear power plants, the use of biological weaponry be it prions or the new ZOG-virus and using the Collapse to set up local military dictatorships and exterminating the local ruling race-traitor classes. There are literally millions of words advocating this the past 25 years of Pastor Lindstedt being a White Supremacist and Aryan Nations Pastor. Pastor Lindstedt is merely suggesting that since this Bryan Reo litigation is spurious and there is no reason to reward this barratry by Reo or Konrad that this Court simply deny them a payoff by leaving Pastor Lindstedt’s modest inheritance in the hands of his sister who is a good little ZOGling who is horrified by the thinking of her older crazy brother as opposed to opening the precedent wherein racial and religious civil warfare is on

the table and no then one can leave any inheritance or property other than by being on the winning side.
