COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as “Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt’s Church) to file these Objections to Bryan Reo and his unethical attorney Robert Konrad getting anything other than the skinning of themselves and their entire families along with the ruling parasitical elites of South Dakota for engaging in the civil lawfare leading to religious and racial civil warfare much less whatever inflated figures proving that Bryan Reo -- a known homosexual mongrel and agent provocateur pretending to be a white supremacist and working for a false-front organization which brought about the Charlottesville 1.0 -- who has been “lawfare” stalking Pastor Lindstedt and his Aryan Nations Church for over a decade and with Attorney Konrad stealing Pastor Lindstedt’s sister Susan Bessman’s confidential legal files around late 2013 thus notifying Reo that there was something to steal other than some decayed old buildings in Granby Missouri not worth more than \$20,000, if that, in the form of an inheritance of 1700 acres in Stanley County South Dakota. Judge Mayer has allotted until Feb. 2, 2022 for all other parties to respond, Pastor Lindstedt shall respond via

e-mail attachment and mail off copies via cheap postage with a copy to return via letter today as well. Indeed Judge Mayer sent off today 2 Feb 2022 around 2:00 pm her Final Amended Judgment and Order Modifying her and Attorney Konrad's Receivership Scheme trying to funnel Pastor Lindstedt's and Lindstedt's sister's property into Bryan Reo's and Attorney Konrad's pockets before the Lake County Ohio kangaroo kort action was finished with appeals. The South Dakota courts and South Dakota legal profession do the work of the federal regime trying to combat White Racial Resistance which is morphing into overt White Supremacy of which Pastor Lindstedt and his Aryan Nations Church is the most militant and overt of these 2d Civil War times.

Pastor Lindstedt's sister, Susan Bessman hasn't spoken with Pastor Lindstedt since 27 Sept. 2021 or even visited her brother since before the mid-Feb. 2021 freeze out when she was whining about how Bryan Reo, Attorney Robert Konrad and her own less-than-worthless lawyer Kody Kyriss were pressuring her to sign over the inheritance given her by Pastor Lindstedt to Bryan Reo in violation of this own Court's permanent injunction that these lawyers sought. Pastor Lindstedt did not tell his sister in Oct. 2019 about wanting to shoot these Granby city council-criminals working with Bryan Reo much less about Bryan Reo. Susan Bessman loves this evil system and lawyers and thinks that just because she is a good little ZOGling she-whigger that she can hire some lawyer who isn't a crook selling himself to a Satanic form of government before an "honest judge" likewise an even more dishonest lawyer and all will be well. In fact on Sept. 26<sup>th</sup> 2022 Bryan Reo sent Pastor Lindstedt an e-mail gloating about having Susan Bessman pay \$37,400 to a jew Ohio lawyer to overturn Bryan Reo's frivolous \$400 federal lawsuit against Susan Bessman, Pastor Lindstedt and Aryan Nations. The next day there was another extortionary "settlement" offer in which Bryan Reo threatened to take away Susan

Bessman's entire estate if both Pastor Lindstedt and Susan Bessman didn't sign a quitclaim deed to Bryan Reo while on a 23 Sept. 2022 filing yet another federal lawsuit re-litigating what was allegedly said about Bryan Reo getting fired from the North Perry Nuclear Power Plant in Lake County Ohio already sued over before the Mentor Ohio municipal court and moved up sans any jurisdiction to the Lake County Court for judicial sodomication and false/fraudulent dominion.

Sometime in September 2019 Pastor Lindstedt called the Ollinger Law Firm, explained the situation of a \$105,000 judgment against Pastor Lindstedt and \$400 against Pastor Lindstedt's Aryan Nations Church (which was used to inflame the gliberal whigger and nigger jury to madness) and asked if Pastor Lindstedt could set aside \$105,000 worth of property and deed the rest to his Church or to friends and family. The lawyer said of course that this would be "unethical" to lawyers (the conceit is that lawyers own whatever they see fit to steal before a "common-law" court before other lawyers) and that no, he wouldn't draft up a warranty deed.

So after receiving the last \$15,600 in rent and after 15 Oct. 2019 when Bryan Reo and the Granby City Council-Criminals were working together Pastor Lindstedt decided to quit-claim it back to his sister without telling her anything because there would be no need for title insurance or a title search. Roxie Fausnaught, who everyone else urged me to deed it to her was dying and because she was dying is why Pastor Lindstedt decided to hold off on shooting Granby regime criminals until she could be safely buried. Susan Bessman didn't know Bryan Reo existed until some process server tried to serve her Florida renter on around 27 Feb. 2020. When Bryan Reo contacted her via e-mail Pastor Lindstedt informed her that it must have been an Ollinger law firm lawyer who gave Reo her e-mail address as she is totally against Pastor Lindstedt's racism having to explain it away about being "Half-Beard Mad Dog's" sister to the Newton County Social Services baby-stealers. However she knew much less than most people in Newron County

and Missouri about Pastor Lindstedt being head of the Aryan Nations and a militia leader in the early 1990s or being a Christian Identity figure since the late 1980s. Susan Bessman is repelled by Pastor Lindstedt's racial, religious and political White Supremacist / Dual-Seedline Christian Identity beliefs and actions, stupidly thinks that there are any "innocents" as opposed to sides in a religious and racial civil war, or that what is necessary is for the Great Tribulation / Collapse to clear the entire world

Thus ever since March 2020 when she first found out about this lawsuit Susan Bessman has sought to quitclaim the inheritance back to Pastor Lindstedt but what has happened is that Bryan Reo and Robert Konrad and her first lawyer Kody Kyriess refused to allow her to do so. Her second lawyer Mark Mitchell actually demanded that she do so to protect her own inheritance as a condition of being employed by her. Pastor Lindstedt has informed Susan that there is no making any "deal" with Bryan Reo as that satanic homosexual jew mongrel wouldn't keep any agreement made any more than Reo did with Buck McHugh or Johnny 'Tonto' Britton or "Victor Switzer" who Bryan Reo wouldn't let be until both "Switzer" and "Tonto" were found out as mongrels playing See-Eye Dentistry and thus not possessing any Aryan man-pussy for Reo to cornhole. Bryan Reo broke deal after deal with those ZOGtards within the Movement three or more times before they r.u.n.n.t.-o.f.f.t. from association with Pastor Lindstedt. Pastor Lindstedt's sister who never even wanted much less pretended to agree with Pastor Lindstedt's beliefs is likewise terrorized to the point where she will only respond to texts sent on family holidays and birthdays. But it is in the nature of civil war to destroy the entire families of enemy combatants in order to change the form of government and thus traitor families are liquidated.

Ever since 13 June 2016 when some Lake County judge claimed that Pastor Lindstedt couldn't defend either his woman or his Aryan Nations Church because lawyers decided that

they would control theys' Satanic regime courts, Pastor Lindstedt has said that like Elijah told King Ahab would be punished for his lawlessness by the extermination of his entire family and regime and the wrong-siding population so too would the North Perry Nuclear Power Plant be chernobylized. When Pastor Lindstedt found out about this civil lawfare in Stanley County and knowing what to destroy in order to exterminate the [d]ruling class and their families along with at least half the degenerate population the Oahe Dam became a target, along with the other reservoirs if the lawyers, and other regime criminals and their families are not exterminated. Bryan Reo who has been following my political and religious statements since becoming an agent provocateur informed Attorney Konrad about my intentions the morning of 31 Aug. 2020 before the hearing then. Both Attorney Konrad and this Judge Mayer who slavishly follows Konrad's ORDERS know the stakes regarding this civil lawfare morphing into civil warfare. As the magistrate judge from Lake County in denying Bryan Reo's bogus and fraudulent Civil Stalking Protection Order noted, Pastor Lindstedt can advocate openly exterminating 300 million by prion-poisoning (since 1996) or chernobyling some or all nuclear power plants (since 13 July 2016) or great-flooding South Dakota (or other states) since March 2020 or advocating development of a new ZOGvirus which will kill the 200 million plus who took the Mark of the Beast clot-shot but not make immanent threats of personal retaliation against Reo or Konrad.


Removing Pastor Lindstedt's sister from this litigation and letting her either keep the inheritance given back to her and thus depriving Bryan Reo and Robert Konrad of a payday for barratry regardless of the other litigation or in thoroughly cutting her loose as opposed to allowing Reo/Konrad legalized extortion and so letting her piss down her leg & run for the tall grass otherwise unharmed other than hiring scumbag lawyers and thus being punished for her stupidity might be for the best. Pastor Lindstedt intends to exterminate the satanic South Dakota

Insofar as Bryan Reo and Robert Konrad attorney fees are concerned, this Court should deny them everything, proceed to disbar Attorney Konrad and Kody Kyriss and overturn its injunction and its now final amended judgments, particularly given that its \$18,670 judgment for “violating” any temporary or permanent injunction by cashing the last \$15,600 rent check before transferral to Pastor Lindstedt’s sister on 25 Oct. 2019 and four months before actually filing this entire action in Feb. 2020. Pastor Lindstedt’s sister Susan Bessman should either be allowed to keep the inheritance given her by Pastor Lindstedt in Oct. 2019 and thus deny Bryan Reo and Attorney Konrad any payoff whatsoever. Indeed Bryan Reo and Attorney Konrad lied about finding out that Pastor Lindstedt had an inheritance that Reo as “SwordBrethren” gloated about stealing on William Finck’s Christogenea forum as “Pray for My Success” on 24 August 2014 which has been a fixture of most of this 25+ lawsuits against Pastor Lindstedt, Lindstedt’s family and Church. Attorney Konrad even went so far as to hand Pastor Lindstedt an Ollinger Law Firm pen at the 31 Aug. 2020 hearing which was photographed on the front page of Pierre Daily Capital Journal of September 4, 2020 which was not only seen in the State but all over. Thus this Court is seen being a party to Bryan Reo and Attorney Konrad extortion, corruption and perjury which not only makes this local court be held in contempt by the population but the entire state regime. The lie that Bryan Reo is anything other than a public figure agent provocateur who is seen using the Ohio and South Dakota state and federal courts to destroy the lives not only of Pastor Lindstedt and Lindstedt’s white supremacist Aryan Nations Church but

that the sister of Pastor Lindstedt who is a good little ZOGling whigger ass-clown & loves lawyers and government yet is punished merely for not knowing about this matter and for being related to Pastor Lindstedt and not giving up her grandfather's legacy while being threatened by state-sponsored legal domestic terrorists who own the treasonous evil criminal regime. Insofar as "not discussing Lawyer Konrad's unethical and perjurous [mis]representation of Bryan Reo wanting to take everything that the Lindstedt/Samuelson heirs have gotten" when exactly does this Court wish to address this issue? Not at the 31 Aug. 2020 Hearing upon which this Court decided to grant Bryan Reo a permanent injunction given perjury as to when Reo and Konrad started working together and found out in late 2013 about Pastor Lindstedt's inheritance through stolen Bessman legal files? Not the past year and a half when it was admitted that Bryan Reo, Robert Konrad and Kody Kyriss were extorting Susan Bessman to quitclaim it all to Bryan Reo if she wanted to keep any of her inheritance? Upon appeal? Or rather after Northeastern Ohio has been turned into a biological and nuclear wasteland and now that you know a sundry White Supremacist set of Ten Thousand Warlords mean business and so the Oahe Dam has been destroyed and on the high ground of the high plains a mile atop the Missouri River Basin there are crucifixes, wood chippers and gelding stations to process lawyers, politicians, and police and their families? If this Court doesn't wish to discuss crooked lawyers and courts in South Dakota there are large dams at Mobridge, Chamberlin and Yankton to get this all out into the open and settled eventually just as there is another nuclear power plant in Ohio other than the one at North Perry and plenty of others around Democrat big cities to take out during the 2d Civil War. Pastor Lindstedt has advocated finishing with 10-30 million ex-whiggers lead by Ten thousand Warlords for years and is by no means against using this case to justify the inevitable.
