COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to file this Affidavit of Indigency for Appeal in Lieu of Filing Fee under provision of South Dakota Codified Law 15-26A-5.

## 15-26A-5. Affidavit of indigency in lieu of filing fee.

In lieu of the filing fees provided for in § 15-26A-4, appellant may file an affidavit of indigency which may be contested as provided in § 15-26A-35 for the exception to personal surety.

While both Plaintiff Attorney Bryan Reo and his ethically challenged Attorney Robert Konrad – both of which should be disbarred and Attorney Konrad used to work for the Ollinger Law Firm and stole confidential files and the e-mail of Pastor Lindstedt's sister Susan Bessman and thus is barred from [mis]representing Bryan Reo – may challenge this finding in their own Findings of Fact and Conclusions of Law (FFCL) which were unconditionally accepted by Judge Bridget Mayer, See Paragraph 54 in her Previous FFCL as drafted by Attorney Konrad, i.e. "Defendant Lindstedt testified at the evidentiary hearing that Defendant Lindstedt's home in Missouri was owned in common with the now deceased Roxie Fausnaught, and that the total sum of his assets in Missouri is not worth more than \$10,000. Ibid.

The previous In Forma Pauperis Affidavit to bring this matter up to the South Dakota Supreme court was accepted by Judge Bridget Mayer in Nov. 2020. In fact Pastor Lindstedt's In Forma Pauperis Affidavits for all of the Bryan Reo litigation the past year of 2021 have been accepted before the 6th Circuit Court of Appeals in Cinncinnati and U.S. Supreme Court. Pastor Lindstedt's sister Susan Bessman now refuses to speak to him since 27 Sept. 2021 and she has been beggared for \$150,000 because she knew nothing about Bryan Reo and Attorney Konrad and her own attorney Kody Kyriss have been extorting her, with her new attorneys unable to do anything which goes against the lawyer's guild on her behalf.

While Pastor Lindstedt's sister Susan Bessman is unlikely to do anything against Judge Mayer working with Bryan Reo attorney Robert Konrad's whims and appeal this case in which through no fault of her own was dragged into this case, wanted since she found out about Bryan Reo in March 2020, and even agreed many times to quit-claim it back to Pastor Lindstedt but due to Bryan Reo and Konrad crookedness and intransigence couldn't and wouldn't deed it directly to Bryan Reo she has lost well over \$150,000 and is terrorized into submission.

When Roxie Fausnaught died on 4 Aug. 2020 there was no longer her VA pension coming in. Pastor Lindstedt closed his bank account when Bryan Reo was engaged in barratry for the Lake County Ohio judgment then under appeal against Pastor Lindstedt and Lindstedt's Church. When the corrupt Judge Patrick Condon ruled that the Lake County Court didn't have jurisdiction outside Ohio to enforce theys' civil judgment, Pastor Lindstedt reopened up an account but keeps less than \$100 in it to have the services of a notary. Pastor Lindstedt doesn't trust banks or ZOG. This past year Pastor Lindstedt's financial situation is even more hopeless and Pastor Lindstedt is having to eat his stash of survival canned food from 2009 to 2018.

Wherefore, by this affidavit and the admission of Judge Bridget Mayer as rubber-stamped and drafted up by the unethical and criminal Attorney Robert Konrad (who should be disbarred) own findings FFCL and thus not factually challengeable Pastor Lindstedt has shown that he is indigent, has no sufficient funds to pay the \$150 filing fee for an appeal to the South Dakota Supreme Court nor money to pay for any further transcripts nor for any other court costs and fees.
