## **SECTION B. TIMELINESS OF APPEAL**

### **1. The date the judgment or order appealed from was signed and filed by the trial court: 31**

Dec. 2021 **Exhibit #1** Order Granting Bryan Reo's Fraudulent Motion for Summary Judgment Claiming that Pastor Lindstedt and his sister Susan Bessman fraudulently deeded back his inheritance Bryan Reo has stolen by barratry in Ohio back on 25 Oct. 2019 without the actions finishing appeal. **Exhibit #2** on 31 Dec. 2021 Judge Mayer at Attorney Konrad's urging on Dec. 25, 2021 Judge Mayer decided to punish Pastor Lindstedt for cashing the last half of 2019 rent check for \$18,690 for "disobeying her temporary / permanent injunction" even though Bryan Reo didn't file this lawsuit until 14 Feb. 2020 and thus there was nothing or even the pretense of due process that Lindstedt disobeyed. **Exhibit #3** also of Dec. 31, 2021 is Judge Mayer's punishment before all appeals were finished on the underlying Reo barratry case punishing Pastor Lindstedt's sister Susan Bessman for collecting the rental payments on 2020 and the first

half of 2021 and using those proceeds to pay the property taxes of 2021 before there was any injunction against the useage of what was now her property and to pay legal fees for the never-ending Bryan Reo as a state-sponsored anti-white domestic terrorist engaged in (26+) civil lawfare mainly against Pastor Lindstedt and his Aryan Nations Church but spilling over to her. Susan Bessman is likely out nearly \$200,000 not counting the \$56,070 judgment by Judge Mayer against herself even though it is admitted by everyone including Judge Mayer and Robert Konrad that she knew nothing about the decades long political racial and religious fighting between Bryan Reo and Pastor Martin Lindstedt and his Aryan Nations Church, did in fact several times offer to negate the transfer by signing over a quit-claim deed back to Pastor Lindstedt, but was extorted by Bryan Reo and Attorney Konrad (who stole her confidential legal files from the Ollinger Law Firm [with or without their permission]) to instead in defiance of the very injunction that they had demanded to sign the inheritance over to Bryan Reo (indeed there is an extortionary ‘settlement by Reo with Konrad billing for it ‘offer’ dated Sept. 27, 2021 to use influence over Judge Mayer “to make it all go away”.) Pastor lindstedt has always recommended the extermination of the ruling classes over Aryan Christian Israel, but Susan Bessman by hiring lawyers has gotten screwed over far more than Pastor Lindstedt for wanting to “play nice.” Since Susan Bessman refuses to speak with Pastor Lindstedt about anything since 27 Sept. 2021 and has been terrorized into compliance Pastor Lindstedt probably cannot speak for her or make an appeal of these corrupt decisions by Judge Mayer for her, then so be it. However, it would be safer for the South Dakota Supreme Court to simply let Susan Bessman keep the property thus denying Bryan Reo and Attorney Konrad a payoff on the Bryan Reo ZOGbot civil-lawfare and thus disclaim vengeance being taken upon their entire families belonging to the State of South Dakota and merely getting the Pierre / Ft. Pierre civil toilet flushed by destroying the Oahe Dam

as has been on the table since March 2020 when Pastor Lindstedt found out about this litigation. Presently the North Perry Nuclear Power Plant in Lake County Ohio where all this civil lawfare leading to civil warfare started has been slated for chernobylization since 13 June 2016 as penalty for sodomistic barratry.

While all the files since the Nov. 24<sup>th</sup> Hearing were asked for before 31 Dec. 2021, they were not e-mailed to Pastor Lindstedt until 4<sup>th</sup> or 5<sup>th</sup> January 2022.

Pastor Lindstedt is hereby placing a Notice of Appeal for Three Judgments, Exhibit #1, #2, and #3 signed by Judge Bridget Mayer as drafted by Robert Konrad on 31 Dec, 2021.

**2. The date notice of entry of the judgment or order was served on each party:** Via e-mail around 4<sup>th</sup> or 5<sup>th</sup> January 2022 not via actual postal service

**3. State whether either of the following motions was made:**

**a. Motion for judgment n.o.v., SDCL 15-6-50(b):**  Yes E-mails protesting Bryan Reo / Robert Konrad antifa lawfare actions were filed albeit not yet denied

Motion was made and filed 10 January. 2022 but not yet denied by Judge Mayer, however after eight years of Bryan Reo civil-lawfare barratry it is best to send in this Notice of Appeal. Robert Konrad had filed his objections via e-mail on 19 Jan. 2022 but Pastor Lindstedt has not received them by mail yet.

**c. Motion to reconsider Preliminary Injunction SDCL 15-6-60:**  
Motion was made and filed along with the SDCL 15-6-59 on 10 Jan. 2022 but not yet denied by Judge Mayer, however after eight years of Bryan Reo civil-lawfare barratry it is best to send in this Notice of Appeal. Robert Konrad had filed his objections via e-mail on 19 Jan. 2022 but Pastor Lindstedt has not received them by mail yet.

Pastor Lindstedt challenges Bryan Reo's litigation trying to steal Pastor Lindstedt's inheritance which Attorney Konrad is working to get as well. The ORDER appealed from is Judge Meyer's Three Summary Judgments signed 31 Dec. 2021. Exhibit #1, #2, #3.

**6. State each issue intended to be presented for review. (Parties will not be bound by these statements).**

Pastor Lindstedt and Pastor Lindstedt's Aryan Nations Church is being "civil-lawfared" by one Bryan Reo who far from being a private figure is a known public agent provocateur but Reo won a \$105,000 judgment and \$400 against the Aryan Nations Church. Reo found out about Pastor Lindstedt's 1700 acre inheritance sometime in late 2013 thanks to antifa lawyer Robert Konrad who stole confidential legal files belonging to his sister Susan Bessman with or without the permission of the Ollinger Law Firm and initiated numerous federal lawsuits and state lawsuits in Lake County Ohio where a hostile jury awarded these judgments. The Church of

Jesus Christ Christian / Aryan Nations is a party to this litigation as well. The case was under appeal in the Ohio appellate and state supreme courts and then docketed by the U.S. Supreme Court, denied cert on 10 Jan. 2022. Both Bryan Reo and Attorney Konrad told many lies which Judge Mayer accepted as gospel. Pastor Lindstedt didn't bother to hide that he gave his inheritance over except to his sister, who has wanted to quit-claim it back many times but because Bryan Reo and Robert Konrad have extorted Susan Bessman to sign it over to them has resisted on pain of losing her entire inheritance. Since Susan Bessman has refused to speak to Pastor Lindstedt since 27 Sept. 2021 but through her lawyer has wanted to intervene, Pastor Lindstedt has no good or current idea of what she wants. However Bryan Reo litigation has cost her \$150,000 +, and now an additional \$56,000 +. By order of Judge Mayer, which she may or may not appeal. Pastor Lindstedt is unlawfully and tyrannically assessed \$18,690 by Judge Mayer even though he spent the last \$15,600 in Sept. or early Oct. 2019 of the 2019 rent on the fraudulent basis of "disobeying" her temporary or permanent injunctions on a Bryan Reo case filed 14 Feb. 2020 four months later. Thus Judge Mayer has knowingly made a corrupt judgment on the basis of this case filed four months later with the incitement of Attorneys Bryan Reo and of Attorney Robert Konrad, who stole legal papers belonging to Susan Bessman and is forbidden by ethical standards and law from being a party to this case.

In reality, this is far more than simply bad parties. It is a matter of a corrupt Satanic system doing Satan's work against not only Pastor Lindstedt, and Lindstedt's Church and family, but actually a Satanic Beast / Babylonian Power of jews and non-whites and white race-traitors serving Satan against YHWH's Servant Nation of Aryan Christian Israel. As it is, Dual-Seedline Christian Identity dogma holds that there has to be a Great Tribulation / Collapse which kills over 95% of hue-manity and Satan's Babylonian Regime before Christ can return and usher in

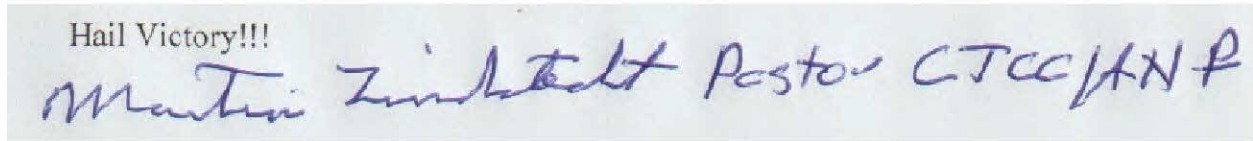
