<u>DEFENDANTS' MOTION FOR CONTINUANCE & MOTION TO APPEAR BY TELEPHONE ON PRE-TRIAL CONFERENCES</u>

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to Motion FOR A Continuance on this Hearing set for 9:15 am on 27 March 2020 and when this Hearing takes place for Pastor Lindstedt to only having to appear by telephone rather than have to drive 750-800 miles across state lines during the Corvid-19 pandemic. In any case, Pastor Lindstedt is informed that the court systems of Ohio, Missouri and possibly South Dakota are closed to the public and therefore there should be no reason why Pastor Lindstedt shouldn't be allowed to attend these proceedings by telephone from his house in Missouri while Bryan Reo is allowed to attend from Mentor Ohio with the lawyer Reo has chosen to work with Reo in a Pierre office.

SUGGESTIONS OF FACT AND LAW

1. **DEFENDANTS/COUNTER-CLAIMANTS** Bryan Reo has made a big deal about how Pastor Lindstedt isn't allowed to defend his Church. However, in one of the follow-up of the

four federal cases now pending Pastor Lindstedt's Church is listed as a Counter-Claimant against Bryan Reo, Bryan Reo's father and wife, Bryan Reo's lawyer friends Kyle Bristow and Brett Klimkowsky, the Lake County Ohio Courts / Judge Patrick Condon, the State of Ohio, and the U.S. Government for using Bryan Reo as a non-white White Supremacist and phony Christian Identity baal-priest. Bryan Reo has a lien against the Church of Jesus Christ Christian / Aryan Nations of Missouri filed before this South Dakota court while the foreign judgment is still under appeal, in fact. This Court and the State of South Dakota will likely be sued in federal court over this matter if not dismissed.

2. However, Pastor Lindstedt's sister Susan Bessman has not been served though the owner of this property. Pastor Lindstedt gave his inheritance to Susan Lindstedt Bessman last October and no longer owns the property Bryan Reo is trying to steal through litigation in the Ohio and federal courts. Susan Bessman promised to leave the inheritance in the family and not to sell it, so therefore there is no valid reason for any temporary or permanent injunction. Pastor Lindstedt upon accepting service via Newton County Deputy Sheriff on 28 Feb 2020 was told that he would have 30 days to answer the bogus and frivolous Reo's bogus civil complaint. Yet this Court in listening only to Bryan Reo and Reo's lawyer has admitted that neither Lindstedt nor his sister were aware of the "hearing" set 11 March 2020. (Bryan Reo and Bryan Reo's lawyer Brett Klimkowsky have been caught flat-out in perjury before an Ohio federal and Lake County Court in the Reo v. National Auto Division 15CV001850 & 16CV000526 cases and the federal case between the two re-filed Lake County cases. Likewise Attorney Konrad is repeating Bryan Reo lies.) Since Susan Bessman has yet to be served and hasn't made an answer to the fraudulent civil complaint, if this Court wishes to proceed other than ex parte then Susan

Bessman must be served. Pastor Lindstedt no longer owns the property and Bryan Reo of all people should be against having Pastor Lindstedt speak for her.

3. Bryan Reo's civil complaint involves claims that he has won a judgment in Lake County against Pastor Lindstedt and Lindstedt's Church. Yet this matter is still under appeal and both Ohio and Missouri law holds that Reo cannot execute on these judgments until the appeals process is finished. Pastor Lindstedt truthfully called Bryan Reo a "homosexual Satanic mongrel ZOGbot abomination" and Bryan Reo called Pastor Lindstedt a child molester – and a convicted one at that. The trial was of an Aryan Nations pastor before a Lake County Lynch Mob jury in which the crooked judge wouldn't allow Pastor Lindstedt to present any evidence -- including of exceeding the Ohio Statute of Limitations of one year – while allowing Bryan Reo to cherry-pick the Pastor Lindstedt's Church's web page to inflame a jury comprised of a foreign negro and liberal whiggers. The Lake County court assessed a judgment of \$400 against Pastor Lindstedt's Aryan Nations Church. Pastor Lindstedt in return has convened an ecclesiastical court which has rendered a judgment of attainder & corruption of blood of \$400 billion against the State of Ohio and its officers, their bloodlines and estates.
