**DEFENDANTS' MOTION FOR CONTINUANCE & MOTION TO APPEAR BY
TELEPHONE ON PRE-TRIAL CONFERENCES**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to Make an Answer & Counter-Claim Against Bryan Reo and Bryan Reo's lawyer and other lawyers working in conspiracy to under color of law force a transfer back to Bryan Reo of property deeded and given back to Pastor Lindstedt's sister so that Pastor Lindstedt's grandfather Martin Samuelson's legacy can remain within his bloodline and shielded from Pastor Lindstedt's political and religious work in bringing about the salvation of YHWH's Servant Nation of Christian Israel upon the Collapse and Destruction into the 10-20 million surviving ex-whiggers ruled over by a theocratic military dictatorships run according to Dual-Seedline Christian Identity (DSCI) religious principles by Ten Thousand Warlords.

Bryan Reo is a homosexual mongrel working as a federal agent provocateur who is a public figure within the White Supremacist and pseudo Christian Identity Movements and a

Founding Member of the Foundation for the MarketPlace of Ideas (FMI) / ZOGbot Poverty [F]Law Center (ZPLC). See **Exhibit #1** 2017 501(c)(3) IRS tax form also showing their participation with the Charlottesville Massacre from one of the current federal lawsuits involving a suit and counter-suit between Bryan Reo & counter-defendants and Pastor Lindstedt and Lindstedt's Church. (Exhibit #1 is from *Reo v. Lindstedt* Doc 26-1 1:19-cv-02589 & Doc. 11-1 1:19-cv-02786). Pastor Lindstedt is the head of the above-ground Christian Identity organization and of the Aryan Nations of Missouri. There has been a conflict between the false-flag operations set up by the federal and state governments to combat "domestic terrorism" by Whites seeking only local government with some functions conceded to the federal and state regimes (called federalism). Bryan Reo is a non-white homosexual mongrel that has fought with Pastor Lindstedt for a full decade and has filed lawsuits in both federal and the Lake County Ohio Courts ostensibly for defamation but in reality to render Pastor Lindstedt "destitute and penniless" to punish Pastor Lindstedt for a hard ruling under Deuteronomy 23:2 law of "no mamzers (miscegenated bastards) within the Congregation of Aryan Christian Israel. Exhibit #2, Prey for My Success of 24 August 2014, from Bryan Reo to William "Baal" Finck's Christogenea forum explaining that Bryan Reo wants to steal Pastor Lindstedt's inheritance using the federal (and state) courts to punish the "greatest enemy of Christian Identity" (as practiced by jews, mongrels, and homosexual perverts) (Exhibit #2 is from *Reo v. Lindstedt* Doc 26-1 1:19-cv-02589 & Doc. 11-1 1:19-cv-02786). On Aug. 24, 2014 Bryan Reo had gotten its first federal lawsuit for \$10.75 million for mythical damages moved to the Western District of Missouri *Reo v. Lindstedt* 3:14-cv-05093-MJW. Reo's case was dismissed on 10 Sept. 2015 because the Digital Millennium Copyright Act (DMCA) action was deemed futile and even given 50 days to do so Reo couldn't show how it was damaged \$75,000 diversity of citizenship

claims worth. So Reo on 18 Sept. 2015 refiled in Lake County Ohio for \$25,000 for defamation on Pastor Lindstedt calling Reo a homosexual mongrel ZOGbot and Lindstedt counter-claimed Bryan Reo and Reo's family and lawyer friends for abuse of legal process, tortuous interference, defamation for calling Pastor Lindstedt a "child molester", destruction of evidence, etc. In the past six years of Bryan Reo lawfare nothing ever changes. After five years of delay caused by Bryan Reo and Bryan Reo lawyers the case went to trial and Bryan Reo got a settlement from a Lake County Lynch-Mob jury comprised of an African negress and seven liberals who wanted to punish a "White Supremacist domestic terrorist" living 900 miles away.

The matter is still on the first stages of appeal in Ohio and according to Ohio, Missouri, and South Dakota 15-16A-6 (as the exact same wording of the laws in Missouri and Ohio) Bryan Reo cannot enforce its judgment while the case is under appeal. The Ohio courts never had jurisdiction to even hear this spurious case in the first place. South Dakota law 15-16-64 may also apply as it is a "defamation" in a foreign country as applicable to Foreign judgments 2013 Senate Bill 174 House Judiciary. Bryan Reo also has at present four federal lawsuits which are in process of going through the motions as Bryan Reo, Bryan Reo's wife and Bryan Reo's father have to provide Rule 26(A)(iii) Initial Disclosures showing how they actually have the \$500,000 in claimed damages. Pastor Lindstedt has a counter-claims against Bryan Reo, Reo's wife and father, Reo's lawyer friends on (FMI/ZPLC), the Lake County Courts / Judge Patrick Condon, the State of Ohio and the U.S. Government. It is extremely unlikely that Bryan Reo will win anything from these cases, as Bryan Reo is only good at filing Motions to Strike. Like the first Bryan Reo federal case, Bryan Reo can't prove that Pastor Lindstedt speaking the truth about this public figure non-white wannabe White Supremacist has been damaged at all, much less for a half-million dollars. On the other hand, Pastor Lindstedt is suing not only Bryan Reo, but Bryan Reo's family, lawyer friends and the Ohio courts and Ohio and federal government for \$2 million for Pastor Lindstedt having to give up his inheritance because of Bryan Reo and Reo lawyer barratry.

Bryan Reo is unlawfully, with the aid of his attorney Robert Konrad and the Ollinger Law Firm, trying to force this Stanley County Court to force the transfer from Pastor Lindstedt's sister Susan Bessman back to Pastor Lindstedt so that Bryan Reo and Reo's family and lawyers can steal Lindstedt's inheritance as been the case since Bryan Reo found out about Lindstedt having a "stake in a South Dakota ranch", see Exhibit #1. Bryan Reo in effect admits that Bryan Reo's lawyers from the Ollinger law firm which worked with Susan Bessman to handle the Jennie Samuelson Estate back in 1998-99 have furnished Reo with the information to perform this thievery under color of SD 54-8A-4 "Fraudulent Transfer." This "law" in effect claims that if a lawyer even threatens a vexatious, malicious and frivolous lawsuit that transferring it to another person or entity is "fraudulent". In short, lawyers can conspire with other lawyers to gin up litigation and the victim can't divest himself of his livelihood and property. This law is of course treasonous on its very face and grounds for extermination of the lawyers as a class of criminal social parasite and the overthrow and abolishment of the regime which enforces such laws. But for today, Pastor Lindstedt is making a mere answer and counter-claims against Reo and Reo's lawyers.

Pastor Lindstedt was served by Newton County Sheriff's deputy on 27 Feb 2020. This is Day 30. Susan Lindstedt Bessman has not been served or even gotten her mail because she is obeying the Missouri mandate to self-quarantine because she lives with people "at risk" of death if infected from this man-made virus engineered and implemented to destroy the current financial system of the Western World and China. There was a hearing at 9:15 am on Friday March 27, 2020 and it was decided to extend the Temporary Restraining Order to prohibit any further transfer from Susan Bessman to another party and hold a hearing with all parties present on June 5, 2020 at 9:30 am to further work on these matters. Susan Bessman has sought and possibly gotten) legal representation uncontaminated by Bryan Reo even though Reo's present lawyer used to work with the Ollinger Law Firm and has a massive conflict of interest. Susan Bessman's legal representation will in no way have anything to do with Pastor Lindstedt and Lindstedt absolutely refuses any legal [mis]representation from either Susan Bessman's lawyers or any lawyers in this matter because lawyers serve Satan's criminal regime and should be exterminated along with their entire families as a matter of public policy of legitimate local theocratic military dictatorships run for the benefit of Aryan Christian Israel.

Pastor Lindstedt's Answer & Counter-Claims

1. Looking at Bryan Reo's lawyer's Civil Complaint and Affidavits both initial and amended served 27 Feb 2020, there is a compendium of claims of both fact and law. Pastor Lindstedt hereby denies all claims made of both fact and law as being either twisted or deliberately a lie. Bryan Reo has had predatory intent against Pastor Lindstedt ever since Reo found out – from the Ollinger law firm? – about Pastor Lindstedt's inheritance sometime in 2013 which Reo expressed in Exhibit #1 of 24 Aug. 2014. Reo has been filing case after case claiming "emotional damages" when since Pastor Lindstedt found out that "SwordBrethren" was Bryan Reo on 29

Oct. 2010 and a deal was made to where Bryan Reo was to leave the Movement which Bryan Reo refused to carry through. The Bryan Reo civil complaint drafted is just a packet of lies and deceit which Pastor Lindstedt repudiates.

2. In October 2019 Bryan Reo was working with the Granby City Council to buy up a settlement arising from a Missouri Sunshine Act Enforcement Action in which a crooked judge had unlawfully granted “legal fees” to Granby’s jew lawyer as a sanction for daring to sue Granby under the statute. Lindstedt found out about this through Bryan Reo gloating about it the night of 14 Oct. 2019. The next day, without a court order, the City of Granby unlawfully set bulldozers upon Pastor Lindstedt’s properties adjoining Rabbit Track Road to “mow the grass” and shred small trees upon Lindstedt’s and Lindstedt’s deceased mother’s and brother’s and niece and nephew’s properties – an action undertaken only against Pastor Lindstedt. On 15 Oct. 2019 Pastor Lindstedt seriously considered simply killing and dying in punishing these treasonous regime criminals. However, Pastor Lindstedt calmed down in order to pick a better time and place in which to exterminate all the regime criminals, their families and supporters under a successor regime after the Collapse according to Biblical law.

3. As mentioned at the hearing on 27 March 2020, Pastor Lindstedt at first considered transferring his South Dakota property to his Church of Jesus Christ Christian / Aryan Nations of Missouri. Bryan Reo unlawfully sued Pastor Lindstedt’s Church and got a \$400 judgment in Lake County. Pastor Lindstedt convened an ecclestial court which has awarded a \$400 billion judgment against the State of Ohio, its officers and employees to be collected through the extermination under Biblical Law (cf. First & Second Kings regarding military coups against the ruling dynasty). The corporation – Lake county Geldings & Walking Wombs – is to carry out the Biblical castrations cf. Daniel and Daniel’s friends of the White regime criminals and the

perpetual enslavement of such along with the Judgment of Sodom of “chernobyling” of the North Perry Nuclear Power Plant. But Pastor Lindstedt’s Aryan Nations Church is nothing more than Pastor Lindstedt – and has no funding other than what Pastor Lindstedt puts into it.

So Pastor Lindstedt decided to give the property back to his sister, bypassing his brother Mike who killed our mother and looted her estate of between \$250-300 thousand. Pastor Lindstedt’s woman Roxie Fausnaught had already been hospitalized the month or so before for kidney failure (and was in the hospital for the same from Oct to Dec. 2019). Pastor Lindstedt forbore mention considering his intentions regarding Granby City council-criminals and anything about Bryan Reo because the least she knew the better. Pastor Lindstedt begged Susan Bessman to take the property off her hands and made out his will regarding his Missouri properties owned in common with Roxie Fausnaught. There was no “conspiracy” with Susan Bessman as Pastor Lindstedt, an experienced operative of YHWH, didn’t tell Susan Bessman anything she didn’t need or probably want to know.

4. Pastor Lindstedt intends to file a federal lawsuit over this matter regarding the proper punishment of Bryan Reo, Reo’s lawyers, and the constitutionality of South Dakota allowing foreign homosexual mongrels working as informants and agent provocateur’s against the property and livelihoods of dissident White racial and religious dissidents. However for now this is Pastor Lindstedt’s Answer: This is a frivolous, malicious and abusive lawsuit designed to steal Pastor Lindstedt’s property by removing it from someone who Pastor Lindstedt returned it to as the only righteous other decendant of the bloodline of Martin Samuelson. If this litigation is allowed to proceed, then no one is safe from having their property stolen by a criminal regime under color of their “law.” If this lawsuit is allowed to continue, then the State of South Dakota

must be destroyed along with their officers and employees as a threat to the White working population as is their right and duty.
