COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to make his Initial Objections to Bryan Reo's Notice of Filing a Foreign Judgment #58CIV-21-24 before this Stanley County South Dakota Court. Bryan Reo and Reo's antifa lawyer Robert Konrad who stole Pastor Lindstedt's sister's confidential files and were extorting Pastor Lindstedt's sister Susan Bessman to turn over the inheritance Pastor Lindstedt deeded to her (without her knowledge of Bryan Reo or City of Granby concerns back in Oct. 2019) to them or they will seize her property as well have now presented a then non-final Judgment by the crazy federal Judge John Adams which is currently under appeal *Anthony D. Reo v. Martin Lindstedt* 19-cv-02615 before the 6th Federal Court of Appeals 21-3661 for which the Briefing Schedule is sent as Exhibit #1.

This is just one of a flurry of cases in which Bryan Reo, a long-time crazed delusional homosexual mongrel pretending to be a white supremacist has for over the past decade as an agent provocateur for the federal and state government of Ohio been trying to infiltrate the above

and below ground white supremacist and Christian Identity Resistance movements and beinfg detected and exposed by Pastor Lindstedt has initiated and succeeded in gaining \$2.8 million before the Ohio state and federal courts by refusing to state its actual damages in violation of the Rules of Civil Procedure mandating computation of damages and then having these corrupt judges refuse under sundry pretexts to hold jury trials in violation of the 7th Amendment and to assess millions of dollars in mythical compensatory and punitive damages in violation of the 8th Amendment. In this particular case, Pastor Lindstedt having overheard from Bryan Reo to his father, Anthony D. Reo who was being counter-sued by Pastor Lindstedt and his Aryan Nations Church to not show up to trial in Lake County Ohio on 24 June 2019 showed up anyways on 25 June 2019 along with Bryan Reo's wife and Pastor Lindstedt thought that this person was yet another one of Bryan Reo's homosexual lovers what with Bryan Reo's regular Aryan homosexual hump attorney Kyle Bristow of the Foundation for the MarketPlace of Ideas (FMI) not being present. Pastor Lindstedt observed Mrs. Reo – a Brazilian Sephardic jewess – jumping up and down in the Lake County Courthouse hallway trying to get the attention of Bryan Reo and what Pastor Lindstedt thought was another homosexual mongrel and not getting anywhere. Several months later Bryan Reo filed yet another lawsuit of four in which Pastor Lindstedt found out that the "other homosexual mongrel" that wasn't Bryan Reo's father who wasn't supposed to show up was in fact Bryan Reo's father after all. Then Pastor Lindstedt removed all these Bryan Reo litigation to the federal level and in the case of Anthony D. Reo v. Martin Lindstedt 19-cv-02615 drew the craziest and worst judge in the Northern Districtof Ohio circuit Judge John R. Adams. Adams believed every single one of Bryan Reo's lies, yelled and screamed at Pastor Lindstedt on 5 March 2020 even though Bryan Reo refused to hold a pre-trial conference. Pastor Lindstedt denied Bryan Reo's claims - Pastor Lindstedt has never spoken to

Bryan Reo's father ever and only saw Bryan Reo's father on 25 and 26th June 2019 and didn't know it was Bryan Reo's father – but still Judge Adams without benefit of jury trial awarded Bryan Reo one \$ 500,000 in mythical compensatory and punitive damages in violation of the U.S. Constitution Amendments 1, 7, and 8. In fact it got so bad between Pastor Lindstedt and Judge Adams that when demanded to show cause why Pastor Lindstedt shouldn't be held in contempt Pastor Lindstedt freely admitted to having nothing but contempt for the federal and state courts in general and for Judge John Adams in particular – so much so that if Judge Adams jailed Pastor Lindstedt for contempt that Judge Adams was at liberty to visit the imprisoned Pastor Lindstedt and lick his asshole and buttcrack clean if he wished. Pastor Lindstedt upon reflection considered that while Judge Adams was nutty as could be and an especially piss-pore judge even by the low judicial standards of lawlessness and tyranny that unlike Bryan Reo and his ZOGbot antifa lawyer pals, that Adams exhibited no signs of unnatural homosexual perversion so Pastor Lindstedt "apologized" to the extent of withdrawing the asshole licking invitation and sufficed it to say that Pastor Lindstedt held Judge Adams and the federal courts in contempt. On Aug. 2, 2021 Judge Adams ruled that his decree about the half-million and that Pastor Lindstedt would have to take down the part about "homosexual incest" - which was the basis for the Bryan Reo litigation and Bryan Reo has admitted before the Stanley County Court at a hearing of 31 Aug. 2020 never happened was the final judgment in the case and granted Pastor Lindstedt's appeal in forma pauperis. A briefing schedule has been set – Exhibit 1.

Thus Bryan Reo and Reo's corrupt lawyer Robert Konrad have simply proceeded to file this fraudulent and bogus claim well before it can be lawfully heard and adjudicated before this Stanley County Court. SDCL § 15-16A-6 states that "If the judgment debtor shows the circuit

court that an appeal from the foreign judgment is pending or will be taken, . . ." then there is a stay of judgment until this matter is resolved. There is not even an appeal in the works as the federal judge is supposed to reconsider his judgment. If the federal judge decides to persist in violating the 1st, 7th and 8th Amendments then an appeal shall be taken.

Nor does Pastor Lindstedt have any money to purchase a surety bond for \$500,000.

Secondly, SD 15-16-45 & 46 states that this Court has an affirmative duty to prevent lawyers from destroying SD property-holders from defamation barratry, in this case from Ohio as opposed to any other third-world country:

15-16-45. Criteria for recognition of out-of-country foreign judgments.

In deciding whether to enforce and recognize an out-of-country foreign judgment, the court shall consider the following factors when deciding whether to enforce and recognize a out-of-country foreign judgment, to wit:

- (1) The foreign court actually had jurisdiction over both the subject matter and the parties;
- (2) The judgment was not obtained fraudulently;
- (3) The judgment was rendered by a system of law reasonably assuring the requisites of an impartial administration of justice which includes due notice and a hearing;
- (4) The judgment did not contravene the public policy of the jurisdiction in which it is relied upon; and
- (5) The jurisdiction issuing the order or judgment also grants comity to orders and judgments of South Dakota courts.

15-16-46. Required findings for recognition of out-of-country foreign defamation judgment.

In matters concerning defamation, the court, before it recognizes an out-of-country foreign judgment, shall by clear and convincing evidence, find that the law applied in the foreign court's adjudication, which resulted in a judgment, provided at least as much protection for freedom of speech and the press as would be provided by the United States Constitution and the Constitution of the State of South Dakota, in addition to the criteria set forth in § 15-16-45.

This Court must follow the criteria established by South Dakota law. This Ohio federal judge as do the Ohio state judges have no problem in dragging Pastor Lindstedt and Lindstedt's Aryan Nations Church 900 miles away to stand trial – with or without a jury – and to impose excessive and unconstitutional civil penalties well outside their jurisdiction in order to please one of their agents provocateur working to destroy white supremacist and Christian Identity Aryan

Nations churches and pastors. Thus all of SDCL 15-16-45 & -46 has been violated by Bryan Reo and Attorney Robert Konrad.

Wherefore for the above reasons this foreign judgment achieved through fraud and tyranny should be dismissed and disowned by this Stanley County South Dakota court. There is absolutely no reason why this racial and religious 2d Civil War should be extended from Ohio and its pet homosexual mongrel ZOGbot Bryan Reo versus an Ameriklan Talibklan Aryan Nations Church and Pastor in which nuclear and biological weapons are being deployed to bring it to South Dakota in which Pastor Lindstedt still has friends and family and doesn't yet want to devastate the countryside and fellow Aryan Christian Israelite People, unlike in Ohio which serves Satan and Satan's Spawn.
