PASTOR LINDSTEDT'S & ARYAN NATIONS CHURCH APPLICATION FOR THIS OHIO SUPREME COURT TO DENY THAT BRYAN REO AND BRYAN REO FELLOW LAWYERS HAVE ANY "LONG ARM" JURISDICTION OVER PASTOR LINDSTEDT AND LINDSTEDT'S ARYAN NATIONS CHURCH AND TO THUS ACCEPT JURISDICTION FOR APPEAL # 2021-0313 TO DISCLAIM ALL "LAWFARE" BY REO

Pastor Martin Lindstedt & The Church of Jesus Christ Christian / Aryan Nations of Missouri as Defendants-Appellants Never Under the Lawful Jurisdiction of Ohio Courts hereby make this Appellate Rule 26(A)(1) Application for Reconsideration of this Ohio Supreme Court's 25 May 2021 declining to accept jurisdiction so that the end result is the ratification of the Bryan Reo – not only a public figure but an agent provocateur for the State of Ohio and Federal Government -- never-ending "lawfare" of nearly 20 cases against Pastor Lindstedt, Pastor Lindstedt's Aryan Nations Church, Pastor Lindstedt deceased woman Roxie Fausnaught and Pastor Lindstedt's sister Susan Bessman not only in cases before Lake County Ohio but in Missouri and South Dakota as well. By this Ohio Supreme Court's refusal to end this Bryan Reo lawfare against Pastor Lindstedt, Lindstedt's Aryan Nations Church and family it has engaged in a religious and racial Second Civil War in which Pastor Lindstedt and his Aryan Nations Church by refusing to "knuckle under" and bow to this Satanic regime has no choice but to engage in civil warfare to exterminate the State of Ohio as a criminal regime and as many of the white population as is necessary for them to destroy their regime and end all ability of the People of Ohio to under color of law from their State and Federal governments to interfere with Pastor Lindstedt and Lindstedt's Aryan Nations Church to expel from the aboveground Congregation such crazed delusional homosexual mongrel agents provocateur (known also as "ZOGbots")

such as Bryan Reo and Reo's fellow Ohio officers of this Ohio court such as Attorney Kyle Bristow and Brett Klimkowsky.

Bryan Reo, the Lake County Court of Common Pleas, and the 11th District Court of Appeals claims to have jurisdiction to drag Pastor Lindstedt, Lindstedt's family, and Lindstedt's Aryan Nations Church 900 miles away in a different state and where there is a larger white supremacist community which holds Dual-Seedline Christian Identity religious beliefs for which Pastor Lindstedt wouldn't face any trial for holding whatsoever around his home community and to be dragged before a lynch-mob jury comprised of an African female and liberal whiggers before a corrupt judge who allowed Bryan Reo to disclaim Reo's infiltration of the white supremacist and Christian Identity above-ground communities over the Internet while anonymous (as Bryan Reo in real life wouldn't be safe appearing to us personally because Reo is a homosexual mongrel to underground members), to disallow Pastor Lindstedt to represent his woman and his Church because you lawyers usurped the general public getting to represent their own interests before your "common-law" courts, to disallow Pastor Lindstedt to present evidence in his own favor upon sundry pretexts of "law", to disallow any punishment for abuse of legal process by Bryan Reo, to try matters years after the Ohio Statutes of Limitations passed, to cherry-pick portions of Pastor Lindstedt's Aryan Nations Church web page to further inflame the biased jury (which having real white supremacists and Christian Identity believers was NOT of Pastor Lindstedt's peers) and countless other examples of unfairness and despotism over the three-day trial. The 11th District Court of Appeals struck appellate brief after brief of Pastor Lindstedt's for racism and for failure to follow their "rules of court" when Pastor Lindstedt has never ever recognized that they ever had legitimate or lawful jurisdiction but rather were nothing

more than a corrupt arm of government to allow favored homosexual mongrels working as agents provocateur to oppress the White Supremacist and Christian Identity above-ground leadership at perpetual war with this Satanic regime known as ZOG/Babylon. Simply put the myth of "rule of law" has been replaced by "Rule of Lawyer" as agents of a criminal and tyrannical regime that needs to be extirpated. These actions by the Ohio courts are thus civil warfare — "lawfare" — against White Supremacists living well outside their lawful jurisdiction.

Accordingly ever since 13 June 2016 in response to a 7 June 2016 ruling by a Judge Richard Collins that Pastor Lindstedt because you lawyers usurped allowing ordinary people to represent their women and churches because you wished to establish tyrannical and corrupt tribunals in which so-called officers of your courts could only be the ones defending the lives, liberties and property of your proposed victims Pastor Lindstedt has claimed the right through conquest and civil warfare the duty of treating Northeastern Ohio like Sodom and Gomorrah whose sins circa 2000 BC were in bringing those outside their legitimate jurisdiction to be robbed, raped and murdered under color of their pretend law for which the penalty was the death of the entire culture and people. Since the North Perry Nuclear Power Plant was so lax in hiring a delusional crazed homosexual mongrel ZOGbot like Bryan Reo and it was only after a series of accidents that the operators did due diligence and found Pastor Lindstedt's Aryan Nations Church web page telling them that "SwordBrethren = Bryan Reo" wannabe white supremacist and them then firing Reo, and then the Lake County trial court usurping jurisdiction that the Mentor Municipal Court disclaimed, it seems that Pastor Lindstedt and his Aryan Nations Church was punished for essentially saving the evil and worthless lives of those living around the nuclear power plant. Thus Pastor Lindstedt has pointed out the necessity of "chernobylizing"

the North Perry Nuclear Power Plant as the punishment for the modern Sodom and Gomorrah and turning Lake Erie into a New Dead Sea. By doing so this means that Northeastern Ohio will never be able again to invade other states and punish its citizens for speaking out against its agents provocateurs like was done to Missouri and its citizens during the First Civil War. There will be no federal government possible for Bryan Reo and Reo's fellow ZOGbots to make any claims upon the lives, liberties and properties of those who like Pastor Lindstedt and Lindstedt's Aryan Nations Church merely wanted Bryan Reo to not pretend over the Internet to be a white supremacist or Christian Identity sub-pastor because any state court would understand that they do not allow their officers of their court to drag outside citizens who have no interest in having anything to do with them before their courts to steal their property either through these corrupt proceedings or by default judgment. Therefore by chernobyling the North Perry Nuclear Power Plant the survivors, if any, of Northeastern Ohio will change their form of government and punish their legal, political and police officers and their families. By reducing the population and the land's carrying capacity the potential for doing evil over walking distance by them is eliminated forever. Pastor Lindstedt has nothing but contempt for the government and People of Northeastern Ohio and if they are largely exterminated or enslaved they will no longer be a threat

Likewise with the federal regime and courts. Bryan Reo has been allowed to play its lawyer tricks in Ohio, and with the aid of antifa lawyers and judges in South Dakota not only against Pastor Lindstedt and his Aryan Nations Church but against Pastor Lindstedt's sister to whom Pastor Lindstedt signed over his \$2 million inheritance in Stanley County South Dakota. As in Ohio you lawyers seem to think that if you want an ordinary citizen's property you can use your rapacious corrupt courts to get it. As a result Pastor Lindstedt's sister has been terrorized

and extorted by Bryan Reo and Reo's antifa lawyer Robert Konrad who stole legal documents belonging to Pastor Lindstedt's sister when Konrasd used to work in the Ollinger Law Firm in Pierre SD to sign over the property given to her or Reo and lawyer friends will take her inheritance as well. This has caused incredible strain between Pastor Lindstedt and his sister who have also been sued in Ohio before their corrupt federal courts as well. If there was no federal regime then there would be no way for Bryan Reo and his antifa ZOGbot lawyer friends to do anything to Pastor Lindstedt because Pastor Lindstedt has no assets in Ohio. Therefore as with Northeastern Ohio the federal system needs to be destroyed for the good of White People in general and Aryan Christian Israel in particular so that they can be ruled only at the local level.

Therefore this system of "common law" must be destroyed in favor of a Biblical civil law as Moses gave to the Israelites in which no lawyer nor unaccountable judges or corrupt politician nor brutal police could exist because there would be no overall federal regime imposing its will upon people living over 25 miles away. And in destroying this Babylonian System those who occupy and enforce this system must be destroyed as horrendously as possible.

Therefore, Pastor Lindstedt and his Aryan Nations Church support the extermination of Northeastern Ohio, its people, and its regimes in the most brutal and efficient way possible. However for this tenth day after this Ohio Supreme Court's refusal to clean up the tyrannical lawless mess left by Bryan Reo and its ZOGbot friends and family and the antifa lawyers and the Lake County Court of Common Pleas and the 11th Appellate District Court's claims that they can run a lawless and illegitimate tribunal with a lynch mob of an African negress and 7 gliberal whiggers and a corrupt judge all pretending that they have "long arm" pretend jurisdiction over Pastor Lindstedt and Lindstedt's Aryan Nations Church living 900 miles away and can take his life, liberty and property under color of law, Pastor Lindstedt and his Aryan Nations Church simply wants this Ohio Supreme Court to rule – like the Mentor Municipal Court did – that all of this Bryan Reo "lawfare" silliness and corruption is mooted simply because Bryan Reo has not been harmed ever as Bryan Reo could have simply stopped pretending to be a "white Supremacist" and "Christian Identity" and simply walked away as agreed on Nov. 1-4, 2010 after being detected on 29 Oct. 2010 and never ever come back into these Movements instead of forming false ZOGbot organizations and probably still pretending to be a white supremacist. This Ohio Supreme Court by its cowardly and corrupt decision to decline to hear and thus finish Bryan Reo lawfare by the simple declaration that the Ohio courts never had jurisdiction in the first place to drag a White Supremacist Aryan Nations pastor and his Aryan Nations Church 900 miles away to face trial before a Lake County lynch-mob and crooked judge to stand trial for "defaming" a crazed homosexual mongrel infesting the white supremacist and Christian Identity movements dedicated to the violent destruction of the current non-white Satanic system. This current decision means the only solution is for us to destroy

Northeastern Ohio and its population in order to bring down the current System and thus this failure to set things right means that upon your heads lies responsibility for your destruction.
