(ALTHOUGH OHIO
COURTS NEVER HAD
JURISDICTION) TO
PUNISH BRYAN REO

Comes now Pastor Martin Lindstedt and The Church of Jesus Christ Christian / Aryan Nations of Missouri (henceforth Pastor Lindstedt's Church but not Roxie Fausnaught, deceased since 4 Aug. 2020) to plainly pro-offer under this Ohio Court sans jurisdiction an Appellee Rule 26 Application for this Court to have an opportunity to Reconsider its Judgment/Opinion of 26 April 2021 ten days ago wherein it affirmed the Lake County Court of Common Pleas judgments against Bryan Reo getting anything in regards to Reo's claims of Pre-Trial Interest against Pastor Lindstedt and Lindstedt's Aryan Nations Church. Thus this appeals court of Ohio has simply rubber-stamped the trial court's decision in one of the nearly 20 cases filed by Bryan Reo originating in Lake County Ohio based upon "defamation" against a long-time wannabe non-white homosexual mongrel federal and state agent provocateur (also known as ZOGBots) since 2002 who is not only a public figure within the White Supremacist and Christian Identity above-ground but along with other Ohio attorneys Kyle Bristow and Brett Klimkowsky working for the Foundation for the Marketplace of Ideas (FMI) which was an ostensible "White Supremacist

lawfare organization” working to bring about Charlottesville 1.0 in August 2017 and Charlottesville 2.0 / Insurrection Day of the Glorious and Pathetic Sixth of January 2021. Thus these Ohio local, state and federal courts are working with their own state-sponsored “lawfare – civil war legal” domestic terrorist officers of this Court to oppress a White Supremacist spokesman & to persecute an Aryan Nations Pastor and his Church for speaking out against these literally state-sponsored domestic counter-terrorists who happen to be officers of this Court. Thus this Court, by claiming and exercising an usurped false jurisdiction over Pastor Lindstedt and Lindstedt’s Aryan Nations Church living in another state (Missouri) 900 miles away under color of some Ohio “long-arm” statute is engaged in acts of civil warfare which has lead to Pastor Lindstedt advocating chernobylization of the North Perry Nuclear Power Plant. (Since 13 June 2016 when the Mentor Municipal Court disclaiming any jurisdiction over Pastor Lindstedt, Lindstedt’s woman and Aryan Nations Church had Lake County Judge Richard Collins on 7 June 2016 taking up the Mentor litigation and claiming that Pastor Lindstedt could not defend his woman or Church). Now the “New 16 Words” of the Aryan Nations is: *“We must chernobylize the North Perry Nuclear Power Plant and exterminate and sterilize North East Ohio.”* Given that the entire country is splitting apart then the best policy for winning this Second Civil War is to destroy the portions of the former Mighty Evil Empire which invaded and oppressed portions of the country like Missouri which wanted no part of it in either the First or Second Civil Wars. The current evil System needs to be destroyed and abolished so that those of us who want no part of it can leave in peace, Bryan Reo and Reo’s FMI “lawfare” group have in effect made it inevitable that by persecuting and harassing through “lawfare” that ailing old nuclear power plants and a degenerate population will be hard hit through biological and nuclear retaliation in order to make it possible that local theocratic military dictatorships over county-

level entities can go their way in peace because places like Northeastern Ohio are irradiated,* depopulated and destroyed beyond any possibility of projecting power within the boundaries of Ohio, much less Missouri. Bryan Reo is bringing down destruction upon your heads because you allow and enable Bryan Reo to do so under color of your authority, even though illegitimate.

Furthermore, four more Bryan Reo and Bryan Reo wife's and Bryan Reo father's bogus defamation cases filed in September and October 2019 were foolishly removed by Pastor Lindstedt up to the federal district court wherein those federal courts refused to make Bryan Reo obey the Federal Rules of Civil Procedure (hereafter FRCivP) Rule 26 Initial Disclosures regarding damages. The past month or so these federal judges have not only violated theys' precious First Amendment but the Seventh Amendment right to a jury trial and the Eighth Amendment prohibition against excessive fines by assessing around \$2.5 million in mythical compensatory and tyrannical punitive damages even though Pastor Lindstedt denied three times in each separate case doing any damages to Bryan Reo, its fake-beard wife and mongrel father and that they were anything other than non-white poseurs working as ZOGBots. Bryan Reo and Reo's South Dakota lawyers have been extorting Pastor Lindstedt's sister Susan Bessman to sign over the South Dakota inheritance deeded back to her or else they will take her property as well and render her impoverished like they have done to Pastor Lindstedt and Lindstedt's Aryan Nations Church. Bryan Reo even filed a fraudulent federal lawsuit before the Ohio federal court *Bryan Anthony Reo v. Martin Lindstedt, Church of Jesus Christ Christian / Aryan Nations of Missouri, & Susan Bessman* 21-cv-00753 even while pursuing a fraudulent Stanley County South Dakota action against Pastor Lindstedt and Lindstedt's sister in which Bryan Reo and Reo's antifa lawyer Robert Konrad who stole Susan Bessman's confidential files from the

Ollinger Law Firm and Susan Bessman's first lawyer Kody Kyriss were working to violate the injunction that they sought prohibiting Susan Bessman from further transfer of the property unless given judge's permission. Susan Bessman who did not know anything about Bryan Reo or that she was put down as a Church Board member until she was sued by Bryan Reo & Associates has been terrified and extorted and not sure whether to simply quit-claim the SD inheritance back to Pastor Lindstedt or simply fight to keep it even though Bryan Reo and Reo lawyers threaten to "render her destitute like Pastor Lindstedt" as well. Susan Bessman refuses to give to Pastor Lindstedt this "lawfare" terrorism and extortion so that Pastor Lindstedt can publish it on the Aryan Nations web site proving that all lawyers need to be exterminated and sterilized. Thus Bryan Reo along with his antifa FMI lawyer associates working as state-sponsored domestic counter-terrorists against genuine white supremacist Pastor Lindstedt and Lindstedt's Aryan Nations are going against the family of Pastor Lindstedt as well.

Pastor Lindstedt also is appealing this appellate court's decision in Reo v. Lindstedt, Aryan Nations 2019-L-073 & -74 to the Ohio Supreme Court in Case # 2021-0313.

Pastor Lindstedt thinks that the entire federal System needs to be destroyed as it allows ZOGBots in Northeastern Ohio to harass Pastor Lindstedt, Lindstedt's family and Lindstedt's Aryan Nations Church in Missouri and South Dakota and to drag Pastor Lindstedt 900 miles away to face civil "lawfare" at never-ending time and expense 900 miles away. The consequences of this lawfare will be horrendous as it leads to civil warfare and the destruction of all sides.

But for today, Pastor Lindstedt and Lindstedt's Aryan Nations Church is timely asking for this 11th District of Ohio Court of Appeals to Reconsider their ruling 10 days ago on 26 April 2021 and to punish Attorney Bryan Reo, Attorney Kyle Bristow and Attorney Brett Klimkowsky (officers of FMI) as errant officers of your Court with disbarment, several millions in fines as they have cost Pastor Martin Lindstedt and Lindstedt's Aryan Nations Church over \$2.5 million so far in actual damages, and refer them to the Ohio Attorney General's office for prosecution for their various crimes of barratry, extortion and fraud.
