

**PETITION FOR RESERVING RENTAL FUNDS FOR PAYMENT OF PROPERTY TAXES ON PROPERTY**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as “Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri having already Petitioned numerous times for the Return of Pastor Lindstedt’s inheritance, returning the deed back to Pastor Lindstedt and cancelling all claims of Bryan Reo pending retrial in the federal US District Court of the Northern District of Ohio. One of these Petitions has been seemingly accepted by this Court. However the return has been bogged down in a hearing to be held in July or August of this year while Bryan Reo files yet more litigation in Ohio and Missouri against Pastor Lindstedt.

Pastor Lindstedt’s brother calls Pastor Lindstedt incessantly but yesterday informed Pastor Lindstedt that the renter of over 50+ years who uses Pastor Lindstedt’s inheritance for grazing was loading his herds to graze on the basis of a deal made with Bryan Reo by which Reo gets paid by the month. Now Reo is probably not renting just \$105,000 worth of Pastor Lindstedt’s inheritance much less \$400 worth against the Aryan Nations which has no property in South Dakota. Thus Bryan Reo is renting property which Reo has no lawful interest in given

that the Ohio judgments for \$2.75 million plus interest were reversed and remanded. This Court is obviously not interested in either law or justice, however Pastor Lindstedt suggests that this rentor – The Roseths -- put the rental money in a trust account to be paid first to pay the April and then the October 2023 property taxes, with the surplus held in that trust account. Bryan Reo and Attorney Robert Konrad have already caused enough damages in reviving this 2d Civil War but in the meantime rental funds on my inheritance it it is not going to myself should at least be used to satisfy third-party claims, even that of the South Dakota criminal regime. The renter who would rent 200 acres of farmland doesn't want to mess with it this year.
