**PETITION FOR IMMEDIATE RELIEF AND THE RETURN OF PASTOR LINDSTEDT’S INHERITANCE & HIS 2023 RENTAL INCOME GIVEN OFFICIAL NOTICE THAT ABOVE BRYAN REO JUDGMENTS TOTTALLING \$2.75 MILLION WERE REVERSED & REMANDED**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as “Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri to Petition for the Return of Pastor Lindstedt’s inheritance, returning the deed back to Pastor Lindstedt and cancelling all claims of Bryan Reo pending retrial in the federal US District Court of the Northern District of Ohio. This claim seems to be congruent with the position of Sheriff Brad Rathbun and Stanley County States Attorney Tom Maher given that Attorney Maher filed a certified copy of the 8 Dec.2022 Judgment&, Opinion and Mandate of the 6<sup>th</sup> Circuit yesterday on 23May 2023 which seems to be accepted for filing by this Court. Indeed this Court in its recent ORDER denying Pastor Lindstedt’s filing of 15 May 2023 claimed that if Pastor Lindstedt stripped a future filing of its usual content it would be received by this Court.

My former renters want to graze their cattle on my inheritance like they have for the past 50 years and try to raise a crop as well but the cut-off dates are in June. Pastor Lindstedt would like to receive a check to pay the property taxes and get income for the first time since

October 2019 when this litigation began and not wait until July or August for a hearing on this matter for purpose of Reo civil-lawfare delay against Pastor Lindstedt and his Aryan Nations Church. And during a May 18, 2023 Conference Call with Bryan Reo and U.S. Magistrate Judge Thomas M. Parker concerning the re-trial of reversed & remanded Reo v. Lindstedt 19-cv-2103 consolidated cases when Pastor Lindstedt brought up that Bryan Reo was still trying to sell Lindstedt's inheritance based upon these overturned judgments, Judge Parker said as a lawyer Bryan Reo knew better than to try it, and Bryan Reo, usually ever-quick to make a novel legal theory said nothing. While a transcript could be ordered, Pastor Lindstedt has no money to do so. However Pastor Lindstedt did make a video and audio copy of the hearing which Pastor Lindstedt put up on his Odysee Channel that very same day at:

Insofar as Case # 58CIV20-07 is concerned, Pastor Lindstedt has no objection to it being heard in July or August sometime, as Bryan Reo is currently seeking execution for the Lake County Ohio foreign judgment as well against Pastor Lindstedt and running fast and loose with the truth down in Newton County Missouri as well. This Petition for Relief on the execution for Bryan Reo foreign judgments based upon the federal Ohio judgments which have been reversed and remanded and which neither Stanley County Attorney Tom Maher nor Sheriff Brad Rathbun wish to enforce contrary to South Dakota State Law 15-16A-6 are the sole issue of this Petition for immediate relief:

**15-16A-6. Stay of enforcement pending appeal or during stay of execution--Proof of security.**

If the judgment debtor shows the circuit court that an appeal from the foreign judgment is pending or will be taken, or that a stay of execution has been granted, the court shall stay enforcement of the foreign judgment until the appeal is concluded, the time for appeal expires, or the stay of execution expires or is vacated, upon proof that the judgment debtor has furnished the security for the satisfaction of the judgment required by the state in which it was rendered.

Both Pastor Lindstedt and Stanley County Attorney Tom Maher and Sheriff Brad Rathbun have put this Court on Notice that the Reo v.Lindstedt 19-cv-2103 consolidated cases have been reversed & remanded. This property never should have been sold at a sheriff's sale back on May 26,2022 according to SDSL 15-16A-6 and the deed transferred to Bryan Reo absent any payment. But it was. The very first item is to stop the bleeding, return the property, stop the illegsl final sale and then probably in a different court deal with the damages since Feb. 2020. Not only Pastor Lindstedt is affected but also two renters who have rented this inheritance for grazing and cropland for over 50 years who live in Stanley and Haakon counties as well,so this matter /cases limited to the foreign judgments which have been overturned must be done as a matter of law right away or before June 2023.
