**CHURCH OF JESUS CHRIST CHRISTIAN / ARYAN NATIONS OF MISSOURI,
PASTOR MARTIN LINDSTEDT'S NOTICE OF DEFAULT JUDGMENT & CRUSADE
& LETTERS OF MARQUE AND REPRISAL**

COMES NOW The Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter Church), and Pastor Martin Lindstedt with Roxie Fausnaught, a director of the Church non-profit incorporated in Missouri to make to this corrupt Court ~~of Sodom and Gomorrah and the Cities of the Plain~~ of Lake County Ohio to speak unto its doom and that of its corrupt population which allows through fraudulent legal process for Bryan Reo to file numerous frivolous lawsuits for purpose of enrichment against this Church, its directors, and religious practices in which there is absolutely no jurisdiction over this Church and its directors/believers living 900 miles away in a different state. However, as with Elijah, this Church will proclaim to

this corrupt Court of a corrupt People its doom as did Elijah to King Ahab. Roxie Fausnaught, in her own largely illiterate way, presents her answer as well.

SUGGESTIONS CONCERNING FACTS & LAW

1. The reality of the situation is that this corrupt Court of absolutely zero jurisdiction pretends that since it allows Bryan Reo to file these numerous fraudulent lawsuits against others but more importantly against Pastor Lindstedt and Pastor Lindstedt's Church and Pastor Lindstedt's elderly bed-ridden domestic partner that Pastor Lindstedt needs to pretend that this corrupt Court 900 miles away has any jurisdiction whatsoever. Bryan Reo drafted up on behalf of William Finck and Melissa Epperson in 15CV001950 in December 2, 2015 that this corrupt Court didn't have subject-matter jurisdiction even though Finck gave Bryan Reo server space for Bryan Reo to libel Pastor Lindstedt as a "convicted child molester".

2. This fraudulent case started in the Mentor Municipal Court as 16CVE00245. The Municipal judge John Trebits kicked the case up to this Lake County Court even though it was admitted that Bryan Reo is allowed to file numerous fraudulent cases and the Mentor Municipal Court didn't want Bryan Reo to file further nonsense before their municipal court. Pastor Lindstedt advised the Mentor Court that while it didn't have jurisdiction over Pastor Lindstedt's Church, that it did have jurisdiction over Bryan Reo and could end this nonsense by a summary judgment against Reo. The Mentor Municipal Court decided to simply kick this fraudulent case up to this corrupt Court and this Court has been squeamish in defining how and why it would possibly have any jurisdiction.

3. Bryan Reo wanted this case to be returned to the Mentor Municipal Court and this Court was evasive at best as to how this Court would have jurisdiction when the Mentor Municipal Court didn't want or desire to have any jurisdiction. Bryan Reo hasn't stated any Ohio statute or law as to how Roxie Fausnaught or the Church of Jesus Christ Christian / Aryan

Nations of Missouri is responsible for Pastor Lindstedt posting the proceedings of a bogus and fraudulent stalking case that Bryan Reo perjured itself to attain against Pastor Lindstedt living 900 miles away in a different state with a different time zone allegedly said on a web page not owned by Pastor Lindstedt's Church. In any case, posting judicial proceedings, whether it be from a federal court or even this corrupt Lake County Court, as in Reo vs. Lindstedt 16CS000102, is not an actionable matter.

4. What this corrupt Court absent all and any jurisdiction has done is to pretend that these fraudulent proceedings requires the expense of hiring Ohio lawyers and that Pastor Lindstedt's Church and Roxie Fausnaught cannot have Pastor Lindstedt to defend them against Bryan Reo's abuse of legal process. This when it is obvious that neither Roxie Fausnaught nor the Church of Jesus Christ Christian / Aryan Nations ever did anything against Bryan Reo. Rather, Bryan Reo is using this corrupt Lake County Court to now demand (on its August 1, 2016 Motion for Default Judgment) that both Roxie Fausnaught and The Church of Jesus Christ Christian / Aryan Nations of Missouri be ruled against by default because they do not have the assets or intention of hiring an Ohio attorney to defend themselves against a bogus, vexatious and frivolous lawsuit brought by a professional *pro se* litigant who uses a corrupt local county court absent jurisdiction to file these malicious lawsuits.

5. Roxie Fausnaught is enclosing her reply without any assistance by Pastoe Martin Lindstedt. She is nearly 61 years old, has never said anything against Bryan Reo except for once when she seen a picture of the mongrel on a computer screen and said that "It don't look white to me." She refuses to read Bryan Reo's nonsense, doesn't know how to spell Reo's name (she had a nephew named Brian and was watching the Rio Olympics) and rightly says that she doesn't know "Brain Rio." Roxie gets a VA check and nothing else. How is Roxie liable?

6. The federal courts recognize that corporations have “First Amendment rights” as in *Citizens United v FEC*, 558 U.S. 310 just as a natural person. Therefore The Church of Jesus Christ Christian / Aryan Nations would have a First Amendment right to say, truthfully, that according to Deuteronomy 23:2 forbidding a mongrel from entering the Congregation of Christian Israel that Bryan Reo was obviously not white by showing a Facebook profile picture. And, contrary to this corrupt Court absent all jurisdiction self-serving notions designed to benefit legal parasites, this right doesn’t have to be paid for by hiring an expensive Ohio attorney. In fact, Bryan Reo abuses this conceit by ganging up on small family businesses and shaking them down for a settlement of a few thousand by telling them that if they want to defend themselves as an out-of-state corporation with razor-thin profit margins and cash flow that hiring an Ohio attorney will cost them far more than the settlement. In any case, this fraudulent case will eventually be taken out from before this corrupt Court absent jurisdiction and brought to the federal courts, where this Court might well be rendered a figure of ridicule.

7. Pastor Lindstedt accuses this corrupt Lake County Court absent jurisdiction of a criminal conspiracy to allow Bryan Reo to file all these bogus and fraudulent cases to where Bryan Reo is able to conduct these “legal” shakedowns and extortions under color of law in forty-three & counting in general and three or four against Pastor Lindstedt in particular. Cf. *Reo v. Lindstedt*, Lake County Ohio, 15CV00590, pending for trial 2 Aug. 2016, now 20 Sept 2016; *Reo v. Lindstedt*, Lake County Ohio, CS16000102, pending appeal, bogus stalking case, *Reo v. Aryan Nations, et. al*, Mentor Municipal Court /CVE 1600245 and now this particular case 16CV000825. This corrupt Lake County Court could have ended Bryan Reo’s abuse of legal process three years ago by simply making Bryan Reo pay the full amount Reo fraudulently demanded in any one of Reo’s frivolous litigation. Instead, this corrupt Court has doomed the People of Ohio in general and Lake County Ohio in particular to the Judgment of Sodom.

THE BIBLICAL & MORAL CASE FOR THE EXTERMINATION OF LAKE COUNTY

OHIO AND, IF NECESSARY, OF THE STATE OF OHIO

8. There is the conceit that there is something new under the sun by idiots. There isn't. In the time of Abraham, circa 2000 BC, the Cities of the Plain of which Sodom and Gomorrah were the leading metropolises, had a scam much like that of Lake County Ohio in which they would prey under color of law over anyone stupid or desperate enough to venture into their lands. As proof of what happened back then as to what the "Sin of Sodom" was, Exhibit #1, Book of Jasher Chapter 19 details how the People of Sodom set up corrupt courts which under color of law strangers outside their venue were robbed and murdered under color of their "law."

9. When Eliezar, servant of Abraham was sent by Sarah to inquire over the condition of Lot, Eliezar was to be "fined" for being assaulted by some Sodomite – a sort of pseudo Bryan Reo type – who brought a malicious and abusive lawsuit to the crooked Judge Collins Culotta Foster Serak. Eliezar (a 2000 BC Pastor Lindstedt) had already given descriptive other names to these four crooked Lake County judges of the Common Pleas Court of Sodom. Eliezar simply gave unto the crooked Judge Collins Culotta Foster Serak/Shakra a blow to the forehead of the corrupt Judge Collins Culotta Foster Serak/Shakra and told the cash-register judge of Sodom that according to the Law of Ohio Sodom to pay Bryan Reo the Sodomite the charges due for the assault upon Eliezar, just as that Judge did judge. Cf. Jasher 19:11-22.

10. Likewise, the People of Lake County Sodom and Gomorrah did judicially murder Lot's righteous daughter Paltith Roxie because she came to the assistance of a stranger to Lake County Ohio Sodom. Cf. Jasher 19:23-35. Other Roxies women, like the one living in Mentor Admah, a suburb of Lake County Sodom, was slathered in honey and stung to death by bees for feeding and watering a stranger. Her cries for mercy ascended to YHWH and YHWH made the decision to exterminate absolutely all of Lake County Ohio Sodom and Gomorrah through the

mechanism of a Church of Jesus Christ Christian / Aryan Nations of Missouri Letter of Marque & Reprisal two Angels of YHWH who would use sterilization, selling into slavery and biological weaponry fire and brimstone to carry out the sentence. Cf. Jasher 19:36-44.

11. YHWH sent two importunate mamzers pretending to be Christian Identity named “Victor Switzer” and Johnny Tonto Britton Angels to carry out YHWH’s Sentence if not even ten righteous men couldn’t be found to skin out the four corrupt judges along with their police forces but instead these mamzers were blackmailed to provide they’s manginas by a Mamzer from Mentor wanting to pretend to be a be a Christian Identity pastor and whether they ever gave up their man pussies to Ol’ Niggerlips is an item of inquiry to the Congregation of Aryan Christian Isreal to this very day instead they were subject to attempted rape by the “Men” of Painesville & Mentor Sodom and Gomorrah. Cf. Jasher 19:45-60, Genesis Chapters 18 & 19.

12. Four thousand years later, on the verge of The Great Tribulation / Great Collapse, YHWH uses other means to destroy the congenitally wicked and corrupt. Pastor Martin Luther Dzerzhinsky and Lindstedt’s Church of Jesus Christ Christian / Aryan Nations of Missouri preaches that the best way to achieve Armeggeddon and the Second Return of Jesus Christ is to use the means at hand of extermination being the usage of readily available biological weaponry, i.e. “prion poisoning” and civil war to bring about the extermination of ZOG/Babylon the Third and Final. Corrupt judicial process violative of The Church’s Freedom of Speech and Religious Practice are to be settled by the same means as during The Thirty Years War and during the History of Ancient Israel. It is not necessary or desirable to “threaten” Divine Justice any more than YHWH did to Sodom and Gomorrah for their corrupt practices. (Nineveh being sent Jonah was an exception because YHWH was going to use Assyria to punish and carry away Ancient Israel.) Therefore it is sufficient for Pastor Lindstedt to notify this corrupt Lake County Court absent any and all jurisdiction that a Letter of Marque and Reprisal is hereby in effect for the



However, as this matter unfolds there will be litigation at the state and federal levels while those who want vengeance upon ~~Sodom & Gomorrah~~ Lake County Ohio do their own “lone wolf” thing.

Wherefore this Court should summarily rule in favor of Roxie Fausnaught, Pastor Martin Lindstedt and The Church of Jesus Christ Christian / Aryan Nations of Missouri to penalize Bryan Reo for \$25,000 for abuse of legal process as while this corrupt Lake County Ohio Court of Common Pleas has absolutely no jurisdiction against these putative “Defendants” it does over Bryan Reo, and would be in the position of Nineveh of asking for mercy that it doesn’t deserve and thus changing its Status from that of Sodom and Gomorrah to one of Nineveh.
