DEFENDANTS PASTOR LINDSTEDT'S ANSWER & AFFIDAVIT TO BRYAN REO'S FRAUDULENT, HARASSING & PERJUROUS CLAIM OF CIVIL STALKING

COMES NOW the current Defendant Pastor Martin Lindstedt along with Lindstedt's non-profit church corporation in good standing The Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter in person described as "Pastor Lindstedt" and the Church corporation referred to as "Pastor Lindstedt's Church") to timely file this Answer & Affidavit to Professional Plaintiff in fraud Pro Se Bryan Reo's threatened/extorted fraudulent perjurous civil stalking charge designed, as Bryan Reo threatened - "to force Pastor Lindstedt to make a halfdozen, or more, appearances in person, in court in Lake County" (nearly 900 miles away) (Exhibit #1, p4) – so as to harass Pastor Lindstedt and cause Pastor Lindstedt and Lindstedt's Church tremendous expense and harassment under color of law, thus a criminal matter of oppression and tyranny if this Lake County Court and Lake County civil authorities allow this to happen. Wherefore, Pastor Lindstedt calls for this Court and the Lake County civil authorities to investigate this matter, to jail Bryan Reo and Reo co-conspirators, and allow Pastor Lindstedt to appear before this Court on Thursday, Feb. 25, 2016 @ 8:30pm to quash this fraudulent civil stalking charge. Otherwise, this Court will be deemed to be in criminal collusion to violate Pastor Lindstedt's and Lindstedt's Church's Constitutional rights by allowing Bryan Reo to use this Court for purposes of harassment, tyranny and oppression under color of law. This Court

will have to answer for such conduct before the U.S. District Court for the Northern District of Ohio before which there are other Bryan Reo frivolous and fraudulent litigation which this Court has allowed to proceed so that Bryan Reo can profit out of other businesses needing to use the Internet for their business. This Court and the judges therein shall receive an abysmal reputation for allowing Bryan Reo to run wild for the past over two years and 38 cases so far.

STATEMENT & SUGGESTS OF BOTH FACT AND LAW

1 Exhibit #1 consists of the posts up so concerning Bryan Reo's latest fraudulent case so far on Pastor Lindstedt's Church's Forum at:

http://christian-identity.net/forum ←-- This is a v-bulletin forum, NOT a "tetra-BBS"

Exhibit #1, pages 1-5 concerns how Bryan Reo threatened to make a number of fraudulent court filings in Lake County Ohio to force Pastor Lindstedt to appear. This latest frivolous and perjurous stalking charge by Bryan Reo has achieved its aim by getting this Court to hold a Notice of Hearing nearly 900 miles away from Pastor Lindstedt's home and Church headquarters in Granby, Missouri before this Court on some "threat" which doesn't exist on Pastor Lindstedt's Church property and which in fact Pastor Lindstedt didn't express – and Bryan Reo knows as much. The so-called "threats" Bryan Reo claims are made against Reo by Pastor Lindstedt are on a different forum using different forum software, and none of these alleged threats contain hyperlinks leading either to Pastor Lindstedt's Church's forum at www.christian-identity.net or the NIM-Busters forum at www.hateandflame.com. This is deliberate Bryan Reo fraud and perjury designed to violate Lindstedt's civil rights.

Later, on Exhibit #1, pages 7-10, Bryan Reo deliberately violates Reo's own Restraining Order granted *ex parte* on 19 Jan 16 in order to trick Pastor Lindstedt to go to the Newton County Sheriff's Department in order to collect this Court's fraudulent *ex parte* Order granted Reo. Pastor Lindstedt was unaware of this fraud by Reo until this Court's Summons and Cause was signed for on 8 Feb. 2016. The Newton County Sheriff's Department is currently being sued on another matter, cf. *The Church of Jesus Christ Christian/Aryan Nations of Missouri*, 13-cv-05020-SRB, and it is doubtful that they want to face more litigation simply because some mongrel homosexual in Cleveland Ohio wants to have them serve up some more fraud. Every time Bryan Reo contacts Pastor Lindstedt there is something crooked happening, so Pastor Lindstedt said that he would get in touch with Sheriff Copeland – but didn't. Why obey Reo?

In any case, except for one or two others who have permission to post on the Church forum but haven't for over six months, Pastor Lindstedt is the only one who has posted on the Church forum for nearly eight months – no one else.

2. Exhibit #2 of seven pages is the NIM-Buster Forum on a Tetra-BBS forum software

Pastor Lindstedt hasn't been to the NIM-Buster forum(s) for nearly a year because the NIM-Busters are Internet trolls and idiots. Pastor Lindstedt hasn't posted on a NIM-Buster forum since March or April 2012 because it is such an ungodly and faggy and stupid place. However, there are a few new Bryan Reo pics and Pastor Lindstedt notes that Bryan Reo has grown into and become a really really ugly mongrel homosexual. The pictures were saved for future use.

In any case, anyone claiming to be Pastor Lindstedt and posting as such on the NIM-Buster forum(s). is impersonating Pastor Lindstedt. It is possible that Bryan Reo is performing this imposture. Maybe the mongrel is so far gone in delusions that it might think that Pastor Lindstedt posted as Pastor Lindstedt on the NIM-Buster tard corral, but that is doubtful, because Bryan Reo was careful to delete all mention of Pastor Lindstedt's Church's real web page.

There can be no mistaking the differences between Exhibit #1 which contains material on a \$250 v-bulletin forum all of which (except for Bryan Reo e-mail text) belongs to Pastor Lindstedt on Lindstedt's Church's forum web page and Exhibit #2, of purported death threats against an extraordinarily ugly mongrel homosexual with nothing better to do than stalk Pastor Lindstedt on a crappy free open-source tetra-bb forum on a NIM-Buster web page, none of which was written or even looked at by Pastor Lindstedt before the morning of 20 Feb. 2016.

This is Bryan Reo fraud and perjury, nothing else.

Exhibit #3 is 20 pages concerning Bryan Reo perjury to this Court, to the U.S. federal district court in the Western District of Missouri and to the 8th Circuit Court of Appeals over Bryan Reo making a fraudulent police report to the Lake County Ohio Sheriff's Department. How this is evidence of cyberstalking or making death threats to an addlepated homosexual mongrel is anyone's guess, but Bryan Reo makes such a fraudulent and frivolous claim in Reo's complaint which this Lake County Court was stupid and corrupt enough to grant ex parte.
- 4. Exhibit #4 is from a Stormfront racist forum in which Bryan Reo, being a paranoid schidzophrenic mongrel claimed that he was being followed by the FBI and coerced to become an agent for them.
