DEFENDANTS PASTOR LINDSTEDT'S OHIO RULE OF CIVIL PROCEDURE
65.1(F)(3)(d)(i-iv) WRITTEN OBJECTIONS TO THIS COURT'S UNLAWFUL &
FRAUDULENT RULING TO ENABLE BRYAN REO'S PERJUROUS, VEXATIOUS,
MALICIOUS AND FAR-FETCHED CLAIMS OF CIVIL STALKING FROM 900 MILES
AWAY COMMITTED BY UNKNOWN THIRD PARTIES OVER THE INTERNET

COMES NOW the current Defendant Pastor Martin Lindstedt, ArchBishop of Missouri for Lindstedt's non-profit church corporation in good standing The Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter in person described as "Pastor Lindstedt" and the Church corporation referred to as "Pastor Lindstedt's Church") to timely file this written objection to this obviously corrupt and incompetent absent subject-matter and personal jurisdiction Lake County Ohio Court of Common Pleas to in concert with Bryan Reo, professional Plaintiff pro se with 39 other cases (including one already against Pastor Lindstedt for defamation and libel (Reo v. Lindstedt, Case #15CV001590) for publishing public documents concerning Bryan Reo on Lindstedt's Church's web pages in a federal lawsuit, (Reo v. Lindstedt, 14-5093-CV-SW-MJW, Western District of Missouri (dismissed) and Reo v. Lindstedt, 15-3756, U.S. 8th Circuit Court of Appeals, pending)) to indulgently allow Bryan Reo to use this Court for purposes of interstate wire fraud and extortion and criminal colawsnspiracy against the Constitutional rights of not only Pastor Lindstedt and Pastor Lindstedt's Church, but numerous

other people and corporations. Bryan Reo has abused the Ohio laws designed to protect those who have some reason to think that they are in immanent physical danger of death or injury in an emergency situation and used these laws and this corrupt, incompetent and lawless Court to issue a fraudulent and bogus restraining Order against a person who has never been in Lake County Ohio a minute in his entire life, doesn't ever want to go within 500 miles of the Cleveland Ohio area if he can help it, has never actually threatened Bryan Reo with anything other than ridicule for pretending to be an Aryan Christian Israelite while being a twisted homosexual mongrel abomination, and has no knowledge of third parties threatening Bryan Reo while impersonating Pastor Lindstedt's name until this fraudulent and perjurous matter made up by Bryan Reo came up. This Court should be dissolved, stripped of any jurisdiction outside the confines of Lake County Ohio, and the judges disbarred and possibly imprisoned for corruption for violations of civil rights under color of law.

SUGGESTIONS AS TO FACT AND LAW

1. This Lake County Court lacks both subject-matter and personal jurisdiction over Pastor Lindstedt, as Bryan Reo admitted in drafting up a Motion for Dismissal against Pastor Lindstedt's Counter-Claim in the Motions to Dismiss of Reo co-conspirator / co-counter-defendants William Finck and Melissa Epperson submitted on Dec. 7, 2015 in the other Reo case Reo v. Lindstedt 15CV001590. In this unauthorized practice of law motions drafted by Bryan Reo, "Finck" and "Epperson" argued that because they had no connection with Ohio except through Bryan Reo, that this Court lacked personal jurisdiction.

Thus Bryan Reo wants to have it both ways, of abusing this corrupt court absent jurisdiction whenever filing frivolous and vexatious litigation designed to harass but whenever it is necessary to protect his criminal co-conspirators drafting up motions which point out, correctly, that this Ohio county court has no jurisdiction over citizens of different states hundreds and thousands of miles away for whatever Bryan Reo wants to dream up for purpose of harassment and unjust enrichment under color of law.

2. This Court admits that Pastor Lindstedt was more than willing to testify via telephone to this matter on Feb. 25, 2016, and that Magistrate Adrienne Foster refused to allow this on the basis of claiming that even though in Pastor Lindstedt's Answer & Affidavit that Pastor

Lindstedt couldn't afford to travel 900 miles to and back from Lake County on the basis of Bryan Reo fraud and insisted on being heard by telephone, this corrupt Court claims that due to the "logistics of questioning witnesses, and exhibits" that this wasn't possible. In which case, this corrupt, lawless and incompetent Court has in essence tried and condemned Pastor Lindstedt *in abstentia*.

The Affidavit & Answer with exhibits showed that Bryan Reo had threatened via e-mail to file bogus harassing litigation in Lake County in order to impoverish Pastor Lindstedt. Rule 65(C) says that a bond for expenses needs to be given by Bryan Reo. Pastor Lindstedt is sure that if Bryan Reo had to pay for a dollar per mile there and back plus per diem expenses for over \$2000 that this fraudulentcivil stalking protection order never would have been made..

- 3. The evidence shows that any threats have been made by Bryan Reo against Pastor Lindstedt on Pastor Lindstedt's Church's web pages. Pastor Lindstedt in Exhibit #2 showed that Bryan Reo's claims that Pastor Lindstedt threatened Reo were made on a forum not owned by Pastor Lindstedt in which anyone, especially Bryan Reo, could have made these alleged threats. There is no proof, and can be no proof, because Pastor Lindstedt hasn't posted on a NIM-Busters prior now-defunct forum since March or April 2012. Thus this corrupt and inept Court has simply taken Bryan Reo's perjured claims as fact, when there is ample proof to the contrary.
- 4. These written objections are made to this Court to clean up its own mess rather than to be embarrassed and humiliated before superior Ohio and federal courts. They should prosecute Bryan Reo for perjury because eventually this Court and its judges will be a byword for lawlessness, corruption and lawlessness. This matter most certainly won't remain in Lake County Ohio forever, or for very long for that matter.
