## DEFENDANTS PASTOR LINDSTEDT'S OHIO RULE OF CIVIL PROCEDURE 65.1(F)(3)(d)(i-iv) WRITTEN OBJECTIONS TO THIS COURT'S LATEST UNLAWFUL & FRAUDULENT RULING TO ENABLE BRYAN REO'S PERJUROUS, VEXATIOUS, MALICIOUS AND FAR-FETCHED CLAIMS OF CIVIL STALKING FROM 900 MILES AWAY COMMITTED BY UNKNOWN THIRD PARTIES OVER THE INTERNET

COMES NOW the current Defendant Pastor Martin Lindstedt, ArchBishop of Missouri for Lindstedt's non-profit church corporation in good standing The Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter in person described as "Pastor Lindstedt" and the Church corporation referred to as "Pastor Lindstedt's Church") to timely file this written objection to this obviously corrupt and incompetent absent subject-matter and personal jurisdiction Lake County Ohio Court of Common Pleas to in concert with Bryan Reo, professional Plaintiff pro se with *now 42 other cases* (including one already against Pastor Lindstedt for defamation and libel (Reo v. Lindstedt, Case #15CV001590) and now against Pastor Lindstedt's Church of Jesus Christ Christian / Aryan Nations of Missouri 16CVE000245 in the Mentor Municipal Court and since the Mentor Municipal Court didn't want anything to do with the fraudulent Bryan Reo case absent jurisdiction transferred it to the Lake County for a new consolidated case Reo vs Aryan Nations 16CV000825. Bryan Reo proceeded on the basis of this corrupt Lake County Court's decision to accept the idiotic and perjurous civil complaint of a

notorious vexatious litigant who uses this corrupt Lake County Court to commit mail and wire fraud against out of state and international corporations and individuals based upon the delusions of a psychotic mongrel with no other means of support. Pastor Lindstedt filed a timely written objection and Bryan Reo refused to file his own response given that it would be perjurous atop the perjurous claim that this corrupt Lake County Court already accepted.

The fact of the matter is that in Missouri, this sort of "emergency" Temporary or Permanent Civil Stalking Restraining Order is invalid outside the county court in which it was issued. A jewess state senator from St. Louis was bitching about how in Missouri a restraining order is only effective within the county in which it was issued. Unlike Ohio, the Missouri courts and police don't want to get involved in extended litigation lasting for years and costing thousands of dollars and jeopardizing the respect of the citizens getting involved in domestic disputes in which any party can turn against them given reconciliation. Also, in Missouri, an "emergency situation" is defined far differently than allowing some litigious mongrel using the police and courts as an attempt to get back at Klansmen and Aryan Nations types who have ridiculed and essentially kicked this vicious evil lying mongrel homosexual abomination Bryan Reo / SwordBrethren out of the White Supremacist and Christian Identity above-ground Resistance Movement. In Missouri there actually has to be an emergency situation, not some claim that someone from 900 miles away in a different state is posting public records on Church web pages. Therefore this fraudulent and corrupt finding has no real application against Pastor Lindstedt living peacefully in Missouri. It does have the effect of giving Pastor Lindstedt standing to sue for violations of civil rights under color of law and allegations of criminal conspiracy against the State of Ohio and Lake County Ohio and the judges there, especially Magistrate Adrienne S. Foster and Vincent Culotta (for allowng corrupt judges absent jurisdiction to suborn perjury against citizens of another state using court rules to advance the fraudulent and malicious litigation of a known vexatious litigant who has filed five frivolous lawsuits against Pastor Lindstedt and now Lindstedt's Church). This litigation will probably take years at the state appellate and federal levels and lead to ridicule and obologuoy against this corrupt and foolish Court.

Pastor Lindstedt received the CD-ROM of the lying words of Bryan Reo to the idiotic Magistrate Adrienne S. Foster. Pastor Lindstedt will make a Youtube of this perjury and also of calling in to ask to testify on behalf of himself on Feb. 25, 2016. However, there is no real obligation, either moral or legal for Pastor Lindstedt to at the expense of himself nor his Church

to spend funds in the transcription of fraud and perjury. If this Court wishes to do so at its own expense then it is welcome to do so. The gravamen and genuine material facts behind Pastor Lindstedt's Written Objections timely filed were that Bryan Reo threatened to file bogus and frivolous litigation before the Lake County and Mentor Municipal Courts in order to harass abusing legal process and malicious prosecution up to a dozen cases about how something which Pastor Lindstedt posted on a Church web page was "libelous" and "defamatory." In absolutely no instance was anything which was posted on Church web pages advocating any harm to Bryan Reo, this corrupt court decided to knowingly accept the fantastic and perjured "testimony" of Bryan Reo claiming that on another web page not owned by Pastor Lindstedt's Church and for all likelihood posted by Bryan Reo in order to in collusion get this corrupt ruling from this corrupt Court absent any and all jurisdiction of getting a permanent restraining order against Pastor Lindstedt who has never been in Lake County Ohio and has, if possible, no intention of going there if it can be helped, much less a dozen times in order to deal with Bryan Reo malicious civil litigation. What is relevant isn't Bryan Reo's perjury held without the presence of Pastor Lindstedt by a deliberate refusal to allow Pastor Lindstedt to communicate via telephone, but rather that this corrupt Court encouraged, suborned and enabled this perjury and corruptly acts to preserve this corrupt ruling by means of abusing the corrupt Court rules which allow this corrupt Court to pretend to "due process" against parties well outside its jurisdiction who cannot afford to travel 900 miles across multiple state lines to handle the malicious and perjurous neverending fraudulent and malicious complaints of a professional perjurous plaintiff pro se.

Pretty much all of this Bryan Reo litigation against Pastor Lindstedt and Pastor Lindstedt's Church deals with Bryan Reo abusing the courts, both federal but mainly local to civilly punish through abuse of legal process the simple truths concerning Bryan Reo. In the Northern District of Ohio and then in the Western District of Missouri Bryan Reo attempted to sue Pastor Lindstedt for \$10.75 million for the "crime" of publishing Reo's Mentor High School yearbook picture of 2004 Reo used as a public Facebook profile picture under color of the Digital Millennium Copyright Act (DMCA). That bogus case was dismissed but presently is in front of the 8<sup>th</sup> U.S. Circuit Court of Appeals as #15-3756 in which Pastor Lindstedt is asking that the federal courts in Missouri (and Ohio) prosecute Bryan Reo and Bryan Reo coconspirators for perjury and wire and mail fraud. Likewise Bryan Reo filed on Sept. 18, 2016 against Pastor Lindstedt in Lake County Case # 15CV001590. This case if likewise fraudulent and frivolous in which Bryan Reo asks for a permanent gag order on Church web pages and

whines about how Pastor Lindstedt revealed that this mongrel pretending to be a White Supremacist was an obvious non-white and probable homosexual. The entire thing is well past the Ohio Statute of Limitations except for the publication of the federal court filings from March to July 2015 which filings were successful in getting Bryan Reo's frivolous lawsuit dismissed. These filings are a matter of public record available via PACER.org, the federal government web page, but now can be read for free on Pastor Lindstedt's Church web page.

This corrupt Court's Permanent Restraining Order absent all jurisdiction has been used as an excuse by Bryan Reo to file yet another vexatious and frivolous civil complaint to the Mentor Municipal Court asking damages of \$15,000 against Pastor Lindstedt's Church, and Pastor Lindstedt's elderly and bed-ridden domestic partner Roxie Fausnaught in yet another Lake County Court of absolutely zero jurisdiction, namely the Mentor Municipal Court. (See Exhibit #1, Bryan Reo's Civil Complaint 16CVE00245.) Pastor Lindstedt filed an Answer & Counter-Claim against Bryan Reo on behalf of his Church asking the Mentor Municipal Court for Summary Judgment against Bryan Reo on the grounds that while the Mentor Municipal Court had no jurisdiction over out-of-state Church corporations for Internet postings, the Mentor Municipal Court did have jurisdiction to summarily punish Bryan Reo for abuse of legal process and malicious prosecution for \$15,000. (Exhibit #2). The Mentor Municipal Court kicked the matter upstairs to the Lake County Court of Common Pleas on 12 May 2016 to where it is now yet another Bryan Reo case #16CV000825. (Exhibit #3)

In all this flurry of Bryan Reo litigation against Pastor Lindstedt and Lindstedt's Church, namely four cases so far there is a current pattern. Bryan Reo files these frivolous and malicious and vexatious lawsuits against the same party who lives 900 miles away in another state for his supposedly aggrieved feelings and before an Ohio court absent any and all jurisdiction and rather than summarily punish Bryan Reo for doing so chooses instead to act as an criminal conspirator under color of law in encouraging this treasonous and oppressive behavior.

While answering the Mentor Municipal litigation, Pastor Lindstedt found out that Bryan Reo was fired from his job at the North Perry Nuclear Power plant because it was belatedly found that Bryan Reo was a wannabe "White Supremacist." This matter was found out because of Pastor Lindstedt's Church's web pages documenting Bryan Reo's delusional and criminal and extortionary behavior. Thus the fact that Bryan Reo didn't kill 10-20 million people in the Cleveland area is because of the very same web pages that Bryan Reo is suing over in this Court.

This Court is going to be criticized that they are covering up for a perjurous delusional criminal who not only wants to kill law enforcement personnel in your area, but was allowed to work in a nuclear power plant until detected by the efforts of Pastor Lindstedt.

Wherefore, this corrupt Court absent any and all jurisdiction is expected to not only terminate its bogus and fraudulent Protective Order against Pastor Lindstedt, but to proceed to direct the Lake County Sheriff's Office to arrest Bryan Reo for perjury.
