**PASTOR LINDSTEDT'S OBJECTIONS TO MAGISTRATE PARKER'S SEPARATE
REPORT & RECOMMENDATION ON DEFENDANT'S "COUNTERCLAIMS"
AGAINST PLAINTIFF BRYAN REO (Doc. 78 #2589) AND FAKE-PLAINTIFF
STEFANI ROSSI REO, BRYAN REO'S WIFE (Doc 41 #2786) GRANTING SUMMARY
JUDGMENT ON LINDSTEDT'S "COUNTER-CLAIMS" AGAINST BOTH BRYAN
REO PLAINTIFFS.**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to timely file as best as possible these his OBJECTIONS to Mag. Thomas Parker's SEPARATE REPORT & RECOMMENDATION ON DEFENDANT'S "COUNTER-CLAIMS" Doc #80 for *Bryan Anthony Reo v. Martin Lindstedt* 1:19-cv-02589 and Doc #41 *Stefani Rossi Reo v. Martin Lindstedt* 1:19-cv-02786 both dated of 3 Dec. 2020. Pastor Lindstedt received these REPORTS

in one envelope in his mailbox at the foot of the hill the afternoon of 12 Dec. 2020, although Pastor Lindstedt checks his mailbox every single day six times per week excluding Sundays and Holidays. This doesn't leave Pastor Lindstedt much time to respond and with the Christmas rush no real guarantee that this response written and mailed off today will get there by Thursday, Dec. 17, 2020 but at least Pastor Lindstedt got a whole day to figure out how to respond.

Pastor Lindstedt makes an Objection to EVERYTHING within these two of Magistrate Parker's REPORT(s) and RECOMMENDATION(s) because they are based upon nothing more than Bryan Reo's and other Bryan Reo fellow antifa "lawfare" attorneys Kyle Bristow, Brett Klimkowsky, and South Dakota Attorney Robert Konrad's attempts – actually successful – to render Pastor Lindstedt and Lindstedt's Aryan Nations Church "destitute and penniless" cf. (See "Pray for My Success" by "SwordBrethren/Bryan Reo 24 Aug. 2014 on William Finck's Christogenea Forum" Exhibit 26-2 Reo v. Lindstedt #2589 p. #255-257, Exhibit 11-2 Stefani Reo v. Lindstedt, #2786.) Pastor Lindstedt after losing a "defamation case" based upon what was said a decade ago about Bryan Reo upon detection of its homosexual mongrel agent provocateur indentity and after Reo lost a 2014-15 federal lawsuit filed again against Pastor Lindstedt and then Lindstedt's Aryan Nations Church won a judgment against both in Lake County for \$105,000 against Lindstedt and \$400 against Pastor Lindstedt's Aryan Nations Church. Reo then proceeded to file four more lawsuits in Lake County on behalf of itself, its fake wife, and father and started to move these Lake County Ohio cases up to federal district court like the rest of Bryan Reo's victims in Lake County do to get them out of Lake County. Bryan Reo also bought a fake judgment against Pastor Lindstedt by the City of Granby, the City of Granby proceeded to bulldoze the property of Pastor Lindstedt, Lindstedt's common-law wife Roxie Fausnaught, and Lindstedt's niece and nephew who were given the junk properties back in the mid-1990s. Pastor

Lindstedt was thinking of shooting the Granby regime-criminals so decided to deed his south Dakota inheritance back to his sister who was the administrator of the grandmother's estate in late Oct. 2019. Lindstedt said nothing to his sister Susan Bessman about Bryan Reo or about thinking of shooting the Granby piglice or council-criminals. Bryan Reo's antifa South Dakota lawyer Robert Konrad stole confidential files from Susan Bessman's legal work from the Ollinger Law Firm from whence he worked until a year ago or so along with Susan Bessman's e-mail address which Konrad gave to Bryan Reo for a shakedown attempt. In fact, at a evidentiary hearing on 31 August 2020 to determine whether a preliminary injunction against Lindstedt and Bessman further transferring the SD inheritance, Bryan Reo admitted that Pastor Lindstedt never used the terms "transsexual prostitute" in discussing Bryan Reo's wife – a fake plaintiff in *Stefani Rossi Reo* 1:19-cv-2786 – or "homosexual incest" involving *Anthony Domenic Reo v. Martin Lindstedt* 1:19-cv-2615. In fact, Bryan Reo denied ever having been known as "SwordBrethren" being involved in a white supremacist "lawfare" organization responsible for Charlottesville, or having found out about Pastor Lindstedt's South Dakota inheritance until 2018, all easily disprovable perjury by Bryan Reo and his antifa lawyer Robert Konrad. Pastor Lindstedt has presented evidence as to that in his "Consolidated Answers, Withdrawal of Admissions answering Bryan Reo's discovery interrogatories and requests for admissions" filed 9 Nov. 2020 (Doc 74 in #2589 and not filed in #2786) that all of Bryan Reo's claims are perjury, frivolous and malicious as well as other proof of Bryan Reo barratry and "lawfare".

Pastor Lindstedt rejects the Talmudic rationalizations in which by after refusing Bryan Reo's civil complaint during the initial answer & counter-claims, the amended ORDERED answers & counter-claims, and the later "Withdrawal of Admissions" of Nov. 15, 2020 that Bryan Reo and its fake-wife plaintiff Stefani Reo are going to be prejudiced, especially given

that they didn't make a half-hearted Rule 26 Initial Disclosures until 4 Sept 2020 (Doc 66 #2589 and Doc. 30 Stefani Reo #2786). Even then they refused to make a computation of actual damages required under Rule 26(a)(1)(A)(iii) to where they show where and how they were actually damaged, thus necessitating a jury trial to determine damages of which neither Reo nor its fake wife have any of done by Pastor Lindstedt. A jury verdict of zero or nominal damages will take quite a while to accomplish, as Judge Oliver rendering a verdict upon FedRuleCivProc (FRCivP hereafter) Rule 36 admitted in his after-verdict rulings. In an age of Covid-19 mutating into Covid-2020 to 2021, finding a jury to render some crazed delusional homosexual mongrel ZOGbot anything against a White Supremacist Aryan Nations pastor and his Church who Bryan Reo has been stalking, or its fake wife who is a mere catspaw of Bryan Reo given a total Collapse of the financial, economic, and political sectors may well prove impossible but such is Pastor Lindstedt's "right" even though Magistrate Parker has trashed the First Amendment pretty well as it is.

Regarding Pastor Lindstedt's "counter-claims" against Bryan Reo and Reo's fake-wife Stefani Rossi Reo (who before this litigation was never referred to by Pastor Lindstedt on his Aryan Nations Church forum as "Mrs. Niggerlips") they are part of a legal strategy which worked in Bryan Reo's first federal lawsuit against Pastor Lindstedt. By suing not only Bryan Reo but Bryan Reo's father, mother, and around forty other jews, mongrels, homosexuals, perverts, ZOGbots and such other vermin pretending to be fake White Supremacists / Nationalists, Christian Identity and Foundation(s) for the MarketPlace of Ideas racist libbertoons the Western District of Missouri Judge Matthew Whitworth in Reo's first lawsuit in 3:14-cv-0593-MJW decided to flush the entire mess by making Bryan Reo show / compute actual damages according to Rule 26 and gave Bryan Reo 50 days to do so and when Bryan Reo

couldn't, dismissed the entire mess, Reo litigation and Lindstedt's counter-suits. Bryan Reo then went to the Lake County Ohio courts and filed the exact same lawsuit stripped of the DMCA part

Pastor Lindstedt's litigation strategy is to make it potentially expensive for Bryan Reo litigation by counter-suing everyone Lindstedt has the funds and ability to counter-sue. Pastor Lindstedt holds the federal government responsible for not reining in its crazed delusional homosexual mongrel ZOGbots, Lake County and the State of Ohio for letting Bryan Reo drag an Aryan Nations pastor and his Church 900 miles away to stand trial for making fun of a delusional homosexual mongrel ZOGbot while it gets to call Pastor Lindstedt a "child molester" even during the trial much less over the entire past decade which is at lawsuit. Lake County has an ailing obsolete nuclear power plant which Bryan Reo blames for firing Reo because they finally did a google search after a number of nuclear accidents in 2013 after Reo took down most of its ravings and read Pastor Lindstedt's Church's web page pointing out about Bryan Reo being a delusional crazed homosexual ZOGbot for all of the past decade and fired Reo as an internal security hazard. Pastor Lindstedt thinks that the Curse of Sodom & Gomorrah's abuse of legal process against strangers outside their jurisdiction should rain down lie fire and brimstone and Lake Erie turned into a Dead Sea by chernobyling the North Perry Nuclear Power Plant. Attorneys Kyle Bristow and Brett Klimkowsky and their families should be hunted down as traitors to the Movements they infiltrated according to Biblical law. The State of Ohio wants to justify Bryan Reo "lawfare" then let them put up their nuclear power plant around Columbus into the devastation civil war kitty. The State of South Dakota, Stanley County, and their lawyers and judiciary should be counter-sued so that while they go against Pastor Lindstedt and Lindstedt's Church their lives, liberty and property are forfeit to warlord successor states. All of Pastor Lindstedt's litigation is aimed at creating the maximum hatred, resistance and revenge possible

Bryan Reo's and Reo's lawyers' and criminal regime courts' lawfare have cost Pastor Lindstedt his South Dakota inheritance worth around \$2 million which he had to give away to his sister, has cost Pastor Lindstedt at least \$20,000 or more, and several years worth of Pastor Lindstedt's time and waking efforts. Pastor Lindstedt figures out that fighting Bryan Reo lawfare takes up half of his waking hours. Pastor Lindstedt is literally destitute except that Pastor Lindstedt has built up a support network and has the love of YHWH.

So Pastor Lindstedt is counter-suing Bryan Reo and Reo's fake wife Stefani Rossi Reo over this damages. In both Bryan Reo case # 2589 Doc. #40 Bryan Reo calls Pastor Lindstedt a child molester. Stefani Rossie Reo in her "answers" case #2786 in Doc. 23 claims that Pastor Lindstedt is likewise a "child molester" even though admitting not ever speaking to Pastor Lindstedt or knowing about that dismissed case which is on Pastor Lindstedt's Church's web page thus having no independent knowledge to do so. In actuality, Stefani Rossi Reo is merely a fake Plaintiff used for Bryan Reo to have another vexatious litigation against Pastor Lindstedt.

Pastor Lindstedt thinks that the main result of this Bryan Reo litigation shall become the realization all across the ZOGland by White People that no one has any business living under the thumb of ZOGling non-whites, jews, or whiggers, certainly not NE Ohio ZOGlings over SW Missourians and we all should break up into Ten Thousand local Warlordcies.
