**PASTOR LINDSTEDT’S EMERGENCY FILING DUE TO COVID DELAYS OF
MAILINGS DUE OBJECTIONS TO MAGISTRATE PARKER’S SEPARATE REPORT
& RECOMMENDATION ON DEFENDANT’S OBJECTIONS AGAINST PLAINTIFF
BRYAN REO (#2589) AND FAKE-PLAINTIFF STEFANI ROSSI REO, BRYAN REO’S
WIFE (#2786) GRANTING SUMMARY JUDGMENT ON BOTH CASES & AGAINST
LINDSTEDT’S “COUNTER-CLAIMS” AGAINST BOTH BRYAN REO PLAINTIFFS.**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as “Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt’s Church) to timely file via e-mail to this Court as best as possible the explanations that he filed via priority mail Objections to Magistrate Thomas Parker’s Report & Recommendations Granting Summary Judgment & Disposing of Counter-Claims against Bryan Reo (Doc 78 & 80, Reo v. Lindstedt 19-cv-2589) and fake-Plaintiff Bryan Reo’s wife (Doc 39 & 41 Stefani Reo v. Lindstedt 19-cv-2786). The paper letters

from this Court did not arrive until 9 Dec. and 12 Dec. 2020. Pastor Lindstedt mailed off his Objections on Saturday 12 Dec. 2020 at 12:16 pm for priority mail two-day delivery by 15 Dec. 2020. Pastor Lindstedt did not receive Mag. Parker's REPORT & RECOMMENDATION to dismiss both of Pastor Lindstedt's Counter-suits against Bryan Reo and Reo's Wife until the afternoon of 12 Dec. 2020 at his mailbox at 338 Rabbit Track Road at the foot of the hill as the mail was running late again. Pastor Lindstedt mailed off his Objections on Monday 14 Dec. 2020 at 4:31 pm. In both cases, Pastor Lindstedt only has a day or so to respond and to try to get his response in the U.S. Mail to reach this Court by the 15th and 17th of this month respectively.

Pastor Lindstedt used "Priority Mail" Two-Day service for what was supposed to get to this Court within two or three days. This was a big mistake over sending it by first-class postage certified mail, not only because it costs \$2 more to mail it that way, but because "Priority Mail" is treated as a package and package delivery bow takes forever. Pastor Lindstedt sent at the same time something for the South Dakota Supreme Court and Stanley County for an appeal of a preliminary injunction on Bryan Reo and antifa FMI Attorney Robert Konrad trying to get Pastor Lindstedt's inheritance back from his sister so they can steal it under color of "law", i.e. the payoff of all this Bryan Reo litigation in the federal and state courts of Ohio but sent it first class certified mail and it got there earlier than expected.

Exhibit #1 for this filing shows when these mailings were sent on 12th & 14th December. The 12th December mailing was supposed to arrive the 15th. Instead, upon departing Granby at 12:16pm Dec. 12 and being logged into the Springfield Mo sorting office at 12:50 am Dec. 13th (Sunday) it took a full week until Dec. 20th at 11:23 pm to arrive, then leave St. Louis where it is "in transit" since Dec. 21st presumably towards Cleveland.

Likewise for the Priority Mailing of Dec. 14th mailed off in Granby at 4:31pm. Its next stop was Springfield Mo sorting post office but was not logged into there until five days later on Dec. 19 @ 2:15pm. Then it went on to Kansas City sorting office by 20 Dec. and onto Indianapolis where it also is “in transit.”

Doubtless the mailings of these filings to Bryan Reo sent first class are already in Reo’s possession. Pastor Lindstedt was going to e-mail the other parties once these filings were filed with the exception of the Stanley County SD Court as the matter is in the appeal hopper and Pastor Lindstedt doesn’t want to add to that 600+ pages.

Pastor Lindstedt shall re-send to this Court the past filings in the mail as well by e-mail. Finally Pastor Lindstedt got hold of a clerk on 21 Dec. 2020 and the clerk gave Pastor Lindstedt this emergencyfiling@OHND.USCOURTS.gov e-mail address. Pity this Court will not allow Pastor Lindstedt e-filing for all of his Bryan Reo litigation before this Ohio federal court or for this court to simply dismiss all of their pet homosexual mongrel antifa agent provocateur “lawfare” litigation against White Supremacist Aryan Nations Pastor Lindstedt & his Aryan Nations Church. However, seeing that this Covid-19 ZOGvirus lay waste to the Post Office, these regimeist courts and to the entire ZOGland itself, especially in Ohio and South Dakota it is doubtful that much of anything will remain to oppress Pastor Lindstedt and Lindstedt’s Church once all the appeals in these sundry regimeist courts are done.

Pastor Lindstedt shall mail off ONE copy of all Objections to this Court sent first-class certified mail so that it shall arrive sometime after Christmas as opposed to waiting for the Priority Mailings to arrive. Pastor Lindstedt shall also send e-mails to all parties. Sending off two copies, each for Bryan Reo v. Lindstedt 19-cv-2589 and for fake-plaintiff Stefani Reo v.

Lindstedt 19-cv-2786, is confusing enough for Pastor Lindstedt, much less this Court. Exhibit #1 concerns the proof of mailings and where they are at "in transit".
