**DEFENDANT LINDSTEDT'S AMENDED ANSWER & COUNTER-CLAIMS TO PLAINTIFF REO'S FRAUDULENT AND PERJUROUS AND DELIBERATELY UNVERIFIED CIVIL COMPLAINT WITH JOINDER OF ADDITIONAL PARTIES IN ACCORDANCE WITH THIS COURT'S SCHEDULING ORDER OF FEB 17 2015**

Defendant / Counter-Claimant Pastor Martin Luther Dzerzhinsky Lindstedt, ArchBishop of Missouri and President of the incorporated in Missouri public benefits church corporation Church of Jesus Christ Christian/Aryan Nations of Missouri, Missouri Corporation # N00773365 in good standing until August 31, 2016 (hereafter Pastor Lindstedt) makes the following Amended Answer and Counter-Claims to Plaintiff / Counter-Defendant Bryan Anthony Reo (hereafter Bryan Reo) in Reo's deliberately fraudulent & perjurous & unverified original civil complaint originally filed in the Cleveland US Northern Ohio District Court and transferred to this Western District of Missouri US District Court and Joins Additional Parties to this ongoing case in accordance with Pastor Lindstedt's pro se understanding of the Federal Rules of Civil Procedure and to obey this Court's Scheduling Order of February 17, 2015. Bryan Reo's filings shall be in italics and Pastor Lindstedt's responses shall be in normal type. Unlike Bryan Reo's bogus and perjurous filings, Pastor Lindstedt's response herein shall be verified by oath before a notary public since Pastor Lindstedt isn't a liar or interested in purposes of fraud.

**INTRODUCTION**

*1. Plaintiff's Complaint is based on the Digital Millennium Copyright Act [17 USC 512], the doctrine of defamation, libel, intentional infliction of emotional distress, and defamation via online impersonation and cyber-stalking.*

1. Pastor Lindstedt has already pointed out in previous filings, particularly his Pro Se Rely Suggestions of 23 Feb 2015 (Doc. 23) that Bryan Reo's claim of there being any subject-matter and personal jurisdiction under the Digital Millennium Copyright Act (hereafter DMCA) is bogus and fraudulent because it arises out of Pastor Lindstedt's posting Reo's Facebook public profile picture well over three and a half years since Reo issued a DMCA take-down notice on

Nov. 15, 2010 and Lindstedt filed a counter-notice on Nov. 18, 2010. On November 28, 2010 Reo called into Lindstedt's Talkshoe show and admitted that he wasn't going to file any litigation under the DMCA anytime soon and certainly within the ten business days required by the DMCA. Rather Reo would file a lawsuit at his "leisure" since by making other bogus Terms of Service complaints he had already taken down Pastor Lindstedt's web pages on 1and1.com as well as on Hostmonster.com. Reo decided to finally file his bogus DMCA litigation after Reo had threatened Lindstedt's then current Hosting Provider, CrisisHost.com with bogus litigation and thus forced CrisisHost to send Lindstedt packing. Lindstedt then with but 15 hours remaining on CrisisHost posted Reo's public domain Facebook public profile picture in an effort to get Reo to file this fraudulent and bogus and perjurous litigation so that Reo would lose and maybe be sent to prison for perjury and lying to these US District Courts. So far this has resulted in Reo lying repeatedly to two federal judges, James Guinn of the Northern District of Ohio and US Magistrate Judge Matthew Whitworth of the Western District of Missouri. Pastor Lindstedt also hopes to put some of the newly joinded parties as Reo's co-conspirators into prison and to litigation which they shall lose as well.

The other claims of Lindstedt libeling, defaming, and cyberstalking are fraudulent as well. They are allegations of law as Bryan Reo pretends to claim, with the fraudulence of there being no DMCA jurisdiction there is no subject-matter or personal jurisdiction. Reo is a public figure and Pastor Lindstedt has only said what he and others know to be true – that Reo isn't remotely white and is justly suspected of not being heterosexual. Also, pretty much everyone thinks as much yet Reo is making a fraudulent claim against Lindstedt as opposed to others because of personal animus and greed, as already shown by Exhibit #1 – Pray for my Success of 23 Feb 15 (Doc. 21, Exhibit 1). Reo wants to steal by fraud and deceit Pastor Lindstedt's inheritance and render Lindstedt "destitute" and penniless. Also, Reo has maliciously claimed that Lindstedt is a convicted child molester and "grooms children" as a pedophile, which is malice per se, no requirement for Lindstedt to prove malice because such an accusation is malicious on its very face even though Lindstedt is a public figure as well. Insofar as accusations of "cyber-stalking" are concerned, Reo has done all the cyber-stalking in taking down ten or a dozen of Lindstedt's blogs, forums, and web pages, along with those of others who merely wrote the truth about Bryan Reo's Internet rampages against Lindstedt, NIM-Busters, and others.

Thus this entire fraudulent and perjurous case lacks subject-matter and personal jurisdiction by Bryan Reo although Pastor Lindstedt would have jurisdiction over Reo in

Lindstedt's counter-suit under the DMCA and because Reo is committing fraud and perjury and mail and wire fraud in an effort to unjustly enrich himself and Reo's co-conspirators.

### **JURISDICTION AND VENUE**

2. *Jurisdiction of this Court arises due Federal Question jurisdiction over the DMCA claim. Additionally, this Court may exercise jurisdiction over the other claims, and jurisdiction exists due to the total diversity of both parties and the amount in controversy.*
3. *Because Defendant communicates libelous material into Ohio and sends electronic communications to a resident of Ohio, and has committed substantial injuries against a resident of Ohio, personal jurisdiction is established.*
4. *Because the injuries have occurred in Northeastern Ohio, subject matter jurisdiction is established.*
5. *Venue is proper as this is the area in which the injuries occurred to Plaintiff.*

Item #2 has already been answered. There is no DMCA jurisdiction by Reo because the DMCA has been violated repeatedly by Reo. Item #3 is a lie because Pastor Lindstedt has ever since November 2010 when this nightmare from Reo began by Reo taking down Lindstedt's web pages and forums and blogs Lindstedt has been hiding from Reo insofar as possible. Reo is an Anti-Racist Activist masquerading as a White Nationalist and Christian Identity pastor who deliberately picks a fight and then when this Internet stalking and criminality is defended against by Lindstedt and others then Reo plays the victim. Item #4 is also a lie given that Lindstedt has never taken down any web pages, blogs or forums or Internet communications of Bryan Reo nor his criminal confederates William Finck, Eli James or others pretending to be Christian Identity pastors or scholars while being jews and mongrels. Bryan Reo hasn't suffered any injuries whatsoever from Pastor Lindstedt other than having his public Facebook and Xuqa.com pictures being discovered for others not under Lindstedt's control to disseminate and Pastor Lindstedt mentioning Reo's present and past activities as an Anti-Racist Activist out to pretend to be what Reo is not, i.e. white, much less a racial Aryan or Christian Israelite. These pictures are public domain or parodies and thus not protected by the DMCA, according to case law and statute.

Item #5 has been rendered moot as Federal Judge James Gwin transferred this matter to the Western District of Missouri. Pastor Lindstedt in looking at Reo's past fraudulent federal litigation notes that Gwin had already heard at least two of Reo's bogus lawsuits, the one against AC Nielsen / Arbitron, NDOh Case 1:14-cv-00235-JG which was filed in the winter of 2014, and disposed of when AC Nielsen figured out, as did the National Rifle Association, that Reo was using another cell phone to induce them to make a telephone call and then Reo filing a bogus complaint against them. Gwin might have decided that he didn't want another bogus Bryan Reo case and hoped that if it was sent according to law to Missouri, 800 miles plus from Cleveland, that Reo would drop the matter. In any case this matter is before this Court now.

#### PARTIES

6. *Plaintiff is a natural person who resides in Mentor, Lake County, Ohio and is being defamed, cyber-stalked, and impersonated online by Defendant. Plaintiff has no criminal record and has never received so much as a parking or traffic citation and is particularly distressed to be declared a murderer and an insurance fraudster by Defendant.*

6. Actually back when Bryan Reo pretended to be a "Dual-Seedline Christian Identity" (hereafter DSCI) sub-pastor under William Raymond Finck and not the Anti-Racist Activist working for Daryl Lemont Jenkins who is the public persona for the One People's Project that Reo actually was and is, someone like Bryan Reo, with Reo's obvious non-white genetic profile would have been labeled a "mamzer" or miscegenated bastard with the bloodline of Satan through Cain.

Reo also used to work with a Chicago jew named Eli James whose previous aliases were Joseph Kutz-Putz then Joseph November. Under DSCI theology there are Two Seedlines, one good through Adamic Man through to Seth, then Noah, then to Abraham, Isaac, and Jacob Israel. There is an Evil Seedline which is of the jews, who are descended from Satan's seduction of Eve, giving birth to Cain. And those outside these Two/Dual Seedlines are the 6<sup>th</sup> Day Beasts of the Field, animals without souls. Since Bryan Reo used to pretend to be DSCI when not being an Anti-Racist Activist brought into the supposed flock through The One People's Project with the connivance of the jews William Finck and Eli James (or whatever that jew's name is this week). Thus according to Bryan Reo's pretended professions, it is not and never was a human being or natural person. But that was then and this is now. If Mr. Reo wants to now disown his former pretenses, then that is fine by Pastor Lindstedt.

Insofar as the so-called “cyberstalking” is concerned, Reo’s problem with Pastor Lindstedt is that Lindstedt found out Reo’s true identity because of William Finck’s stupidity, found Reo’s public Facebook profile, and let everyone in the [bowel] Movement of White Nationalism and Christian Identity see what Reo looked like. From there it was a simple matter of looking on the Internet for Reo’s past incursions into pretending to be a white supremacist under the now deceased (he was killed by a homosexual prison negro in April 2010) homosexual government agent provocateur and lawyer Dickie Barrett. Reo and Finck had threatened anonymous violence against others, particularly a then 86-year-old Greek woman in a wheelchair and by posting this discovered information on the Internet, Reo couldn’t pretend to be white or Israelite or Aryan or anything other than a psychotic mongrel with a history of being an asshole. Reo and one Mike Delaney had already gotten taken down Lindstedt’s [www.pastorlindstedt.org](http://www.pastorlindstedt.org) site in March 2010 on Hostmonster.com by making numerous Terms of Service (TOS) complaints, a practice called “TOS snitching.” White Nationalist and Christian Identity web pages live in fear of jews and ARA activists like Bryan Reo, Daryl Lemont Jenkins, the Southern Poverty Law Center, the Anti-Defamation Center, and others claiming to be Social Justice Warriors taking down their web pages. Thus as a result, Bryan Reo was outed by Pastor Lindstedt and could no longer threaten violence or Internet terrorism under concealment. This put Bryan Reo and William Finck out because they are cowardly psychopaths of jewish origin.

Insofar as the other claims of cyberstalking and are concerned, it is Reo who has done this against Lindstedt. Insofar as the claim of Lindstedt putting up claims of the murder of Catherine M. Williams in Spartanburg SC (Reo’s initial Civil Complaint of April 16, 2014, Exhibit #1 & #2) this matter was brought to Lindstedt’s attention by one Buck McHugh who has used Lindstedt as a catspaw against Bryan Reo – with Reo’s knowledge and permission. Sometime last summer Lindstedt was surfing the Internet and found that there was indeed another Bryan Reo who was around the same shade of skin color as Plaintiff-in-fraud Reo who also drove a Toyota Land-Cruiser of the same year. So it looks like Pastor Lindstedt made an innocent mistake given the same name and model of car to thinking that Buck McHugh was correct, that Bryan Reo had indeed murdered some middle-aged woman. This is particularly the case given that Bryan Reo used to have a blog and put up on it how Reo would always carry around an mp3 player/recorder and use it to record “accidents” with elderly women driving late-model Medicare sledge automobiles. Then Reo took that blog entry down when Pastor Lindstedt brought attention to this “co-incidence” of Bryan Reo driving a Toyota of the same model and



year killing some woman in South Carolina. Since Pastor Lindstedt doesn't know whether Buck McHugh was working with Bryan Reo or not like what happened back in March 2011, Pastor Lindstedt hereby joinders Buck McHugh as a party to this litigation.

*7. Defendant is a natural person residing in Granby, Newton County, Missouri, who has previously spent approximately three and one-half years in the Fulton State Mental Hospital for allegedly sodomizing his grandson. Defendant apparently also spent 660 days in jail on 30 consecutive contempt of court charges.*

7. Bryan Reo lost when he fraudulently filed this lawsuit any hopes of prevailing against Pastor Lindstedt for "slander, libel and defamation" because Reo and his co-conspirators in taking down Lindstedt's web pages, forums and blogs know that Lindstedt is not a child molester, much less a "convicted" child molester. This is knowing and deliberate libel per se, which thus defeats anything that Reo claims Lindstedt supposedly said, i.e.. that Bryan Reo isn't white and is suspected of being a homosexual. Bryan Reo and Pastor Lindstedt are public figures, but a knowing continuing false claim of Lindstedt being a convicted child molester proves malice. Thus any claim by Reo, that Lindstedt slandered him is rendered moot as well as fraudulent because Reo has made the ultimate libelous claim that Lindstedt is a convicted child molester.

Reo even posted as much from Eli James' article of November 2010 claiming that Lindstedt was a convicted child molester and an agent provocateur on Reo's blog provided by William Finck from November 5<sup>th</sup> 2010. (Exhibit #1) Reo didn't take this article down until recently Reo decided to sue Lindstedt for libel, slander and defamation. Thus Reo has committed fraud as well by hiding and concealing his own malicious and knowing libel per se. Reo has a long history of taking down such incriminating material in order to try to prevail upon bogus litigation. Lindstedt's strategy is to allow Reo to lie all Reo pleases and then prove the willful knowing perjury. This Court is at liberty to observe for itself this matter.

Also, William Shawn DeClue, also has worked as a TOS-snitch for Bryan Reo and made a comment Nov. 21, 2010. William DeClue begged Lindstedt to ordain him as one of Lindstedt's pastors, claimed that he would never call Lindstedt a child molester because he was accused – twice – of sexual assault against his niece. DeClue lasted a whole day and a half before running back to Mark and Debbie Downey and claiming that Lindstedt was a child molester. Later Lindstedt found DeClue's lengthy criminal record as a petty thief and criminal informant. DeClue actually claims he was sick from eating spaghetti cooked by Lindstedt because DeClue

watched Lindstedt cook it from a plastic jug storing Lindstedt's urine used as asparagus fertilizer. Sometimes Lindstedt denies LiarBill MumpsNut DeClue(less)'s claims but sometimes Lindstedt claims that he also fed DeClue some "fudge pudding" which was actually Lindstedt's own shit straight from the toilet bowl and used post-hypnotic suggestion to make DeClue scarf it right down. DeClue has by DeClue's own admission TOS-snatched for Bryan Reo. Hence Lindstedt hereby joinders William Shawn DeClue as a party to this litigation.

*8. Defendant claims to be the "arch-bishop" of the "Church of Jesus Christ Christian-Aryan Nations of Missouri," which he declares is a 501(c)3 tax-exempt religious organization incorporated in Missouri. Plaintiff has been unable to find any evidence that articles of incorporation or documents for tax-exempt religious organization were ever filed by Defendant. That aside, Plaintiff is pursuing Defendant solely in his capacity as a private individual and is not interested in pursuing an action against a fictional cult church that does not actually exist.*

8. Bryan Reo obsessively stalks and complains about Pastor Lindstedt's web page. In the above matter Reo deliberately lies again. Reo doesn't want to risk having this matter dismissed because as a matter of religious belief, i.e. Dual-Seedline Christian Identity dogma known mongrels like Bryan Reo are prohibited from pretending to be one of us Aryan Christian Israelites and thus Lindstedt was acting under religious belief. Pastor Lindstedt has never claimed to be running a 503(c)3 tax exempt religious organization or to be asking for, much less accepting, tithes or donations. Thus Reo, who obsessively lies in these bogus court filings yet relentlessly stalks Lindstedt's forums and blogs and web pages for an excuse to take them down now pretends that he has never seen the Official Announcements web page and after pretending to be a "Christian Identity" believer of pure Aryan Christian Israelite descent calls a Dual-Seedline Christian Identity incorporated church a "cult." Bryan Reo often "forgets" that he is supposed to impersonate a White Supremacist while actually being an Anti-Racist Activist mongrel but wants to sue Lindstedt for noticing that Reo isn't even remotely white or Aryan or DSCI. *9. Defendant is engaged in cyber-stalking, defaming, and impersonating Plaintiff*



*on the internet.*

9. Bryan Reo is repeating the same nonsense already answered by Pastor Lindstedt. Lindstedt found out Bryan Reo's real face and identity and let others know about Reo's obvious negroid, oriental and Indian ancestry and past history as an Anti-Racist Activist working with the jews Eli James and William Finck. Reo chooses to fraudulently call these facts and ridicule "cyber-stalking". Due to Reo's taking down so many of Lindstedt's Internet web pages Lindstedt has had to create secret admin eyes-only until Lindstedt found an actual free-speech Web host in CrisisHost. But Lindstedt agreed with the owner of CrisisHost that if Bryan Reo made a bogus and fraudulent DMCA complaint that Lindstedt would voluntarily take down anything and everything that Reo claimed was a DMCA violation. Insofar as TOS complaints, Lindstedt usually hid these posts as well because Lindstedt simply wanted to have a web presence and Reo posts were at most a percentage of one percent of Lindstedt's material. It wasn't until Josh Singer, the CrisisHost owner decided to cave into Reo's bogus complaints and gave Lindstedt three days to "move on" that Lindstedt decided to set a trap for Reo and post the already Noticed and Counter-Noticed Facebook profile picture of Reo from 2010 hoping that Reo would file this bogus DMCA litigation and perjure himself to some US District Court judge and be sent to prison as a result of this along with other of Reo's friends and supporters. So far this has worked. Reo continues to perjure himself and now Lindstedt can add other criminals to the mix of this litigation which was dead upon filing. Lindstedt's new host, Dreamhost, doesn't care about how much Reo makes bogus Terms of Service complaints or threatens to sue them. Dreamhost disabled the Reo avatar immediately and accepted Lindstedt's Counter-Notice and Reo didn't dare sue Lindstedt after getting the Counter-Notice from Dreamhost. Rather, Reo chose to sue Lindstedt over his use of Reo's public domain fair-use Facebook profile picture because CrisisHost pussied out on Lindstedt. There is no DMCA jurisdiction for Reo's case because Reo has violated the DMCA time and again. Reo can't claim slander or libel because everyone knows what Reo looks like and it isn't even remotely white. There are thousands of Bryan Reo pictures on the Internet but Reo wants to pretend that Lindstedt is the only one to be sued because Reo and Reo's allies malice against Lindstedt.

#### **REO'S "FACTUAL" ALLEGATIONS**

*10. Plaintiff had the misfortune of coming into contact with Defendant in early 2010 when Defendant was invited into a lively online Skype conference chat call where the topics of*

*discussion ranged from hunting and camping, to target shooting, to outdoor activities, to current events.*

10. Reo is talking about one Buck McHugh and McHugh's Skype conference calls from early summer 2010. McHugh had already informed Lindstedt that Bryan Reo was a particularly vicious mongrel that McHugh was scared of. Reo didn't work because Reo simply couldn't keep a job even when Reo got one for a week or two. McHugh also insisted on Lindstedt writing down where Bryan Reo went to college – some Jesuit university called John Carrol around Cleveland, about how Reo was an insurance fraudster, how Reo played at Mixed Martial Arts but claimed disability. McHugh told me everything about Reo except Reo's real name and where Reo lived with his daddy. McHugh told me that Reo had killed some woman someplace through insurance fraud. That Reo's mother was a mentally ill race-mixing mongrel whore who was caught screwing the local jew lawyer when Bryan Reo was five years old. So Pastor Lindstedt wrote all of this down in his paper "sockpuppet book" at McHugh's insistence. When asked why McHugh would put Lindstedt on the same Skype call as "SwordMamzer" – a "mamzer" is a Deuteronomy 23:2 Hebrew word for "miscegenated bastard" and Reo called itself "SwordBrethren" pretending to be a Teutonic knight – along with other fuktards as well, McHugh said that he liked the way Lindstedt "stirred shit up." Pretty much everyone loathed Bryan Reo on these Skype calls.

Three years later in April 2013, a week after the Boston Marathon bombing, Lindstedt braced McHugh as to why he was using Lindstedt as a catspaw after reviewing the old "sockpuppet book". McHugh claimed that Lindstedt was a pussy for not suing Bryan Reo as promised to McHugh and John Britton. Lindstedt asked McHugh why he didn't sue Reo by himself for causing McHugh trouble. Why had McHugh and Britton abandoned Lindstedt at the end of March 2013 when Lindstedt was thinking of suing Reo because Reo was stirring things up with CrisisHost and Lindstedt wanted affidavits from McHugh and Britton. McHugh called Britton via Skype but Lindstedt's mike wouldn't work and Britton promised to call Lindstedt but didn't do so. Lindstedt figured that McHugh and Britton were already working again with Reo like they had cut a deal with Reo back in March 2011. Reo broke that agreement with McHugh and Britton though and caused trouble for Britton by interfering with Britton's civil lawsuit and posting that Buck McHugh was a Wall Street fraudster.

Plaintiff has seen that Reo used McHugh to stir the pot in an old e-mail or Talkshoe conversation and will bring this matter up at trial, or upon discovery. Reo and McHugh hated each other, which is why McHugh used Lindstedt and invited Lindstedt onto these Skype calls hosted by McHugh. This is why Lindstedt is adding McHugh to this litigation in order to receive honest testimony and discovery. If McHugh tells the truth, Lindstedt won't seek damages.

*11. Defendant was invited into the chat conference by one of the other participants in the chat conference. Defendant rapidly began to engage in incoherent ranting and made disparaging remarks, declaring that he had "followers" and that they were going to castrate police officers, judges, and politicians, and murder the children of same. Plaintiff was concerned by these bizarre and absurd remarks and gently suggested that Defendant could benefit from professional mental health assistance. Defendant promptly exploded on Plaintiff and dedicated himself to discovering the real-life identity of Plaintiffs screen-name.*

11. Some, but very little of the above nonsense might actually be true, albeit irrelevant. Bryan Reo has always wanted to be a police officer but has allegedly been kicked out of ROTC and cannot pass psychological testing. After all, who wants on the payroll a self-loathing jew mongrel who wants to be a self-proclaimed racist religious bigot and nazi while being an Anti-Racist Activist? Who wants to hire someone who will inevitably sue them after a week or two of hiring Bryan Reo given that having him as a public employee is a public relations disaster? Nobody. Can you imagine, given the hue and cry recently over white police shooting criminal negroes in the back what would happen if someone like Bryan Reo, a multi-racial White-Supremacist and Christian Identity wannabe also acting as a self-loathing Anti-Racist Activist does the inevitable and kills someone, either white or black the inevitable fallout and public relations disaster? Yes & yes..

The actual truth of the matter is that Reo tried to placate Lindstedt in June 2010 and Lindstedt, having heard from Buck McHugh that Reo was a mongrel would have nothing of it.

Insofar as Lindstedt trying to find out "SwordMamzer's" real identity that is correct. Buck McHugh wouldn't give out Reo's real name and address. But given the fact that there is no real organized White Nationalist or Christian Identity organization which isn't already filled with jews, mongrels, agents provocateur / ZOGbots and criminals – there is no such real organization

having over a dozen members which is not infiltrated, Pastor Lindstedt has devoted his time and efforts in unearthing such as Bryan Reo, William Finck, Eli James, Dan Johns and those joined today by Pastor Lindstedt. Why let any of these Satannic jews and mongrel criminals get to work destroying White Aryan Christian Israelite lives in secret? Pastor Lindstedt is committing no crime in keeping his ear to the ground and raising the hue and cry to those who will listen.

Nor is Bryan Reo adverse to stalking and outing people. "Victor Switzer" of Pine Bluff Arkansas did some TOS snitching on a forum not owned by Pastor Lindstedt but upon which Pastor Lindstedt was an honored poster. "Victor" found out the not-so secret information that Lindstedt's mother's maiden name was Samuelson. Victor told every one of the Finckbots that Samuelson was a jew name ignoring that Lindstedt's great-grandfather Charles Samuelson was born Karl Svenson and that the Samuelsons were one of the First Families of South Dakota. Charles Samuelson's Union Army double-homestead is a South Dakota state park. "Victor Switzer" ignored that Finck is altogether a jew name meaning 'snitch' and "stool-pigeon". Victor Switzer run off before some NIM-Buster tard spent \$14.94 at ancestry.com to find out that William Finck comes from a long line of jews on both sides – that on Finck's fathers side Finck is related to Matt Lauer and on Finck's mother's side to Mark Potok of the Southern Poverty Law Center. No, what made Victor Switzer run off was Bryan Reo's doing.

Bryan Reo is to everyone's mind a homosexual. A noted Movement activist, Billy Roper called Reo a "Mexican faggot" back in 2004-2005 when Reo was working with the known open homosexual Dickie Barrett. Bryan Reo got angry and posted a DMCA complaint when Lindstedt posted a two pictures of Jerel Mosely of Shrieveport Louisiana leering at him in homosexual lust that Lindstedt labeled "Avionce Night" after the classic TV ad. Finck had boasted that neither Bryan Reo nor Finck had anything to hide and that there were plenty of Bryan Reo pictures on Finck's christogenia server. So a NIM-Buster calling himself "Frankenwhigger" after a short story parody of Frankenstein being Aryan and screwing Esther-kikesses and spawning kikelets downloaded them two pictures and sent them to Lindstedt, who used them. So Bryan Reo wanted some of "Victor Switzer's" man-pussy/mangina while travelling through Pine Bluff Arkansas on his way to Jerel Mosely's in Shrieveport.

But Victor Switzer used to be in the Navy and didn't want any more sodomy without the lash or rum from Bryan Reo. So Reo blackmailed Victor, threatening to tell Switzer's boss the Captain of the local Volunteer Fire Department that Victor was Christian Identity and a White

Supremacist if no man-pussy was forth-cummin'. Victor Switzer refused to put out and so Reo told on him to Victor's boss. Victor nearly got fired, but said that he wouldn't be racist no more and abruptly quit Finck's Christogenia forum on February 12 or 13<sup>th</sup> 2011. This story came out in October 2011 on the Talkshoe program of this Staten Island jewboy calling himself the Newsguy 2005 pretending to be an Aryan living with some Icelander in Iceland. On that show Reo tried to claim the Lindstedt had outed "Victor Switzer" when if Lindstedt had known Switzer's real name Victor Switzer would have indeed been outed by Lindstedt. Bryan Reo knows Victor Switzer's real name and has recently lied to Lindstedt given Lindstedt's request for initial admissions as to Reo's co-conspirators.

Buck McHugh knows Victor Switzer's real name but refuses to give it out absent subpoena. McHugh told Lindstedt the rest of the story: Victor Switzer came back to Finck's forum in October 2011 and was promised that Bryan Reo wouldn't harass him. But Victor's family told him that someone from Cleveland Ohio was digging around in Victor's past and found out that Victor Switzer's grandfather was a full-blood Choctaw Indian. Victor Switzer wasn't a pure Israelite but rather was a mongrel, albeit less of a mongrel than Bryan Reo and not a jew like Bill Finck. But yet again Bryan Reo wanted Victor Switzer's man-pussy so Victor had no choice but to run off for the second time and be labeled a "mamzer" because he wouldn't be a pitcher or catcher for Bryan Reo on Finck's forum and web page. Bryan Reo is a hypocrite as well as a liar and fraudster.

*12. Approximately six months later, in October 2010, Defendant discovered Plaintiffs identity and began a relentless campaign of harassment, posting pictures of Plaintiff on pornographic forums, posting Plaintiff's phone number on adult websites, using Plaintiffs full [real] name and Plaintiffs picture to create accounts on forums and post writings in favor of non-mainstream causes such as NAMBLA.*

12. William Finck was allowing Matt Ott and Bryan Reo to threaten Pastor Lindstedt on his Christogenia forum. Lindstedt went over to the Neosho Public Library and at 1:30 pm Oct. 13, 2010 found out that Finck had lied to him and violated an agreement. So Lindstedt did a Talkshoe podcast on his Movement Turd program called, "I got fucked at Finckelsteins."

Soon after Finck banned Lindstedt and Britton. Bryan Reo was scouring Lindstedt's web page trying to find an excuse to have it taken down. Finck said that the jew had denied my Facebook friends request from six months earlier. Lindstedt wondered who else was Finck's friend and found, in addition to Finck's hose-nosed sister "Bridget Thor-Thompson" the Facebook of a little brown-skinned unbrowed effeminate mongrel from someplace around Cleveland who was into MMA and attended John Carroll University. Bingo. Then a Google search revealed Reo's past with Dickie Barrett and as an Anti-Racist Activist. Lindstedt had a Facebook public profile picture to go by which revealed that Bryan Reo wasn't even remotely white, much less Aryan.

Lindstedt hasn't done any photo shopped pictures or put Reo's name on pornography sites. What Reo claims Lindstedt has done has been done by Reo itself or by others.

*13. Defendant has repeatedly declared that Plaintiff would "one day be found dead in a dumpster" [a police report of Plaintiffs criminal complaint about Defendant's threats and conduct towards Plaintiff is on file with the Lake County Sheriff's Department in Lake County Ohio] and has declared that he [Defendant], despite having been involuntarily institutionalized for 3.5 years in a mental hospital in Missouri, has firearms and will use said firearms in the event that the police ever attempt to take him back to the mental hospital.*

13. Mr. Reo has already made an attempt to get Lindstedt gunned down by the US Marshal's Service using this particular claim. There is also a Skype audio somewhere where Reo claims that he is going to gun down the police when they come for him. At trial we can exchange these irrelevant audios. Insofar as the Lake County Sheriff's Department Lindstedt asked for and got the complaint which Reo didn't sign because it is a crime to file a bogus police report. Of course it is also illegal to make a bogus DMCA complaint under penalty of perjury and to lie to two federal judges as well, so it goes to show that Reo has less respect for this Court than for the local county sheriff. Also, Bryan Reo and Eli James and possibly William Shawn DeClue sent the US Secret Service to my door claiming that Lindstedt was going to shoot the President and federal judges. The Secret Service left after twenty minutes or so and never came back.



*14. Defendant has also declared that he and his "followers" know how to make weaponized anthrax and that they will poison the water supply in Southwestern Missouri if Defendant is incarcerated. The remarks about Anthrax were made while Defendant was incarcerated in 2005 in jail in southwestern Missouri. While in jail Lindstedt penned a 20+ page paper [which was previously available on his website, a PDF of which Plaintiff has saved] wherein he outlines that he and his "followers" will attack the government and "force police and judges to bite the testicles off of their own children." The Plaintiff may wish to have the letter in question entered into evidence so that the Court may get an impression of the Defendant's mental status and to help them in deciding whether or not to have Defendant held for psychiatric review.*

14. Mr. Reo is at liberty to present whatever irrelevant material Reo pleases. Lindstedt wishes to present the dozens of more relevant bogus DMCA complaints made under penalty of perjury that Reo has presented to Lindstedt's Web Hosting and upon discovery / initial disclosures the hundreds of Terms of Service bogus complaints.

*15. Defendant recently [in the last 18 months] created an account on his hate-filled website, under Plaintiffs name, and posted things where he purports to declare that Plaintiff is a homosexual, Plaintiff is a drug dealer, Plaintiff is a con-man, Plaintiff is a murderer, Plaintiff engages in insurance fraud, Plaintiff is a pawn store owner, Plaintiff is a "Jewish pimp," Plaintiff is a "mamzer baal-priest," and other defamatory things.*

15. "Hate-filled website"??? Lindstedt supposes Reo has forgotten that it is supposed to be a White Supremacist and DSCI clergymamzer some of the time as opposed to an Anti-Racist Activist all of the time, especially when filing bogus fraudulent litigation and engaging in perjury and interstate mail and wire fraud.

Lindstedt hasn't called Reo to his recollection a drug-dealer or a "jewish pimp". Lindstedt thought Reo's father was a pawn shop operator because of all the guns Reo has shown. Pity that Reo couldn't sell one of them rather than engage in fraud to federal judges trying to make sure that his fraudulent and unverified civil complaints are done *in forma pauperis*. Insofar as defamation is concerned, perhaps Reo thinks that his grievances against Lindstedt outweigh

calling Lindstedt a "convicted child molester" and taking down a dozen of Lindstedt's web pages and those of anyone else making fun of Reo.

*16. Defendant insults and denigrates Plaintiffs heritage and Defendant's perception of Plaintiff's heritage.*

Mr. Bryan Reo is not white. Nobody else looking at Reo's Facebook public profile picture thinks Bryan Reo is white. The Xuqa.com pictures that have flooded the Internet show Reo as a Mexican, as a negro with blubber lips, and as an oriental. The picture of Reo in his Toyota Cougar Assault and Maim and kill Landcruiser show Reo as an oriental. Looking at it one time Lindstedt denied that it was a picture of Reo, it was some fat gook in a Toyota. Lindstedt had to admit that he was wrong when a number of NIM-Busters asked Lindstedt that if it wasn't Reo what was it doing on Reo's Google blog. So yes, it was Reo, looking non-white.

Reo has claimed that Lindstedt is committing a racial hate crime for denying Reo's whiteness. Yet Reo must roam around taking down them Bryan Reo pictures because they show the truth – Bryan Reo isn't white.

*17. Defendant makes contradictory and bizarre allegations that Plaintiff is a "Mexican mestizo," a "Jewish pimp," an "Italian-Arab nigger" and a "white supremacist" none of which are consistent or valid. At varying times Defendant has accused Plaintiff of being a "communist," a "fascist," a "nazi," and an "anarchist" the contradictory nature of such accusations provides insight into the mentally ill mind of the Defendant.*

17. Mr Reo is the one who cannot distinguish the reality of when to pretend to be a white supremacist and when to maintain being an anti-racist activist. Lindstedt simply says that Reo isn't white and is the spawn of Satan. Speaking of which, others have the same problem as Lindstedt, i.e., someone who spent \$14.95 cents to Ancestry.com to find out Finck was a jew.

*18. Defendant makes specific references to a man in South Carolina, who shares Plaintiffs name [first and last], who apparently was the at-fault party in a fatal car collision in South Carolina, and Defendant declares that Plaintiff is the man being discussed in the article*

*[see attached Exhibit 1 and Exhibit 2]. Defendant declares that Plaintiff purposefully staged an auto-mobile accident in South Carolina, murdered a woman, and did so for the purpose of insurance fraud. Plaintiff wishes this Court to note that as an adult Plaintiff has never been in South Carolina and has never driven a vehicle in South Carolina.*

18. Pastor Lindstedt was given that link by Buck McHugh years ago. Lindstedt thought that Bryan Reo had indeed murdered Catherine Williams through insurance fraud. Six months ago Lindstedt found out that yes, there actually was another Bryan Reo who drove a Toyota Landcruiser of the same year. Unlike Bryan Reo, who commits fraud and perjury and concealment by taking down deliberately malicious lies when preparing to commence bogus litigation, Pastor Lindstedt fesses up to his mistakes because Lindstedt is a real Dual-Seedline Christian Identity White Supremacist instead of an Anti-Racist Activist Satannic mongrel abomination trying to get rich from fraud and perjury. Savvy? It's a White thing which you wouldn't ever remotely understand, Reo. Nor Finck. Nor "Eli James". Nor the rest of the muds.

*19. Defendant has conducted a relentless and ruthless campaign of harassment and libel against Plaintiff. Plaintiff has made terms of service violation complaints on at least eight occasions with separate website server hosting companies, complaints which have always resulted in the prompt termination of Defendant's website services. However the Defendant simply switches to a different company and continues his libel, his impersonation, and his cyber-stalking.*

19. Reo admits that Reo has wages a relentless and ruthless campaign of harassment and censorship and fraud against Pastor Lindstedt, Lindstedt's church corporation and at least eight occasions through making fraudulent and bogus DMCA complaints and Terms of Service harassment and has thus become liable for his criminal activity under color of law. Because Pastor Lindstedt refuses to be censored, Reo claims that he is a victim of some sort. Hence this litigation which should end in Reo and Reo's co-conspirators liable for hundreds of thousands of dollars and decades of prison for mail and wire fraud.

*20. Defendant has posted online [falsely] that Plaintiff has syphilis and other infectious venereal diseases [see attached Exhibits 3, 4, 5, and 6]. Additionally, Defendant has made the posts about Plaintiff [falsely] having syphilis in the name*

*of the Plaintiff, signing Plaintiffs names to the posts and attaching Plaintiffs picture to the post.*

20. So Reo's name is now "Broke Back Mamzer?" There is no picture of Reo there nor mention of syphilis. There is mention of one of Reo's many bogus federal lawsuits trying to avoid paying his just debts. The theme is one of ridicule. Nobody except Reo would pretend that he has a disease common to sheep like scabies and rabies. Also, this post was done back when Bryan Reo was maliciously interfering with the civil case of John Britton. Reo had deliberately made a fraudulent affidavit and sent it to one Ray Mariani of Rolls Royce trying to get Britton's federal case dismissed. John Britton had gotten a PACER account and sent it to Lindstedt so that Reo and Mariani and Rolls Royce would back off by having their names mentioned on the Internet and get no compensation for a broken back caused by the failure of a critical engine part after being tied up in the federal courts for nearly nine years. Bryan Reo shouldn't mention this case of malicious criminal interference in a case that didn't concern him just because John Britton wasn't homosexually attracted to Bryan Reo and was at that time a close personal friend of Pastor Lindstedt.

21. Defendant has posted defamatory content about Plaintiff on at least a half-dozen websites, although Plaintiff has since had most of the content removed by filing terms of service violation complaints and [where appropriate- such as issues involving pictures of Plaintiff that Plaintiff owns and has an exclusive claim on] DMCA complaints.

21. Herein Reo admits yet again that Reo has taken down numerous of Lindstedt's web pages and blogs and forums based upon fraudulent claims that Reo owns an exclusive copyright to a Facebook public profile page which in any case was duly Noticed and Counter-Noticed way

back in Nov. 2010 and never litigated by Reo. It has already been settled law that this is well under public use and Reo has made numerous perjurous DMCA complaints and then when Lindstedt didn't use any Reo pictures in any case, Reo settles down to making Terms of Service complaints for purpose of harassment and fraud against Lindstedt. We have already mentioned this at least three times before.

*. 22. On 7<sup>th</sup> December 2010 Defendant wrote a forum post [attached Exhibit 7] in which he declared that he knew where Plaintiff lives and that retribution was going to come down upon Plaintiff and that Plaintiff would be destroyed without mercy. Defendant also threatened to do violence against a sheriffs deputy in his [Defendant's] home county of Newton Missouri.*

Reo is mentioned only in passing and Reo has done nothing but post Lindstedt's home address, phone number and other personal information hundreds of times.

*23. The Defendant has shown that his use of the internet is solely for the purpose of harassment, bullying, stalking, libeling, defaming, and impersonating decent people.*

23. Bryan Reo has shown that his use of the Internet is solely for the purpose of censorship, harassment, bullying, stalking, libeling, defaming and defrauding White people.

24. Plaintiffs name appears on the Defendant's vile website no less than 525 times. It is clear that one of the major purposes of Defendant's website is to libel and injure the Plaintiff.

24. So out of several million words on Pastor Lindstedt's "vile" to this Anti-Racist Activist this importunate mongrel occasionally impersonating a White Supremacist there are 525 times wherein Reo is mentioned. Which comes down to less than a fraction of one percent, and when for most of the time Reo couldn't see it anyways. And Reo wants to claim that this web page is all about itself. This is of course a lie and meant only to enrich Reo through fraud.

*25. Plaintiff has suffered extreme anxiety as a result of Defendant's conduct and has had the embarrassing misfortune of having to explain to others that Plaintiff has no connection to Defendant and does not in any way, shape, or form, support his "Aryan Church" or anything remotely connected with his cult.*

25. Bryan Reo's primary emotion has been greed and malice in which Reo goes to his co-conspirators on Finck's forum and asks them to pray for his success in using the courts to

defraud and dispossess Pastor Lindstedt and Lindstedt's "cult" of Lindstedt's inheritance and property. This matter has already been addressed before.

26. *Defendant has stolen one of Plaintiff's pictures from Plaintiff's Facebook account, where not only is Plaintiff the individual pictured, but Plaintiff was the photographer as Plaintiff shot his own picture. Thus Plaintiff is the only possible individual with a claim [indeed an exclusive claim] to the picture, as Plaintiff is the subject of the picture and the photographer. Defendant has stolen and infringed on Plaintiff's claim to the picture in question. The most recent infringement occurred on or around 6th April 2014. The infringement is associated with the account Defendant made in an attempt to impersonate Plaintiff [a forum user avatar picture] and thus the infringed picture appears repeatedly on Defendant's website, anywhere he makes a post with the impersonating account.*

26 It is already settled law that a Facebook public profile picture is not copyrightable under settled law. Besides, yet again, Reo Noticed and Lindstedt Counter-Noticed and Reo refused to act according to the law of the Digital Millennium Copyright Act. Reo's purpose is fraud.

27. *Defendant has since moved his website/defamation/infringement activities to another one of his numerous websites, at the following links:*

27. Lindstedt has moved his public site to Dreamhost wherein they don't pay much attention to Reo's fraudulent nonsense. Lindstedt's web page has been there for over a year now. Lindstedt's web page would have still been on Crisishost but the owner caved because of fear of Reo's bogus threatened litigation.

28. *In March of 2011 Defendant obtained a Lexis Nexis report on Plaintiff, containing information such as voter registration, party affiliation, vehicle registration, vehicle license plate, social security number, etc, and posted it on numerous websites [including his own at the time] and thus intruded on the seclusion of Plaintiff. A copy of what Defendant posted is attached as Exhibit 8, Exhibit 9, Exhibit 10, Exhibit 11, and Exhibit*



12.

28. Bryan Reo has committed mail and wire fraud and perjury again. Reo interfered with John Britton's federal civil case out of malice and lust by submitting a fraudulent affidavit to one Ray Mariani of Nixon-Peabody, attorneys for Rolls Royce who made a defective gas turbine nozzle which was the case for this helicopter crash which injured Britton. Britton's lawyer looked up Reo's Lexis-Nexis information and Britton gave it to a number of people, Pastor Lindstedt among them. However Lindstedt didn't submit this information to Bryan Reo, another individual named Russell Walker did, and Walker sent it to around 40 people, especially Bryan Reo. Lindstedt got down on Russ Walker for transmitting this information although it is not illegal to do so and Walker agreed to claim that Walker got it from the law school of Duke University instead of Britton. Lindstedt has asked for an affidavit from Walker admitting this so as to send Bryan Reo to prison for deliberate knowing fraud committed against Lindstedt and against this Court. Reo has already squalled that Reo will object to being caught out in a lie at trial.

*29. Plaintiff made a DMCA complaint with Defendant's former website service provider, Crisis Host, on 7th April 2014. Defendant supposedly made a counter-notice on 8th April 2014, although the website service provider never sent a copy to Plaintiff. However, Defendant did send, by email, a copy of what he purported was a DMCA counter-notice [which he claimed had been sent to the service provider] to Plaintiff on 9th April 2014. The website service provider has been unable to verify that Defendant submitted a counter-notice to them as provided by the DMCA.*

29 Pastor Lindstedt tricked Reo into filing yet another bogus DMCA Notice on something that had already been noticed and counter-noticed without suit under the DMCA three and a half years before. The purpose of doing this was to induce Reo to make a fraudulent federal civil lawsuit and send Reo and Reo's co-conspirators to prison for conspiracy and fraud. By then Joshua Singer was so terrorized of Reo that Singer refused to provide Lindstedt's Counter-Notice.

**COUNT I –  
DEFENDANT HAS DEFAMED AND LIBELED PLAINTIFF**

30The entire purpose of Reo's bogus litigation is for purpose of fraud and malice. Nothing more.

**COUNT II**

***DEFENDANT HAS CYBER-STALKED PLAINTIFF***

31. Actually Bryan Reo and his co-defendants have cyber-stalked Pastor Lindstedt and through fraud and criminality took down a dozen or so of Lindstedt's forums, blogs, and web pages. They have not been bothered or molested in their Internet activities albeit they have been ridiculed and criticized. Pastor Lindstedt has suffered real damages, Reo only imaginary ones. Reo cannot show how he has been damaged other than by Pastor Lindstedt telling the truth about Reo's racial origins and past criminal and fraudulent behavior

**COUNT III - DEFENDANT HAS INTENTIONALLY INFLICED EMOTIONAL DISTRESS ON PLAINTIFF**

32. Actually, Pastor Lindstedt has told people on his Talkshoe show that Reo is a "judas mamzer" and to not harm the vicious misbegotten critter because Reo is stupid and by watching who has anything to do with Reo what kind of people they are. Lindstedt would suffer no problems if Reo were to commit suicide though but doesn't recollect saying as much. The rest of the above is mere puffery or something Reo has done against Lindstedt five times as much.

**COUNT IV – DEFENDANT HAS IMPERSONATED PLAINTIFF FOR PURPOSES OF DEFAMATION AND INTENTIONAL INFLICTION OF EMOTIONAL DISTRESS**

33. Actually Reo cannot show how anyone has been fooled by Pastor Lindstedt's burlesque and parody of Bryan Reo. Is Reo claiming that the avatar of a small monkey is him? Of course not. Reo is merely a parasite and predator pretending to be a victim.

**COUNT V – DEFENDANT VIOLATED THE DIGITAL MILLENNIUM COPYRIGHT ACT**

34. Actually, Bryan Reo has violated the DMCA by making knowingly making fraudulent DMCA complaints, then whenever Lindstedt would file a Counter-Notice would refuse for years to file the lawsuit as Reo was supposed to do in order to protect Reo's "copyright" to his Facebook public profile picture or to pictures taken from and marked as Xuqa.com. Reo would also make bogus copyright claims to parody third-hand pictures taken from these pictures which Reo would fraudulently claim as well. On the other hand, Pastor Lindstedt has the right under the DMCA to pursue civil and criminal remedies against Bryan Reo and Reo's co-conspirators.

**COUNT VI – DEFENDANT INTRUDED ON THE SECLUSION OF PLAINTIFF**

35. Bryan Reo is willfully committing criminal fraud given that Reo knows that it was another party, Russ Walker, who sent Bryan Reo the Lexis-Nexis report with Reo's information along with 30-40 others. This is not even an unlawful act by itself. Russ Walker got the report from John Britton who in turn got it from Britton's lawyer, who sent it to Britton after Reo improperly and criminally interfered with Britton's pending federal civil litigation out of no motive other than malice and hatred.

**BRYAN REO'S BOGUS, VINDICTIVE, FRAUDULENT AND CRIMINAL DEMANDS OF THE FEDERAL COURTS AGAINST PASTOR LINDSTEDT – ITEMS 36-48**

Items 36-48. Has Bryan Reo demanding something of the Court that cannot be granted even with a jury trial. Reo demands \$10.75 million in non-existent damages. That without jury trial or due process of law that Pastor Lindstedt be deprived of technology, the Internet having a computer, be imprisoned in a psychiatric prison, be denied Lindstedt's Second Amendment rights, and that all web pages, forums and blogs be transferred to Bryan Reo – who has never been able to run or operate anything other than a free wordpress blog operated by his criminal co-conspirator William Finck or by Google.

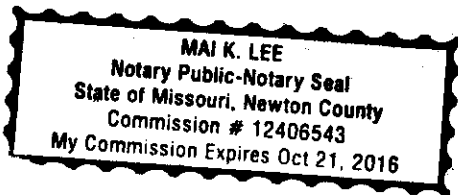

**“We know we have passed out of death to life because we love the brethren. He that loves not his brother abides in death. Whosoever hates his brother is a murderer: and you know that no murderer has eternal life abiding in him.” – I John 3: 14-15.**

One of ZOG’s favorite tactics against True Israel is to prop up phony pastors. They usually come out of the prison system. I have had much personal experience with the subversives among us, as I have related in this earlier article, posted on my website: <http://anglo-saxonisrael.com/site/node/111> The most common tactic of the subversive is false accusations, made publicly, in order to discredit the true servants.

What these impostors never realize is that disobeying Yahweh’s laws immediately disqualifies them from being a part of our congregation. It may be easy to fool White nationalists, but CI is hard to impersonate.

Numerous people have called me a Jew or a mamzer or worse, but none of them have been able to prove any of their charges against me. Those who know me personally know that I do my best to be a guileless Israelite. I do not claim to be perfect, but neither do I actively go out to make trouble for others. Sadly, we have another impersonator trying to weasel his way in, but his behavior has exposed him as an impostor.

One of the biggest complaints I get is that I am too lenient with the trolls in the chatrooms of my talk shows. Martin Lindstedt has been a frequent troll during many of my shows; and the only time I have censored him is when he has resorted to ad hominem attacks or profanity. These two things are part of his act, as I will abundantly prove in this expose’ of this ZOG agent.

The fact that he calls his “ministry” the “Movement Turd” should be a quick tip-off to anyone that he cannot possibly qualify as an Identist, since we are not to engage in loose language or obscenities. Martin Lindstedt is an obscene person. His morbid fascination with excrement is a very Jewish trait, as are many of Rabbi Lindstench’s traits, such as lying and impersonating a pastor. It demonstrates that he is really mocking us to our faces; and wants to rub our faces in it!

Identity, which is based on the Bible, not on Martin Lindstedt’s eyesight or disingenuous opinions, clearly tells us that, in order to be a True Israelite, we must obey Yah’s Laws. This, Rabbi Lindstench adamantly refuses to do, as he continues to attack well-established ministries with lies and ridicule.

The infamous 1977 Nazi demonstration in Skokie IL was actually arranged by a Jew, Frank Collin, posing as a Nazi. {See [http://en.wikipedia.org/wiki/Frank\\_Collin](http://en.wikipedia.org/wiki/Frank_Collin) After being exposed as a Jewish infiltrator, Collin left the neo-Nazi movement and became a pornography distributor.} Given all of the money the Jews have, it is easy for them to hire people to infiltrate any and all patriotic movements. Today's Jews are even bragging that they have infiltrated the Tea Party movement, in order to undermine it.

The German philosopher, Arthur Schopenhauer, was one of the first to expose this Jewish tactic, when he said,

*"Every time new and promising opportunities for meddling have arisen, the Jew has been immediately involved. He has demonstrated an uncanny ability to sniff out like a bloodhound anything which was dangerous to him. Having found it, he uses all his cunning to get at it, to divert it, to change its nature, or, at least, to deflect its point from its goal. How does the Jew respond? He establishes a Schopenhauer Society." – <http://www.jrbooksonline.com/eckart.htm>*

To demonstrate how well Arthur Schopenhauer understood the perfidious Jew, he also said,

*"While all other religions endeavor to explain to the people by symbols the metaphysical significance of life, the religion of the Jews is entirely immanent and furnishes nothing but a mere war-cry in the struggle with other nations."*

Alas, their power is today stronger than it has ever been, at any time in history! Satan is, indeed, the prince of this world! We have to understand how these Jew-financed infiltrators operate and how they insinuate themselves into our company.

Here is the typical profile of an informant/infiltrator: Someone who

- 1.) has been prosecuted and convicted of a crime and sent to prison. Usually, these potential informants are convicted of drug charges, as in the case of Bradley Jenkins, who was posing as an Aryan Nations "Identity minister" right after his release from jail. Sometimes, these potential prisoners agree to become informants before going to prison, and make a deal to avoid prison.
- 2.) plea-bargained for a lower sentence.
- 3.) had his sentence reduced in exchange for being let out early.
- 4.) after being released, appears out of nowhere, claiming to be a White nationalist, patriot, or Christian Identity.
- 5.) incites people to commit violent or illegal acts.
- 6.) talks a good game at first, bashing the Jews and commies, but does not walk the Identity walk.
- 7.) as he attracts his own following, he begins bashing real patriots
- 8.) never produces any Christian scholarship of his own. Rather, he uses the cut and paste technique of posting factual articles about the Jews and Zionism, but never doing any positive work.
- 9.) avoids the "Good News" that Yahshua will return to destroy our enemies. Instead, he encourages us to engage in violent acts or violations of the law.
- 10.) flagrantly disobeys Yahweh's laws, while claiming to be an "Identity minister."
- 11.) once exposed for these violations of Identity protocol, he begins all out attacks on real Identists.

Does Lindstench fit this profile? The infiltrator du jour is the self-proclaimed "Pastor" Martin Lindstedt.

#### **Beware of Martin Lindstedt**

The surest way to get a White nationalist in trouble is to bait him into doing something illegal or violent. The ADL loved it when Hal Turner recruited gullible White nationalists and entrapped them into doing something stupid. The important thing to realize here is that Hal Turner was not just a propagandist, he was setting people up. His undoing was caused by the fact that a real patriot had intercepted emails that Turner was exchanging with his FBI handler.

In my Judgment Day Perspectives Newsletter, I reported on Hal Turner on several occasions. Apparently, Pastor Visser did not get this Newsletter, or he might not have gotten involved with Mr. Turner. I suspect that all of Visser's current problems are a direct result of his brief involvement with Turner. Here is the text of a Newsletter I put out in October of 2008:

.....

**BEWARE OF HAL TURNER!!!! HE IS A CLASSIC AGENT PROVOCATEUR!!!!**

Hal Turner is a federal agent. The real reason his show was taken down was that he was exchanging emails with the FBI, informing on White Nationalists. Having been exposed in this way, he shut down his old site. This was a voluntary decision by himself, because his cover had been blown. Now, in the referenced video, he is trying to make a comeback. He claims that the shut-down was due to "government pressure." Don't be fooled. Hal Turner is a sophisticated shill. All White patriots should be aware of who and what Hal Turner is. A good agent provocateur must occasionally provide true information in order to be credible; but his purpose is really to entrap unsuspecting White nationalists, who might be prone to acting on his provocations. **Turner even brags about this in his email to one of the feds!!!**

In January, hackers broke into Turner's computer server and found e-mails between Turner and an FBI agent who was apparently Turner's handler. Turner was providing information to the FBI agent about individuals who attended his neo-nazi rallies, along with a potential assassination plot against Senator Russ Feingold.

"Once again," Turner wrote to the agent, *"my fierce rhetoric has served to flush out a possible crazy."*

**When he was confronted by his readers, Turner shut down his website and vowed to separate himself from the "pro-White" movement. His site later returned in the form of a blog hosted on [blogspot.com](http://blogspot.com).**

The Southern Poverty Law Center documented the case in an article entitled, *FBI's Use of Neo-Nazi Informant Knocked*. Both the FBI and Turner have refused to comment on the allegations.

**Considering the fact that Turner has been left alone [by the authorities - Eli] despite arguing that killing certain federal judges "may be illegal, but it wouldn't be wrong" and outright calling for the murder of immigrants crossing the border from Mexico, it's no surprise that his latest scam, despite its blatant illegality, will go unnoticed by the same authorities that Turner apparently accepts a paycheck from.**

The SPLC article states, In 2006, Turner told his audience to *"clean your guns, have plenty of ammunition, [and] then do what has to be done"* to undocumented workers.

Around the same time, he suggested that half the U.S. Congress *"may have to be assassinated."* A year earlier, he suggested *"drawing up lists of yeshivas,"* or Jewish religious schools. He once started a website called [www.killtheenemy.com](http://www.killtheenemy.com) for the purpose of posting photos and names of those who marched in favor of immigrant rights. Hearing that anti-racist activist Floyd Cochran was visiting Newark, near his home town, last June, Turner said he had *"arranged for a group of guys to physically intercept"* Cochran and added that Cochran would likely *"get such a beating that his next stop is going to be University Hospital."* (Although complaints were made both to the FBI and to Newark police about this threat against Cochran, both declined to press criminal charges.)

**So Turner's alleged relationship with the FBI apparently affords him immunity from any legal consequences of making death threats, just as neo-con radio talk show host Michael Reagan was left alone despite openly advocating the assassination of Mark Dice and stating "I'll pay for the bullets".**

I think I can honestly state that my Judgment Day Perspectives Newsletter has always provided the most factual, up-to-date information on the activities of the Jews, the Illuminati, and their henchmen. Most "anti-Zionists" dare not go into the territory of exposing the fact that the Jews are neither Shemites nor Israelites. Nor is their religion based upon the Bible. In the wake of Hal Turner's demise, Rabbi Lindstench now masquerades as one of the people who condemns Turner as a "phony." Well, this is just another Jewish tactic, which can be added to his profile. It is a very clever tactic to feign patriotism by pretending to expose those who have already been battered and bruised. It makes one look warrior-like. (We have to imagine Lindstedt wearing a Viking helmet and an oversized sword!) But it's just another Jewish ruse. Once a fellow infiltrator has fallen, he is fair game; and it is easy for other agents to pretend to attack one of their own, in order to ingratiate themselves with gullible White Nationalists. This is exactly what Lindstench has done. When Martin Lindstedt looks in the mirror, he sees Hal Turner. As Turner was coming down, Lindstedt was being groomed as his replacement.

Here are Lindstench's own words from the above link. I have highlighted some of the more provocative statements:

*Well, after 3 1/2 years I am finally out on bail. ZOG/Babylon/the Beast for whatever reason finally decided to belatedly obey its own sacred scrap of toilet paper, the CONstipation and Bill of Goods. ["Whatever reason" indeed! There most definitely IS a reason, but Lindstench is not offering any good reasons. Things just happen, right? Also, Lindstedt's disrespect of our Constitution is fascinating! Whose side is he really on? ZOG doesn't have a Constitution or a Bill of Rights. Is he talking about America? – Eli] I suspect that I am like Lenin and my hero Felix Dzerzhinsky, who would be turned loose whenever the Tsarist regime was tottering and finally released in the October Revolution of 1917, to then exterminate the old regime. [Lenin was released under the orders of the Jew, Max Warburg, then head of German Intelligence under the Kaiser. (See this article for how WWI was orchestrated by the Warburg brothers: <http://mostaqueali.blogspot.com/2008/12/scum-that-threaten-humanity-jewish.html>) I suspect that Lindstedt's release was arranged by Warburg's relatives. Isn't there a policy that the local community should be warned when a convicted child molester is turned loose upon society? Was this policy followed in the case of Lindstench? Maybe Martin is being facetious when he refers to Dzerzhinsky, a Jewish mass murderer of White Christians, as his "hero."*

Is this prose anything like the writings of Swift, Compaet, Rand, Emry, et al? Or is this a raving lunatic, sly like a fox, or one pretending to fill the shoes of the above?]*

*In the time I've been imprisoned, I've been tortured and drugged, like every police state loves to do before it collapses. And as a result I hate — a lot. By propping up their phony "pastors," the ADL uses them as the "Jerry Springers" of Identity. This is Lindstench's true function, as should be obvious to anyone that has eyes to see and ears to hear. All you have to do is check out his supposed "Identity" postings and talk shows, which are filled with nothing but obscenities and HATE SPEECH — AGAINST IDENTITISTS!! On his 10/28/2010 talkshoe show, Lindstedt, after talking about cannibalistic chickens for about half an hour, finally gets to the meat of his "sermon." So, Lindstench is a liar when he accuses me of "censorship." I do not have to tolerate his nonsense during my shows. Nor should any minister have to tolerate someone getting up in the middle of his sermon and starting his own sermon from the pew. You can go to his site any time and listen to his garbage. The fact that he calls his "ministry" **The Movement Turd** is a **mockery** of Christianity and Christian Identity. He has never produced any Christian scholarship, nor does he intend to. Even the commentators on his blog weren't fooled by him. The fact that he has taken, as a middle name, the name of a Jewish mass murder is a good indication of how sincere he is. 8.) never produces any Christian scholarship of his own. Rather, he uses the cut and paste technique of posting factual articles about the jews and Zionism, but never doing any positive work.

His pleasure is hate rhetoric. **We know that this does not benefit Christian Identity.** The Jews have been known to hire provocateurs to pose as ministers. We should be on our guard at all times for those who refuse to walk the walk. Most of his hate-spewing is actually directed against Israelites, which violates Yahshua's command that we be guileless. Rabbi Lindstench is so full of guile that he exudes it into the stratosphere. Jesus said, "Be ye therefore wise as serpents, yet guileless as doves." Rabbi Lindstench has "wise as serpents" part down pat.

10.) flagrantly disobeys Yahweh's laws, while claiming to be an "Identity minister."

Non-stop.

11.) once exposed for these violations of Identity protocol, he begins all out attacks on real Identists.

This has apparently been going for a long time, but I only recently became aware of Lindstedt's attacks upon our established identity shows. This is when he started to call myself and Sword Brethren "mamzers." He did this without any proof whatsoever, so I called in on his show on Halloween night – fitting night for a spook to be exposed! – and challenged him to obey Yahweh's laws. ## Conclusion

Every con artist has to have a convincing sales pitch, by which to hook his victims. By coming out against easy targets, such as Turner, and those who were associated with him, Wickstrom, Faber and Visser, Lindstedt tries to set himself up as "the good guy." This is a very clever tactic; but it is only part of this race traitor's disguise.
