**DEFENDANTS RULE 59(e) & RULE 60 (FRCP) MOTION FOR JUDGE ADAMS TO  
ALTER, AMEND OR RECONSIDER HIS ORDER (DOC 30) AND TO ALLOW  
PASTOR LINDSTEDT TO FILE AN AMENDED ANSWER & COUNTER-  
COMPLAINT A YEAR LATER AFTER THE INITIAL ANSWER AND COUNTER-  
COMPLAINT WHICH WERE STRUCK (DOC #4, #7)**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as “Pastor Lindstedt along with His Church of Jesus Christ Christian / Aryan Nations of Missouri hereafter “Pastor Lindstedt’s Aryan Nations Church” OR “The Church”) to Motion Judge Adams to either under Rule 59(e) or Rule 60 of the Federal Rules of Civil Procedure (Hereafter FRCP) to Alter, Amend or Reconsider his Order (Doc 30) or preferably allow Pastor Lindstedt to File an Amended Answer and Counter-Complaint to professional plaintiff Bryan Reo’s barratry attempts using his father, the supposed Plaintiff Domenic Anthony Reo, to file spurious litigation, originally before the Lake County Ohio Court of Common Pleas. The sum of this litigation concerns Pastor Lindstedt mistaking a non-white follower of Bryan Reo sitting in the Lake County Courthouse the second day of trial on 25 June 2019 against Pastor Lindstedt and his Aryan Nations Church who was ignoring Bryan Reo’s wife Stefani Rossie Reo jumping up and down trying to get the attention of Bryan Reo and what Pastor Lindstedt mistook for a

homosexual mongrel lover of Bryan Reo given that Pastor Lindstedt had overheard Bryan Reo telling its father the first day of trial on 24 June 2019 to not show up at court because Pastor Lindstedt is a “vile racist White Supremacist”. After being sued Pastor Lindstedt later learned that this fake Plaintiff was actually Bryan Reo’s father, not just another homosexual mongrel. Admitted by Bryan Reo in the innumerable court proceedings in Ohio and South Dakota since the Original Answer and Counter-Complaint (Doc. #4 of 15 Nov. 2019 and Doc. #7, 6 Jan. 2020) was that the entirety of Bryan Reo’s civil complaint is nothing but lies, that Pastor Lindstedt never said anything about “homosexual incest” (speaking of this instant case *Anthony Reo v. Martin Lindstedt* 1:19-cv-2615) or about “transsexual prostitutes” ) speaking of the *Stefani Rossi Reo v. Martin Lindstedt* 1:19-cv-2786 and the rest of the other cases, *Bryan Reo v Martin Lindstedt* 1:19-CV-02103-SO (which Judge Adams references in Doc 30) and *Bryan Reo v. Martin Lindstedt* 1:19-CV-02589-CAB. All four of these Bryan Reo cases are designed to punish and censor Pastor Lindstedt and Lindstedt’s Church documenting to the White Nationalist / Supremacist and Christian Identity Movements the activities of a long-time homosexual non-white agent provocateur who has been used by the State of Ohio and Federal Government to create incidents against “White Nationalists / Supremacists” especially Charlottesville 1.0 of August 2017 and likely Charlottesville 2.0, also known as the Glorious Sixth of January Second Civil War Capitol Insurrection & Second Civil War Inauguration.

In the past year all manner of information has come out about Bryan Reo and Reo’s Foundation for the MarketPlace of Ideas (hereafter FMI) also known as the ZOGbot Poverty [F]Law Center (ZPLC). The federal authorities set up a “Rally” be it for statutes of Confederate generals or for President Trump and then when egged on stupid whiggers walk into a trap set by agents provocateur working with the local, state and federal police to have antifa and Black

Lives Matter initiate the violence in which fools and others get killed and there is the excuse for censorship, a crackdown of “white supremacy” and endless lawfare by antifa lawyers like Reo.

Pastor Lindstedt wants an opportunity to file an Amended Answer and Counter-Claims against not only the fake antifa pretend white supremacist Plaintiff Anthony Domenic Reo being used by Bryan Reo but the other entities ranging from the federal government to the State of Ohio, Lake County Ohio Courts, Bryan Reo’s fellow Ohio attorneys Kyle Bristow and Brett Klimkowsky of the FMI “lawfare” NGO. And additional parties such as the State of South Dakota, its licensed bar, antifa Reo lawyer Robert Konrad, Pastor Lindstedt’s sister’s lawyer Kody Kyriss and their past and current law firms for extortion and wire fraud and blackmail in not only going after the South Dakota inheritance that Pastor Lindstedt gave back to his sister in late October 2019 but her assets independent of Pastor Lindstedt in order to “render her destitute and destroy her life as well” according to Attorney Konrad, Bristow, and her own lawyer as well as Bryan Reo. It is not enough for this court to do, as Judge Oliver did, to simply allow Pastor Lindstedt to make a “general denial” and certainly not given that Pastor Lindstedt has explained in great detail in his answers both to the initial civil complaint but in all the ORDERED Amended Complaints & Counter-Claims and to Bryan Reo interrogatories. Simply put, Bryan Reo as a non-white, non heterosexual long-time antifa agent provocateur since at least 2003 before it graduated from high school, has a long history that Pastor Lindstedt has documented on Church web pages and these state and federal courts have violated their First Amendment pretensions in allowing this endless Bryan Reo lawfare litigation. Khazar jew capitalist courts at the federal and state level work no different or better than Khazar jew communist courts in that they serve the same master – Satan – in their attempt & duty to destroy the White Foundational People under genocide under color of “law” as they put it. Pastor Lindstedt and Lindstedt’s

Aryan Nations Church to the contrary have a duty to YHWH to serve YHWH's Servant Nation of Aryan Christian Israel.

Pastor Lindstedt, given that since he originally filed his Answer & Counter-Claim (Doc. 4) on Nov. 15, 2019 and his Motion to Strike Bryan Reo's Motion to Strike (Doc. 7) on Jan 6, 2020 this was over a year and well before additional information came out, certainly not the FMI Board of Directors 501(c)(3) IRS Short form proving that Bryan Reo along with Kyle Bristow and Brett Klimkowsky and Richard Spencer and others in the Movement were an antifa "lawfare" group responsible for Charlottesville 1.0 in August 2017 which Pastor Lindstedt derived from a hate watch group later in January 2020. (See Exhibit 11-1 2017 tax return).

Also the past year Pastor Lindstedt has found out that Attorney Robert Konrad and Bryan Reo sued not only Pastor Lindstedt but his sister to whom he transferred his South Dakota inheritance to in late October 2019 so that if Pastor Lindstedt had shot the Granby City Council for conspiring with Bryan Reo to collect a bogus judgment arising out of a Missouri open records lawsuit and them bulldozing Pastor Lindstedt's and Roxie Fausnaught's and niece and nephews' properties then neither Bryan Reo nor the Granby City Council-Criminals could collect anything and the inheritance would go to the sister, who isn't very racist and knew nothing about Pastor Lindstedt's musings and never heard about Bryan Reo until she was sued in late February 2020 when informed by her renter being served in Florida. Since then Pastor Lindstedt's sister is being extorted and blackmailed and threatened by Attorney Robert Konrad working with her own attorney to violate the Stanley County South Dakota judge Bridget Mayer's injunction against Pastor Lindstedt's sister selling the inheritance under threat of taking away her property unrelated to the gifting back of Pastor Lindstedt's inheritance. Pastor Lindstedt's sister has been

crying and upset but refuses to give Pastor Lindstedt the audio recordings and e-mails of the extortion by Bryan Reo and Attorney Konrad and her own lawyer so he can put it up on his Aryan Nations web page to make the point that all lawyers need to be exterminated and/or enslaved under a racial successor Warlord's regime. Right now the injunction is under appeal before the South Dakota Supreme Court. These lawyers have committed criminal activity in trying to pressure under blackmail and deceit Susan Bessman to violate a judge's injunction and thus should be prosecuted criminally and sued civilly, especially antifa Attorney Robert Konrad for stealing Susan's Bessman's confidential documents from when he worked at the Ollinger Law Firm of Pierre SD from when she was settling her affairs back in 2011.

Therefore, Judge Adams should remember that Bryan Reo lied to him about not participating in a pre-trial FRCP Rule 26 / L.R. 7.4 conference (Doc 13) before the telephonic 5 March 2020 Case Management Conference, and lost his temper at Pastor Lindstedt due to Bryan Reo lies. Judge Adams calmed down and assigned a Magistrate Judge to hear the matter.

These people and organizations both NGO and state counter-sued by Pastor Lindstedt are mainly officers of the court for Lake County Ohio, State of Ohio and of South Dakota and are using Bryan Reo and Reo family and lawyers as part of an antifa agents provocateur operation to engage in pre-civil war activity against genuine long-time long-term White Supremacist individuals and organizations like Pastor Lindstedt and his Aryan Nations Church and now ZOGling whigger useful idiots who are engaged in precursor domestic unrest leading when thwarted to domestic terrorism and insurrection like what happened at Charlottesville 2.0 on the Sixth of January. Thus Pastor Lindstedt wants to counter-sue all the aforementioned individuals and groups from Doc. #4 Answer and Counter-Suit but new parties just discovered as well.

Lastly, Judge Adams puts Pastor Lindstedt on notice regarding Pastor Lindstedt having pointed out that Bryan Reo is indeed a “delusional self-loathing predatory homosexual non-white antifa agent-provocateur / Satanic homosexual mongrel abomination” and has been since at least 2003 when it was pretending to be a White Supremacist. Thus if Pastor Lindstedt responds and gives an answer with a listing and proof from the Internet, audio recordings, and even court records then Pastor Lindstedt will be sanctioned by this Court for participating in his and his Church’s defense upon one of Bryan Reo’s Motions to Strike. If not, then Pastor Lindstedt will lose by default through one of Bryan Reo’s numerous Motions for Sanctions. Thus Judge Adams gives Pastor Lindstedt no real defense to this fraudulent litigation carried out where Bryan Reo’s father Anthony D. Reo is the putative plaintiff but Bryan Reo is the actual person / real plaintiff who is not only a public figure within the White Nationalist / Supremacist Movement but an agent provocateur as well. Thus this criminal regime which needs to be destroyed has set up a non-white homosexual mongrel who is likely part jew to laughably infiltrate the organic real White Supremacists, Klansmen, Aryan Nations and then when inevitably the head of the Aryan Nations calls it out as being a non-white homosexual mongrel who lives around Cleveland, used to work at the North Perry Nuclear Power Plant until fired because the operators found out about it and its delusions and then tries before its own corrupt courts before a biased jury and corrupt judge and then wants to steal his inheritance and destroy his remaining family and then has some of its judges claim that with the ongoing spurious litigation that the genuine racial patriot cannot speak or disseminate the Truth, both past and present.

Pastor Lindstedt prefers to answer Bryan Reo’s barratry before these Satanic courts of a Mighty Evil Empire by speaking the truth. Bryan Reo agreed to leave the White Supremacist and Christian Identity Movement in late October (until the 5 Nov.) 2010 in return for no more

exposing Bryan Reo furthermore. Bryan Reo would have suffered no damages whatsoever if Bryan Reo had kept the deal. Instead, Bryan Reo reprinted an Eli James / Joseph November article “Rabbi Lindstentch – Race Traitor or jew” article on his SwordBrethren Blog on (the jew agent provocateur snitch who murdered a Puerto-Rican sneak thief named Arnauldo Ortega in the Jersey City Jail) William Finck’s Christogenea Forum. Which article claimed that Pastor Lindstedt was a child molester over 20 times and a convicted one at that nine times.

*Bryan Reo v. Martin Lindstedt*, 3:14-cv-0593-MJW 22 Apr. 2015 Joinder & Amendment of Pleadings, Counter-Claims. This will be **Exhibit #1** to show nothing has changed since 2014.

This was Bryan Reo’s first lawsuit against Pastor Lindstedt and Lindstedt’s Aryan Nations Church under the spurious jurisdiction of the Digital Millennium Copyright Act and claiming the exact same claims of defamation and libel and demanding censorship of Pastor Lindstedt reporting on the activities of this non-white homosexual agent provocateur on Lindstedt’s Aryan Nations Church web sites for which Bryan Reo later upon dismissal of the federal lawsuit on the grounds that the DMCA filing was “futile” and that even upon being given 20 days for the magistrate judge plus an additional 30 days upon request Bryan Reo could not overcome the FRCP Rule 26-mandated (Rule 26 (A)(1)(a)(iii) computation of actual damages to show that Reo had likewise been damaged for over \$75000 diversity of citizenship requirements. Therefore that lawsuit was dismissed. (Although Pastor Lindstedt did appeal the judgment to the 8<sup>th</sup> U.S. Circuit Court of Appeals where the dismissal was upheld.) Bryan Reo then went on 8 days later to file the very same lawsuit stripped of the DMCA provisions before Lake County Ohio Courts on 18 Sept. 2015 and eventually won before a Lake County lynch-mob jury and crooked judge a judgment of \$105,400 against Pastor Lindstedt and Lindstedt’s Aryan Nations Church on 26 June 2019. The Ohio 11<sup>th</sup> District Appeals Court has upheld Bryan Reo’s barratry.

Bryan Reo filed four more lawsuits in Lake County Ohio which Pastor Lindstedt foolishly removed to the federal courts.

There are other lawsuits, twelve on Lake County plus the two civil stalking frivolous litigation neither of which Pastor Lindstedt went to Ohio to contest because he lacked the funds, the one in 2016 was promoted, the one of 30 March 2020 was dismissed when the Lake County Magistrate Judge Andre figured out Bryan Reo was lying and dismissed it. See Doc. 19-1 submitted 10 July 2020. Thus counting the two bogus Civil Protection Stalking Orders Bryan Reo has fourteen lawsuits against Pastor Lindstedt, Lindstedt's deceased woman Roxie Fausnaught, and Lindstedt's Aryan Nations Church. See **Exhibit #2** Printout of Bryan Reo v. Lindstedt litigation. 12 cases plus 2 civil stalking plus 2 against trial court judge = 16 Bryan Reo cases in Lake County over the past five and a half years plus five federal cases plus Missouri and South Dakota shows that Bryan Reo as a homosexual mongrel agent provocateur has been very busy, along with Reo's antifa lawyers against Pastor Lindstedt and Lindstedt's Church.

Pastor Lindstedt is now rendered penniless and due to having to keep up with his curtailed bills and not having any income since 4 August 2020 when his bedbound domestic partner of over 33 years died and so no longer getting a VA check, hasn't been able to "keep up" with all of this Bryan Reo litigation in which Reo's antifa lawyer buddies Kyle Bristow, Brett Klimkowsky and now Robert Konrad (and Susan Bessman's putitive lawyer Kody Kyriess is enabling the Reo/Konrad blackmail and extortion against Susan) are piling on. As a result Pastor Lindstedt has to access PACER sparingly because of being unable to use it every single time Bryan Reo files something over the weekend. Reo will wait a day or two and then maybe send it on and with the holiday rush the mail would take 10 days or two weeks to arrive. Pastor Lindstedt suspects that it is too late for a Rule 59(e) Motion so alternatively files a Rule 60.



The past few weeks have revealed that Pastor Lindstedt is not the only one who is facing “lawfare” and censorship under color of law, but rather even President Trump as the Mighty Evil Empire falls apart. Indeed the FBI is rounding up some ZOGbots for their tweets right now. Bryan Reo was as a homosexual mongrel ZOGbot merely a decade ahead of the rest in taking down web pages, censoring the Internet and lawfaring and criminalizing dissent by going against the premier White Supremacist of the ZOGland in Pastor Lindstedt & His Aryan Nations Church

Wherefore, Pastor Lindstedt will keep on telling the truth about Bryan Reo being a long-time homosexual mongrel agent provocateur. This particular lawsuit is bogus because Pastor Lindstedt simply made a mistake in assuming that the obvious non-white sitting next to Bryan Reo was yet another one of Bryan Reo’s homosexual lovers in the Lake County Courthouse on 25 June 2019 having overheard the previous day that he wasn’t supposed to appear. Nor prior to being sued via this fraudulent litigation Pastor Lindstedt never referred to Bryan Reo’s father by name but rather as “Ol’ Niggerlips’ Alleged Spawner.” Bryan Reo as the real engine behind this fraudulent and frivolous litigation hasn’t shown any actual or real damages, certainly not under the mandated FRCP Rule 26(a)(1)(a)(iii) “computation of damages” provision simply because Pastor Lindstedt has never spoken to the putative Plaintiff Domenic A. Reo. Instead Bryan Reo has lied in claiming that Pastor Lindstedt said something about “homosexual incest” which was admitted to be a lie by Bryan Reo at a Stanley County South Dakota evidentiary hearing on 31 Aug. 2020 and disproved by Pastor Lindstedt’s “Consolidated Answers” to Bryan Reo Interrogatories Doc. 27 filed 9 Nov. 2020. This fraudulent case supposedly by Bryan Reo’s father Anthony D. Reo is based upon delusional lies of both fact and law. Mistaking Bryan Reo’s father for one of Bryan Reo’s homosexual mongrel lovers is not an actionable cause of action but

rather prime reason for a counter-suit by Pastor Lindstedt. Therefore since this Court chooses to go with the status quo of Pastor Lindstedt making a simple denial, Pastor Lindstedt hereby requests leave to Amend His Answer and to Make a Counter-Complaint against Bryan Reo, Reo's father, Reo's wife, the rest of the Bryan Reo fellow antifa friends and lawyers and the government enablers and supervisors in Lake County Ohio, the States of Ohio and in South Dakota and Missouri.
