**DEFENDANTS REPLY TO BRYAN REO'S INCESSANT MOTIONS (DOC. 34) TO
CENSOR PASTOR LINDSTEDT'S & LINDSTEDT'S CHURCH REPLIES TO REO'S
NEVERENDING "LAWFARE" LITIGATION AND VERIFIED DECLARATION AS TO
THE PAST DECADE OF REO V. LINDSTEDT POLITICAL STRUGGLE**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt along with His Church of Jesus Christ Christian / Aryan Nations of Missouri hereafter "Pastor Lindstedt's Aryan Nations Church" OR "The Church") to Reply to the latest (Doc. 34) of literally hundreds of Bryan Reo Motions for the judicial apparatus of the federal and state courts to censor and oppress Pastor Lindstedt and Lindstedt's Aryan Nations Church for documenting the machinations of Bryan Reo – a notorious antifa homosexual mongrel agent provocateur over the past decade or so. Pastor Lindstedt in his last Motion for a Rule 59 & 60 Motion for Judge Adams to Reconsider his Rulings to Strike Pastor Lindstedt's Answers & Counter-Claims earlier this month (Doc. 32) which this court denied, used the very same terminology to describe Bryan Reo which this Court has forbidden and which Bryan Reo as a "protected" non-white homosexual agent provocateur is making a big deal of in its Rule 34 Motion to Show Cause. (Doc. 34). Bryan Reo has infested the white supremacy / white nationalist Movement since 2003 and Christian Identity and Klan paramilitary groups since 2007

and Pastor Lindstedt has been aware that this non-white homosexual agent provocateur which used to call itself "SwordBrethren" was in fact the notorious Bryan Reo the Mamzer from Mentor (Ohio) since 29 Oct. 2010. A deal was made by Bryan Reo and Pastor Lindstedt on 1 Nov. 2010 by which Bryan Reo would leave permanently these Resistance Movements and in return Pastor Lindstedt would not publish new Bryan Reo outrages since there would be nothing new to report since Bryan Reo would leave the Movement for good that time unlike when Reo was expelled by Richard Barrett – another homosexual agent provocateur (henceforth known by the Resistance term of "ZOGbot") who kicked Reo out from his homo ZOGbot organization because Reo wasn't white in 2004 or 2005. Reo used the four days of peace to try to ascertain who had fin[c]ked Reo out them broke the cease-fire on 5 Nov. 2010 by republishing on its "SwordBrethren Blog" the Eli James article "Rabbi Lindstench – Race Traitor or Jew?" in which Reo and Eli James called Pastor Lindstedt a child molester and a convicted one at that 20-some times. (See Doc. 32, Exhibit #1). Bryan Reo then proceeded to take down a dozen or so of Pastor Lindstedt's Aryan Nations Church's web pages and those of allied or even neutral Movement onlookers the next year or so then commenced litigation in April 2014 and the litigation never stops be it in Ohio (See Doc. 32, Exhibit #2 already submitted) or South Dakota or Missouri.

Pastor Lindstedt is hereby submitting as part of this Motion a ten-page Verified Declaration regarding the past ten years already submitted in Bryan Anthony Reo v. Martin Lindstedt 19-cv-2103 Doc. 63-1 as **Exhibit #1**. **Exhibit #2** has already been sent and filed in this case revealing sixteen Bryan Reo v. Lindstedt lawsuits since Sept. 18, 2015 as Doc. 32-2 and thus won't be resent in this case. **Exhibit #3** is a resending of where in Bryan Reo v. The Church of Jesus Christ Christian / Aryan Nations of Missouri the 11th Ohio Circuit Court of Appeals / Lake County Court of Common Pleas / State of Ohio shows that Pastor Lindstedt's Aryan

Nations Church has been a Defendant in Bryan Reo's never-ending litigation and as such is engaged in a Crusade against the federal regime and State of Ohio since mid-2016 when first the trial judge ruled that Pastor Lindstedt could not defend either his woman nor Lindstedt's Aryan Nations Church from Bryan Reo's bogus litigation sans any legitimate jurisdiction because Pastor Lindstedt was not a licensed officer of their court nor intended to hire any such. Thus under Biblical Law that Ohio court by acting like Sodom and Gomorrah of exercising a false dominion over those well outside their jurisdiction then the Judgment of Sodom and Gomorrah means that the North Perry Nuclear Power Plant is to turn NE Ohio into an irradiated nuclear wasteland and Lake Erie into the Dead Sea upon opportunity since the Sin of Sodom was committed circa mid 2016 when the Mentor Municipal Court evaded Reo litigation and Lake County usurped it. Under Biblical law when a criminal regime commits an act of treason under color of law against a member of YHWH's Servant Nation everyone under rule of that regime is to be exterminated, i.e. act like a Canaanite then be treated as a Canaanite.

Thus Bryan Reo as a longtime delusional psychotic homosexual mongrel agent provocateur working for a Satanic criminal regime is whining to the Satanic criminal regime's courts because Pastor Lindstedt persists in his filings in literally calling a spade a spade. Bryan Reo is demanding that this Court which Pastor Lindstedt views as being a corrupt court belonging to Satan in the end times punish Pastor Lindstedt with a ruling of civil contempt even while Pastor Lindstedt is encouraging unknown genuine white supremacists to use nuclear weapons lying around in the form of ailing old nuclear power plants with low security or biological weapons such as the ZOG-made corona-virus which kills non-whites far more than urban whites and rural whites in good health least of all to destroy this Satanic regime. Pastor Lindstedt thus has the military advantage – why should this Court render to Pastor Lindstedt the

moral advantage of justifying as protecting religious freedom by censoring Pastor Lindstedt from pointing out that Bryan Reo is filing a perjurous case in which Bryan Reo's father suffered no damages whatsoever simply because Pastor Lindstedt having been told by Bryan Reo that its father wouldn't be there mistook Bryan Reo's father for one of Bryan Reo's mongrel homosexual lovers when Bryan Reo's wife was jumping up and down to gain their attention?

The purpose of this Response to Bryan Reo's Motion for this Court to find for Contempt is the same as Pastor Lindstedt's Response in Bryan Reo v. Martin Lindstedt 19-cv-2103 Doc 63 plus exhibits, some recycled in this Response. For the past 20 years or so Bryan Reo as a homosexual mongrel antifa agent provocateur has been trying to infiltrate White Supremacism / White Nationalism and the above-ground Christian Identity churches. Bryan Reo has the problem that Reo isn't even remotely white and is effeminate and as a predatory homosexual preferring blond blue-eyed Nordic Aryan man-pussy cannot help but engage in blackmail and stalking as "Victor Switzer" fireman of Pine Bluff Arkansas and John Britton can testify to. Until Reo found out that "Victor Switzer" was ¼ Chocktaw and from myself John Britton was an anglo-mestizo from NE Oklahoma Reo gave them no rest. Pastor Lindstedt truly didn't know until sued that what he thought was a homosexual mongrel because Bryan Reo was hard up was this fake plaintiff Anthony Domenic Reo and thus Bryan Reo's father until being sued in one of these Bryan Reo lawsuits.

So Bryan Reo cannot infiltrate In Real Life the genuine White Supremacist and Deep-Woods Dual-Seedline Christian Identity Klans and churches because Reo is rightfully scared that if detected that Reo would simply disappear somewhere in the back forty or down the gullets of someone's hogs for those who justify pig farming. Thus this crazed delusional homosexual

mongrel ZOGbot must do its antifa work – along with others from the Foundation for the Marketplace of Ideas (FMI) who are a mixture of new crazed delusional homosexual mongrels, jews, perverts and some like James Edwards and Thom Robb’s lawyer son Jason are White Nationalist 1.0. (See 2017 FMI 501(c)(3) IRS Tax Form Doc. 11-1) The entire [bowel] Movement has been infiltrated and run by ZOG since before the 1960s. Attorneys Bryan Reo, Kyle Bristow, and Brett Klimkowsky helped set up Charlottesville 1.0 in August 2017. More than likely, just as the Proud Boys leader for Charlottesville 2.0 / Glorious Sixth of January 2021 was a Puerto Rican jewlatto like Bryan Reo and the rest were FBI/CIA informants like the “Oath Keepers” and “III-Percenter ZOG-militia” this dying Mighty Evil Empire runs agents provocateur to get stupid Trump-MAGA-tards into trouble in order to mount their coups. They then get their corrupt federal and state courts to hide the provocative conduct of their professional agents provocateurs through “lawfare” like this court is doing right now.

Of course this is not working. In late February and 5 March of 2020 Bryan Reo lied and tricked this Court by refusing to hold a Rule 26 / Local Rule 7.4 Pre-Trial Conference and got Judge Adams to yell at Pastor Lindstedt. The Covid-19 ZOGvirus has slowed down this process and allowed Pastor Lindstedt to appear by telephone. Nor is it working in a larger sense. Even the stupid Republicans realize that what they are being blamed for was antifa operatives let in by the Capitol police in order to “crack down” on “white supremacist domestic terrorism” or what was merely posing and Live Action Role Playing was a “violent insurrection”. Speaking as the de facto ZOG-recognized/persecuted genuine Head of the Aryan Nations, the current antics are nothing other than ZOGbots entrapping ZOGling whigger ass-clown ZOGtards NOT genuine real White Supremacists, especially given their own set of mongrels like Bryan Reo.

Pastor Lindstedt has had no choice but to appear in the ZOG state and federal korts lest he lose

by default. These courts are corrupt and after what they claim is “due process” they proceed to try to give Pastor Lindstedt and Lindstedt’s Church property, liberty, and lives. Ever since Pastor Lindstedt found out that Bryan Reo was fired from the North Perry Nuclear Power Plant in early 2016 and then when the first Lake County Ohio judge Collins [d]ruled in June or July 2016 that since you lawyers had given to yourself a spurious patent of nobility to where Pastor Lindstedt couldn’t defend his elderly fat bed-bound dying illiterate woman Roxie Fausnaught nor especially The Church of Jesus Christ Christian / Aryan Nations of Missouri but must hire one of the officers of these spurious Satanic courts instead Pastor Lindstedt has invoked the Doom of Sodom and Gomorrah of “abuse of process / fraudulent dominion” in which the Sodom & Gomorrah & Three Other Cities of the Plain were destroyed by fire and brimstone for kidnapping & judicially murdering travelers on the caravan route a half-day away to the entire North East Ohio region within radiational distance of the North Perry Nuclear Power Plant. The penalty for dragging a Christian Identity White Supremacist pastor and his Aryan Nations Church to face fraudulent and tyrannical farcical legal proceedings before a non-white and gliberal whigger lynch mob jury and a corrupt judge who will not allow a fair trial (absent jurisdiction) should be exactly the same in both 2000 BC around the time of Abraham and in 2020 in the time of Pastor Lindstedt. It would have been nice if this crazed homosexual mongrel playing white supremacist Bryan Reo had chernobyled the nuclear power plant when Reo worked there in 2012 after disabling his white supremacist and Christian Identity Talkshoe podcast and web page but Reo got fired because of Pastor Lindstedt’s Aryan Nations web page finally alerting the operators after a series of accidents at the plant. But far better is to chernobylize the North Perry Nuclear Power Plant as policy with Bryan Reo back at the controls and Reo’s wife, father, antifa lawyers Kyle Bristow, Brett Klimkowsky, the Lake County Ohio

Wherefore this Court should and must ignore Bryan Reo's latest Motion for this Court to find Pastor Lindstedt in civil contempt (Doc. 34), especially given that there is no legitimate reason for respect by Pastor Lindstedt for these lawless proceedings in any case.
