EXPLANATION OF WHY THIS CASE IS A CASE OF PUBLIC OR GREAT GENERAL INTEREST AND INVOLVES A SUBSTANTIAL CONSTITUTIONAL QUESTION

Statement of the Case & Facts. Comes now Pastor Martin Lindstedt and The Church of Jesus Christ Christian / Aryan Nations of Missouri (henceforth Pastor Lindstedt's Church but not Roxie Fausnaught, deceased since 4 Aug. 2020) to explain that absolutely no Court of the State of Ohio ever had legitimate jurisdiction over a genuine White Supremacist Aryan Nations Pastor -- much less His Aryan Nations Church -- speaking the Truth as they saw it concerning nonwhite homosexual federal and state agent provocateur Bryan Reo and Bryan Reo's associates and fellow attorneys going about their business of the federal and state regimes to disrupt the racial and religious beliefs of genuine white supremacists and Dual-Seedline Christian Identity pastors to actually bring spurious legal process in destroying via "lawfare" the lives, liberty and property under color of their foreign "law" allowing an officer(s) of their foreign secular state courts to drag before a Lake County lynch mob jury of an African female and seven gliberal whiggers and crooked biased judge for "common-law" "defamation" and "invasion of privacy" without allowing Pastor Lindstedt to represent his Aryan Nations Church or bed-bound illiterate elderly female domestic partner because they were not officers of your foreign court without jurisdiction. At those pretend proceedings the corrupt trial judge Condon refused to allow Pastor Lindstedt to present evidence in his own and his Church's favor, dismissed under sundry pretexts Pastor Lindstedt's counter-claims against Bryan Reo abusing legal process over the past decade, taking down Church web pages, stalking and harassing Pastor Lindstedt's friends, allies and suspected followers, getting to call Pastor Lindstedt a "child molester" from 2010 until closing arguments at trial closing arguments, and while forbidding Pastor Lindstedt to present evidence allowed Bryan Reo to "cherry-pick" portions out of context on the grounds that Pastor Lindstedt

hadn't provided a list of exhibits *but neither did Bryan Reo*. The entire proceedings were spurious fraudulent kangaroo court proceedings which the Ohio 11th District Court of Appeals essentially rubber-stamped in affirming this tyranny on 14 Dec. 2020 and in Refusing to Reconsider on 25 January 2021.

Since then Bryan Reo has filed a fraudulent Civil Stalking Protective Orders on March 30, 2020 which was found to be fraudulent in June 4, 2021 by Mag. Judge Andre and Judge Lucci of Lake county even though Pastor Lindstedt could not afford to go up to Lake County Ohio 891.1 miles away. Bryan Reo has filed over 20 "lawfare" lawsuits against Pastor Lindstedt in Ohio, Missouri, and South Dakota to get at Pastor Lindstedt's South Dakota inheritance so much so that Pastor Lindstedt deeded it back to his sister in late October 2019. Whereupon Bryan Reo got another antifa lawyer named Robert Konrad who stole confidential legal files belonging to his sister Susan Bessman and commenced lawsuit in Stanley County South Dakota for a restraining order to prevent further transfer of the inheritance. However over the past two months Bryan Reo, Attorney Konrad and Susan Bessman's lawyer Kody Kyriss have been extorting Susan Bessman to disobey the Judge Bridget Mayer's injunction to forbid transfer in favor of schemes to transfer the property to sale to Bryan Reo favorites otherwise these Bryan Reo lawyers would go after Susan Bessman's inheritance. Therefore in order to get a lawyer for Susan Bessman her new lawyer is qorking on a quitclaim deed back to Pastor Lindstedt which is what Bryan Reo and Reo attorneys don't want.

Bryan Reo filed two more lawsuits for "defamation" and "invasion of privacy" which have been taken up to the federal district courts in Northern Ohio where Pastor Lindstedt is slowly losing because these corrupt federal judges allow Bryan Reo to not explain how Reo has been damaged by Pastor Lindstedt publishing the truth about Bryan Reo and friends and family.

Just like the federal lawsuit filed by Bryan Reo for \$10.75 million against Pastor Lindstedt which was removed to SouthWest Missouri and Pastor Lindstedt counter-claiming about 40 fellow Reo real and suspected federal and state agents provocateur (known as ZOGbots) the federal magistrate judge dismissed the federal lawsuit because Bryan Reo couldn't prove \$75,000 damages for diversity of citizenship. In all this lawfare Bryan Reo cannot and will not prove any damages, especially given that Pastor Lindstedt and Bryan Reo had a deal for four days after "SwordBrethren the Teutonic Crusader" was revealed as being longtime homosexual mongrel Bryan Reo the "Mamzer from Mentor Ohio" on 29 Oct. 2010. Bryan Reo agreed from Nov. 1-4, 2010 to leave the White Supremacist and Christian Identity Movement in return for no further mentioning of new material by Pastor Lindstedt and violated that agreement on 5 Nov. 2010 by reprinting on the "SwordBrethren Blog" on William Finck's (another Bryan Reo counterdefendant who pretends to be a Christian Identity pastor even though Finck murdered a Puerto-Rican sneak thief named Arnauldo Ortega in the Jersey City Jail, turned informant, and was jailed for a dozen years and infiltrated by Bryan Reo) Christogenea.org web page an Eli James article "Rabbi Lindstench – Race Traitor or Jew?" Then Reo proceeded to take down a dozen or so of Pastor Lindstedt's Aryan Nations Church's web pages, those of neutrals and allies, until getting into litigation in April 2014 when Reo found out that Pastor Lindstedt had an inheritance to steal under color of "lawfare."

In early 2016 Bryan Reo formed – along with Attorneys Kyle Bristow and Brett Klimkowsky a "white supremacist lawfare" organization calling itself the Foundation for the MarketPlace of Ideas (FMI). They brought in other ZOGbots such as Richard Spencer, Mike Enoch, Jason Edwards, Augustus Invictus, and old timers such as William Johnson and Thom Robb's lawyer son Jason Robb. They were responsible for litigation behind Charlottesville 1.0 in

August 2017 (which 2017 IRS 501(c)(3) Income Tax forms have been put before all Reo litigation. Thus all the Ohio state and federal courts and those of Missouri and South Dakota have had ample display that Bryan Reo was – and remains – a federal and state agent provocateur and inciter or fools for a number of ZOG false-flag operations including the latest Charlottesville 2.0 / Glorious Sixth of January 2021 which brought about the current coup.

Thus Bryan Reo and Reo friends and family and lawyers are simply ZOG agents provocateurs who are being benefited by the state and federal courts to destroy genuine White Supremacist and Christian Identity dissent by using this state-sponsored infiltration by Bryan Reo to go after the property of Pastor Lindstedt, (Pastor Lindstedt's sister Susan Bessman and Pastor Lindstedt's woman Roxie Fausnaught), and Pastor Lindstedt's and Pastor Lindstedt's ability to warn the Resistance about Bryan Reo and Reo associates (indeed in two of the latest Bryan Reo Ohio federal court cases Bryan Reo has asked for – and received – a "gag order" for which by allegedly violating these fraudulent and tyrannical ORDERS by federal judges Pastor Lindstedt faces huge fines and jailing for civil contempt) thus Pastor Lindstedt's and Lindstedt's Aryan Nations Church freedom and literal existence on this earth under the ZOG Satanic tyranny

Argument. Pastor Lindstedt has literally waited until the last day to file this Notice of [Jurisdictional] Appeal even though Pastor Lindstedt does not recognize that this Satanic criminal regime and its lawless courts have any jurisdiction over YHWH's Servant Nation of Aryan Christian Israel. These frivolous and fraudulent Bryan Reo state-sponsored lawfare terrorism has had the benefit of acknowledging that Pastor Lindstedt is the de facto First Servant of YHWH's Servant Nation of Aryan Christian Israel and that the Church of Jesus Christ

Christian / Aryan Nations of Missouri / ZOGland is the legitimate above-ground Dual-Seedline Christian Identity Church.

Rather this ZOG-sponsored domestic "lawfare" tyranny-terrorism against not only its subject population spilling over to YHWH's Elect and thus its criminal regime being destroyed along with much of its whigger and jew population is nothing new. Around 2000 B.C. in the time of Abraham the non-Canaanite Cities of the Plain around what became the Dead Sea were the Five Fertile Cities of the Plain on the south of what became the Dead Sea was a depression into which fresh water flowed, so much so that Lot, Abraham's nephew chose to take his flocks there while Abraham moved to the Oaks of Mamre around Hebron. Lot soon enough sold his flocks and moved into the town of Sodom, the Cleveland of its day. They annoyed Gilgamesh/Nimrod who conquered them and carried them away as slaves but Abraham got 350 trained men of his household and freed the Sodomites & others, taking nothing for his efforts. Yet Sodom being rich wanted more. They passed laws to rob and murder travelers so the travelers refused to go any more to Sodom and the other cities like Mentor / Gomorrah. So the Sodomites took to going to the caravan route a half-days journey off carrying trade from China and India from the Red Sea port to Mesopotamia, robbing and murdering these travelers under color of law. Elieazar, Abraham's Servant was sent by Sarah to check up on Lot and was taken prisoner when defending other travelers and hit by a rock by the Sodomite Bryan Reo equivalent of the day. When the crooked head judge – the Patrick Condon of its time – after a crooked trial in which Elieazar was fined for being hit with a rock by the Sodomite Reo lawyer with having to pay a ruinous fine. So Eliezar asked if that was indeed the law and when told that their law based upon robbery and kidnapping and false dominion absent any legitimate jurisdiction picked up a rock and hit the crooked judge in the head and told the judge to collect the fine from the Sodomite

Reo-lawyer and escaped. Lot's righteous daughter Palthiel was burnt alive for feeding a kidnapped prisoner, a young woman of another town which was the moral equivalent of Painesville was slathered in honey and stung to death. So YHWH decided to send Jesus Christ and the ArchAngel Michael to destroy Sodom and Mentor-Gomorrah and Painesville-Adanah. But Abraham bargained with YHWH to where if only ten righteous men of Adamic descent would do something – like exterminate the Canaanites, mongrels, crooked Reo-lawyers, thieving piglice and regime criminals – then Sodom/Cleveland would be spared and Lake Erie would not become the Dead Sea. In early January 2016 while Bryan Reo was suing Pastor Lindstedt and Lindstedt's Aryan Nations Church Pastor Lindstedt came across an article in which Bryan Reo was fired from the North Perry Nuclear Power Plant after a series of nuclear accidents at that ailing old plant which was supposed to be decommissioned. Bryan Reo had disabled its Talkshoe podcast in order to get into the plant. But Pastor Lindstedt's Aryan Nations Church web page had sufficient material and coupled with Stormfront material in which Reo discussed being a federal informant and wanting to "whack & stack" FBI and Lake County piglice the plant operators fired Reo as an "internal security risk" and later Hirum Reppert who operated the Lakeland Community College

nuclear technician kicked Reo from their program upon which Bryan Reo sued Reppert and this matter is on Pastor Lindstedt's Church web page which these crooked courts both state and federal want to censor. When Pastor Lindstedt found this out his first impression was that it was a pity the Bryan Reo was fired before the crazed delusional psychotic homosexual mongrel ZOGbot could chernobylize the North Perry Nuclear Power Plant itself. Pastor Lindstedt made japes on his Internet ministry. "I have both good news and bad news. First the good news: I may have inadvertently saved six million whiggers by getting Bryan Reo fired from the North Perry Nuclear Power Plant. The bad news is that these sorry sacks of shit live around Cleveland and they ain't dead yet thanks to me." Pastor Lindstedt is resolved to make good on his mistake by making sure Sodom/Cleveland is chernobylized and the irradiated area becomes a reservation for whatever "good jews" and "good niggers" the Ten-Thousand Warlords want to let live.

Therefore, since June or July of 2016 since the Reo v. Aryan Nations 16CV000825 lawsuit was transferred from the Mentor Municipal Court because the negro municipal judge and city officials didn't want annoyed White Supremacists / Aryan Nations types targeting their city for domestic terrorism and the Lake County Court of Common Pleas usurped jurisdiction and Judge Collins ruled upon Bryan Reo motion that Pastor Lindstedt could not defend His Aryan Nations Church because the lawyers usurped a patent of nobility in which only they can profit from their positions as officers of their Satanic secular courts Pastor Lindstedt has urged 'the Movement' as a whole to target the North Perry Nuclear Power Plant for destruction so as to destroy any ability for gliberal areas of the Empire to bother rural conservative areas of the country or those outside their jurisdiction. NE Ohio was an enemy combatant against Missouri in the First Civil War and is now a proper enemy target in this Second Civil War. When the NE Ohio population is reduced through irradiation, starvation, disease and civil unrest to one-tenth

or less of its current population and the ruling elites have been hunted down and exterminated they will have no interest in allowing homosexual mongrel ZOGbots to harass under color of law Pastor Lindstedt and His Aryan Nations Church. Thus regardless of what this Ohio Supreme Court decides, White Supremacist and Aryan Nations policy should be to make it impossible for any portion of the Mighty Evil Empire dominated by jews and non-whites to project its will upon areas of the country full of rural whites given that Cleveland will inevitably become the Second Civil War's Hiroshima. If the State of Ohio persists then the second nuclear power plant around Columbus shall become the Second Civil War's Nagasaki. Civil wars are like that. Once "rule of law" is replaced by "rule of lawyer" then everything dire becomes what's for lunch on the table.

Likewise with the State of South Dakota in which Bryan Reo, Attorneys Robert Konrad and Kody Kyriss have working with the South Dakota judges decided to make claim upon Pastor Lindstedt's inheritance based upon Reo's lawfare and have decided to target Pastor Lindstedt's sister for destruction. Why these regime criminals working as ZOGbots think that the Movement won't destroy their families when they reveal themselves as traitors – that their families will not suffer their fate – is because the [bowel] Movement has never ever targeted the families of traitors and infiltraitors once discovered – which is why it is so unsuccessful and has failed. A real White Supremacist underground should in all circumstances exterminate several million ZOGling whigger herd animals and then leave it up to the survivors to vent their wrath upon them and the lawyers, judges, politicians and police which unleashed these ZOGbots. This is why Pastor Lindstedt has expressly mandated that no harm by his White Supremacist underground followers shall be done to Bryan Reo and Reo's family because Bryan Reo is to be preserved for working the controls of the North Perry Nuclear Power Plant as the first Hiroshima and if the State of Ohio persists the Columbus nuclear power plant as well. However, Pastor

Lindstedt makes no such protection orders for Bryan Reo's lawyers and their families who are "fair game" just like any non-white or jew or regime criminal along with their families.

The fate of South Dakota is to have its federal impoundments on the Missouri River destroyed until it eliminates its system of government allowing lawyers to run wild under a common-law judicial thievery system as opposed to YHWH's civil law system.

Under YHWH's common law Pastor Lindstedt and Lindstedt's Aryan Nations Church has received a \$400 billion default judgment in which only officers of their ecclesiastical court can appear against the State of Ohio, The Judgment of Cleveland/Sodom is to be applied in that their nuclear power plant is to be used as a stationary nuclear weapon to win the Second Civil War, that the native non-whites and jews are to be eliminated or if the better sort put on the NE Reserve reservation, and those in power who created this mess are to be judicially murdered and their children – if salvageable – to be turned into eunuchs and walking wombs per Biblical Castration as happened to Daniel. The federal government is to be broken up into local military dictatorships in which only whites can live or not be enslaved.

Conclusion. Wherefore, what Pastor Lindstedt wants for this Ohio Supreme Court to do is to make a determination as to whether Northeast Ohio deserves what is going to happen to it. A crazed delusional psychotic homosexual mongrel which lost in federal court was allowed well past the Ohio Statutes of Limitation to work with a corrupt judge to empanel a Lake County lynch mob jury with an African female and seven gliberal whiggers in which Pastor Lindstedt was not allowed to represent His Aryan Nations Church or woman or under sundry excuses regarding procedure was not allowed to present his evidence or to effectively counter-sue Bryan Reo and Reo fellow agent provocateurs. In short Bryan Reo was allowed to drag the public spokesman for the White Supremacist and Christian Identity underground religious and racial

Resistance to fraudulent court proceedings absent any legitimate jurisdiction simply because on Pastor Lindstedt's Aryan Nations Christian Nationalist Forum and other Internet public places Bryan Reo and other ZOGbots pretending to be White Supremacists were called out for their antics as ZOG police informants and provocateurs. In short, just the same old Satanic tyranny under color of Satanic "law" aimed at destroying YHWH's Servant Nation of Aryan Christian Israel which follows the exact same pattern as in the day of Adam in 4000 BC and Abraham in 2000 BC. The response of Pastor Lindstedt and Lindstedt's Aryan Nations Church as Defendants in this case before this Ohio Supreme Court is not to whine about how this Satanic regime isn't obeying its precious First Amendment to its Ohio and Federal CONstitutions of the Bill of Goods, but rather as with the Thirty Years War to fight a racial and religious Second Civil Holy War in which the foundations of this Mighty Evil Empire of ZOG/Babylon is destroyed and a surviving 10-20 million ex-whigger population able to care for itself is ruled over by local theocratic military dictatorships no bigger than a county or less. What Pastor Lindstedt calls the Ten Thousand Warlords which are inevitable, certainly when nuclear fallout carries downwind from Ohio to the Northeastern ZOGland. The point isn't that Pastor Lindstedt has any duty to whine about the Mighty Evil Empire doing away with the First Amendment but rather that Pastor Lindstedt and his Aryan Nations Church has an affirmative duty to extirpate the Mighty Evil Empire when they furnish the provocation and excuse by going against YHWH's Servant Nation and Church-State.

Therefore, Pastor Lindstedt and The Church of Jesus Christ Christian / Aryan Nations of Missouri files this Memorandum for a Jurisdictional Appeal to this Ohio Supreme Court asking that they overturn their crazed psychotic homosexual mongrel agent provocateur Bryan Reo's entire lawsuit(s) against Pastor Lindstedt, Lindstedt's Church, and Lindstedt's woman (now dead

since Aug. 2020) and the Ohio 11th District Court of Appeals decision of Dec. 14, 2020 and Refusal to Reconsider of 25 January 2021 be over-ruled, that Bryan Reo and Bryan Reo attorneys Kyle Bristow and Brett Klimkowsky be disbarred and pay up for abuse of legal process, and that Judge Patrick Condon and the Appeals Court judges be removed from office for getting NE Ohio turned into an irradiated wasteland, and that Ohio courts stop harassing white people and churches well outside their jurisdiction at the whim of a homo mongrel ZOGbot.

Since Pastor Lindstedt and Lindstedt's Aryan Nations Church will cover this matter more thoroughly in a Merits Brief upon this Ohio Supreme Court deciding that it doesn't want to deserve its fate and those over whom it rules and because Pastor Lindstedt wants to get this filed electronically today, the 45th day after 25 January 2021, Pastor Lindstedt will bring this matter to a close. The Ohio appeals court decisions are attached as is a Notice of [Judicial] Appeal and a Verified Affidavit of Indigency given that Pastor Lindstedt is without income since Roxie Fausnaught died in Aug. 2020 and Pastor Lindstedt was her caretaker.
