<u>DEFENDANTS' OBJECTIONS TO MAGISTRATE JUDGE HENDERSON'S REPORT</u> <u>& RECOMMENDATION (Doc. 37)</u>

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt along with His Church of Jesus Christ Christian / Aryan Nations of Missouri hereafter "Pastor Lindstedt's Aryan Nations Church" OR "The Church") to make Objections to Magistrate Judge Carmen Henderson's Report and Recommendation (Doc 37) filed on March 3d 2021, mailed March 4th and received in Pastor Lindstedt's mailbox at the foot of the hill in Granby March 8, 2021. Pastor Lindstedt shall electronically e-mail these Objections on the 17th of March and ask via telephone on 18th March before he mails off a paper copy if necessary. Bryan Reo shall receive notification of Pastor Lindstedt's Objections so that he can write a Reo Reply on 18th March.

This is the most ridiculous of all the 20+ Bryan Reo delusional homosexual mongrel agent provocateur / ZOGbot lawsuits in the Ohio, Missouri and South Dakota state and federal courts. Bryan Reo is suing Pastor Lindstedt for making the assumption that the mongrel sitting next to Bryan Reo in the Lake County Courthouse while Reo's Brazilian jewess wife jumped up and down for attention of the two mongrels was one of Bryan Reo's homosexual friends because

Pastor Lindstedt was suing Bryan Reo's father and overheard the first day of trial on 24 June 2019 Bryan Reo telling its father to not show up because "Lindstedt is the most vile white supremacist" ever. Pastor Lindstedt didn't know that what he assumed was just another homosexual mongrel was Bryan Reo's father - who Pastor Lindstedt never referred to by name but rather as [Ol' Niggerlips' Fake-Plaintiff's Son the Lawyer] Alleged Spawner. In fact pretty much all of Pastor Lindstedt's responses have covered that this is a frivolous and malicious lawfare case using Bryan Reo's father who is seldom, if ever, mentioned by name.

This Ohio federal court and the Ohio State courts in Lake County and at the Ohio 11th District Court of Appeals are in fact using their usurped powers as part of a Satanic Mighty Evil Empire to destroy "white supremacists" imaginary or real in the case of Pastor Lindstedt and Lindstedt's Aryan Nations Church through Bryan Reo FMI legal state-sponsored "lawfare" anti-demoestic terrorism. The problem is that since this regime court is engaged in lawfare terrorism then they shall surely find "White Supremacist Aryan Nations" style defensive counter-terrorism.

Pastor Lindstedt as spokesman and chief political and religious figure for the White Supremacist and Dual-Seedline Christian Identity (DSCI) Church has had to become a target of this Satanic criminal regime of ZOG/Babylon/Beast Mighty Evil Empire that wants to "mix the seed of man" (Daniel 2:44) and thus Bryan Reo and Bryan Reo's Foundation for the Marketplace of Ideas (henceforth FMI) comprised of lawyers in the new [Alt-Right] (and old White Nationalism 1.0 & 2.0) racially mixed "Movement" to coonduct "lawfare" – legalized racial and religious civil warfare by officers of the regime courts before those regime courts without any legitimate or lawful jurisdiction – for the better part of a decade. Under YHWH's Law and Precident these "lawfare" actions are exactly the same thing as what Sodom and Gomorrah and the other three Cities of the Plain did in going out to rob, kidnap and judicially murder travelers on the caravan route between the Red Sea port and Mesopotamia / Babylon. Thus as Pastor Lindstedt has already pointed out in his Memorandum Brief to the Ohio Supreme Court asking for a Jurisdictional Appeal (Exhibit #1) that since Northeast Ohio wants to act like Sodom and Gomorrah and rob, rape and murder those outside their proper jurisdiction that they be treated like Sodom and Gomorrah and that the North Perry Nuclear Power Plant be chernobyled by Bryan Reo as the Hiroshima to end this Second Civil War. Those antifa lawyers Kyle Bristow, Brett Klimkowsky, and Robert Konrad of South Dakota know what every revolutionary Movement does to regime criminals and their families. Indeed, by dragging in Pastor Lindstedt's sister to extort and terrorize her under color of the Ohio and South Dakota courts with not only taking Pastor Lindstedt's inheritance that he deeded back to her but all of her property as well they have legitimized going after their friends and families. In fact, Bryan Reo complains in the other federal cases that he can't find a head shrinker expert witness to claim that Bryan Reo is all screwed up in the head because he violated the four-day deal of Nov.

1-4, 2010 to leave the Movement forever and Pastor Lindstedt wouldn't talk about Reo no more if Reo left and didn't cum back. Bryan Reo is not nutty but rather at Satanic homosexual mongrel ZOGbot abomination since conception thus the perfect pure evil golem of which there is no like.

This magistrate judge's Talmudic rationalizations & monkey-talk regarding how Pastor Lindstedt's denials of Bryan Reo's claims using Bryan Reo's father as a fake-plaintiff but overt admissions and how they are not good enough under the Court interpretations of their self-serving rules of Civil procedure leads to outright injustice. Bryan Reo lied to this court about how Pastor Lindstedt claimed "homosexual incest" where in other cases Bryan Reo admitted that Pastor Lindstedt's Aryan Nations Church said no such thing. Only Bryan Reo has made the perjurous claim. This court has thus collaborated with Bryan Reo to simply allow this fraudulent case to continue even though there is no cause for it to proceed whatsoever as there are no real damages.

Thus Pastor Lindstedt objects to the findings of this Court altogether in Doc. 37.

Rather, this Court should summarily rule against the Fake-Plaintiff Bryan Reo's father, fine him everything that his spawn Bryan Reo seeks against Pastor Lindstedt (which Pastor Lindstedt probably won't bother to collect until it comes time to chernobylize the North Perry Nuclear Power Plant and the Columbus nuclear power plant if the State of Ohio insists on doubling down) and to summarily find Bryan Reo in contempt of this federal district court for bringing it into disrepute as an organ of this Mighty Evil Empire without any legitimate jurisdiction over Pastor Lindstedt and his Aryan Nations Church.
