**DEFENDANTS APOLOGY FOR WHAT WAS SAID TO JUDGE JOHN R. ADAMS IN  
HIS MOTION SHOWING CAUSE FOR HIS CONTEMPT FOR JUDGE ADAMS AND  
HIS CORRUPT FEDERAL COURT WITHOUT ANY LAWFUL JURISDICTION  
WHATSOEVER – PASTOR LINDSTEDT HAS NO REASON TO THINK JUDGE  
ADAMS IS A HOMOSEXUAL AS OPPOSED TO STUPID ARROGANT & CORRUPT**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as “Pastor Lindstedt along with His Church of Jesus Christ Christian / Aryan Nations of Missouri hereafter “Pastor Lindstedt’s Aryan Nations Church” OR “The Church”) to make an apology for his (Doc. 46) Federal Rule of Civil Procedure (FRCivP) Rule 59(e) and Rule 60 Motion to Alter, Amend, or Reconsider his ORDER (Doc. 43) setting a judgment of \$250,000 in compensatory damages and \$250,000 in punitive damages contrary to the recommendations of the Magistrate Judge to at least allow a jury trial to decide Bryan Reo’s father, the Fake-Plaintiff’s damages arising from Pastor Lindstedt mistaking him for one of Bryan Reo’s mongrel homosexual friends at the 2d day of a Lake County Ohio jury trial on 25 June 2019 after overhearing Bryan Reo telling his father to not attend the trial. On the attached Motion to Show Cause Why Pastor Lindstedt has Contempt for both John Adams as a foolish, mentally unbalanced idiotic and the worst judge of the entire Northern District of Ohio as well as the

entire corrupt federal court that needs to be overthrown & destroyed along with its federal & state regimes and altogether without jurisdiction or dominion over an Aryan Nations pastor fighting with long-time (See **Exhibit 1**) crazed delusional homosexual mongrel state-sponsored domestic counter-terrorist agent provocateur (known as a ZOGbot) Bryan Reo. These corrupt federal courts that Pastor Lindstedt was stupid enough to transfer up from the corrupt Lake County Ohio courts have done away with the First Amendment paper ‘guarantees’ of Freedom of Speech, of the press, and of religion – i.e. freedom to remove Bryan Reo from our white supremacist and Dual-Seedline Christian Identity racial religion – and now of the 7<sup>th</sup> Amendment to jury trial – which is the entire basis of its legal system – and the 8<sup>th</sup> Amendment of no excessive fines or penalties for the mere fact that Pastor Lindstedt mistook Bryan Reo’s father for one of his homosexual lovers when observing Bryan Reo’s wife jumping up and down on 25 June 2019 at the Lake County courthouse trying to get the two mongrel’s attention. Pastor Lindstedt had been informed that Bryan Reo’s father would not attend the day before by overhearing Bryan Reo and in any case never referred to Bryan Reo’s father by name. This corrupt court even provided a gag order in which Bryan Reo says that Pastor Lindstedt must remove “any statements that Plaintiff [Bryan Reo’s father] had incestuous sexual relations with his own son or an illicit extramarital affair with his daughter-in-law.” (Doc 44 Judgment Entry by Bryan Reo). This corrupt court awarded Bryan Reo’s father \$250,000 in compensatory damages and \$250,000 in punitive damages violating the 7<sup>th</sup> Amendment right to a jury trial and 8<sup>th</sup> Amendment right to no excessive fines over something that never was published on Pastor Lindstedt’s Aryan Nations web page in the first place. Indeed in Doc. 22-1 of 18 pages Pastor Lindstedt did present to this Court on Sept. 24, 2020 everything written about Bryan Reo and Mrs. Reo and Bryan Reo’s father which Bryan Reo is suing over and nowhere is “homosexual

incest” regarding Bryan Reo and Reo’s father or “transgendered prostitution” regarding Mrs. Reo or either of the Reo mongrels having sex with Mrs. Reo. Rather Pastor Lindstedt republished Bryan Reo public Quora posts – some of which Bryan Reo withdrew thus spoliation of evidence. Upon being told that Bryan Reo had filed a lawsuit and that what I thought was just another Bryan Reo homosexual mongrel lover turned out to be Bryan Reo’s father and so the entire thread was closed. Bryan Reo in other cases such as an evidentiary hearing on 31 August 2020 in Stanley County South Dakota in which Reo and Reo’s antifa lawyer Robert Konrad admitted that Pastor Lindstedt never said or wrote anything about “homosexual incest” or “transgendered prostitute” in referring to Bryan Reo’s father – who was always referred to not by name but rather as “Ol’ Niggerlips’ Alleged Spawner” (and as “Mrs. Niggerlips” respectively).

This corrupt and tyrannical court without any lawful jurisdiction whatsoever with its idiotic ruling in turn encouraged the negro-jew Judge Solomon Oliver to impose a \$250,000 compensatory damages and \$750,000 in punitive damages against Pastor Lindstedt and set aside letting there be a jury trial to determine the damages because the smarter judge Boyko and then the idiotic maniac Judge John Adams likewise did away with the 7<sup>th</sup> and 8<sup>th</sup> Amendments. Commanded to Show Cause Why Pastor Lindstedt shouldn’t be held in Contempt of this federal court and this idiotic tyrannical judge Pastor Lindstedt confessed that *of course* he had nothing but contempt for this federal district court and for the Judge John R. Adams.

However Pastor Lindstedt let his temper get away from him by insinuating that Judge Adams was a homosexual and would like to lick Pastor Lindstedt’s asshole clean of dried up shit tangled in ass-hole hairs:

*So Pastor Lindstedt has been racking up the huge tyrannical fines as an unrepentant White Supremacist of the Aryan Nations persuasion while the Dying ZOG collapses living in penury with his dog for company spewing out massive quantities of haet and rebellion and filing these Rule 59(e) Motions because that is what Pastor Lindstedt does for most of his waking hours the past decade – dealing with Bryan Reo and the Rest of the ZOGbot shit. However, time for something extra special for the nuttiest and what some consider the worst judge of the pathetic lot of black-robed tyrants on the Northeast Ohio bench: John R. Adams.*

*When or if you throw Pastor Lindstedt in jail for civil coontempt of kort and are waiting until the end of ZOG or of Pastor Lindstedt to purge hissself of the non-civil Second Civil War Coontempt of kort then I'll offer a treat that ZOGbot White-Nationalist pretending faggots like Bryan Reo, Kyle Bristow and Richard Spencer would like to enjoy and my pure-blooded Jack Russell Mountain Feist Pastor Lindstedt's Gustavus Adolphus hound wants to do all the time when Pastor Lindstedt lets him and the toilet-paper is low because we both enjoy it too much: **Northern District of Ohio Federal Judge John R.
