**DEFENDANT’S REPORT OF REFUSED RULE 26(f) & L.R. 16.3(b) PLANNING
MEETING DELIBERATELY DENIED BY FAKE-PLAINTIFF’S LAWYER
HUSBAND BRYAN REO REFUSING TO ARRANGE SAID MEETING**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as “Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt’s Church) to make his Report for which will have to do because for Professional Plaintiff Bryan Reo’s refusal to hold a Rule 26(f) & Local Rule 16.3(b) planning meeting because like all of Bryan Reo’s barratry these cases removed from the corrupt Lake County Ohio courts for defamation to the federal level the Federal Rules of Civil Procedure do not allow Bryan Reo to operate in an *ex parte* manner. Indeed this federal Court admonished Bryan Reo for trying to get around holding a planning meeting by excusing the presence of Stefani Rossi Reo on 30 March 2020 and that while Bryan Reo can (and does)

get all manner of *ex parte* favors from its corrupt lawyers on the bench, that this federal “Court will not engage in any *ex parte* communication and will not respond to such requests made by e-mail”, cf. ORDER 30 March 2020. On 27 April 2020 Bryan Reo instead filed a “Unilaterally Filed” supposed Report of what is supposed to be a Rule 26(f) and L.R. 16.3(b) planning meeting to be held with all parties involved. Bryan Reo instead filed yet another stalking temporary protection order in Lake County allegedly based upon what Pastor Lindstedt wrote in court filings concerning yet another *ex parte* court proceedings held in Stanley County South Dakota in which Bryan Reo is trying to force Pastor Lindstedt to take back his inheritance given to his sister. Bryan Reo notified Pastor Lindstedt about the supposed stalking protection temporary restraining order via e-mail 67 minutes before the Lake County secret proceedings were to be held but Pastor Lindstedt doesn’t have broadband access and so didn’t get the e-mail message via cell phone hot spot until 5 or 6 hours after the secret proceedings were over. Since then Pastor Lindstedt has received a communication from the corrupt Lake County judges saying that there was a secret magistrates’ ruling against himself on 30 March 2020 regarding holding a temporary restraining order for something and another on 6 April 2020 but yet another hearing is to be held on 28 May 2020. Pastor Lindstedt will refuse to drive 891.1 miles from his front yard in Granby but might phone it in if allowed although Pastor Lindstedt routinely refuses to recognize the jurisdiction of the Lake County Court over himself or his Church. Much the same thing happened back in early 2016 when Bryan Reo impersonated Pastor Lindstedt on a homosexual NIM-Buster site and using them fraudulent postings sought out – and got – another stalking order for three years based upon the claim that the “Pastor Lindstedt” impersonations had threatened Reo with “castor-ration” and death. In Missouri domestic protection orders can’t cross county lines unless within 300 yards, much less state lines, and even the corrupt Judge

Patrick Condon admitted that his orders could not be enforced outside the boundaries of Ohio. However, Bryan Reo today, as then and always keeps on claiming all manner of stuff Pastor Lindstedt must do in responding to Reo which is doubtless a pack of lies so Pastor Lindstedt does the least minimum possible in responding to Bryan Reo except in posting onto the Church's Aryan Nations Christian_Nationalist forum for everyone who wants to do so can see.

The truth is that Pastor Lindstedt has always asked anyone who listens to himself in his capacity as a Prophet and Churchman of YHWH is not to harm or bother or have anything to do with Bryan Reo or Bryan Reo's family but rather to hold the delusional crazed homosexual Satanic mongrel abomination agent provocateur (ZOGbot) in cool coontempt. Bryan Reo is Satan's own ZOGbot and should not be harmed because if it is Pastor Lindstedt will be blamed and even more importantly be replaced with someone who actually is white and not as openly delusional evil. Pastor Lindstedt makes all sorts of observations. Some, like processing the dead bodies of Chronic Wasting Diseased deer and spreading it to Wisconsin in 2000 and Missouri in 2010 are heard. Some like spreading it to Ohio, not so much. Pastor Lindstedt can observe how easy it would be to spread this man-made Covid-19 ZOGvirus, but it is spreading about without any input from Pastor Lindstedt. Pastor Lindstedt is in reduced circumstances and must stay within four hours drive to take care of his bed-bound domestic partner Roxie Fausnaught. Pastor Lindstedt has neither the time, opportunity, or inclination to harm Bryan Reo but rather must take time and remaining money in dealing with Bryan Reo and Reo's counter-defendants litigation which is never-ending until the inevitable Collapse later on this year puts an end to it.

Pastor Lindstedt notices that Bryan Reo has claimed that Pastor Lindstedt has not "co-operated" with Bryan Reo in staging a Rule 36/Local Rule 16 Planning Report. This is a lie. Bryan Reo refused to even set one up. There are four current Bryan Reo v, Lindstedt lawsuits:

The only time Bryan Reo held an actual Planning Report meeting was on the first case, *Reo v. Lindstedt* 1:19-cv-02103. Reo was annoyed that Pastor Lindstedt recorded it on his end and posted it to the Church forum. So on the bogus *Anthony Domenic Reo v. Martin Lindstedt* 1:19-cv-02615 case, Bryan Reo did agree to holding a planning conference and then on sundry pretexts himself and Attorney Kyle Bristow, Reo's presumed Aryan homosexual lover and Executive Director of the Foundation for the MarketPlace of Ideas (FMI) / ZOGbot Poverty [F]Law Center (ZPLC) refused to hold said Planning Conference and lied about it. So Pastor Lindstedt submitted the following to the Magistrate in *Anthony Domenic Reo v. Martin Lindstedt* 1:19-cv-02615-JRA, Doc. 16, Report of Party's Planning Meeting with Exhibit 16-1 of pages #159-165 consisting of seven e-mails between Bryan Reo and Kyle Bristow and Pastor Lindstedt. Pastor Lindstedt hereby incorporates Doc. 16 plus Exhibit #1 of that case in this Motion as this case involving a fake Plaintiff in Bryan Reo's wife is as with Bryan Reo's father. From that motion (Doc. 16 plus Exhibit #1) *Anthony Reo v. Lindstedt* :19-cv-02615-JRA:

Back in the first of the Bryan Reo federal case transferred to Missouri Pastor Lindstedt sued Bryan Reo's father but Bryan Reo bragged about how Bryan Reo refused service on May 2015. Bryan Reo's sole means of support is through deceit of both the facts and law and Bryan Reo thus refuses to allow his supposed client speak for himself. It has been rumored that Bryan Reo's father wants to kick Bryan Reo and Bryan Reo's green-card Brazilian Sephardic jewess wife out of the house if Reo gets

Anthony Domenic Reo involved in counter-litigation from all of Reo's fraudulent litigation, of which there is plenty other than with Pastor Lindstedt and Lindstedt's Church.

So upon agreeing with Bryan Reo to engage in a Fed.R.Civ.Proc. Rule 26(f) and Local Rule 16.3(b) telephone conference, the e-mail exchange began in which Bryan Reo refused to hold any such mandated telephone conference because I gave Reo a pretext. Here are the e-mails originally printed on 2 March 2020 which Pastor Lindstedt decided to not send in so that this Court could act unjustly in believing Bryan Reo's lies and in so doing make for years and years of appeals – if the Corvid-19 virus and the financial, commercial, political collapse doesn't render ZOG/Babylon extinct.

Exhibit #1 – Agree to “Coonference” at 1:24pm 24 Feb 2020. Bryan Reo is an obvious effeminate homosexual mongrel of negroid, oriental, Indian (both Coonsino and Dothead) and jewish ancestry with the delusion that it is some sort of “Teutonic Crusader” or “SwordBrethren” pureblooded nazi German, although sometimes in moments of reality it admits that “Reo” is a South Italian or Sicilian name. Reo has been pretending to be a pure-blooded Aryan since before 2003 when it ran around with Richard Barrett, a homosexual lawyer and fellow agent provocateur, who eventually kicked out Bryan Reo because “Bryan Reo has to learn that it is not White.” Thus Pastor Lindstedt knows that the sure way to get Reo all hot and bothered is to imply that it is mainly of African and jew descent. Thus Pastor Lindstedt agreed to hold a “Coonference” which is what Aryan Christian Israelites like Pastor Lindstedt calls a meeting with African congoids – like Bryan Reo and Reo's father. In this e-mail Pastor Lindstedt included the names of Bryan Reo's Aryan-looking possible homosexual hump Attorney Kyle Bristow and Reo's former attorney Brett Klimkowsky, both of whom Pastor Lindstedt and Lindstedt's Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter Pastor Lindstedt's Aryan Nations Church) in one of four cases *Bryan Reo v. Lindstedt* 1:19-cv-02589-CAB. Brett Klimkowsky is hiding from Pastor Lindstedt although Klimkowsky did show up at Bryan Reo's insistence in July 2019 to present a bill for Bryan Reo's litigation in Lake County. So this e-mail was sent out to Reo and Reo lawyer parties.

Exhibit #2 -- Bryan Reo responds with an e-mail 11 minutes later at 1:35pm 24 Feb 2020 saying that no one else will be on the call – presumably Reo’s pretend client his father – and threatening that if Pastor Lindstedt doesn’t stop sending a copy of the e-mails to fellow lawyers Bristow and Klimkowsky of the Foundation for the MarketPlace of Ideas (FMI) / ZOGbot Poverty [F]Law Center (ZPLC) then Reo would refuse to hold the conference except before Judge Adams and making Pastor Lindstedt drive 850 miles or more to do so.)(See Exhibit #8 *Reo v. Lindstedt* 1:19-cv-02589-CAB, Doc 26-1, filed 03/19/20 p251-254, Stefani *Reo v. Lindstedt* 1:19-cv-02786-CAB filed 02/07/20 Doc #11-1, pages 103-106). While Bryan Reo as the initiator of the conference call would *of course* have complete discretion as to whether it would allow Reo counter-defendant parties not yet served on this call, still Reo was planning to prevent any such call whatsoever from occurring and then telling Judge John Adams, a notorious hothead on the bench whatever lies were necessary to force Pastor Lindstedt to have to waste time and money appearing directly before this Court. However, the Corvid-19/BoomerRemover biowar virus panicdemic later came about to where this Court by general order is pretty much shut down to even this dog of a case. But Bryan Reo is relentless, and has worked on making this frivolous and malicious case to where it is expensive and onerous as possible upon Pastor Lindstedt and Lindstedt’s Church. (See Exhibit #9, “Pray for My Suckceess” on William Finck’s Christogenea Forum 24 Aug. 2015, *Reo v. Lindstedt* 1:19-cv-02589-CAB, Doc 26-2, filed 03/19/20 p255-257, Stefani *Reo v. Lindstedt* 1:19-cv-02786-CAB filed 02/07/20 Doc #11-1, pages 107-109). Bryan Reo as a crazed delusional homosexual mongrel has been working with federal and state agencies to infiltrate all manner of jews, homosexuals, mongrels, perverts into both the underground White Supremacy and Christian Identity Movements and out of spite has decided to go after Pastor Lindstedt’s South Dakota inheritance and render Lindstedt “desolate and penniless” in order to personally profit from this by claiming to have been “defamed” by Pastor Lindstedt’s writing and publishing this on Pastor Lindstedt’s Aryan Nations Church website and forums. This frivolous case involves using Bryan Reo’s father, whom Bryan Reo doesn’t want to expose to questioning or to inquiry as to how Reo’s father suffered \$500,000 in damages because Pastor Lindstedt

mistook him for one of Bryan Reo's homosexual friends after Pastor Lindstedt has overheard that Reo's father wouldn't be appearing at Reo's Lake County trial against Lindstedt and Lindstedt's Church.

Exhibit #3 – An hour and a half later at 3:01 pm 24 Feb 2020 Bryan Reo apparently loses its objections to e-mailing Bryan Reo Counter-Defendants Kyle Bristow and Brett Klimkowsky of the FMI/ZPLC (or perhaps the only objections are to Pastor Lindstedt e-mailing Bryan Reo co-conspirators Bristow and Klimkowsky of the FMI/ZPLC as doubtless Bryan Reo is always in close contact with these Reo barraters). Bryan Reo as a delusional homosexual mongrel would go on for hours and days on end yapping about how Adolf Hitler was the ArchAngel Michael with William "Baal" Finck and get all huffy when Eli James / Joseph November wanted to spare those of less than 20% jew blood while at the same time taking down a dozen of Pastor Lindstedt's Church's web pages for "racism." Today is no different in that Bryan Reo would still go online yapping about racial extermination and ZOG tyranny while at the same time whining that Pastor Lindstedt called the mandated Rule 26 / Local Rule 16 pre-trial conference a "coonference" because it involved Pastor Lindstedt of the Aryan Nations having to talk to such pretend "White Supremacists" as Bryan Reo and Bryan Reo's father. Neither Bryan Reo nor Bryan Reo's father had any intention of having a substantive discussion of the lawsuit that they initiated litigation upon the merits, as there are no merits. It is merely a "lawfare" money grab and Bryan Reo's father is the weak link

Exhibit #4 – After waiting with my video camera set up for Bryan Reo to call in as promised at 4:30pm CST / 5:30pm EST Pastor Lindstedt sends out an e-mail started at 4:45 and sent out at 5:05pm noting that "I'm two Coons shy a Coonference." Allusions are made that Bryan Reo was always antifa, to the StormFront posting of Dec. 2007 in which Bryan Reo threatened to kill FBI and Lake County Sheriff's Deputies because Bryan Reo ostensibly refused to work as a FBI informant, that Bryan Reo's father needs to pull the plug on this lawsuit and red-flag its delusional psychotic homosexual mongrel son, and send Kyle Bristow and Brett Klimkowsky back to defending negro gang-bangers as public pretenders rather than as FMI/ZPLC ZOGbot shysters. Then since it is past 6:00 pm Cleveland Mamzer Time to call in and let's do this.

However, in all the interactions in which Bryan Reo has called myself in every single case Bryan Reo makes threats, gloats how it is not going to accept service for its father, drafts up lack of jurisdiction for William Finck and its Craigslist-girlfriend while not a lawyer, rambles on as to how it thinks depositions should go while arguing with the magistrate judge, demands Pastor Lindstedt's Church Web pages be "gag ordered" or "permanently enjoined from publication, self-servingly tells how it interprets the Federal or Ohio Rules of Civil Procedure or how it will file countless frivolous Motions to Strike, for Summary Judgment, for not letting Pastor Lindstedt testify or for waging open religious and racial civil warfare against Pastor Lindstedt's Aryan Nations Church by refusal to let it defend itself before a Bryan Reo friendly ZOG/Babylon kangaroo kort. Pastor Lindstedt refuses to contact Bryan Reo if at all possible and if given no other choice will send an e-mail to Bryan Reo with the minimum necessary filings. Pastor Lindstedt has never initiated contact by telephone with Bryan Reo. On Pastor Lindstedt's Church's web pages Pastor Lindstedt counsels everyone to not harm or threaten Bryan Reo but rather to have absolutely nothing to do with Bryan Reo or anyone who will have anything to do with Bryan Reo.

Exhibit #5 – 11 minutes later at 5:14 pm CST Bryan Reo admits that it isn't going to do any conference call outside Judge's Chambers. Nor will Bryan Reo consent to my recording on my end (as if Bryan Reo has any control over me recording the exchange) the call like what happened in Reo v. Lindstedt 19:-cv-2103 which was recorded and put on the Church Christian-Nationalist forum at:

In this recording Bryan Reo makes a number of threats while Pastor Lindstedt pretty much ignores Bryan Reo's nonsense and carries through with the meeting agenda as defined by Judge Oliver's local rules for this meeting. Bryan Reo thus refuses to actually meet in a telephone conference according to the Rule 26 (f) and Local Rule 16(b) because he cannot control Pastor

Lindstedt's responses or Pastor Lindstedt making and displaying a video copy and Reo refuses to allow the actual pseudo-plaintiff Anthony Domenic Reo speak for himself. Also note that Bryan Reo e-mails his lawyer co-conspirators Kyle Bristow and Brett Klimkowsky gloating as to how there isn't going to be any real telephone meeting.

Exhibit #6 – A half hour later – 5:45pm 24 Feb. 2020 – Bryan Reo's fellow FMI/ZPLC buddy Kyle Bristow gloats about how Bryan Reo will prevail in their fight vs Pastor Lindstedt & Church. Also contacted is Attorney Brett Klimkowsky who is a Reo counter-defendant and FMI/ZPLC board member. The point being is that both Bryan Reo and Kyle Bristow, being agents provocateur tasked with promoting the Charlottesville Massacre in order to destroy the largely fake Alt-Right, are working together to also harass Pastor Lindstedt and Lindstedt's Church through "lawfare" and are so confident in their regimeist support that they don't bother much to hide their conspiracy to do so anymore.

On March 1, 2020, Bryan Reo, probably with the aid of Reo attorney co-conspirators of the FMI/ZPLC Kyle Bristow and Brett Klimkowsky files a lying report (Doc 13) as to how the Plaintiff-mandated Report of the Planning Meeting couldn't be held due to Pastor Lindstedt's "bizarre and threatening conduct in the e-mail exchanges. Bryan Reo of course did not provide any of these e-mail exchanges proving that Reo had no intention of carrying out this conference because Reo didn't want Reo's father to crack on the litigation carried out in his name and because Reo couldn't control Lindstedt recording the telephone meeting and posting it on Lindstedt's Church's forum. Reo also whines about Lindstedt sending e-mails to lawyers Bristow and Klimkowsky while also e-mailing on his own both Bristow and Klimkowsky. So according to Bryan Reo's notions Reo can do exactly whatever he pleases while claiming that the same actions openly presented without deceit by Lindstedt are somehow unlawful. Bryan Reo therefore lied to Judge Adams and with the benefit of this deceit on 5 March 2020 Judge Adams lost his temper with Pastor Lindstedt and threatened to force Pastor Lindstedt to conduct the initial planning meeting that Bryan Reo deliberately refused to hold in Youngstown, Ohio 900 miles away.

Luckily for Pastor Lindstedt Ohio has been hard hit by the ZOG-made Certificate of Vaccination I.D. 2019 (Corvid-19) virus and perhaps Judge Adams listened to the March 5, 2019 recording made on his end and figured out Bryan Reo had manipulated him into acting intemperately that afternoon.

Exhibit #7 – an e-mail sent to Pastor Lindstedt and Reo co-conspirator Kyle Bristow on 7 April 2020 in response to yet another two Bryan Reo cases, *Bryan Reo v. Lindstedt* 19-cv-02589 and *Stefani Reo v. Lindstedt*, 19-cv-02786 shows that Bryan Reo has all sorts of unlawful stipulations regarding discovery, especially in questioning Reo’s father and wife who have filed these frivolous actions by Pastor Lindstedt. (Not that Lindstedt has any money or intentions of deposing Reo’s wife or father as Lindstedt has never spoken to either one of them and accidentally mistook Reo’s father for one of Bryan Reo’s homosexual lovers when he saw Mrs. Reo jumping up and down like an idiot in the Lake County courthouse on 25 June 2019.) Bryan Reo is also threatening to get another “gag order” against Pastor Lindstedt and Lindstedt’s Church for telling the truth about Bryan Reo. All this goes to show that the sole purpose of Bryan Reo litigation is mere “lawfare” against Pastor Martin Lindstedt and Lindstedt’s Church of Jesus Christ Christian / Aryan Nations of Missouri church.

Pastor Lindstedt thinks this case should be on the standard track, consents to a Magistrate Parker hearing this frivolous case of Bryan Reo’s father to trial, insists that Bryan Reo complete Rule 26 Initial Disclosures, especially how Reo thinks his wife is due \$500,000 for Pastor Lindstedt republishing a Bryan Reo public Quora post bemoaning the fact that Bryan Reo’s wife didn’t want to squeeze out any more homosexual Satanic mongrel abominations but wanted to earn (and keep) her marriage and jumped up and down in the Lake County Courthouse while Bryan Reo and Reo co-conspirators insist on calling Pastor Lindstedt a child molester, through the discovery plan finding out Bryan Reo’s & co-conspirators’ activities in promoting this Bryan Reo fraudulent and frivolous litigation, finishing off the Rule 26 initial discoveries by June 30th, Discovery ending by Nov. 2020, dispositive motions ending by end of Dec.

2020, cut-off date for Amending Pleadings and adding Additional Parties a month after discovery ends of January, 2021, and a trial Status Hearing of end of March, 2021.
