**In forma pauperis Affidavit Item #9 for Bryan Anthony Reo v. Martin Lindstedt for an Appeal to the 6<sup>th</sup> Circuit Court of Appeals of Judge Christopher Boyko's Judgments Doc. 58 against Pastor Lindstedt's Rule 59(e) Motion to Reconsider dated 15 Dec. 2021 in Stefani Reo v. Martin Lindstedt #19-cv-2786.**

**Item #9 asks** "Do you expect any major changes to monthly income or expenses or in your assets or liabilities during the next 12 months?"

Bryan Reo is a homosexual mongrel who has been an agent provocateur for the Ohio and federal regimes since 2002 or 2007 under a set of Internet aliases until Pastor Lindstedt detected his real name and address on 29 Oct. 2010.

Whereupon Bryan Reo offered to leave the Movement in return for not generating more postings on the Aryan nations web page from 1-4 Nov. 2010 and then promptly broke that arrangement by taking down a dozen or so of Pastor

Lindstedt's Aryan Nations web pages. For 3 ½ years Bryan Reo didn't engage in litigation because Bryan Reo thought Pastor Lindstedt lived off of Roxie

Fausnaught's VA Check. In late 2013 antifa lawyer Robert Konrad stole Pastor Lindstedt's sister's Susan Bessman's legal files while working at the Ollinger Law Firm of Pierre SD and finding out about Pastor Lindstedt's inheritance of 1700+ acres in Stanley County decided to with lawyers Kyle Bristow and Brett

Klimkowsky to engage in lawfare in Northeastern Ohio to "render Pastor Lindstedt and his Aryan Nations Church penniless and destitute."

For the past 15 years Pastor Lindstedt has plowed the rent from his South



Dakota inheritance into his Church and the Movement unlike what the Order did with their \$3 million armored car heist as it is better to invest in frugal White People given the breakdown of ZOG, literally casting your bread upon the water in hope that some will return to you from the best of Whites and living off of Roxie Fausnaught's \$1200 VA check – which dried up with her death on 4 August 2020. She left Pastor Lindstedt \$5000 in her checking account and another \$1000 in CDs. This money is nearly gone. Meanwhile the Bryan Reo litigation against Pastor Lindstedt and his Church never ends. At the same time Pastor Lindstedt has been taxed with litigation domesticated in South Dakota to where Lawyer Robert Konrad has gotten a judgment of \$18,600 against Pastor Lindstedt and \$56,000 against Susan Bessman, his sister for Pastor Lindstedt deeding back his South Dakota inheritance to her in Oct. 2019, four months before Bryan Reo and Attorney Konrad filed litigation in Stanley County to render moot this transfer in Feb 2020.

Pastor Lindstedt has advocated ending this “civil lawfare” against White Supremacists and Christian Identity above-ground activists by chernobyling the North Perry Nuclear Power Plant and rendering Cleveland into an irradiated wasteland and future military reservation and concentration camp for jews, muds, and racially treasonous whiggers since 13 June 2016 and “flushing the toilet” of the state capitol of Pierre and county seat of Ft. Pierre South Dakota by destroying the Oahe reservoir as ZOG collapses in this Second Civil War in order to create a

continent with less than 30 million ex-ZOGLings ruled by local theocratic Christian Identity military dictatorships which will result in that acme of White civilization – 1910 Missouri. Pastor Lindstedt calls this Armageddon Plan the “Ten Thousand Warlords Project” & argues before the Movement that such is inevitable anyways.

The past few years, especially this past year and especially the past few months means Pastor Lindstedt must live frugally. Pastor Lindstedt has several boxes of paper, and toner cartridges and old computers, a cell phone hotspot. This past month Pastor Lindstedt managed to off-load paying much of the property taxes to friends, cuts down driving to Neosho and the soup kitchen, and takes canned meat and vegetables from one of the decaying houses from 2009. Last month’s electric bill was reduced to \$59 by turning off and unplugging kitchen appliances and lights and only leaving running one desktop computer. The current temperature is 18 Degrees outside and 38 degrees inside where a teapot is on the propane stove to keep the air humid and it above freezing. Pastor Lindstedt is camping inside now.

The problem with these decaying properties is that with them being still under probate as Roxie owns some of them in common is that they can’t be sold or with Bryan Reo around given away to generate a few thousand to live off of before Collapse and everyone is in Pastor Lindstedt’s position. All they are is a burden which is in decay and at the mercy of arsonists, crackheads, thieves and the local authorities who hate and fear Pastor Lindstedt. On the plus side, this hatred and fear

means that they don't want to harass Pastor Lindstedt in an area full of less vocal white supremacists and racist bigots who don't mind killing if provoked.

Bryan Reo has filed all sorts of actions in Newton and Ray Counties in Missouri. Regardless of how many millions of ZOGbux is racked up by these Ohio state and federal courts for making fun of homosexual mongrel pretend white supremacist agent provocateur Bryan Reo and his Sephardic jew wife and struggling manzer father and the staff and lawyers of the Foundation for the MarketPlace of Ideas (FMI) / ZOGbot Poverty [F]Law Center (ZPLC) it is very unlikely that any of them are going to evict Pastor Lindstedt from any of his shithole properties and Pastor Lindstedt gets to claim the best of them which is the Lamp House in Granby. Indeed with the chernobyling of Cleveland and the Flushing of Pierre this will enable secession of the States of Klan in former Missouri, Arkansas, as Oklahoma good full tribal.

The Church building in Ray County is empty. Pastor Lindstedt has no intention of renting it out to some more deadbeats or drug users or in bothering to garnish the wages of these "Christian scumbags" who didn't pay the \$400 per month rent in return for fixing the building and mowing the grass who had no intention of paying the past two years. They had to be evicted while the grass didn't grow but this eviction cost \$250 or more. Pastor Lindstedt would like to sell the Church building to the State of Missouri to house convicted child molesters for a

fraction of the price of prison or civil commitment as the town is full of old poor white people with no schools or broadband internet and spotty cell-phone service.

Pastor Lindstedt has no intention of going to any trouble to collect for Bryan Reo.

A number of people have pledged to let Pastor Lindstedt into their safehouses, but it hasn't come to that -- yet.

So today, Pastor Lindstedt is living well below poverty level, has no way to pay anything on this appeal other than postage, and is looking forward to the Collapse & 2d Civil War hitting high gear.

Time to just grant Pastor Lindstedt's *in forma pauperis*.
