<u>DEFENDANT'S REPORT OF RULE 26(f) & L.R. 16.3(b) PLANNING MEETING OF 21</u> <u>NOV. 2019 AT 3:00 PM EST VIA TELEPHONE</u>

Defendant Pastor Martin Lindstedt and Plaintiff Bryan Reo held a Local Rule 16.3 (b) telephone conference in which Bryan Reo called Pastor Lindstedt from 1:58 to 2:30 Central time on Nov. 21, 2019 as agreed upon from Bryan Reo's suggestion. Bryan Reo had proposed his own Scheduling Order which he has since submitted as Document #22. Pastor Lindstedt, lacking Electronic Case Filing, hereby submits his own independent report via the slower and more expensive U.S. Mail.

This meeting was one in which Plaintiff and Defendant could not agree on anything. Bryan Reo wants a quick looting operation trial of a foreign defendant associated with Aryan Nations before a hostile jury in December 2019. Pastor Lindstedt wants full discovery and a defense against Bryan Reo's abuse of legal process, trial date in late 2020 or early 2021 and is amenable to a magistrate judge.

Much the exact same thing occurred in Bryan Reo's first lawsuit against Pastor Lindstedt in 2014-2015 before Magistrate Judge Whitworth in the Western District of Missouri, *Reo v. Lindstedt*, 14-cv-5093 in which Bryan Reo made much of Pastor Lindstedt's Aryan Nations affiliations in his lawsuit for \$10.75 million for making fun of non-white Bryan Reo playing a White Supremacist and Christian

Identity sub-pastor over the Internet. Judge Whitworth was hearing a case in which some drunken white kid had been set up by a federal informant pretending to be a more militant Aryan Nations faction plotting to assassinate Obama in Kansas City. Bryan Reo made a big deal about Pastor Lindstedt's racism and was filing Motions to Strike via U.S. Mail and wanted Electronic Filing as a non-lawyer plaintiff pro se. Pastor Lindstedt made no objection to Bryan Reo being able to appear for these pre-trial conferences or to filing his numerous motions electronically. Eventually the case fell apart because it was frivolous and Bryan Reo filed it after dismissal in Lake County Ohio and after nearly four years in front of a biased judge and hostile jury prevailed in getting a judgment against an Aryan Nations pastor and his Church for what was said on the Internet 8 or 9 years ago over the Internet. Bryan Reo wants to render Pastor Lindstedt penniless and destitute and to steal his South Dakota inheritance. Pastor Lindstedt wants to forestall Bryan Reo. Thus there really has been no change as to party goals in 2019 since 2015.

Enclosed is Pastor Lindstedt's Attachment 1 Form filled out as to when and how Defendant Pastor Lindstedt wants to schedule this particular case, as well as how Judge Whitworth settled the matter of much the same sort of case back in Feb, 2015 showing that fairness should be extended to all parties, especially Defendant living 850 miles away being able to defend himself equally with Bryan Reo living 30 miles away. Bryan Reo is still a non-white antifa, Pastor Lindstedt an Aryan Nations pastor.
