**DEFENDANTS JOINDER/COUNTER-CLAIMS VERSUS BRYAN REO COUNTER-
DEFENDANTS AS PER CASE MANAGEMENT SCHEDULING ORDER**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt" to joinder and counter-claim Bryan Reo family members Anthony Dominic Reo (Bryan Reo's father) and Stefani Rossi Reo (Bryan Reo's wife) who is used by Bryan Reo to gin up vexatious & malicious frivolous litigation in order to steal Pastor Lindstedt's inheritance, Bryan Reo's fellow attorneys / board members Kyle Bristow and Brett Klimkowsky of the White Supremacist "lawfare" antifa / federal "lawfare" agent-provocateur 501(c)(3) corporation "Foundation for the MarketPlace of Ideas" (FMI) also known humorously as the ZOGbot Poverty [F]Law Center (ZPLC). These parties were already counter-claimed in Pastor Martin Lindstedt's Second Amended Answer filed 27 Nov. 2019 (Doc 29). Further Counter-claimed and Joindered as Parties are the Lake County Court of Common Pleas in general and Judge Patrick Condon in particular for violation of and conspiracy to violate Pastor Lindstedt's and Lindstedt's Church of Jesus Christ Christian / Aryan Nations of Missouri's First Amendment civil rights under color of law and without any jurisdiction to do so under 42 U.S.C.

§ 1983 & 1985. Also joindered and counter-claimed is the State of Ohio and the U.S. Government for failure to control their licensed attorneys Reo, Bristow, and Klimkowsky working as agents provocateur connected to the Charlottesville Massacre through their false-flag 501(c)(3) operation officially known as The Foundation for the MarketPlace of Ideas (FMI) and colloquially as the ZOGbot Poverty [F]Law Center. Bryan Reo is nothing more than a delusional antifa non-white homosexual mongrel that has infested the White Supremacist and Christian Identity Resistance Movements for the past 20 years and oppressing Pastor Lindstedt and Lindstedt's Church for a decade and lawfaring the past six years. There would be no case except for Bryan Reo and fellow ZOGbots and the crooked state and federal courts making this happen. During the past week the 501(c)(3) IRS Short Form for the FMI/ZPLC has come out and part of the expenses – as well as the Board of Directors members – was for the Charlottesville false-flag Massacre. As discovery progresses, the other board members of FMI/ZPLC may well be joindered as parties to this case as well.

Bryan Reo, as is its habit has already filed numerous Motions to Strike and pretended that it doesn't understand Pastor Lindstedt's counter-claims concerning Reo's Bryan abuse of legal process in using "lawfare" against Pastor Lindstedt and Pastor Lindstedt's Church because Pastor Lindstedt has truthfully reported over the Internet to the White Supremacist and Christian Identity community that Bryan Reo is a non-white homosexual mongrel and agent provocateur. Bryan Reo and Reo family and Reo lawyer friends have used the Lake County Ohio and federal courts to violate the Pastor Lindstedt's and Lindstedt's Church's First Amendment rights of free speech, of the press in reporting on Bryan Reo antics of infiltration and subversion, and of religion. Bryan Reo, Bryan Reo family members i.e. Reo's father Anthony Dominic Reo and Reo's Brazilian 'wife' Stefani Rossi Reo have already been counter-claimed and joindered as

parties to this federal lawsuit of four ginned up by Bryan Reo in order to steal Pastor Lindstedt's South Dakota inheritance. Likewise with the FMI/ZPLC attorneys [mis]practicing lawfare against Pastor Lindstedt and Lindstedt's Church namely Bryan Reo, Kyle Bristow and Brett Klimkowsky, of which Bryan Reo and Kyle Bristow are still libeling Pastor Lindstedt as a "child molester" and "Nazi pedophile". Thus nothing more need be said in this new Joinder of Parties other than Pastor Lindstedt officially joinders the Lake County Courts / Judge Patrick Condon, the State of Ohio and the Federal Government in this Addendum Amendment of Pleadings.

Officially Joindered /Counter-Claimed to this Case

1. The Lake County Courts in general and Judge Parrick Condon are hereby joindered and counter-claimed for exceeding / usurping jurisdiction and proceeding via corrupt legal process in conspiracy with Bryan Reo, Brett Klimkowsky and Kyle Bristow to violate the First Amendment rights of Pastor Lindstedt and Pastor Lindstedt's Church, thus in violation of 42 U.S.C. § 1983 & 1985 – Violation of Civil Rights and Conspiracy to Violate Civil Rights. This Lake County Court and Judge Patrick Condon are being sued in their personal and official capacities for declaratory and injunctive relief and Pastor Lindstedt seeks to strip them of their authority to exceed / usurp jurisdiction over individuals, churches & corporations outside Lake County Ohio. Pastor Lindstedt does seek not monetary damages at this time unless it can be proven that conspiracy and treason against the property and civil rights and religion are not

“official acts” if or when the System wishes to blame anti-white subversion on Judge Condon / Lake County whereupon Pastor Lindstedt can make a monetary claim against Lake County / Judge Condon. For now Pastor Lindstedt and Lindstedt’s Church seeks only injunctive and declaratory relief.

2. The State of Ohio presumes to “license” attorneys who are otherwise self-regulated by their bar associations and Ohio Supreme Court. Thus Bryan Reo has been allowed to run wild filing frivolous and malicious litigation against Pastor Lindstedt and Lindstedt’s Church. Furthermore, the Ohio Supreme Court has given attorneys a false patent of nobility to where Pastor Lindstedt couldn’t defend in their court his Church. Therefore a federal question is why cannot a Church be represented by its clergy as part of its exercise of religion and free speech? Contrary to Bryan Reo’s lies, the Church of Jesus Christ Christian / Aryan Nations of Missouri is NOT a 501 (c)(3) organization or anything else other than a non-profit religious organization for the benefit of Aryan Christian Israelites to advance Dual-Seedline Christian Identity beliefs. Bryan Reo used the mere name “Aryan Nations” to inflame a hostile jury and to get at Pastor Lindstedt under color of trial. Therefore the State of Ohio, its bar associations and legal associations, and its courts absent any jurisdiction over the Church are violating the First Amendment and is hereby joindered for civil rights violations and conspiracy to violate Pastor Lindstedt’s and Lindstedt’s Church’s civil rights for failure to adequately supervise and control their licensed attorneys acting under a patent of nobility under 42 U.S.C. § 1983 & 1985. The damages are unknown at this time however Pastor Lindstedt also seeks declaratory and injunctive relief as a federal question in seeking strict regulation of the legal profession or abolishing legal business privilege in what claims to be an independent branch of government given that Bryan Reo with the connivance of the federal and Lake County Courts allowed Bryan Reo to sue Pastor Lindstedt’s Church while Pastor Lindstedt and Pastor Lindstedt’s Church – who as an Article of Faith regards the Ohio and federal

government as being Under Satan's Administration (U.S.A.) – and licensed attorneys as being the worldly analog of Satan on Earth. Indeed the very word Satan means “adversary” and Satan's profession is the make charges – both true and false – against the Elect of YHWH. Thus Bryan Reo is literally the homosexual mongrel Satanic abomination whose job it is to harass Pastor Lindstedt and Lindstedt's Church on behalf of a Satanic regime as an agent provocateur. There is a judgment against the State of Ohio in general for \$200 billion in compensatory and \$200 billion for punitive damages arising from the Lake County kangaroo proceedings by Bryan Reo against Pastor Lindstedt and Lindstedt's Aryan Nations Church before a secret ecclesiastical military warlord tribunal in which the principles of Biblical castration and execution and forfeiture of estate and corruption of blood against government officials and workers is invoked upon the ending of the Second Civil War. Lake County is to be “quantrillized” and “chernobyled”. However, for this day and this case Pastor Lindstedt is seeking only what the federal [quasi]-legal process affords for relief.

3. The federal government is running agents provocateur like Bryan Reo, Kyle Bristow and Brett Klimkowsky in order to harass genuine White Supremacists and Christian Identity aboveground leaders like Pastor Lindstedt and to oppress Lindstedt's Aryan Nations Church. The federal government, worried about White Supremacist political efforts to send their ZOGling whigger herd animals into revolt, has always infiltrated White Supremacist / White Nationalist organizations since before the 1960's using COINTELPRO. Today the federal government sets up non-white jewish and negroid mongrels like Bryan Reo and the rest of the FMI/ZPLC Board of Directors to practice “lawfare” upon the Old Resistance like Pastor Lindstedt and Lindstedt's Aryan Nations Church. The last week Pastor Lindstedt found out through an investigative journalist about the 501(c)(3) IRS Short Form for the FMI/ZPLC the Board of Directors and their involvement in the Charlottesville Massacre:

Attorneys Bryan Reo, Kyle Bristow and Brett Klimkowsky, Counter-Defendants in this case are not only seeking to defraud Pastor Lindstedt and Lindstedt's Church through this abuse of legal process case, but they literally have blood on their paws through their infiltration conspiracy of enabling themselves and their fellow FMI/ZPLC conspirators leading to the Charlottesville Fiasco designed to destroy White Nationalism. The federal government is thus culpable as well for the Charlottesville Massacre. In the present case they are enabling Bryan Reo and Reo's fellow attorneys and FMI/ZPLC to violate Pastor Lindstedt and Lindstedt's Aryan Nations Church even though Pastor Lindstedt opposed the Charlottesville "Unite-the-Right" Rally as being nothing but [bowel Movement] ZOGbot mongrels, jews, homos, trannys, perverts and other such ZOG offal out to uncover those whiggers stupid enough to think that they have rights, especially if they have White racial pride or self-awareness. Thus the federal government is allowing its own ZOGbots / Agents Provacateur to run wild oppressing Pastor Lindstedt and Lindstedt's Church under color of law and thus a federal question under 42 U.S.C. § 1983 & 1985. Pastor Lindstedt seeks compensatory and punitive damages against the U.S. federal government to be determined by jury trial as well as declaratory and injunctive relief as with the Lake County Courts/Judge Condon and the State of Ohio.

4. The Other Board Members of The Foundation for the MarketPlace of Ideas (FMI) / ZOGbot Poverty [F]Law Center (ZPLC). Pastor Lindstedt just found out the further extent of FMI/ZPLC infiltration and Charlottesville Massacre Involvement just this past week. Upon further discovery Pastor Lindstedt will seek to joinder with the leave of this Court the additional members, especially Richard Spencer and Mike Enoch. All of the members of FMI / ZPLC like Bryan Reo are public figures and thus Pastor Lindstedt publishing that they are ZOGbot degenerate homosexual mongrels means that Bryan Reo as a public figure cannot

collect anything from this fraudulent lawsuit Reo and Reo's family have initiated in Lake County and now before this federal district court.

Wherefore, as per the Scheduling ORDER propounded by this Court, here is Pastor Lindstedt's joining additional parties and amendment of pleadings sufficient for them to render an answer.
