**PASTOR LINDSTEDT'S EXPLANATION CONCERNING HIS 9 NOV. 2020 BELATED
DISCOVERY REQUESTS OF BRYAN REO & REO LAWYERS KYLE BRISTOW AND
BRETT KLIMKOWSKY (OF THE FMI) AND ATTORNEY ROBERT KONRAD OF
SOUTH DAKOTA AND SOUTH DAKOTA RULE 59 & 60 MOTIONS FOR ALTERING
JUDGMENT FOR PERMANENT INJUNCTION REGARDING PASTOR
LINDSTEDT'S FORMER INHERITANCE**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church and in point of fact Pastor Lindstedt is the *de facto* Chief ArchBishop of the entire above-ground Dual-Seedline Christian Identity Church in North America) to explain to these Ohio federal courts and the Stanley County South Dakota Circuit Court why Pastor Lindstedt filed just before midnight via e-mail belated

Discovery Requests of Bryan Reo and his Foundation for the MarketPlace of Ideas (FMI) / ZOGbot Poverty [F]Law Center Ohio-practicing lawyer friends and fellow Board Members Kyle Bristow (suspected of being Bryan Reo's and Richard Spencer's Aryan homosexual romp) and Brett Klimkowsky (who has been Bryan Reo's lawyer against Pastor Lindstedt and others). And South Dakota antifa lawyer Robert Konrad, who is suspected of giving confidential files and the e-mail address of Susan Bessman – Pastor Lindstedt's sister – stolen from the Ollinger Law Firm, and thus unfit and disqualified to serve as Bryan Reo's attorney in trying to force back the transfer from Lindstedt's sister back to Lindstedt so that there will be a payoff for all this Bryan Reo litigation. Pastor Lindstedt had gotten timely filed the Reply Motion In Opposition to Bryan Reo's Motion for Summary Judgment as ORDERED by Magistrate Parker due Nov. 9, 2020. Pastor Lindstedt decided that because Bryan Reo likes to play games regarding discovery to send a Consolidated Answer for all of Bryan Reo's and Reo's wife's and father's discovery requests. In reality every single one of Bryan Reo's litigation papers against Pastor Lindstedt and Lindstedt's Church are much the same with but a slightly different pretext to achieve the same result over the years: To impoverish Pastor Lindstedt and Lindstedt's Church and to seize Pastor Lindstedt's South Dakota inheritance using the state and federal courts. Every single one of Bryan Reo's lawyer friends shares the same goals because they too are antifa lawyers, some of whom used to pretend to be lawfare for aboveground "White Nationalist/Supremacist" individuals and organizations and still do in the case of Kyle Bristow serving David Duke just a few months ago. When pretending to be White Supremacists Bryan Reo and FMI used to extol "racism" and "homophobia" and now they want Pastor Lindstedt to be punished for daring to remain the same in defense of himself and his Church. Given that Pastor Lindstedt had provided "Consolidated Answers" then it seemed best to slip in Discovery requests upon Bryan Reo and

Reo's lawyers Kyle Bristow, Brett Klimkowsky and Robert Konrad just before midnight of 9 Nov. 2020. Attorney Konrad responded almost immediately.

Also filed via e-mail to South Dakota Judge Bridget Mayer and her clerk was a South Dakota 15-6-59 (and 15-6-60) Motion for Amendment of Judgment which is supposed to be filed within ten days of her judgment on 30 Sept. 2020 and Monday, Nov. 9th was ten days. Pastor Lindstedt is asking her to reconsider her signing a permanent injunction against Pastor Lindstedt or Pastor Lindstedt's sister transferring Pastor Lindstedt's inheritance further and to simply in effect dismiss Reo and Konrad litigation because it is based upon Bryan Reo and Konrad fraud, as is all this Bryan Reo litigation.

The fraud is that Bryan Reo is not only a public figure within White Supremacy and Christian Identity but that Bryan Reo (and the entire Foundation for the Marketplace of Ideas FMI/ZPLC) is actually agents provocateurs charged with enticing stupid whiggers to do something stupid (especially at Charlottesville Va in August 2017) and then use the resulting riots as a pretext for Senile Joe Biden and others to crack down against real white supremacists. Thus Bryan Reo is a police NGO operative working to destroy genuine White racial, religious and political dissent and use "lawfare" against such as Pastor Lindstedt and Lindstedt's Church. However when it comes to a hearing Bryan Reo pretends, with the assistance of such as Attorney Konrad that he never was "SwordBrethren" (trivially proven to be a lie), never was affiliated with white supremacy but rather that of 100,000 negro homosexuals in the Cleveland Ohio area that for no good reason Pastor Lindstedt chose to defame him and that Pastor Lindstedt's reporting of the facts of this agent provocateur must be censored. The corrupt negro judge Solomon Oliver agrees with Bryan Reo that because Pastor Lindstedt didn't hasten to obey Bryan Reo's discovery games then Pastor Lindstedt should be punished and Pastor Lindstedt's

Aryan Nations Church censored. *Reo v. Lindstedt* 19-cv-02103 Doc 49, pg ID 551 in fact says that Pastor Lindstedt “*identifies no error of law, let alone a clear error, he offers no new evidence; he points to no intervening change in law; and he does not assert manifest injustice. Instead his Motions threatens the court and various other entities, predicts a looming religious race war, and rehashes the same accusations and vile insults that have plagued his filings throughout this litigation. Because Defendant’s Motion is utterly devoid of merit, the court denies the Motion.*” (ECF No. 47 Motion under Rule 59 (e) to reconsider)

Like Eve believing Satan and choosing beguilement, Judge Bridget Meyer also chooses to believe Bryan Reo’s and Attorney Konrad’s lies in making her judgments, for which, like Eve, she must atone for with the consequences. This Rule 59 & 60 Motions were meant to let her off.

This both exhibits were filed just before midnight on 9 Nov. 2020.

What all these regime courts must consider is that Bryan Reo uses these courts to drag Pastor Lindstedt and Lindstedt’s Aryan Nations Church 800-900 miles to face judicial process created by a common-law system which allows lawyers to file never-ending litigation before other lawyers pretending to have jurisdiction and that Pastor Lindstedt has to obey whatever monkey-talk or procedures are set according to the notions of agent provocateur lawyers justly terrified of “white supremacism”. The so-called First Amendment of paper guarantees does not matter. Their Talmudic interpretation does.

However, Pastor Lindstedt looks at it this way: It is up to him as a First Servant of YHWH’s Servant Nation to use this spurious never-ending litigation against himself and his Aryan Nations Church as an excuse to ask the fighting forces of Aryan Christian Israel to exterminate the non-whites and to eliminate the ruling elites and their families from life and

power and to take their lives and property and give it to successor local theocratic military dictatorships run for the good of Aryan Christian Israel and none other. Northeastern Ohio must be laid waste simply because it is a threat to the new order, same as it was in 1861-1865.

Pastor Lindstedt asks questions only of Attorneys Bryan Reo, Kyle Bristow, Brett Klimkowsky and Robert Konrad. Based upon Bryan Reo's quora posts Reo's wife Stefani Reo is merely a "beard" from Brazil and if not for Reo wouldn't be doing this litigation. Bryan Reo's father – while spawning the most evil Satanic golem ever whelped – in reading Anthony Reo's divorce papers from 1984-2000 sees how this monster was created and thus Pastor Lindstedt has no questions of Anthony Reo because Anthony Reo has no case.
