**Doc 78** Report and Recommendation that the Court grant plaintiff Bryan Anthony Reo's motion for summary judgment on the liability portions of Count I and II of his complaint. In the interest of consistency with another case pending in the Northern District of Ohio, 1:19-cv-2013, I recommend that the Court exercise its discretion and permit defendant Martin Lindstedt to withdraw his admissions as they relate to damages on Counts I and II and that the Court DENY summary judgment on Count III of Reo's Complaint. Because there are adequate remedies at law and because issuing a permanent injunction would needlessly require the Court to supervise the parties' conduct, I recommend that the Court DENY Reo's motion for summary judgment on his Count IV demand for a permanent injunction. 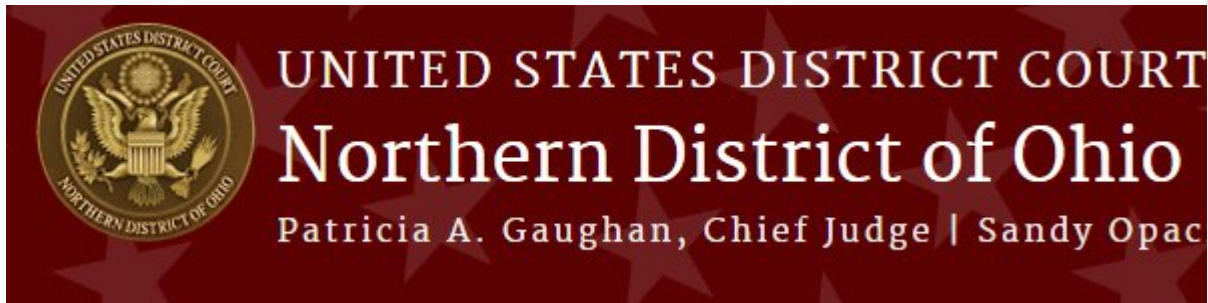

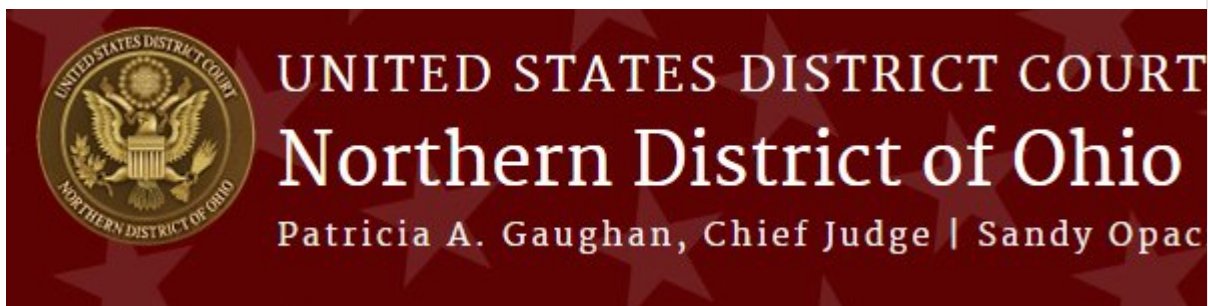
