**DECLARATION OF PASTOR LINDSTEDT OF THE CHURCH OF JESUS CHRIST
CHRISTIAN / ARYAN NATIONS OF MISSOURI / ZOGLAND PURSUANT TO 28
U.S.C. § 1746 FOR ALL CURRENT BRYAN REO V. LINDSTEDT LITIGATION**

1. I, Pastor Martin Lindstedt has personal knowledge of the facts and matters stated herein and am competent to testify as such if called as a witness before any court, both regimeist and Resistance which claim to be ones of law.

2. I, Pastor Lindstedt, am a party, along with my Church of Jesus Christ Christian / Aryan Nations of Missouri which is the de facto and de jure primary Aryan Nations faction / ministry / Resistance faction for the entire so-called United States / ZOGLand (hereafter referenced to as Pastor Lindstedt's Aryan Nations Church) to all of this Bryan Reo litigation above initiated in a Lake County Ohio Court of Common Pleas without any lawful jurisdiction and transferred by Pastor Lindstedt to the Northern District of Ohio where Pastor Lindstedt transferred it to because the Lake County Ohio Court was deemed corrupt. Since then Pastor Lindstedt and Lindstedt's Aryan Nations Church has fared not much better in the barratry proceedings. Bryan Reo along with his fellow antifa Attorney Robert Konrad took stolen confidential files belonging to Pastor Lindstedt's sister from 2011 from where Konrad worked and initiated a lawsuit in order to steal Pastor Lindstedt's inheritance worth \$2 million and now is extorting Pastor Lindstedt's sister to steal her inheritance as well – and Pastor Lindstedt's sister as well as the South Dakota judge is enabling this thievery and extortion. Thus there is a state of racial and religious civil war in effect

Plaintiff Bryan Reo is a known delusional psychotic homosexual mongrel who is an admitted federal and state agent provocateur (known as a “ZOGbot”) who has been pretending to be a white supremacist since 2003 or before and a Christian Identity sub-pastor for these two infiltrating jews named “Eli James” / Joseph November and William “Baal” Finck since June 2009. Bryan Reo, along with Attorneys Kyle Bristow and Brett Klimkowsky formed the NGO white supremacist “lawfare” corporation known as The Foundation for the MarketPlace of Ideas (henceforth FMI) in 2016. The 2017 IRS 501(c)(3) Income Tax Form shows that the Board of Directors consists of a Whos Who for Charlottesville 1.0 false-flag operators Richard Spencer, Mike [The Kike] Isaac “Enoch” Peinovich, Austin Gillespie / Augustus Invictus were directors as well as William Johnstone, Thom Robb’s lawyer son Jason Robb, James Edwards, and other White Nationalist notables were also officers and a page mentions that FMI funds were spent on Charlottesville 1.0. They were also lawyers for Charlottesville 1.0 participants, some now openly antifa like Matthew Heimbach and David Duke, William Finck and League of the South. The federal government maintains these “white supremacist” groups such as FMI, “The Proud Boys” (whose leader like Bryan Reo is a jewish mulatto FBI informant since 2013) and fake militia groups such as “Oath Keepers” whose second in command was an FBI and CIA operative. Bryan Reo is thus an operative for the federal regime and likely for the State of Ohio as well and has special dealings with the Lake County Court of Common Pleas.

3. According to Bryan Reo testimony Bryan Reo knew that Pastor Lindstedt would not allow any non-white, much less homosexual, agent provocateur to pass within white supremacy and certainly not within the above-ground congregations of Christian Identity and particularly not within the Dual-Seedline Christian Identity variant. However, Bryan Reo with its negroid features, dark skin, unibrow and negroid lips and effeminate manner – not to mention the Facebook and other social media public profiles hid under the alias of “SwordBrethren” and pretended to be a “Teutonic Crusader” and of pure German descent. Bryan Reo would use his alias to threaten to murder some old Greek mongrel woman for making fun of William Finck’s inability to speak Greek. William Finck is a jew from Jersey City who murdered a Puerto-Rican sneak thief named Arnauldo Ortega in the jail and took a plea bargain and fin[c]ked out another murdering pig named David Dumers and ruined his appeal – and then was installed as a Christian Identity pastor. Pastor Lindstedt knew from one Everett ‘Buck’ McHugh who lost his stockbroker’s license and \$2.5 million because of Bryan Reo that Bryan Reo was a homosexual mongrel and other confirming details but wasn’t given “SwordBrethren’s” real name and address

4. On Oct. 29, 2010 Pastor Lindstedt found out that one of Finck’s “Facebook Friends” was Bryan Reo whose public Facebook Profile Picture was its 2004 Mentor High School yearbook picture looking like an effeminate mongrel. Bryan Reo had pretended to be a white supremacist before with one Richard Barrett, another homosexual ZOGbot from Pearl Mississippi. Reo was kicked out of Barrett’s operation because “Bryan Reo will have to learn and accept that he is not white and therefore cannot be in white nationalism” or words to that effect. Bryan Reo threatened Attorney Barrett with legal action but those words were not removed until a year after Barrett was killed by a prison negro homosexual that Barrett picked up in April 2010 and no one paid the server bill now that Barrett was dead.

5. After Bryan Reo and Eli James and William Finck denied over the weekend that “SwordBrethren” was non-white homosexual Bryan Reo, Bryan Reo asked Pastor Lindstedt

what it would take for Bryan Reo to no longer be mentioned on Pastor Lindstedt's Aryan Nations Church's web pages. Bryan Reo was told that it had to leave permanently the white supremacist / nationalist Movements and Christian Identity and never come back. Bryan Reo agreed to do so and that Pastor Lindstedt would not add anything if there was nothing to add since Reo would be gone on 1 Nov. 2010. On Wednesday Nov. 3, 2010 in an effort to ascertain who had fin[c]ked him out Bryan Reo, Buck McHugh and another jew mongrel going by the name of "Martin 41" who Pastor Lindstedt found out was one Martin Hughes in early 2019 called up Pastor Lindstedt via Skype and Pastor Lindstedt said truthfully that Buck McHugh hadn't revealed Bryan Reo's real name and living in Mentor Ohio but insinuated that it was another Finckbot.

6. There was therefore a deal – which Bryan Reo of course broke like similar deals with Buck McHugh and John Britton – that in return for psychotic delusional non-white homosexual mongrel agent provocateur ZOGbot Bryan Reo leaving the white supremacist and Christian Identity Movements that Pastor Lindstedt wouldn't print up or publish any new material on Bryan Reo if there was no new material to publish because Bryan Reo would be gone. The old material would stay until it was demonstrated that Bryan Reo was truly gone if Pastor Lindstedt wished to do so upon continued good behavior. Bryan Reo as "SwordBrethren" had already called Pastor Lindstedt a child molester. *Thus Bryan Reo could have left pretending to be an Aryan Christian Israelite and White Supremacist while working as a ZOGbot and promoting William Finck and Eli James and got on with its life around Cleveland and left Pastor Lindstedt and Lindstedt's Aryan Nations Church alone – but deliberately broke that agreement on 5 Nov. 2010.* (By re-publishing the 1 Nov. 2010 Eli James hit piece "Rabbi Lindstentch – Race Traitor or Jew?" on the SwordBrethren Blog hosted on William Finck's Christogenea.org web page.) *Thus any damages that Bryan Reo has allegedly suffered because of Pastor Lindstedt publishing the antics of this crazed delusional homosexual mongrel ZOGbot going about its business as a government inciter and informant is entirely due to Bryan Reo's conduct in breaking the arrangements made that Bryan Reo intended to break when he made those arrangements. Any criminal regimeist government at the Ohio and South Dakota county and state level and at the federal level oppressing under color of their pretend "law" or "legistreason" to tyrannize over Pastor Lindstedt and Lindstedt's Aryan Nations Church serving YHWH's Servant Nation of Aryan Christian Israel has thus committed an act of racial and religious civil warfare and treason against said People of YHWH and thus are subject to extermination if non-People and/or enslavement if treasonousbut salvageable against YHWH's People according to YHWH's Law as codified by Holy Scripture.*

7. A week after breaking the deal Bryan Reo proceeded to make fraudulent Digital Millennium Copyright Act (DMCA) claims against Pastor Lindstedt and Lindstedt's Church web pages. Bryan Reo would also force the removal of allied or neutral Movement web pages through false DMCA claims, through blackmail and extortion. Pastor Lindstedt's hosting out of reach of the DMCA in Montreal Canada was removed by Bryan Reo working in conjunction with the jew Richard Warman. Bryan Reo even found the underlying backbone server of 1st-Amendment.dot net and in return for Bryan Reo not taking down SolarGeneral and WNTube (White Nationalist Tube) Pastor Lindstedt's Church's non-database flat Christian-identity.net web page was taken down. Pastor Lindstedt bought server space in India and other foreign lands but eventually decided to simply buy a secret server space or two and pour into it the forum and other content.

8. Bryan Reo along with Eli James got Pastor Lindstedt's popular with NIM-Busters and other Internet 4-Chan trolls Talkshoe Internet Podcast "The Movement Turd" taken down. A full decade before the tech giants censored and deleted Prez-o-dint Trump and others, Bryan Reo with the aid of his handlers was showing how its done to remove web pages standing alone with the help of Reo's federal handlers. (Bryan Reo managed to get them deplatformed four times, took down permanently upstandingfuckingcitizens.com – a NIM-Buster homosexual porn and Movement current events web page in which he impersonated John Britton and interfered with Britton's federal civil litigation against Rolls-Royce for machining a defective helicopter engine part and thus causing a crash because of wanting to extort Britton into having Aryan-mamzer homosex. On 28 Nov. 2010 Bryan Reo and Eli James discussed taking down NIM-Busters sites and informing on them to the Chicago FBI.) Bryan Reo supposedly went into hiding and was calling the cops on all them Internet trolls.

9. Pastor Lindstedt after getting the secret web page and forum set up and having Bryan Reo and Eli James and William Finck take down all of Pastor Lindstedt's Church's and allied web pages took an "Internet vacation" for six months until CrisisHost.com – a real free speech web page operated by a jew – allowed Pastor Lindstedt to come aboard. Bryan Reo made all sorts of objections, admitted to notifying the ZOG bureaucracy, sent the Secret Service to call on Pastor Lindstedt at his home, and all sorts of harassment of Pastor Lindstedt and John Britton. The agreement with Crisishost.com was that if Bryan Reo made any sort of DMCA complaint that Pastor Lindstedt would immediately remove the disputed item then file a DMCA counter-notice. Pastor Lindstedt on one occasion replaced a picture of Bryan Reo in a ROTC uniform with a one public domain one of a female orangutan pissing in an arc into her mouth. Then upon Bryan Reo failing to have any grist under DMCA, Bryan Reo then started to threaten to sue Crisishost for "defamation" issues. Bryan Reo also predated by 10 years the "takedown" of web pages now common in 2021 by attacking Crisishost by going against its backbone like was done to Parlor.

10. Bryan Reo as a predatory homosexual was also interfering with Pastor Lindstedt's friend and fellow Christian Identity pastor John Britton's lawsuit against a subsidiary of Rolls-Royce for a defective engine part which caused a crash. Bryan Reo stalked and blackmailed another individual with an alias named "Victor Switzer" until Reo found out that "Switzer" wasn't white. Reo would get on web pages impersonating John Britton until detected and then take web pages down to cover its tracks – like Bryan Reo is petitioning this Court to do. Bryan Reo referred to itself as "Bryan Nicewonger" in drafting up its satisfaction with censorship success. However the main federal judge Edward Lodge of Idaho ruled that there would be no censorship and that there would have to be a hearing regarding what Pastor Lindstedt's interaction with John Britton in discussing Bryan Reo and the Britton case. Eventually a settlement was reached in which the Magistrate Judge admitted that John Britton got something because of Pastor Lindstedt's stirring up the "white supremacist" interest in that case, just as having non-white homosexual agents provocateur being used by ZOG/Babylon to start a religious and racial civil war using the corrupt court system to do so. In short these Bryan Reo cases are being used by both the criminal regimeists and the white supremacists to justify the civil war using biological & nuclear weapons in destroying the foundations of the Mighty Evil Empire and reducing its population.

11. In early spring of 2013 Bryan Reo mounted another flurry of attacks upon Crisishost to where Crisishost said that he wouldn't renew hosting for Pastor Lindstedt's Church's web page past June 30th because of the Bryan Reo oppression. Pastor Lindstedt considered suing Bryan Reo but Buck McHugh and John Britton "cut a deal" with Bryan Reo for the third or fourth time. In mid-April 2013 the day this chemical fertilizer plant in Texas blew up Buck McHugh when asked why he gave pages about Bryan Reo but not his name and address, admitted that he hated Bryan Reo for costing him \$2.5 million and his stockbroker license and was using Pastor Lindstedt as a catspaw. Likewise John Britton admitted that he had cut yet another deal with Bryan Reo and having gotten and spent his civil judgment settlement wanted nothing more to do with Lindstedt. Pastor Lindstedt thinks that both these weak-minded idiots were & are ZOGbots

12. Sometime in 2011 or 2012 Bryan Reo suspended its Talkshoe Channel of around 200 shows in which Bryan Reo working with Eli James and William Finck would speak of its worship of Hitler and call Pastor Lindstedt a pedophile. Bryan Reo had decided to work in the North Perry Nuclear Power Plant. The power plant had a number of accidents and probably decided to do "due diligence" and do a google search and presumably found out that they had a delusional psychotic homosexual mongrel pretending to be a white supremacist working in their troubled ailing nuclear power plant and fired Reo for some reason. In early 2016 while Pastor Lindstedt was dealing with a bogus Civil Stalking Protection Order Reo obtained through perjury and Reo suing Pastor Lindstedt's Aryan Nations Church Pastor Lindstedt did a google search and found out about how he might have saved Cleveland from going all Chernobyl and regretted for the first time that he had kept the Bryan Reo material up. Perhaps because of Pastor Lindstedt blowing the whistle on a crazed delusional psychotic homosexual mongrel ZOGbot infesting the Movement Pastor Lindstedt kept Bryan Reo from "nuking" the Mistake by the Lake and killing 6 million or more ZOGlings. Something that Pastor Lindstedt was punished for by the Lake County Court, Judge Patrick Condon and a Lake County ~~lynch-mob~~ jury of one African negress & 7 gliberal whiggers with a \$15,000 defamation judgment against Pastor Lindstedt and \$400 against Lindstedt's Aryan Nations Church. Thus Pastor Lindstedt owes a chernobylization against Lake County and NorthEastern Ohio as well and Bryan Reo to be the one at the controls when carried out. After all, these Ohio state and federal courts by committing the Sin of Sodom – exercising false dominion & abuse of legal process against those well outside its jurisdiction – must by YHWH's Law suffer from the Judgment of Sodom which is [nuclear] fire and turning the nearest body of water into a "Dead Sea." Thus the Church of Jesus Christ Christian / Aryan Nations of Missouri has had a policy since the local judge of the Lake County Ohio Court of Common Pleas claimed that the Church "lost by default" because Pastor Lindstedt refused to hire an officer of its court to defend this Church against false claims by Bryan Reo (Kyle Bristow and Brett Klimkowsky of FMI) in mid-2016 that by committing the Sin of Sodom that the People and Population were to be punished as was Sodom regardless of the outcome of the fraudulent and unjust proceedings. According to Biblical Law an extermination-level offense is punishable when committed (in 2016), not when Biblically lawful penalties are finally imposed in the future.

13. In early April 2014 – Bryan Reo having found out that Pastor Lindstedt had an inheritance worth \$2 million – filed yet another complaint to Crisishost, whose operator found out that Pastor Lindstedt was still on after the June 30, 2013 date. Pastor Lindstedt agreed to leave within the week as opposed to two weeks threatened by Bryan Reo. When Pastor Lindstedt pointed out

that the DMCA legislation promised “safe haven” for his business the owner said that he didn’t want Bryan Reo to make his business the #13th lawsuit in Lake County and have to provide his personal information and submit to a subpoena and hire a lawyer. Pastor Lindstedt republished the newspaper clipping from South Carolina where a Bryan Reo driving a 2003 Toyota Landcruiser killed a Catherin Williams and put back up the 2004 Reo Facebook profile picture then migrated onto Dreamhost as agreed and CrisisHost pulled the plug. Then Bryan Reo filed for \$10.75 million for alleged DMCA violations before this Ohio federal court in forma pauperis. The Ohio federal judge Guinn moved it to the Western District of Missouri. Bryan Reo published its intentions on 24 August 2014 “Pray for My Success” on William Finck’s Christogenea forum wherein Bryan Reo announced its intentions to impoverish Pastor Lindstedt by taking everything Lindstedt had (which has been provided by all the state and federal courts in Ohio, Missouri and South Dakota to show Bryan Reo and friends’ criminal evil intent to use ZOG courts to steal). Bryan Reo refused to provide Rule 26 initial disclosures most particularly whence Reo derived \$10.75 million in damages. Pastor Lindstedt in turn decided to simply joinder Bryan Reo’s father, William Finck, Eli James, LiarBill ‘MumpsNut’ DeClue(less), and 40 or so other suspected Reo ZOGbots. The Magistrate Judge Whitworth decided to pull the plug on this foolishness and after giving Bryan Reo 20 days for Magistrate Judge plus 30 days additionally Bryan Reo couldn’t explain how Reo had been damaged \$75,000 worth to keep diversity of citizenship jurisdiction. Reo would have to pay the \$400 filing fee to continue. Pastor Lindstedt filed an appeal given that Bryan Reo violated the DMCA by filing a fraudulent claim against Pastor Lindstedt and his Aryan Nations Church but the 8th Circuit Court of Appeals refused it.

14. On Sept 18, 2015 Bryan Reo filed exactly the same sort of lawsuit stripped of the federa; DMCA in Lake County Ohio Court of Common Pleas, asking for a “gag order” prohibiting publication of Bryan Reo activity since 2003 and future publication of Bryan Reo material. The Ohio Statute of Limitations were long since passed but Bryan Reo claimed that the failed federal lawsuit acted as a sort of refrigerator preserving its claims. Bryan Reo would file countless motions to strike and motions for summary judgment and Pastor Lindstedt would file counter-motions right back. Bryan Reo would file motions for continuance refusing to take the matter to trial. Bryan Reo hired its fellow FMI attorney Brett Klimkowsky who would file ridiculous Motions to disallow Pastor Lindstedt to testify on behalf of himself on the basis that Pastor Lindstedt was locked up at the Fulton State Nuthouse for refusal to hire a lawyer on bogus child molestation charges so Lindstedt was thus insane and not qualified to testify (although competent enough to be sued for calling Bryan Reo a crazed delusional psychotic evil homosexual mongrel ZOG agent provocateur). Bryan Reo in March 2016 decided to sue Pastor Lindstedt’s Church and Roxie Fausnaught in the Mentor Municipal Court. However at the same time Bryan Reo, Kyle Bristow, Brett Klimkowsky and other ZOGbots were setting up a so-called Foundation for the Marketplace of Ideas (FMI) as a white supremacist “lawfare” NGO, dedicated to “free speech” for racial dissidents. Pastor Lindstedt of course made fun of that pretense of having jews, mongrels, homosexuals, and ZOGbots running this false-flag operation, especially Bryan Reo. The Mentor Municipal Court refused to accept this spurious jurisdiction so the Lake County Court usurped it as well. Pastor Lindstedt in talking to the Mentor Court Clerk had her admitting that they knew what Bryan Reo was up to and refused to be a party to the matter. Judge Richard Collins ruled that Pastor Lindstedt since he wasn’t a lawyer couldn’t defend his woman, Roxie Fausnaught who was elderly, illiterate, bed-bound, and agent for the Aryan Nations of Missouri

nor Pastor Lindstedt's Aryan Nations Church. Bryan Reo even sued Judge Collins over this matter before the Ohio 11th District Court of Appeals, several times – and lost.

15. After over four years of delay caused by Bryan Reo, trial on these cases went to Lake County Ohio on 24-26 June 2019 where a jury with an African female and seven gliberal whiggers run by a crooked judge Patrick Condon refused to allow Pastor Lindstedt to present evidence (even though Bryan Reo never obeyed the local rules to present his exhibits in advance of trial either but did allow Bryan Reo to cherry-pick through Pastor Lindstedt's Aryan Nations Church web page for items to place outside context) or to show that Bryan Reo was pretending to be a white supremacist / Christian Identity follower and to claim that Pastor Lindstedt was a child molester and to not allow Pastor Lindstedt to counter-sue Bryan Reo for anything, especially abuse of legal process and so Bryan Reo was given by the Lake County lynch mob jury \$105,000 against Pastor Lindstedt and \$400 against The Church of Jesus Christ Christian / Aryan Nations of Missouri. The corrupt judge Patrick Condon didn't give Bryan Reo the "gag order" that was requested however. They did punish open white supremacy real hard however.

16. Bryan Reo soon initiated four more lawsuits in Lake County Ohio, which before the end of the year Pastor Lindstedt removed to the Northern District of Ohio. Two on behalf of itself for what was said about Bryan Reo. Bryan Reo v. Martin Lindstedt 19-cv-2103 & 2589. One on behalf of its Brazilian Sephardic wife, Stefani Rossie Reo 19-CV-02786 after Lindstedt republished a public Quora post by Bryan Reo bemoaning how Reo's "beard" wife claimed that she would have much spawn by Bryan Reo, refused to do so, so Reo initiated divorce proceedings and then she offered to have some spawn then the divorce was dropped so then she reneged on having any Reo spawn so Bryan Reo was bemoaning female deceit and wanting to be alone. The overall impression was that a homosexual married a trophy wife and brought her to the ZOGland because Brazil is an even bigger Turd-Whirrrld shithole and they had a Bryan Reo deal as well. Bryan Reo initiated a lawsuit on behalf of its father Anthony Dominic Reo 19-cv-2615 because Pastor Lindstedt seen Stefani Reo jumping up and down on 25 June 2019 in the Lake County Courthouse trying to get the attention of what Pastor Lindstedt thought were two homosexual mongrels, of which one of them was Bryan Reo's father who Pastor Lindstedt had overheard from Bryan Reo wouldn't attend the trial the day before. Bryan Reo has admitted that Pastor Lindstedt never used the terms "homosexual incest" or "transgendered prostitute" in referring to Bryan Reo's father or wife and Pastor Lindstedt has presented evidence of Bryan Reo fraud in Reo's bogus civil complaints. Bryan Reo has gotten summary judgment on elements of three of these bogus federal proceedings.

17. Bryan Reo has initiated litigation in Newton County Missouri and in Stanley County South Dakota on its Lake County judgments against Pastor Lindstedt and Lindstedt's Aryan Nations Church. Bryan Reo is also suing not only Pastor Lindstedt but Pastor Lindstedt's sister Susan Bessman in Stanley County South Dakota for "illegal transfer" of Pastor Lindstedt's inheritance. Bryan Reo had bought a spurious \$4000 judgment for Pastor Lindstedt seeking a Missouri Sunshine Act Enforcement Action (under the open records act, filing a lawsuit seeking records cannot result in sanctions against the whistle-blower – but it did) from the City of Granby for \$1000 and gave notice, confirmed over the Columbus Day 14 Oct. 2019. The very next day 15 Oct. 2019 the City of Granby without due-process or court order proceeded to send a bulldozer to shred the grass and small trees of Pastor Lindstedt's and Roxie Fausnaught's and niece and

nephew's properties in Granby. Around 12:30 pm on 15 Oct. 2019 Pastor Lindstedt seriously considered shooting these Granby city council-criminals and employees and police but decided to hold off until he could transfer his property and the person chosen instead of Pastor Lindstedt's Church, (Roxie was ailing and very sick) was Pastor Lindstedt's sister. Pastor Lindstedt chose to fight Bryan Reo's request for permanent injunction on transfer of the property and at a 31 Aug. 2020 evidentiary hearing Bryan Reo and Attorney Konrad chose to lie about the facts and law of this matter. The matter is presently on appeal before the South Dakota Supreme Court albeit because Pastor Lindstedt has been ailing and all of this Bryan Reo litigation pending Pastor Lindstedt is late in filing an appellate brief. For the past two months, Bryan Reo and Attorney Konrad have been conspiring to have Susan Bessman violate Judge Meyer's injunction to transfer by setting up some sort of arrangement by which she sells the \$2 million inheritance to someone approved by Bryan Reo and lawyer Konrad and receive a mere "six-figure reward" for doing so.
