DEFENDANT’S BRIEF IN RESPONSE TO BRYAN REO MOTION (Doc. 60) FOR ORDER COMPELLING PASTOR MARTIN LINDSTEDT TO CENSOR HIMSELF IN VIOLATION OF THE FIRST AMENDMENT TO HIDE BRYAN REO ACTIVITY AS AN ANTIFA AGENT PROVACATEUR

NOW COMES Pastor Martin Lindstedt (“Plaintiff”), *pro se*, to make a Response to Plaintiff Bryan Reo’s Verified (by itself) Motion (Doc 60 filed and later mailed allegedly on 1 Jan. 2021) for this Court to further destroy its legitimacy by censoring and jailing for contempt of a “gag order” foolishly made by this Court on 28 Sept. 2020 (Doc. 44 & 45) from which this Court verbally backed off of on 30 Nov. 2020. Now given that *of course* a long-time non-white homosexual antifa federal agent provocateur (known in the White Supremacist & Christian Identity anti-government Movements as “ZOGbots”) still working with the collection of pretend “white supremacists” – the same ones behind Charlottesville 1.0 in August 2017 and the Glorious Sixth of January 2021 / Charlottesville 2.0 will insist that even public records such as

court filings from this Northern District of Ohio and state courts and press interviews like given to a reporter from the Cleveland Plain-Dealer is somehow censorable because it mentions the paranoid and psychotic homosexual mongrel ZOGbot Bryan Reo going about its business of “lawfare” against genuine White Supremacists and Dual-Seedline Christian Identity Aryan Nations clergy living 900 miles away. This same federal district court in two of the Bryan Reo cases against Pastor Lindstedt, *Bryan Reo v. Martin Lindstedt* 19-cv-2589 and *Stefani Reo v. Martin Lindstedt*, 19-cv-2786 has recommended that Bryan Reo claims for a permanent injunction be denied simply because Mag. Parker understood that if they foolishly followed the course of Judge Oliver the end result would be that their court would be inundated with Bryan Reo reports for censorship of Pastor Lindstedt and Lindstedt’s Aryan Nations Church for everything and anything this crazed delusional psychotic homosexual mongrel working as an agent provocateur would apply. Instead, by making this decision Bryan Reo is *of course* filing motions to hold Pastor Lindstedt acting upon the dictates of Dual-Seedline Christian Identity policy of disallowing non-white homosexual jew spawn of Satan to infiltrate the Aryan Christian Israelite Body of Christ by exposing such whenever possible using the publications of Pastor Lindstedt’s Aryan Nations Church. In short open public censorship by this Court acting as the judicial arm of combating genuine white supremacy by going against an Aryan Nations Church and pastor means that Bryan Reo is an open non-white homosexual commissar acting upon the allowance of a negro federal judge to destroy the racial religious and political speech of an open White Supremacist Dual-Seedline Christian Identity Church pastor who is in effect the ArchBishop not only of Missouri 900 miles away, but also the *de facto* and by this federal district court’s workings under color of its judicial decree ArchBishop over the entire ZOGland.

Bryan Reo is and has been not only a delusional psychotic homosexual mongrel of probable jew origin pretending to be a pure blood Aryan Christian Israelite but has been and is an admitted agent provocateur who with another jew pretending to be Christian Identity reported along with another jew named Eli James / Joseph November to the Chicago FBI on Pastor Lindstedt and some Internet trolls known as NIM-Busters on 28 Nov. 2010 a month after breaking its deal with Pastor Lindstedt to leave the Movement in return for Pastor Lindstedt not reporting any new material if there was none to report. Bryan Reo went on to help found the Foundation for the MarketPlace of Ideas (FMI)) along with fellow antifa lawyers Attorney Kyle Bristow and Brett Klimkowsky) a white supremacist :lawfare” NGO which staged Charlottesville 1.0. See Doc. 47-1 FMI 501(c)(3) 2017 IRS Tax Form for a listing of Officers, Including Charlottesville 1.0 inciters Richard Spencer and Mike “Enoch” and moneys spent on Charlottesville 1.0 in August 2017. Thus like Charlottesville 2.0 on the Glorious Sixth of January 2021 which will go down as the firing shot for the Second Civil War, antifa agents provocateur like Bryan Reo, Kyle Bristow and Brett Klimkowsky are used to incite and provoke what will turn out to be a violent riot and “insurrection” in which like the Prez-o-dint Trump and others get blamed for the violence and destruction which agents provocateurs like Bryan Reo incited.

What Bryan Reo is asking for this Court to do is to destroy evidence under color of law going back since 2003 about Bryan Reo as a non-white delusional psychotic homosexual working as a federal agent provocateur in order to incite wannabe ‘white supremacists’ from the safety of the Internet (As there is no way anyone In Real Life thinks Bryan Reo is remotely pure white, hence only by anonymous Internet cocontact can Bryan Reo pass muster.) This is why when on 29 Oct. 2010 when Pastor Lindstedt discerned that “SwordBrethren” was Bryan Reo the Mamzer from Mentor Ohio that Bryan Reo offered a deal in which in return for not posting

further Bryan Reo material on Pastor Lindstedt's Aryan Nations forum that Bryan Reo would not provide reason to post further material but rather remove itself from pretending to be a white supremacist in general and a DS-CI sub-pastor under Eli James and William Finck. Bryan Reo kept this agreement for all of four days and then on 5 November proceeded to break the deal by republishing on the "SwordBrethren Blog" on Baal Finck's Christogenea.org blog. See Anthony Reo v. Martin Lindstedt 19-cv-2615 Doc. 32-1 Pages 400-408, "Rabbi Lindsteneh: Race Traitor Or Jew" (Originally Doc. 24 filed 22 Apr. 2015 Reo v. Lindstedt 3:14-cv-5093-MJW WDMo)

Bryan Reo is also – as a licensed lawyer – non-parilel at dragging before a hostile regime court Pastor Lindstedt and His Aryan Nations Church before a corrupt Lake County Court and negro and gliberal *lynch-mob* jury and corrupt judge so that the jurisdictional barriers which maintain racial and religious political peace can be breached and battened down so that White Supremacist and Christian Identity Warlords can have a causus belli to chernobylize an ailing obsolete nuclear power plant and devastate an entire racially treasonous region hostile to White People. Ever since Bryan Reo filed against the Church of Jesus Christ Christian / Aryan Nations of Missouri and Lindstedt's bed-bound elderly illiterate woman Roxie Fausnaught in early Jan. 2016 before the Mentor Municipal Court and then it was transferred to the Lake County Ohio Court, then the crooked judge Collins ruled – as do ALL of you Satanic corrupt ZOG-korts that neither Churches nor People may be defended by their Men because as a Satanic policy Satan's Servants the lawyers have granted to themselves a fraudulent patent of nobility, then committed the Sin of Sodom, Gomorrah, and the other Three Cities of the Plain of False Dominion Under Color of Law. These Sodomistical Cities around the Dead Sea circa 2000 BC around the time of Abraham were not Canaanite but Adamic whigger and being ever so rich from living around what became the Dead Sea decided to extend their fraudulent jurisdiction over travelers living a

half-day away on the caravan route between the Red Sea and Mesopotamia. So they would, like these courts in Ohio today in order to oppress “White Supremacy” and “Dual-Seedline Christian Identity” go out onto the caravan route and bring in strangers to rob and murder under color of their “rule of law.” After engaging in this judicial “highway robbery” with Abraham’s servant Elieazar, of judicially executing Lot’s righteous daughter Palthiel, and some other people YHWH sent Jesus Christ and the ArchAngel Michael to destroy Sodom & Gomorrah and the other Cities of the Plain, except that there be enough righteous men to overthrow these city regimes and restore Righteous Judgment. There were no righteous men, only self-righteous homosexuals like Bryan Reo who proceeded to try to rape Jesus Christ and Archangel Michael, so upon hustling less-than-righteous Lot and his two daddy-loving daughters and the wife who looked back and telling them to keep running for the hills, Sodom & Gomorrah was burned with fire and brimstone and the lake turned into the Dead Sea.

Which is what needs to happen to Northeastern Ohio. Sin like Sodom and Gomorrah, die like Sodom and Gomorrah. There simply is no living in Peace with you evil and degenerate and ungodly unrighteous People so you all must die and the rest live in a wasteland simply because you as a policy couldn’t let those who want no part of you live in peace. Within the next few years the North Perry Nuclear Power Plant needs to be chernobylized so that no area of the country will ever be able to drag those not under its rightful jurisdiction to face a foreign “justice” ever again. This doom came upon this rogue area of the country when it decided to start the Second Civil War against “white supremacy” and “Aryan Nations” 900 miles away by letting Bryan Reo, and the rest of the antifa lawyers Bristow and Klimkowsky oppress Pastor Lindstedt, Lindstedt’s woman and Lindstedt’s sister and Lindstedt’s Aryan Nations Church.

Accordingly, ever since Bryan Reo was allowed to transfer its lawsuit against Pastor Lindstedt's Church of Jesus Christ Christian / Aryan Nations of Missouri from the Mentor Municipal Court (which did not want or recognize jurisdiction for Pastor Lindstedt's Aryan Nations Church web page getting Bryan Reo fired as an internal security risk from the North Perry Nuclear Power Plant and maybe saving this area from a delusional psychotic homosexual mongrel ZOGbot) **to Lake County Court of Common Pleas which ruled that non-lawyer Pastor Lindstedt could not defend his woman nor Church a Writ of Sodomification has been granted by an ecclesiastical court to where the North Perry Nuclear Power Plant is to be chernobylized preferably with Bryan Reo and its family at the controls.** The chernobylized area is to become the "reservation / ghetto" for the blacks and jews and non-whites of the former ZOGland as the capstone final solution of the Second Civil War. No area of the former ZOGland will ever be allowed to oppress YHWH's Servant Nation of Aryan Christian Israel outside its borders and there will be true consent of the Sons of Aryan Christian Israel split up into local tribes choosing confederation.

Exhibit #1 contains a Verified Statement in response to Bryan Reo's lies of 1 Jan. 2021 (Doc 60, 60-1, 60-2). **Exhibit #2** shows that Bryan Reo has been allowed to file 16 lawsuits in Lake County Ohio against Pastor Lindstedt and Lindstedt's Aryan Nations Church. **Exhibit #3** will show that the Ohio 11th Court of Appeals has dared to claim their fraudulent jurisdiction over Pastor Lindstedt's Aryan Nations Church, thus precipitating this Second Civil War. **Exhibit 4** is the Sept. 28 Interview with the Cleveland newspaper reporter that Bryan Reo mentions.

Bryan Reo as a non-white homosexual ZOGbot has been allowed by the federal and state governments to not only infiltrate the genuine White Supremacist and Christian Identity Resistance groups but when thwarted by being called out by the genuine native leadership of

those organizations who do not recognize these Satanic regimes as legitimate for not being white or sexually normal and for being an agent provocateur then Bryan Reo has been allowed to “lawfare” to penury Pastor Lindstedt and Lindstedt’s Aryan Nations Church, to harass Pastor Lindstedt’s woman more quickly to her death, and to try to destitute Pastor Lindstedt’s sister. Now Bryan Reo wants this federal court to finish off the myth of the CONstitution and Bill of Goods by jailing Pastor Lindstedt for speaking the truth in open contempt for this Satanic regime and its kangaroo courts. Bryan Reo as an officer of this Court shows why there can be no compromise with the Evil One and its children nor its government. This is why entire areas of this continent need to be destroyed by fire and sword, its Babylonian System eliminated, and the rest of YHWH’s Servant Nation having no LORD but Jesus Christ. Pastor Lindstedt will fight on

Answering Bryan Reo Lies to Destroy the First Amendment Rights of Pastor Lindstedt to Document State-Sponsored Agent Provocateur domestic terrorist Bryan Reo public conduct and past history of lawfare.

Bryan Reo quotes to his advantage the unconstitutional finding of this Court to perform a blanket act of censoring Pastor Lindstedt’s Aryan Nations Church’s publishing public records regarding Bryan Reo “lawfare” litigation against Pastor Lindstedt and Lindstedt’s Aryan Nations Church absent any real or legitimate jurisdiction and showing that Bryan Reo has been acting as an agent provocateur and state-sponsored terrorist to infiltrate and disrupt white supremacist and Christian Identity above-ground organizations acting as the political forces to justify reactionary acts of racial survival of the American White People that this Satanic Mighty Evil Empire is out to destroy. As a delusional non-white homosexual mongrel of partial negroid and jew descent and known agent provocateur infesting the pretend online white supremacist Internet Movement

working in tandem with a negro federal judge to get a ruling that without benefit of a jury trial under color of a self-serving interpretation of the Federal Rules of Civil Procedure (hereafter FR CivP) and upon continual refusal on both Bryan Reo's and Judge Oliver's part to show actual computed damages according to FR CivP Rule 26 (a)(1)(A)(iii) Initial Disclosures and refusal by Judge Oliver to insist upon obedience of Local Rule 37.1 by Bryan Reo to work with Defendant to show how Pastor Lindstedt and Lindstedt's Aryan Nations Church has harmed Bryan Reo other than to notify those in the White Supremacist and Christian Identity Movements that Bryan Reo is a delusional homosexual mongrel working as an agent provocateur and informant. In fact Bryan Reo's litigation in all the 16 to 20+ cases against Pastor Lindstedt and Lindstedt's Church since April 2014 has consisted of Bryan Reo making complaints as to what is posted over the Internet such as public records and e-mails and threats and Bryan Reo activity in the public sphere yet all Bryan Reo is able to do is to file motion after motion to strike or for summary judgment and to use "lawfare" against Pastor Lindstedt and Lindstedt's Aryan Nations Church. Judge Oliver has in fact "found" that Pastor Lindstedt is guilty of something or another not upon the weight of the evidence or due process but rather because of alleged violations of the Federal Rules of Civil Procedure. Now Bryan Reo insists before the matter is resolved and thus cannot be appealed for now – according to Doc 58 – that any evidence be destroyed via the unlawful "gag order" imposed by Judge Oliver which is the very opposite of the purpose of discovery. Thus supposedly because Pastor Lindstedt didn't provide discovery according to Bryan Reo's notions then evidence of Bryan Reo misconduct is to be removed from Pastor Lindstedt's Church's web page even though most of it is public court documents !!! In short an unworkable and lawless decision by Judge Oliver is to be extended to whatever Bryan Reo wants to complain about. Thus Bryan Reo as an informant and agent provocateur who can't pass as white or

heterosexual is making this Court its bitch and trying to make this Court abandon all pretense of obedience to the First Amendment or due process of law as proceedings veer to open civil war. Pastor Lindstedt denies that this federal court had any business in granting Bryan Reo such a “gag order” in violation of the very same scrap of worthless toilet paper from whence it claims legitimacy or jurisdiction over Pastor Lindstedt and Lindstedt’s Aryan Nations Church. In any case, protecting the “rights” and privileges of Pastor Lindstedt’s racial religion by destroying any men or their form of tyranny to where agents provocateur – especially the non-white and perverted ones at that are kept out of the Body of Aryan Christian Israel – is up to Pastor Lindstedt and every other lawful Aryan Christian Israelite to destroy those who would oppress us

Bryan Reo makes reference to Pastor Lindstedt being aware of Judge Oliver’s ORDER granting Bryan Reo summary judgment “just because” the evening of 28 Sept. 2020 just as the Day of Atonement was ending because a Cleveland Plain Dealer called Pastor Lindstedt’s landline number written in these papers. **Exhibit #4**, Pastor Lindstedt’s Church’s web page has a two-page printout of the recorded interview which the Plain Dealer probably didn’t print. Pastor Lindstedt said that it was *Dred Scott v. Sandford* for the Second Civil War stupidly brought by a homosexual negroid ZOGbot by a negro judge who have nothing but hatred for White Christian Men and thus there simply is no living in peace with certain sections of the country – certainly not with Northeast Ohio vs. Southwest Missouri. Eventually a civil war which would have to morph into extermination would take place. Chernobyling the North Perry Nuclear Power Plant has been advocated and mentioned since Feb. 2016 when Bryan Reo was filing bogus Civil Stalking Protective Orders against Pastor Lindstedt knowing that Pastor Lindstedt couldn’t and wouldn’t afford to go 900 miles to challenge this lying nonsense. While answering this Bryan Reo litigation Pastor Lindstedt found out that Bryan Reo got fired as an “internal security risk”

because after a series of nuclear accidents the operators of the nuclear power plant did a goggle search and found out from Pastor Lindstedt's Church web pages that Bryan Reo was a delusional psychotic homosexual mongrel pretending to be a white supremacist since 2003. That Bryan Reo as "SwordBrethren" has posted on the white supremacist Stormfront web forum about being followed by the FBI/BATF and how Reo was going to "whack & stack" up federal and local police and how the FBI / BATF wanted Reo to become an informant (which in other times and places Reo admitted to being).

When the Cleveland newspaper reporter called in around sunset the evening of 28 Sept. 2020 Pastor Lindstedt was finishing observing the Day of Atonement in fasting and prayer and thus close to YHWH and YHWH's Law. The reporter knew of and followed these Bryan Reo cases and quoted from this Court's ORDER (Doc. 44 & 45) especially given this Court's gag order giving Bryan Reo the power as a federal agent provocateur to cover up its incitements and provocations – which Bryan Reo would of course take advantage of. However by these state and federal courts allowing their non-white homosexual police agents to essentially have free reign over the genuine White Supremacist political and religious leadership and for Bryan Reo and his ZOGbot lawyer friends to oppress Pastor Lindstedt's woman and sister then this creates a civil war free-fire zone in which a successor theocratic series of local military dictatorships / warlords can exterminate the jews and non-whites, enslave and castrate not only race-traitor whiggers along with their entire friends and families, and in the case of NorthEastern Ohio use the aging and mismanaged North Perry Nuclear Power Plant as a low-yield nuclear weapon and under threat of chernobyling the rest of the nearly hundred nuclear power plants force the unconditional surrender of the local state regimes to achieve depopulation and reservationalization of the non-whites and extermination of the jews. The newspaper reporter went from gloating about Pastor

Lindstedt being censored and how this matter would be reported as a triumph over white supremacy to saying that likely this story would not be published given that this ailing nuclear power plant is now a target of destruction by those who follow the Aryan Nations belief or simply hate the current system, This paper refused to print this interview so Pastor Lindstedt posted it not only on his Aryan Nations Church forum but a number of allied locations.

Bryan Reo as a homosexual mongrel ZOGbot trying to infiltrate genuine underground white supremacy fails to understand the nature of both the Internet and of what it is trying to infiltrate. In the past 20 years of trying to pretend to be what it isn't – Aryan White Heterosexual “leader” of white supremacists and Christian Identity men – no one has been fooled. Everyone associated with Bryan Reo has been outed as a mongrel or jew or homosexual or ZOGbot and no one who is the real article has been fooled. Bryan Reo working for this Satanic criminal regime has been successful in taking down dozens of Pastor Lindstedt's Church's web pages both in the ZOGland and abroad. Pastor Lindstedt got so that he backed up his work several times per week and had them on secret forums which would pop up all over the place. Bryan Reo's attempts to scrub the Internet has raised the number of Bryan Reo posts when Bryan Reo cut a deal it never intended to keep from around 30 – most of them hidden away until Bryan Reo started suing – to over 300+ plus tens of thousands court papers in the various state and federal courts. Now the Pres-o-dint Trump is censored along with thousands of others by the mainstream media and social media tech giants and millions are having to understand how evil this pretend Mighty Evil Empire out to destroy them as a White People is and that they have to destroy it and those who do its Satanix purpose. Thus Bryan Reo has been an unprofitable crazed delusional homosexual mongrel ZOGbot, rather raising the hatred, contempt for these corrupt courts and an raising the hatred level against jews, non-whites, sexual perverts, and judges, lawyers, police officers and

politicians. Bryan Reo's demands that this Court destroy what little remains of its legitimacy by a wholesale destruction and censorship of public records displayed throughout the Internet just to please the whining of a paranoid crazed delusional homosexual mongrel agent provocateur and to punish peaceful-for-now racial, religious political dissent and to jail Pastor Lindstedt for a refusal to comply means that every other authoritarian regime running their internal affairs for the good of their people as opposed to this jew-run Mighty Evil Empire out to destroy the White People as slaves will ridicule the pretensions of their faltering criminal regime pretending to be for freedom and liberty. Most of the Bryan Reo material is located in a subforum concerning Bryan Reo and Bryan Reo fellow ZOGbot activity from the FMI ZOGbot operation. However, this federal criminal regime has infiltrated the above-ground Internet-based White Supremacist and Christian Identity Movements since the 1970s and before there was an Internet. Thus in warning the average ZOGling whigger to avoid these ZOG False-F[]ag operations articles tying in Bryan Reo to these operations all over the Internet means that this Court will either have to overtly outlaw Pastor Lindstedt and Lindstedt's Church by openly jailing Pastor Lindstedt and taking down his Church web page in order to satisfy Bryan Reo, if possible. Looking at Bryan Reo Exhibit 60-1 has Bryan Reo printing up the first 25 of 117 threads in which Bryan Reo is mentioned – however tenuously and in passing on Pastor Lindstedt's Church's main open forum and not allied and secret reserve forums and web pages. Looking at the threads most of them are in the "Bryan Reo vs White People" subforum. However, given that this Aussie tranny-poofter playing See-Eye Dentist for the past dozen years named Robert Hancock who manages a warehouse for the Australian chinks who is a homosexual mongrel nearly as nutty and paranoid as Bryan Reo was likewise trying to get Pastor Lindstedt and his genuine Aryan Nations Church

likewise censored from Melbourne Australia means that Bryan Reo has deep deep roots within the Satanic ZOG state-sponsored domestic terrorism apparatus against White Christian Israel.

This is why Pastor Lindstedt had no choice as a Man of YHWH, the First Servant of YHWH's Servant Nation other than to warn unwary ZOGling whiggers about jew, mongrel, homosexual and even whigger agents provocateur infesting the white supremacist and Christian Identity Resistance Movements. Bryan Reo is merely as both jew and mongrel and homosexual and delusional and psychotic merely the most overwhelming of the sorry lot. Quite a few people knew Bryan Reo had a past history as a homosexual mongrel activist for Richard Barrett, who was himself a homosexual ZOGbot who kicked Bryan Reo to the curb because it wasn't even remotely white. "Bryan Reo will have to accept the fact that since he isn't white that he has no place within white nationalism" quoth Dickie Barrett Esquire in 2004. Bryan Reo put pressure on Richard Barrett but because Dickie Barrett was a lawyer and a ZOGbot that quote didn't disappear until after a year had passed after Dickie got knifed by a prison negro homosexual who knifed Dickie and set fire to his house and Dickie wasn't around to pay for the server hosting keeping that Bryan Reo item up on the Internet.

Likewise Everett "Buck" McHugh lost his stockbroker license and \$2.5 million and refused to warn the Movement about Bryan Reo, giving only superficial details as to Bryan Reo insurance fraud, love of MMA fighting, that Reo looked like an effeminate Puerto Rican mongrel and that Bryan Reo went to a Jesuit College. When challenged in April 2013 as to why McHugh hadn't given to Pastor Lindstedt the actual name and location of Bryan Reo, just several pages of superfluous details, Buck McHugh claimed that he didn't want to get in trouble with the Movement by revealing Bryan Reo directly. Both Bryan Reo and John Britton – who Bryan Reo homosexually stalked and tried to blackmail made twice or three times deals with Bryan Reo to

withdraw what they knew of Bryan Reo just to see *Bryan Reo violate these agreements every single time*. Once they removed Bryan Reo material by pressuring their friends to do so their friends in almost every single instance would refuse to put it back up once Bryan Reo violated their deals. This Bryan Reo material is part of the material that Bryan Reo is asking to be removed wholesale by this court. Bryan Reo has been involved as an antifa activist along with his lawyer friends and Richard Spencer and Mike Enoch on the supposedly dissolved Foundation for the MarketPlace of Information (FMI) since 2003 and through to Charlottesville 1.0 in August 2017 while in litigation against Pastor Lindstedt and Lindstedt's Aryan Nations Church and to this very day as part of the FBI ZOGbot antifa leaders who the Capitol Hill police let inside the Capitol Building as part of the color coup against Donald Trump and his MAGA-tards Thus Bryan Reo with all of its lawfare against Pastor Lindstedt and Lindstedt's Church is the most successful enemy against YHWH's Servant Nation of Aryan Christian Israel

Lastly, regarding Bryan Reo's self-sworn statement as Doc 60-2. Bryan Reo has not denied that if it had kept its agreement of four days duration after detection by name and past history as a non-white homosexual ZOGbot from the First to the Fourth of November 2010 and then taking down Pastor Lindstedt's Church web pages and then those of others then in 2014 embarking in a "lawfare" state-sponsored domestic terrorism campaign in the Satanic regime courts both state and federal – that Bryan Reo could be just another one of 100,000 negroid homosexuals still

working at the North Perry Nuclear Power Plant or filing fraudulent litigation under the Telephone Consumer Protection Act (TCPA) by calling up its victims and being a genuine antifa / BLM racial rioter as opposed to pretending to be a white supremacist ‘ Dual-Seedline Christian Identity lawfare litigator operating ZOG false-flag operations like Charlottesville 1.0 and 2.0 / 6th of January Riots.

See Anthony Reo v. Martin Lindstedt. 19-cv-02615 Doc. 32-2 pgs 400-408 from Reo v. Lindstedt 3:14-cv-05093 (WDMo) Doc 24 & Doc 24-1.

Thus Bryan Reo could have avoided 95% or more of this Bryan Reo information coming out publicly concerning its work as a delusional psychotic homosexual mongrel agent provocateur if only Reo had kept an agreement that it sought out and made once detected under its real name and address by Pastor Lindstedt at the end of Oct. 2010 that it only kept for four days. Bryan Reo thus could have avoided any “damages” whatsoever by not providing new material of ZOGbotting by simply getting on with its life as a homosexual mongrel no longer

infiltrating above-ground Internet based white supremacy and Christian Identity. Instead, this Court, along with the Lake County Ohio Court and Stanley County South Dakota Courts have exposed their government workers, fellow lawyers, law enforcement into traitors against the People and in deliberate violation of the toilet-paper protections of free speech religion in a free society in order to spy upon, then destroy White racial and religious dissent.

Pastor Lindstedt has nothing but contempt for this Satanic System, its government, its courts, its mass-media, for the non-white population but nothing but love for YHWH’s Servant Nation of Aryan Christian Israel and obedience to YHWH’s Law. Thus YHWH’s Law as witness the Judgment of Sodom & Gomorrah mandates that the North Perry Nuclear Power Plant be chernobylized so that no area of the Empire can go well outside its jurisdiction to try an Aryan

Nations pastor and His Church for what was said in response to a known infiltrator. Northeastern Ohio needs to be destroyed for starting a Second Civil War in which they choose to punish an Aryan Nations pastor and his Church for speaking as they please in Missouri. The entire legal system of Northeastern Ohio and of South Dakota need to be exterminated and enslaved for using their spurious compact to go after the lives, property and freedom of those who never consented to their usurped jurisdiction. Bryan Reo should not have been given summary judgment. Bryan Reo shouldn't have been given a gag order by this Court. Bryan Reo suffered no damages that it couldn't have avoided if only it had kept an agreement to stop pretending to be a white supremacist and Christian Identity sub-pastor it sought out then broke after four days once detected by Pastor Lindstedt. Therefore, this latest request by Bryan Reo to have this Court jail Pastor Lindstedt for civil contempt should be denied and this case by Bryan Reo and the rest of the Bryan Reo litigation before this federal court have Pastor Lindstedt granted summary judgment to Pastor Lindstedt against Bryan Reo and the rest of Bryan Reo's family, fellow lawyers and the governmental defendants who have started this Second Civil War by spying on and oppressing under color of law Pastor Lindstedt, Lindstedt's Aryan Nations Church, and sister.
