**DEFENDANT’S BRIEF IN RESPONSE TO MYTHICAL BRYAN REO DAMAGES RESULTING FROM REO SUCCESSFUL NEVERENDING LITIGATION AGAINST PASTOR LINDSTEDT GAINING SUMMARY JUDGMENT & REITERATING JURY TRIAL DEMAND**

NOW COMES Pastor Martin Lindstedt (“Plaintiff”), *pro se*, to make a Response to Plaintiff Bryan Reo’s Brief concerning Bryan Reo’s mythical damages that could have been avoided if only Bryan Reo had kept an agreement made just after Halloween 2010 after being detected as “SwordBrethren” = Bryan Reo of Mentor Ohio, long time homosexual mongrel agent provocateur (the Resistance terminology actually used was “mamzer faggot ZOGbot”) in which Pastor Lindstedt wouldn’t put up anything more about Bryan Reo if Bryan Reo would leave the White Supremacist and aboveground Christian Identity Movements and this time leave for good. Bryan Reo made such agreements before, particularly with Richard Barrett, Everett “Buck”

McHugh and John Britton and violated such agreements every single time. Five days later Bryan Reo broke said agreement by reprinting an Eli James article on Reo's SB Blog on William Finck's Christogenea.org forum calling Pastor Lindstedt a "Child molester" twenty-some times and convicted at that 9 times and ever since then there has been name calling to this very day between the two parties and litigation since 2014. Judge Oliver saw fit to grant summary judgment to Bryan Reo and Bryan Reo wants everything Pastor Lindstedt got from winning this "justice lottery" in the Ohio state and federal courts. Pastor Lindstedt wants to in return have the victorious White Supremacist warlords put Northeast Ohio to the sword and enslave the ex-whigger survivors and irradiate the state by chernobyling the North Perry Nuclear Power Plant and maybe the Columbus one as well. But in this filing Pastor Lindstedt disputes any and all Bryan Reo idiotic claims to having any damages whatsoever that could have been avoided by simply leaving the Movement, along with his antifa lawyer friends likewise pretending to be white supremacists, and would rather be tried for these damages by a jury of up to twelve negroes as opposed to being left to the mercy of one negro judge.

Pastor Lindstedt, seeing that he would be destroyed financially by the Ohio state and federal courts, transferred his South Dakota inheritance back to his sister in late October 2019. Since Roxie Fausnaught died on 4 Aug. 2020 there has been no money coming into Pastor Lindstedt's pockets. Since it takes a week to ten days for mail to arrive from Ohio and Priority Mail languishes, Pastor Lindstedt will send this Response via first-class mail and have a copy sent for file-stamping as it is cheaper to use a 55 cent envelope than certified mail which costs \$3. Pastor Lindstedt cannot afford to use PACER until the weekend when there is no more filing. Bryan Reo sent a copy via e-mail to Pastor Lindstedt on 18 Dec. 2020 but Bryan Reo sends

threats all the time through the Internet and Pastor Lindstedt cannot be sure until I see it either in the mail or on PACER.

### **I. COONTROVERTING REO-‘FACTS’**

Bryan Reo makes a number of lies and half-truths as its “Statement of Facts.” In it Bryan Reo engages in making claims that Pastor Lindstedt wrote unflattering things about Bryan Reo as a limited-purpose public figure within the White Supremacist Movement as being a non-white predatory delusional and messed up evil homosexual mongrel ZOGbot. Pastor Lindstedt did indeed publish these truthful things upon his Aryan Nations Church web page(s) since 2010 and even after losing before an Lake County lynch-mob jury consisting of an African female and seven gliberal whigger jurors. In the run up to that trial in a court filing Pastor Lindstedt suggested that Bryan Reo who wanted a delay of those proceedings for the dozenth time should avail itself of an opportunity to visit the “Dr. Joseph Mengele Clinic” in Paraguay or Brazil to get a sex-change operation & pelt bleaching and like Michael Jackson become what Reo always wanted “to become a white woman”. That way Reo could get all the Aryan pecker it wanted right up its mangina instead of just having to rely on its fellow Foundation for the MarketPlace of Ideas (FMI/ZPLC) ZOGbot shyster Attorney Kyle Bristow. Normally by putting it in court filings this is supposed to be “priviledged” according to the First Amendment of the Bill of Goods, but neither Bryan Reo nor this judge Oliver thought so.

Insofar as being a predatory blackmailing homosexual of course Bryan Reo is one. Probably the real reason that Bryan Reo as a non-white homosexual ZOGbot bothered with Christian Identity is because real Christian Identity claims to be pure Aryan Christian Israelite. Bryan Reo was stalking some volunteer fireman from Pine Bluff Arkansas on his way to Shrieveport where there was another elderly homosexual and blackmailing “Victor Switzer” was

because “Switzer” impersonated an Aryan. Reo only left him alone when Reo found out about “Switzer’s” full-blood Choctaw grandpa. Likewise with John Britton who Reo stalked and tried to ruin Britton’s lawsuit against a helicopter company. Reo blackmailed Britton and broke deals to leave Britton and McHugh alone but the only thing which made Reo stop was Pastor Lindstedt finding out that Britton’s grandparents were from Northeastern Oklahoma and likely part Indian, so that Reo wouldn’t be getting pure Aryan See-Eye Dentistry man-pussy from Johnny Tonto.

Insofar as Pastor Lindstedt claiming that the Lake County Court of Common Pleas in general and Judge Patrick Condon are corrupt and working with Bryan Reo to steal Pastor Lindstedt’s property and to destroy Lindstedt’s Aryan Nations Church and censor both, that is correct. In fact this judge Oliver has ruled that some form of prior restraint censorship will take place somewhat and somehow although Magistrate Judge Thomas Parker has begged off from that task. Pastor Lindstedt like when Bryan Reo was taking down Church web pages every two weeks back in late 2010 and early 2011 makes backups of his Aryan Nations forum and is parking the backups on other secret allied Movement servers. All this censorship is doing is spreading the content like it was spread back in 2011 waiting for a time to re-appear if ever.

Yes, of course all the ZOGland courts are corrupt. Every single lawyer and judge should be put to the sword and its children enslaved and sterilized if white or simply put to the sword if non-white. Pastor Lindstedt merely acts in accordance with reality and as the First Servant of YHWH’s Servant Nation of Aryan Christian Israel demands and continues to simply go through the motions of filing motions to Reo silliness as an officer of this court who is allowed to run wild because Reo has always been an agent provocateur and with its FMI lawyers and Board of Directors for Charlottesville. So yes, Bryan Reo works with crooked judges in Ohio, Mo., & SD.

Insofar as “impersonating” Bryan Reo on Pastor Lindstedt’s Aryan Nations Church web page is concerned, no one of any sentience should remotely think that the reposts of Bryan Reo e-mails, public utterances on Quora or elsewhere on the Internet, being a public figure on the Board of Directors of the Foundation for the Marketplace of Ideas (henceforth FMI) a white supremacist “lawfare” organization having the Charlottesville Fiasco planned as a false-flag operation to destroy both Trump and above-ground White Nationalism of the Alt-Right (actually Alt-Kike), and state and federal court filings and any other public interest items meet with Bryan Reo’s approval. Quite the contrary, in fact, as both at trial in Lake County Ohio 24-26 June 2019 and at the Stanley County South Dakota evidentiary hearing to determine whether a preliminary injunction would ensure that Pastor Lindstedt’s sister couldn’t further sell or transfer the South Dakota inheritance that Pastor Lindstedt deeded back to her Bryan Reo lied about being a non-white homosexual mongrel wannabe white supremacist and DSCI sub-pastor “SwordBrethren” and plotting with Reo’s antifa lawyer friends Kyle Bristow and Brett Klimkowsky to steal Lindstedt’s SD inheritance since late 2013 or early 2014 using confidential files stolen from Lindstedt’s sister’s Ollinger Law Firm. Bryan Reo wants to have it both ways as a ZOGbot: Stir things up, get a response from Lindstedt (and others) then scrub the record clean by claiming that as one of a hundred thousand nigger faggots in the Cleveland area that Pastor Lindstedt picked on Bryan Reo for no good reason simply because he is an incorrigible white supremacist nutjob.

Bryan Reo sued in federal court under the Digital Millennium Copyright Act (DMCA) for \$10.75 million because Pastor Lindstedt used Reo’s public Facebook profile picture which was Reo’s 2004 Mentor High School picture and of Reo’s Xuqa.com pictures showing Reo with thick negroid liver-lips (Hence Reo’s nickname of “Ol’ Niggerlips”) and looking like a gook and as a beaner with a six-shooter and effeminate. These pictures showed that Reo wasn’t white or

likely heterosexual. Reo filed in the Northern District of Ohio, Judge James Gwinn transferred the case to the Western District of Missouri *Reo v. Lindstedt* 3:14-cv-05093 where Bryan Reo refused to obey Federal Rule of Civil Procedure Rule 26 Initial Disclosures, especially regarding his real damages. In fact, Bryan Reo was given 50 days – 20 for the Magistrate Judge’s dismissal plus and additional 30 days given – to show that Bryan Reo has been damaged \$75,000 worth. Bryan Reo couldn’t show any damages then (or now) and had the case dismissed. Bryan Reo then ran to Lake County Ohio court and “won” a judgment against Pastor Lindstedt and Lindstedt’s Aryan Nations Church before a lynch-mob jury and crooked judges who allowed this bogus case to proceed absent any legitimate jurisdiction. Both the Ohio state and federal courts believe that they have a “right” and a “duty” to punish White Supremacist Christian Identity pastors and an Aryan Nations Church for making fun of a crazed delusional homosexual mongrel ZOGbot trying to pretend to be a white supremacist one day over the Internet and a poor oppressed negroid homosexual who was just minding its own business of calling Pastor Lindstedt a child molester whenever it is before a corrupt regimeist court the next.

Bryan Reo’s Avatar on Lindstedt’s Aryan Nations Church forum is that of a female African green monkey with a “Xuqa.com” trademark. Bryan Reo having sued Pastor Lindstedt over using the Facebook pic of Bryan Reo Pastor Lindstedt decided to post the monkey’s picture allegedly taken by “accident” that was the source of a DMCA complaint which was settled by a judge ruling that only the she-monkey had standing to sue given that it was a self-portrait. Pastor Lindstedt sees the family resemblance to the Reo family but the African monkey looks smarter.

This court has already ruled that Bryan Reo can’t collect for “emotional damages” or for stating that Bryan Reo is a homosexual already. The rest of the summary judgment is based upon Pastor Lindstedt posting public knowledge about Bryan Reo and while this particular judge

doesn't want to rehash his unlawful granting of summary judgment based upon Pastor Lindstedt's "admissions" even though denied three separate occasions and because this judge chooses not to allow Pastor Lindstedt to withdraw these "non-admissions" as Rule 36 "admissions." Thus Pastor Lindstedt chooses to have a jury of up to twelve Cleveland negroes figure out the "damages" – if any (and there are none) – as opposed to having one negro judge who has already screwed over Pastor Lindstedt and Lindstedt's Aryan Nations Church to decide.

## **II. Bryan Reo's Mythical Damages and absent evidence never produced via Rule 26**

Bryan Reo wants \$250,000 in compensatory damages – even though Bryan Reo cannot and will not compute them as required by FRCP Rule 26(a)(1)(A)(iii) either in Reo's initial complaint or during Reo's fraudulent Brief for Damages today. (Sent to Pastor Lindstedt via e-mail on Dec. 18<sup>th</sup> 2020 @ 9:16 am and Pastor Lindstedt hasn't gotten the paper copy yet in the mail which is running 8 days to 11 days after mailing.) Bryan Reo wants \$500,000 in punitive damages simply because Bryan Reo wants Pastor Lindstedt punished for contempt of mamzer.

### **2. Bryan Reo "Evidence"**

**a. Documentary Evidence.** Sundry screen shots taken from Pastor Lindstedt's Aryan Nations Web Page of public information concerning public-figure & agent provocateur Bryan Reo which is irrelevant given that this judge ruled for summary judgment not on the facts or evidence but rather on how Pastor Lindstedt even though denied three times Bryan Reo's complaints didn't obey the Federal Rules of Civil Procedure as Judge Oliver wanted even though Bryan Reo doesn't obey the Federal Rules of Civil Procedure when inconvenient either.

**b. Witnesses.** Bryan Reo, Bryan Reo's alleged spawner who Pastor Lindstedt mistook for a homosexual mongrel lover of Bryan Reo and never ever spoken to at all, & Pastor Lindstedt.

**II. Invasion of Privacy.** Bryan Reo yaps the same stuff as for Count I – Defamation. This matter is even more tenuous and ridiculous given that as before, Bryan Reo could have simply left pretending to be a white supremacist after detection in late Oct. 2010 as agreed. Instead Bryan Reo insisted on being one of the homosexual mongrels in the “Alt-Right” working as a state and federal agent provocateur and taking down Pastor Lindstedt’s Aryan Nations Church web pages starting in Nov. 5 2020 and filing a dozen or so federal and state lawsuits in Ohio, Missouri and South Dakota trying to steal Pastor Lindstedt’s property and destroy as well Pastor Lindstedt’s sister now simply because Pastor Lindstedt chose to warn the aboveground white nationalist movement and the world in general about Bryan Reo and Reo’s lawyer friends and those who instigated the Charlottesville Fiasco to take down Trump as well.

Reo also claims to have a “therapist” and “therapy records” as evidence. Bryan Reo has as a self-loathing homosexual mongrel pretended to be a “SwordBrethren” “Aryan Teutonic Crusader” and “White Supremacist leader and thinker” and both Eli James’ & William ‘Baal’ Finck’s Dual-Seedline Christian Identity sub-pastor even though both these jews playing See-Eye Dentistry knew “SwordBrethren / Bryan Reo was a crazed delusional homosexual ZOGbot as well.
