

WILL & ASSIGNMENT OF GUARDIANSHIP

• COMES NOW Pastor Martin Lindstedt, getting his affairs in order to make his only Will and Testament to make the following declarations:

1. All of his personal property, papers and real estate in Granby Missouri is to go on the event of his death or disability to the custody, control and ownership of his sister Susan April Lindstedt Bessman who is hereby the executor and sole beneficiary of his estate. Roxie Fausnaught is bedbound and in worse physical condition than Pastor Lindstedt. Pastor Lindstedt's one-third interest in the 18 acres remaining on the farm at Bacon Ridge Road just outside the city limits of Granby with the house and well are hereby also granted to Susan Bessman. The property at 338 Rabbit Track Road and 337 Rabbit Track Road is owned along with Roxie Fausnaught, and Martin's half goes to Susan. 5. Susan is asked to take care of Roxie Fausnaught as needed living in 137 S. Hillcrest if Roxie survives myself and only gets SSI or less. This is a moral, not legal obligation.

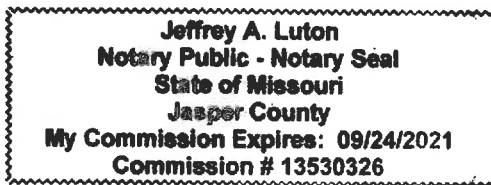
