This Ohio Supreme Court Notice of Appeal comes from a farcical trial on 24-26 June 2019 which happened after Bryan Reo lost its first federal case involving Pastor Lindstedt finding out that "SwordBrethren" on the Internet trying to bring in one bad-tempered jew named William Finck as a Greek Scholar and Christian Identity Pastor who murdered in the Jersey City Jail one Puerto Rican sneak thief named Arnauldo Ortega and got three other jailers to do so as well. Finck got off in the New Jersey courts but the negro and Puerto Rican community agitated for federal civil rights court action and Finck 'fin[c]ked out David Dumers at jury trial and got him 15 years in return for a plea bargain of 15 years, then destroyed Dumers' appeal as well. So then ZOG decided to bring this jew rat-fin[c]k into the above-ground Christian Identity community using another set of marrano jews named Eli James and Clifton Emahiser. Right now Baal Finck is high in the ZOG false-flag operation League of the South which obviously does not care that murderous jew ex-pigs who snitched are in their organization and running their Charlottesville x.xx false-flag operations. Bi-Polar Bradifer Griffin / Cunthair Walrus of Occidental Dissent is another ZOGtard who goes all ZOGbot when ZOG pulls his nutty strings and a 257 - 32 - 127 ... big friend of William Baal Finck.

After a jury trial in which over Pastor Lindstedt's objections an African female juror was empaneled -- which should put an end forevermore the whinings about how the all-white juries of the South lynched negroes and acquitted Klansmen with the Emmet Till coontroversy -- and the crooked judge Patrick Condon allowed Bryan Reo to evade the Ohio oneyear Statutes of Limitation on Defamation given that Bryan Reo waited three years to file in federal court, lost when Bryan Reo couldn't prove damages, then refiled on 18 Sept. 2015, the judge allowed Bryan Reo to cherry pick items from Pastor Lindstedt's Aryan Nations Church web page, refused to allow Pastor Lindstedt to show that Bryan Reo was and is a non-white "white supremacist", disallowed Pastor Lindstedt's counter-claims, allowed Bryan Reo to call Pastor Lindstedt a child molester and a convicted one at that, and refused to allow evidence that Bryan Reo was a public-figure insofar as the White Supremacist and Christian Identity movements were concerned.

Even more to the point, the Lake County Court of Common Pleas -- in addition to letting Bryan Reo run wild against Arbitron, Starkist Tuna (twice) and the NRA -- allowed Bryan Reo to sue Pastor Lindstedt's The Church of Jesus Christ Christian / Aryan Nations of Missouri 16CV000825 after the case was refused by the Mentor Municipal Court refusuing fraudulent jurisdiction. At controversy was Pastor Lindstedt drawing inferences from Reo's working for Attorney Kyle Bristow (since Bryan Reo is a predatory homosexual wanting Aryan mangina it was thought that in the FMI lawfare that Kyle Bristow is Reo's long-time hump). But even more to the point is that during one of Bryan Reo's Civil Protection Stalking Order's (CPSO) sought against Pastor Lindstedt 900 miles away and granted because neither Lindstedt nor Lindstedt's Church could afford to travel 900 miles to appear and the Lake County Court refused to allow Lindstedt to testify over telephone. Reo sought and was caught lying on its second (CPSO) from 30 March 2020 to June 4 2020.

Now to the money shot: In early 2016 while Pastor Lindstedt was dealing with the Mentor Municipal Kort litigation or the bogus Civil Stalking Protection Order by responding to it Pastor Lindstedt did a google search and found out why Bryan Reo disabled its Talkshoe account and some of its blog: Reo had gotten a job in the North Perry Nuclear Power Plant and didn't want to be fired for being a white supremacist. Six months later this ailing ill-run nuclear power plant had a series of minor accidents and so the operators did what they should have done in the first place: Do a background check on the workers there and thus they found out about "SwordBrethren" the "Teutonic Crusader" being Bryan Reo of Mentor Ohio, notorious homosexual mongrel ZOGbot with numerous posts on Stormfront about how Reo intended to "stack and whack" the FiBbles & BATF & Lake County Sheriff's Department and all manner of pigs alongside Reo's father

Both Bryan Reo and the crooked Lake County courts in their racial and religious state-sponsored domestic terrorism against Pastor Lindstedt and Lindstedt's Aryan Nations Church ignored the Ohio Statutes of Limitation given that the last time Pastor Lindstedt published that Bryan Reo killed an old white female was on April 2014 and the Lake County lawsuit had a limitation of 18 Sept 2014.)

Rather than admit that they had negligently allowed a delusional non-white homosexual mongrel ZOGbot with fantasies of killing federal and county piglice and delusions of being a pure-blooded Aryan white supremacist instead of just a mamzer faggot ZOGbot psycho nutcase work at the nuclear power plant (rated #103 out of #104) they fired Bryan Reo as an "internal security risk" and Hiram Reppert who was the head of the nuclear technicians department at the Lakeland Community College told Bryan Reo that since Reo was blacklisted from working in a nuclear power plant that Reo was kicked out of the program. In June 2016 this Judge Collins — who was sued before the appellate court to let Bryan Reo attack Pastor Lindstedt's woman Roxie Fausnaught and Pastor Lindstedt's Church for not hiring an agent /attorney — ruled that The Church of Jesus Christ Christian / Aryan Nations of Missouri was in default because Pastor Lindstedt's answers / counter-claims were stricken because "Ohio law says that corporations and individuals have to be [mis]represented by a licensed-by-the-state attorney."

This is, of course, Satanic tyranny. ZOG's precious CONstipation says that their Satanic regime won't issue "patents of nobility" for favored insiders to use their legal process to rob and defraud their subjects. But what is of importance to Pastor Lindstedt and Lindstedt's Dual-Seedline Christian Identity Church is YHWH's Law. And what does YHWH's Law say about this Satanic criminal regime using its Satansspawn jew mischling homosexual mongrel ZOGbot hireling to under color of law to attack the life, liberty and property of YHWH's Servant and YHWH's Servant Nation Church?
