ORDER

On March 29, 2023, the Court consolidated the above-captioned actions and referred them to the undersigned for pretrial supervision. The Court's order contemplates that the four actions would be managed as if they were one case for pretrial preparation purposes. In furtherance of that directive, the court ORDERS that:

Going forward, the parties shall file all pleadings and documents pertaining to any of these consolidated cases <u>ONLY under case number 1:19-cv-2103</u> and NOT in the other individually filed matters. The parties <u>must</u> use the case caption of case number 1:19-cv-2103 for all future case filings. Any filing made under the other case numbers will be stricken. To the extent a filing raises issues that only pertain to fewer than all four actions, the filing party must in the caption of the filing, state: "This filing relates to Case No. [include the pertinent case number]." But, to repeat, the document must only be filed under case number 1:19-cv-2103. Please see the sample caption appended hereto for an example of how to comply with this order.

Based upon the order of consolidation, case numbers 1:19-cv-2589, 1:19-cv-2615, and 1:19-cv-2786 are hereby administratively CLOSED. The Clerk of Court shall add the parties and their counsel from case numbers 1:19-cv-2589, 1:19-cv-2615, and 1:19-cv-2786 to the docket in 1:19-cv-2103 to facilitate future filings.

The court notes that the plaintiffs filed a motion for a status conference in each case individually. The pending motions in case numbers 1:19-cv-2589, 1:19-cv-2615, and 1:19-cv-2786 are hereby DENIED. The court will consider the motion filed in case number 1:19-cv-2103 as applying collectively to the consolidated cases and address it in due course.
