spokesman for “domestic terrorism” than as a pretend lawyer fighting against an agent provocateur such as Bryan Reo with his never-ending Satanic lies.

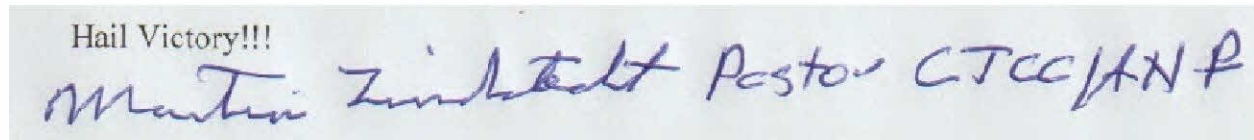
